To the Chairman and Members of the Public Health Committee of the Cannock Rural District Council:-

I have the honour to present to you the Annual Report for the year ending 31st December, 1946 on the health and sanitary conditions of the district: this includes a report by the Senior Sanitary Inspector.

The Birth Rate for the District was slightly higher than, and the Death Rate slightly lower than the respective rates for England and Wales.

Of the Infectious Diseases, the notifications of Scarlet Fever and of Diphtheria were each the lowest for over ten years. There was no severe epidemic during the year; Whooping Cough showed the highest number of notifications.

As in the past years, the Staffordshire County Council has been the Authority responsible for the ante-natal, maternity and child welfare services. Under the National Health Service Act 1946, the County Council will also administer the Ambulance Service from July, 1948.

I wish to thank you, Mr. Chairman, for help and encouragement given throughout the year.

REPORT OF SANITARY INSPECTOR.

ANTHRAX.

During the year 18 suspected cases of Anthrax were reported compared with 10 in the previous year. WATER SUPPLIES.

The chief water supplies in the district remain the same and are obtained from the South Staffordshire Water Works Co., and the Wolverhampton Corporation which supply Cheslyn Hay, Great Wyrley, Huntington, Hatherton, Penkridge and the larger portion of the parishes of Brewood, Stretton, Essington, Shareshill, Featherstone, Hilton, Lapley, Wheaton Aston and Saredon. The Stafford Corporation supplies Coppenhall and Dunston.

The water supplied by the three undertakings is satisfactory in quality and quantity.

31 samples of non-piped water and no samples of piped water have been taken.

When non-piped water is found unsatisfactory, wells are cleaned out; further samples taken, and if the water is still doubtful all Householders using this water are advised to boil it before using.

There is no Plumbo-solvent action in the water supplied by any of the three water companies.

Schemes for supplying water to Acton Trussell and Bednall, Dunston Heath, Shaw Hall Lane, Coven and the Four Crosses and Oak Lane Areas are under preparation and are expected to be put into operation in the very near future.

RURAL HOUSING SURVEY.

The housing survey proceeded steadily during the year, but was unfortunately retarded owing to the Additional Sanitary Inspector leaving in October to take up an appointment elsewhere.

Of the houses inspected 4.91% are considered to be totally unfit for habitation, while 15.71% are considered satisfactory in all respects.

The results of the survey are as follows :-

Statutory lotices.

12 Statutory Notices (including 1 Demolition Order) have been served affecting 32 houses and requiring provision of adequate closet accommodation and Dustbins.

[nformal Some 182 Informal Notices have been served affecting some 533 houses, these are served mainly lotices. on Class 2 and 3 houses requiring urgent repairs to be carried out and on Class 4 and 5 only to maintain them in a weatherproof condition.

The survey revealed that in 17 cases the number of people occupying a house is in excess of the Overcrowding. permitted number. This represents 2.607% of the houses inspected.

PUBLIC CLEANSING.

During the year Public Cleansing by direct labour was continued in the Parishes of Brewood, Penkridge, Stretton, Huntington, Acton Trussell, Bednall and Lapley and the villages of Weston-under-Lizard, Brineton and Blymhill.

The emptying of cesspools in the parishes of Brewood, Cheslyn Hay, Great Wyrley, Saredon, Essington, Huntington, Featherstone, Hilton, Shareshill and Hatherton was done as in previous years by the Council's cesspool emptier.

Collections of Refuse have been fairly well maintained by your Contractor in the Parishes of Cheslyn Hay, Great Wyrley, Essington, Shareshill, Saredon, Hilton, Featherstone and Hatherton.
