### SECTION B. GENERAL PROVISION OF HEALTH SERVICES FOR THE AREA.

In respect of (a) Laboratory Facilities, (b) Ambulance Facilities, (c) Nursing in the Home, (d) Treatment Centres and Clinics and (e) Hospitals, there are no essential changes to note.

### SECTION C. SANITARY CIRCUMSTANCES OF THE AREA.

Water Supply. 2,794 houses were connected to Southend Water Company's mains at the end of the year - an increase of 6.

Drainage and Sewerage. There are 496 connections to the sewer affecting 982 properties. Twelve new connections were made during 1942.

Public Cleansing. 756 loads of refuse were collected from 65 bins, each bin serving several streets.

Salvage. Waste paper is collected on receipt of postcards and also periodical collection is made from various depots on the Island. Tins, scrap iron, rubber, bottles and rags are also collected.

Visits and Inspections. 943 visits were made for public health purposes during the year.

Factories Act, 1937. A total of 25 inspections were made including visits to premises of Outworkers.

Petroleum (Regulations) Acts, 1928 and 1936. 5 inspections were made and one licence was assued during the year.

In other branches of sanitary administration, the usual routine work was carried out but no essential changes occurred.

### SECTION D. HOUSING.

No new houses were erected during the year 1942. 134 inspections were made in respect of repairs carried out under the Housing Act, 1936.

### SECTION E. INSPECTION AND SUFERVISION OF FOOD.

Milk Supply. At the end of the year 7 farms and other premises used as dairies were registered and 20 retail purveyors were also registered.

Milk (Special Designations) Order, 1936. One licence to sell Pasteurised milk and one licence to sell Tuberculin Tested milk were granted.

The licences were supplementary licences for the retail sale of milk in the district.

Meat and Other Foods. No slaughterhouse exists in the District.
Periodical inspection is made of butchers shops and the meat therein examined.

Fish. Fish shops were inspected periodically.

three each from the two vendors of milk on the Island at three separate times and a sample of Custard Powder from a Grocer's shop. All the samples on analysis were found to be genuine.

Milk and Dairies Acts and Orders. Fourteen samples of milk were submitted to the Methylene Blue Reduction Test and three were found to be unsatisfactory.

One sample of milk was submitted to biological examination, the result was negative.

Two samples of Pasteurised milk obtained at a school were submitted to a bacterial count examination, the result was satisfactory.

One sample of sterilised milk was also submitted to a bacterial count examination, the result was satisfactory.

# SECTION F. PREVALENCE OF, AND CONTROL OVER, INFECTIOUS AND OTHER DISEASES.

There are no matters of outstanding importance to report in respect of the prevalence of infectious diseases. Particulars of all cases of notifiable disease occurring in the Urban District during 1942 will be found in the table on page 6.

Scabies. There was an increase in the incidence of scabies during the year, and arrangements are being made for the use of the cleansing section of the First Aid Post at Canvoy Island, for treatment, with the co-operation of the Emergency Medical Services Department - Essex County Council.

The treatment, which will be given on a "family unit" basis, involves a bath and the use of 25% chulsion of Benzyl Benzeate as recommended in the Memorandum of the Ministry of Health, 229/Med, revised June, 1942.

Venereal Diseases. Regulation 33B does not come within the purview of the local sanitary authority.

Diphtheria Immunisation. During the year, the scheme of immunisation against diphtheria proceeded satisfactorily, propaganda being intensified when occasion arose. During the year, 151 children under 5 years, and 144 children between 5-15 years were immunised under the Local Authority's Scheme. At the end of December, 1942, the estimated percentage of immunised children in the district was as follows:-

Under 5 years:

53.4%

5-15 years:

59.1%

It is pleasurable to record that not a single case of Diphtheria was notified during the year.

Tuberculosis. I am unaware of any undue incidence of this disease associated with any local cause or condition. The majority of the cases come from outside the District, chiefly from Greater London, having already been notified and are transfers under the Public Health (Tuberculosis) Regulations, 1930.

During 1942, 11 cases of tuberculosis were notified, 10 pulmonary and 1 non-pulmonary. Of these pulmonary notifications, 3 were males and 7 were females. The non-pulmonary notification was male.

It is regretted that during the year, there were 5 deaths from tuberculosis, 4 pulmonary, 2 males and 2 females, and 1 male non-pulmonary.
