

To the Chairman and Members of the Castleford Urban District Council.

I have the honour of placing before you my twentysixth Annual Report, being a report on the health of your District for the year ended 31st December, 1939.

Acting on the instructions of the Ministry of Health the report is greatly curtailed, and is restricted to dealing with matters which I regard as being of primary importance. Complete records are however being kept for inclusion in a comprehensive report after the termination of the war.

General Provision of Health Services.

These services in respect of laboratory, ambulances, nursing, bospitals (infectious disease and general) midwifery and maternity home, are being fully maintained.

An extensive part time ambulance service has been inaugurated, in connection with Civil Defence.

Maternity and Child Welfare.

. The Maternity Home.

The value of the Home to our people was again fully proved.

Owing to lack of accommodation we had to refuse admission to cases during the year.

Notwithstanding the difficulties arising out of war-time conditions I consider that I must again call your attention to the urgent need for improved and additional accommodation.

The matter has been mentioned in successive reports and I cannot do more than repeat what I said when I last reported to you. viz:-

"I do feel that I must urge the provision at a very early date of proper accommodation for the resident staff, and two additional beds to be kept reserved for emergency cases".

Medical Aid was summoned in 96 cases. Of these 12 were
to Hospital on account of complications.

Clinics. Health Visitors.

The work at the Clinics has proceeded in a satisfactory manner, as has also the work of the Health Visitors.

Details of services above mentioned have already been supplied to the Ministry of Health on Forms MCW 96 and 96 A.

The arrangements for Dental and Orthopaedic services remain as before.

The Sanitary Circumstances of the Area are fully dealt with in the Sanitary Inspector's Report.

Annual Report of the Sanitary Inspector, Year ended 31st. Docember, 1939.

To the Chairman and Member of the Urban District Council.

Gentlemen,

I beg to place before you my twenty-seventh Annual Report.

No attempt has been made to give a complete picture of the work of the Department for the year 1939 owing to the fact that the country is at war.

The activities of the Decartment have, during both the present year and the year under review, been to a considerable extent devoted to work in connection with Air Raid Precautions and Civil Defence. The reason for the omission of many of the usual particulars will therefore be appreciated.

The precaution has been taken however of keeping of necessary records, with a view to the preparation of a comprehensive report at the close of hostilities.

Housing.

The need for the provision of additional houses for persons of the working classes still exists in the district; while some difficulty is being experienced in securing necessary repairs to occupied dwelling-houses.

War time conditions prevented our going forward with projected work in connection with Clearance Areas, action for demolition of unfit houses, and the provision of accommodation for persons who would have been displaced by such action. We were however able to take certain action, particulars of which are given below:-

There were two licences issued under the Milk (Special Designations) Order, 1936, to sell milk as Pasteurised, one of which is a supplementary licence.

As previously reported, there is one dairy in the District where pasteurisation of milk is carried on. In addition to the milk brought to this dairy for pasteurisation, the greater part of the raw milk produced outside the area, and brought into the District for sale by retail, is distributed from this dairy.

For the purpose of bacteriological examination, 55 samples of milk were taken, 46 of ordinary milk and 9 of pasteurised milk. They were submitted to the County Bacteriologist at County Hall, Wakefield, and the results of examination are given below.

All the above samples were further subjected to a biological test, and the following results were obtained:-

Ordinary Milk found to be Tuberculous 1

Pasteurised Milk found to be Tuberculous ... nil

In addition to the foregoing 3 samples were taken of Ordinary Milk for biological test only, and these were found to be satisfactory.

With reference to the sample found to be tuberculous, I am informed by the Public Health Department of the County Council that this was traced back to the farm by the veterinary officer of the Ministry of Agriculture, where a tuberculous cow was discovered and slaughtered. The herd in question was cleared in due course.

It is worthy of note that in the year 1938 we had 10 samples of milk found to be tuberculous, out of 63 submitted, while in 1939 we had 55 samples submitted, of which one was tuberculous, a drop from 16% to 1.8%. This clearly shows the value of regular sampling and biological examination.

Food and Drugs Act, 1938.

Sampling.

In my last report I gave a summary of the provisions of this new Act, and the duties which would devolve upon the Council as a Food and Drugs Authority.

The Act came into force on the 1st. day of October, 1939. The total number of samples taken during the remaining part of the year was 18, comprising:

One prosecution was undertaken, the offence being the attaching of a label to a bottle contaning milk, describing the milk as pasteurised when it had not been so treated, and was calculated to "mislead as to the nature, substance and quality of the said food, contrary to Section 6 of the Food and Drugs Act, 1938."

The defendant pleaded guilty, but this notwithstanding the case was dismissed on payment of costs.

I am indebted to the officers of the West Riding County Council for informing me as to samples taken by them during the first 9 months of the year. These were as follows:-

42 samples of milk. 34 other samples. (dry)

Of these 4 milk samples were found to be adulterated and cautions were issued. All the remainder were genuine.

Meat and Other Foods.

As in previous years careful attention was devoted to the inspection of meat and other foods.

There are 14 private slaughter houses in the district all subject to annual licence.

Early in the present year, one of these was taken over by the Ministry of Food, and all slaughtering for the district is now centralized at these premises. Inspection of all animals slaughtered is carried out.

One prosecution was undertaken, the offence being the depositing and preparing for sale of meat previously surrendered as being unfit for human consumption.

The defendant was convicted, and a fine of £20 imposed.

The number of slaughtermen licensed is 54.

Street Cleansing.

The cost of work done under this head during the present year amounted to £3639. 8. 8d.

The West Riding County Council contributed the sum of £447 in respect of County Roads in addition to the above.

Street Gullies cleansed during the year were as follows:-

Street Gritting and Snow Removal.

The total cost of gritting was £978. 19. 7d and of snow removal £2199. 9. 11d, of which the County Council refunded £401. 16. 2d and £1055. 5. 3d respectively.

The great increase over last year's costs was of course due to the appormal winter conditions.

Transport Work.

Work done during the Year. By Motor Lorries.

Hours worked 28198. Loads hauled 22406, giving an estimated tonnage of 32134 tons 3 cwts, and an estimated mileage of 78674. During the period 15432 gallons of petrol and 3259 pints of oil were consumed.

Motor Vans.

Work done by these two vehicles (Ford van and Dodge van) is as follows:-

Hours worked 1063. Journeys made 2360, giving an estimated mileage of 8501. During the period 569 gallons

of petrol and 91 pints of oil were consumed.

Gulley Emptiers.

Work done by these two vehicles was as follows:-

Hours worked 3592. Gullies cleansed 23329. Other material removed 3686 tons 5 cwts. Mileage 7256. During the period 1860 gallons of petrol and 245 pints of oil were consumed.

The total expenditure for all services including overhead charges and running costs was £4381. 10. 1d.

The income was £348. 14. 8d leaving a net expenditure of £4032. 15. 8d. This does not include drivers wages.

The cost of haulage on these figures was at the rate of 2/2d per ton as compared with 1/10.2d per ton in 1938.

The net expenditure was charged out proportion-ately to the various services of the Council.

The increase in cost was chiefly in respect of petrol and oil purchased and in stock, equipment and loan charges.

A.R.P. Services.

By arrangements with the West Riding County Council petrol has since the outbreak of war been distributed to the various services, from the Council's storage tanks, and re-charged to County Council.

Nearly all the workmen of the Department have been trained in Decontamination work, and are fit to cope with such emergency in this connection as may arise.

The augmented ambulance service, together with cars for First Aid Parties and Sitting Casualties, has been organized by the staff of the Department. They have also co-operated with the Medical Officer of Health in the general organization of casualty services.

Disinfection and Disinfestation.

The steam disinfector installed some years ago is of a type which is now obsolete, and should be replaced by one of modern design at the first opportunity.

House disinfection was done by means of spraying, and fumigation with formalin vapour.

Disinfection of schools by spraying was done from time to time as deemed necessary.

The furniture and effects of 31 families were disinfested before removal to Council owned houses.

In addition to the work done, in respect of families so transferred, attention was given to other occupied dwellings. In this connection 18 Council owned houses and 9 privately owned houses were subjected to disinfestation.

The total sootfall for the year as shown by analysis of the deposit passing through our soot-gauge, was found to be at the rate of 336.37 tons per sq. mile. The amount of tar deposited to the sq. mile was 7.77 tons, and that of sulphur compounds was 28.10.tons.

Petroleum Storage.

There were issued during the year 56 licences for the storage of petroleum spirit and carbide of calcium; the quantity allowed to be stored under licence was 456767 gallons of petroleum spirit and 3146 lbs of carbide of calcium.
