From the Registrar General's figures, 14 still births occurred during the year. This is a large figure and would give a rate per 1,000 (total live and still births) of 57.6. If these figures are accurate, (they do not agree with the

return made by the Local Registrar) than they appear to require investigation and point to some undesirable influence at work in the district.

POPULATION.

The Registrar General's estimate of the population for the Rural District is (a) 15,140. (b) 15,650. The comparability factor being 0.79.

BIRTH RATE.

There were 229 live births compared with 242 in 1938, giving a Birth Rate of 15.06 per 1,000 of the estimated population.

DEATH RATE.

The total number of deaths of persons ordinarily resident in the area was 267. This would give a Death Rate of 17.06, for purposes of comparison with the other parts of the county this rate should be multiplied by 0.79 which would give the corrected rate of 13.47.

INFANT MORTALITY.

Out of the 229 children born only 6 died before reaching the age of one year, of these deaths only one was an illegitimate child. The infant mortality rate was 26. per 1,000 births, a remarkably low rate.

MATERNAL MORTALITY

There were no deaths from puerperal sepsis or other puerperal diseases during the year.

Section C.

SANITARY CIRCUMSTANCES OF THE AREA.

Water.

Negotiations took place for leasing springs at Stanway and Stanton. A Ministry of Health enquiry was held and approval obtained. The Toddington Estate water supply was purchased for the sum of £2120.

Extension of Existing Water Mains.

5,000 yards of 4" main relaid at Bishops Cleeve, Woodmancote & Southam at a cost of £3440. 750 yards of 6" main at Southam, estimated cost £760. 3750 yards of 4" and 7" mains at Toddington, estimated cost £3650.

All gathering grounds were inspected. 112 samples of water were taken for analysis of which 54 were satisfactory and 58 unsatisfactory. There were 117 new connections with the public water supply, 51 being with the Borough and 66 with the Rural District mains.

One spring at Cleeve Hill was found to be contaminated and discarded. During May and June the use of water at Bishops Cleeve and Cleeve Hill was curtailed.

Drainage & Sewerage.

Private undertakings at Southam were taken over and modernised. A new sewage scheme in connection with a factory at Southam was commenced during the year at an estimated cost of £6360. Sanction was received to raise a loan for disposal works at Greet at an estimated cost of £1750, but the work was not proceeded with.

Rivers and Streams.

Pollution of the Hyde Brook occurred as a result of the occupation of Prestbury Racecourse by the Military Authorities. A new plant is about to be constructed.

Closet Accommodation.

16 earth closets were improved and 66 earth closets were converted to W.C.'s.

Public Cleansing.

The collection and disposal of house refuse is carried out in the following parishes:- Prestbury, Leckhampton, Woodmancote and Winchcombe. Private arrangements exist at Southam and Stanton.

70 visits were paid to 32 factories (without mechanical power) and in 3 of these the drainage systems were improved.

25 visits were paid to 15 factories (with mechanical power). Fire exists were improved in two cases.

Bakehouses.

18 visits were paid to 9 bakehouses. One notice was served to repair the roof.

Tents, Vans and Sheds.

13 visits were made to 5 vans, in 3 cases the land was cleared after representations were made to the owner.

Cowsheds and Dairies.

275 inspections of 215 cowsheds were made. 12 cowsheds were newly erected or improved. 7 cooling rooms or dairies were provided.
