# INFECTIOUS DISEASES

The following table shows the incidence in age groups of infectious diseases occurring during the year. Eighteen cases of Scarlet Fever (15 of which occurred at Whiteacre Lane Camp School) and one case of Erysipelas were removed to Isolation Hospital.

One case of Diphtheria occurred at Calderstones Institution, a male age 20,

Hospital facilities for ordinary infectious diseases were available by agreement with the Corporation of Darwen at their Isolation Hospital at Bull Hill, Darwen. For smallpox cases an arrangement existed with the Blackburn Corporation for isolation should this be necessary.


Disinfection is carried out by means of fumigation when required.

Formalin is used and only terminal disinfection is done by the Council. An arrangement exists with Clitheroe Corporation by which means at man disinfection of bedding etc. can be effected. There is no suitable vehicle for the transport of infected bedding to the steam disinfector.

Thirty-two premises were disinfected during the year.

Diphtheria anti-toxin was available to medical practitioners by the Council on request.

During the year 18 specimens were submitted for examination, 17 being in relation to diphtheria, and 1 Sputum.



# NATIONAL HEALTH SERVICE ACT, 1948

The above came into force on July 5th, 1948 and with it the appropriate changes in the various services covered by the Act were made.

The Ambulance Service, for example, was provided by the Clitherce Rural District Council up to July 5th, 1948 and by the Lancashire County Council thereafter. They continued to use the ambulances and car for sitting cases provided by Messrs Temlinsons (Clitherce) Ltd.

The contracts with various hospitals for cades of infectious diseases ceased to be the responsibilty of the Clitheroc Rural District Council on the same date.

All the local General Medical Practitioners joined the Practitioner Service and at the end of the year the scheme appeared to be working as smoothly as could be expected after a period of six wonths.

# TUBERCULOSIS


The total number of cases notified in the year was 10 compared with 13 in 1947.

# WATER SUPPLIES.

The water supply throughout the district is provided chiefly by mains either in public or private ownership. The sources of supply are mostly from moorland springs. Water to the Council's mains is derived from Blackburn Corporation for Hurst Green and Woodfields, from Clitheroe Corporation for portions of Pendleton, Barrow, and to supplement the Council's own supply at Whalley and from the Accrington District Gas and Water Board for the Cock Bridge and Portfield areas of Whalley, Downham, Pendleton, Twiston and Little Hitton and the greater portion of Barrow are supplied from sources and mains in private ownership.


Chatburn, Worston, Chipping and Thornley-with-Wheatley are supplied from the Council's mains which receive water in bulk from springs in private ownership.

The quality of the water supplied to the district is generally satisfactory. The water supply at Whalley which is regarded as being of doubtful bacteriological quality has been safeguarded in this respect by the installation of a chlorination plant.

None is liable to plumbo-solvent action.

As regards quantity there has been no shortage of water to the properties supplied. Some areas of the district are in need of an increased supply, particularly for agricultural requirements. Many farms rely on independent supplies which are known to be inadequate.

Samples from 6 parish supplies were submitted for Chemical and 6 for Bacteriological examination. Bacteriological examination shewed 5 satisfactory and 1 unsatisfactory, but Chamical data shewed there had been no gross pollution. Chemical examination shewed 6 to be satisfactory.

9 samples of proposed private supplies to outlying properties were submitted for examination with the following results:-

The Council purchased the ex W.D. main supplying Moreton Hall and completed an agreement with Accrington District Gas and Water Board for the bulk purchase of water to supply Cock Bridge Cottages, Moreton Hall and the dwelling houses at Portfield Bar. A new 3" water main was laid from Moreton Hall Lodge, by contract, to the Portfield Bar area. All individual houses have been connected to the new main with satisfactory results. This provides a supply to ten houses and to Moreton Hall.

## Mitton Road, Whalley.

Owing to very poor pressure to dwelling houses in the Calderstones area, a new 4" Asbestos main was laid to replace the old 2" main from Brookes Lane to the junction of Broad Lane, a distance of 530 yards. The new main appears to have remedied the previous lack of pressure.

# SEWERAGE AND DRAINAGE.

The existing sewage disposal works at

# Chatburn.

These works were extended by the addition of one settling tank and slight adjustments made to accommodate the new and increased effluent from the Downham area.

A new main sewer was connected from Ribble Lane, Housing Site was completed and connected direct to the Disposal Works.

# Chipping.

Some progress was made during the year with the construction of the Disposal Works and the laying of the main sewers.

#### Downham.

The laying of the main sewer from the village to the connection to the existing sewers at Chatburn was completed.

All houses and premises in the village area were converted from pail closets and middens to Water Closets and connected to the new sewer. The whole of the connections were carried out during the year.


# Hurst Green and Stonyhurst.

The bulk of the work on the sewers and Disposal Works was completed towards the end of the year, it is hoped that the existing water closets now connected to septic tanks will be made to the sewer early in the new year and that the conversion of pail closets to water closets will proceed as quickly as possible.

# Whalley/Caldorstones.

Those works are constantly overloaded and working to full capacity in normal dry times.

Reports of bad samples of effluent are continuously being received, The time is fast approaching when serious consideration be given to the extension and modernisation of the present works.



# Wiswell/Barrow.

These works have continued to function satisfactorily without any adverse samples being reported.

# Pendleton, Worston.

These villages are not yet provided with public sewers. Both schemes have been prepared.

In the following townships, Chaigley, Little Bowland, Little Mitton, Mearley, Thornley and Twiston, it is impracticable to provide public sewers and the necessary sewage disposal works owing to the scattered properties.

# REFUSE COLLECTION AND DISPOSAL.

The greater portion of the District is scavenged by a system of direct labour and the hiring of two vehicles and drivers under contract to the Council. Hurst Creen, Woodfields and Stonyhurst are now included in the area covered by direct labour.

The system provides for the emptying of demestic and trade refuse every two weeks and for the emptying of pails every week, this schedule being maintained as regular as possible though often owing to sickness and holidays the bins have been allowed a three week period before emptying, but every endeavour is made to empty the pails every week.

Salvage is collected along with the refuse and bailed and disposed of at regular intervals.


The refuse is disposed of by the tipping at Tips under the Council's control situated at Chatburn, Pendleton, Whalley, Hurst Green and Chipping.

Very few ashpits are now outstanding and efforts have been made to cradicate all existing ashpits throughout the District.

The housing conditions in the District are fairly good judged by Rural standards. Considerable improvements have been carried out to property in the area rectifying some of the disrepair occuring during the war years. The relaxing of the Control of Civil Building 'free limits' from £10 to £100 in any one year proved of great assistance.

The operation of the Rent Restriction Acts has a detrimental influence on the condition of tenanted houses by the prohibition of rent increases for repairs. The continued high cost of building repairs compares unfavourably with the stabilised rents of houses. Little progress in the survey of houses as recommended in the Hobbouse Report was accomplished during the year due to changes in and shortage of staff.

With regard to the provision of new houses the Council were alloted a further allocation during the year of 18 traditional houses, Chatburn was allocated 12 houses and Hurst Green a further 6 houses. The construction of two Airey houses at Chatburn commenced during the year; these being incomplete at the end of the year, very slow progress having been made to the slow delivery of the Ministry of Health's supplied components.

Work on the Chipping Housing Site continued; at the end of the year 18 houses were occupied and the remaining 14 were in an advanced stage of construction.



Construction of the first six houses at Hurst Green commenced in Jamuary and the six houses were occupied at the end of the year. The six houses built by private enterprise for Stonyhurst College were completed at the end of the year.

# INSPECTION AND SUPERVISION OF FOOD.

# Milk Supplies.

The administration of the Milk and Dairies Acts, Orders, and Regulations depends entirely on the frequent and regular inspection of cowsheds and dairies which was maintained during the year. The Lancashire County Council's Sanitary Officers were accompanied on their visits to Tuberculin Tested and Accredited Farms. The number of milking machines in operation continues to increase and attention is directed towards the proper cleansing of the various parts of the equipment.

## SLAUGHTERHOUSES,


A licence for the slaughter of animals was renewed to the Co-operative Wholesale Society of Manchester for their premises at Shaw House Farm, Whalley. These premises are under the Ministry of Food and used for storage only.

#### INSPECTION OF HEAT AND OTHER FOODS.

The slaughter of animals for human consumption and the inspection of carcases continues under the control of the Ministry of Food in the Borough of Clitheroe.

Inspections of Meat and Shops and Vans in your District have been made, no diseased or unsound meat was found.

Thenever practicable pigs slaughtered for home consumption have been inspected for the protection of the consumer. During the year 81 pigs were slaughtered for home consumption, 29 of this number were inspected; no diseased or unsound carcases were found.



Ice Cream.

8 premises are Registered for the Hamufacture and Sale of Ice Cross and 4 premises for Sale and Storage only. All were frequently visited during the summer months.

Six samples were submitted for examination and reported upon as follows:-

### FACTORIES ACT 1937.

The Factories in the District are in fairly good condition.

61 Factories are in operation in the District 25 of which were inspected. Five defects were discovered and remedied without recourse to Statutary Action.

# RODENT CONTROL.

A full time Rodent Operative is employed by the Council. Properties throughout the Area are surveyed regularly and treated as necessary. The Council has provided a free service for dwelling houses. Business premises are charged for treatments carried out.

All Public Sewers are treated twice yearly in accordance with the Ministry of Agriculture and Fisheries'instructions and under their supervision for which work the Ministry grant is received. Tips and sewage disposal works are frequently treated.
