To the Members of the Cowes Urban District Council :

MR. CHAIRMAN AND COUNCILLORS

I have the honour to submit the Annual Report on the health of the district for 1967.

The Birth Rate fell from 15.8 to 13.8. Out of the 246 births, 19 were illegitimate.

The Death Rate fell from 15.3 to 12.6.

The Infant Mortality Rate fell from 14.2 to 8.1.

There were five deaths from suicide, four of which were attributed to an overdose of sleeping pills.

No cases of food poisoning, diphtheria or poliomyelitis were notified. There was one death from tuberculosis.

Water Supplies

The water supplies have been satisfactory in quality and quantity. The results of bacteriological examination were :-

It is probable that the unsatisfactory sample was caused by a sampling error as subsequent check samples all produced satisfactory results.

The water is hard and not liable to be plumbo-solvent.

No contamination occurred.

Sewerage

The town continued to discharge crude sewage into the Solent and River Medina. While there is no evidence that the discharge of sewage into the open sea is harmful to health, I doubt if the waters around Cowes could be regarded as open sea in this context. As was stated in last year's report, the answer to this problem must be found and the longer the delay the more expensive will a suitable scheme become.

Offensive Smells

During the summer months, Cowes suffered for brief periods from offensive smells. One source was the seashore in East Cowes - probably decaying seaweed, and the other source was a farming area in West Cowes concerned with pigs and poultry.

These smells were not in any way a direct cause of illness and did not, as a few people thought, cause sore throats.

If, however, these odours prevented people from keeping their windows open and from enjoying the normal use of their gardens, they could have had an adverse affect on health. There was no effective action that the Council could have taken regarding the farm smells but the Council was naturally concerned with the state of the beaches. How to relieve East Cowes from this unpleasant experience during hot weather is still unsolved.

Noise

The amount of noise we have to endure increases from year to year. Apart from the noise of road traffic, there was an increase in noise from hovercraft, helicopters, power boats, transistor radios and a new type of fog horn. This increase will no doubt continue - in the name of progress.

Refuse Disposal

The disposal of refuse from the district, on an open tip, continued to be a matter of concern. This method of disposal encourages flies, rats, and other vermin. As the tip is invariably on fire there is also a nuisance from smoke. I am glad to record that this Council is now considering a more modern method of disposal.

Milk

A number of families in the district continued to take unpasteurised milk. This raw or "farm" milk as it is called, is supposed to taste better but I doubt if many people could tell the difference between raw and pasteurised milk. Furthermore, those who drink unpasteurised milk take an unnecessary risk.

Health of Schoolchildren

During the year, in my capacity of School Medical Officer, I examined many of the schoolchildren in the district and, in the vast majority, the standard of fitness was high. There were, however, too many children who were overweight and in many instances this was due to lack of exercise associated with far too much time being devoted to the television.

Casualty Services

During the year there was concern regarding the closure of the casualty department at St. Mary's Hospital at weekends. This particularly affected the people of West Cowes. Fortunately the staff situation improved and weekend casualty services were resumed. It is not easy to find doctors for this type of work and it needs mentioning that the public should not impose upon them by expecting them to provide an alternative service to that provided by the family doctors. The Casualty Department is meant only for accidents and other similar emergencies.

Acknowledgment

As this was the last full year in office of your Senior Public Health Inspector, Mr. P.G. Woods, I should like to place on record the sincere gratitude of the Medical Officer of Health to Mr. Woods for his loyalty and co-operation throughout his service. Nothing has ever been too much trouble for him and he will long be remembered for his enthusiasm and conscientiousness. He was extremely well supported by his Assistant Mr. Sullivan, and during the various occasions I have acted as your Medical Officer of Health I have been extremely grateful to both of them for their loyalty and support.

Dr. John Mills

During the year under review Dr. John Mills was your Medical Officer of Health, and the sad news of his death earlier this year came as a shock to all of us, especially those concerned with Public Health. He will be remembered for his kindness and great sense of humour. Those of us who worked with him will also remember him for his wide knowledge of medical and health matters and his ability to apply this knowledge effectively. This district has indeed been fortunate in having, during the last twenty years, a Medical Officer of Health of such outstanding ability.

SANITARY CIRCUMSTANCES OF THE URBAN DISTRICT

For the sixth successive year the qualified Inspectoral staff remained unchanged.

The year saw the final rehousing of all families remaining in properties previously condemned for Slum Clearance, allowing limited progress on the current five year programme, together with some Individual Unfit Houses discovered in the course of routine work.

It was not found necessary to resort to legal proceedings in any instance during the year.

684 minor rat infestations and 115 minor mice infestations were dealt with. There were no major infestations.

After treatment by poisoning with warfarin, the bodies of 393 rats and 76 mice were recovered and destroyed. No evidence of immunity against warfarin was apparent.

VERMIN AND INSECT CONTROL

No charge is made by this Authority for general disinfection services.

12 complaints of the presence of fleas in private houses were dealt with during the year and extermination of cockroaches and other beetles; woodlice, silverfish, ants, etc., totalled 106 cases.

57 wasps nests were destroyed by the staff of the Department and a proprietary form of Sodium-Cyanide powder was used for the purpose.

DRAINAGE

(a) General

228 inspections were made in connection with examination, testing and supervision of repairs and renewals of existing drainage.

(b) Public Sewers vested in the Local Authority

Section 24 of the Public Health Act, 1936, governs the procedure in connection with these combined drains and clearance of 19 stoppages in public sewers - draining 40 houses - was carried out at the expense of the Local Authority..

COUNCIL HOUSING

640 visits and inspections were carried out in connection with all housing management matters delegated to the department. This figure included 202 inspections of houses to determine their condition of repair, overcrowding, decoration, observance of Conditions of Tenancy and whether the premises were maintained in a cleanly condition.

The Council's second block of flats for old people at Victoria Grove, East Cowes, was commenced during the year, and should be ready for occupation in the latter part of 1968.

POULTRY INSPECTION

There is only one processing establishment in this area, which produces approximately 600 turkeys for the Christmas trade.

The birds are bought as "poults" in late August or early September.

Although the birds are killed - by neck-wringing - on the farm, all evisceration and dressing is done at one of the producer's local shops at which all facilities required by the Food Hygiene Regulations are available.

22 visits were made, to the farm during the development of the stock and to the shop during the time of being prepared for sale.

No birds were rejected as being unfit for human consumption at or after the time of slaughter.

Apart from the usual number of electrical faults in refrigeration plants there was considerable damage due to flooding in a multiple store during a very severe rainstorm.

FOOD AND DRUGS ACT, 1955

(a) MILK

There are 57 registered milk dealers and 5 Dairies in the District.

Samples of milk were taken during the year from herds whose milk is retailed raw without heat treatment. These samples were examined at the Public Health Laboratory, Portsmouth, for the presence of live Tubercle Bacilli.

ICE-CREAM

The number of premises registered in this district for the manufacture, storage and sale of ice-cream is 107 although there are now no actual manufacturers.

7 new registrations were made during 1967.

40 samples of ice-cream were taken for bacteriological examination, the results of which were as follows :-

Grade I and Grade II samples being accepted as satisfactory, only the seven Grade III and one Grade IV samples of the total examined failed to satisfy the exacting tests applied.

The one Grade IV result and three of the Grade III results were from samples taken on the same day. There was some doubt that the sample jars supplied by the Laboratory were completely sterile, as one of the Grade III results was of a wrapped brick, and subsequent re-sampling produced four Grade I results from the same sources.

The other Grade III results were obtained from the same soft-ice machine in spite of a thorough check on the cleansing methods. The trouble was eventually traced to a neoprene rubber component with a roughened surface and replacement of this part resulted in improved grading.

FOOD COMPLAINTS

Eight complaints of food alleged to be unfit for human consumption were received during the year.

Formal warning letters were sent in connection with two of these complaints, as follows :-

(1) Coil of metal in serving of baked beans:

In this case the warning letter resulted in replacement of an unsatisfactory can-opener by an improved appliance.

(2) Loose and excess solder in tin of grapefruit:

On investigation in country of origin, found to be the result of a mechanical fault in the can manufacturing process.

In four cases informal action satisfied the complainants; one, of fungicidal spray dried on the surface of tomatoes, after reference to the Public Analyst proved to be non-toxic and another, similarly referred to the Public Analyst produced no substantive evidence leaving one to assume that any foreign matter must have been confined to the eaten portion of the food.

One complaint, of a sealed product bought in an adjoining district, was referred to that Authority for investigation.

In the remaining case no action was taken as the complaint was found to be unjustified.

FOOD POISONING

No case of Food Poisoning was notified during the year.

SHOPS ACT, 1950

There are now 329 registered shops in this district.

63 inspections were made under the Act which included evening and Sunday observations in connection with "Closing Hours. In this particular connection the Local Authority exercise delegated powers from the Isle of Wight County Council.

On no occasion was it found necessary to serve a notice for any contravention of the Act.

WATER SUPPLY

The mains water supply to the Cowes area is derived solely from the Isle of Wight River and Water Authority an authority upon which all local authorities on the Island are represented.

The sources of this supply remain unchanged, from the wells and boreholes in the chalk and green sand at Carisbrooke and the Bowcombe Valley, supplemented by approximately 20% per day from the local deep well at Broadfields Pumping Station. The Broadfields Reservoir, previously fed entirely from this deep well, is now supplemented by a piped supply of water from Newport.

Analyses of local water supplies show no evidence of plumbo-solvent action and no special precautions are therefore necessary. There is a natural fluoride content of rather less than .1 part per million.

There are 6,184 dwelling houses in the area with an estimated population of 18,000 all of which are supplied from the mains.

Samples for bacteriological examination are taken regularly by the staff of the Water Authority and results sent to the Public Health Department. Where considered necessary check samples are arranged or taken by the Public Health Inspectors. The source of the supplies to the sub-areas included in the following table is subject to variation. The results of the 65 samples taken were :-

It will be seen that of the 50 samples taken from consumers' taps, one was classified as unsatisfactory but subsequent check samples all produced satisfactory results.

SWIMMING AND PADDLING POOLS

There are no swimming pools in the district open to the general public, the only open-air pool being in the grounds of a holiday camp, which is in continuous use by the camp visitors during the summer season, and is also used, by permission of the camp owners, for swimming instruction to the pupils of two local schools by the Isle of Wight Education Authority.

Five samples were taken from this pool for bacteriological examination, all of which produced satisfactory results.

There is also a children's paddling pool at this camp and another at a Caravan Camp. Both are fed from the Isle of Wight River and Water Authority mains, and are mechanically chlorinated. The eight samples taken - four from each site - all produced satisfactory results.

The indoor swimming pool at a local school functioned satisfactorily throughout the period it was used by the pupils. There was no recurrence of the troubles experienced during the previous year and it was thereafter considered unnecessary to sample the water more frequently than at monthly intervals.

Seven samples of the water were taken for bacteriological examination, all of which were returned as satisfactory.

The Local Authority have a children's paddling pool on East Cowes Esplanade in which sea water is used and is hand-chlorinated by the daily addition of an hypochlorite solution.

All eight samples of this water proved satisfactory.

It is noted that all the satisfactory samples indicated above isolated

neither coliform bacilli or foecal coli (type 1) per 100 ml.

CARAVAN SITES

There are five licensed Caravan Sites in the area, three at West Cowes and two at East Cowes. The permitted number of caravans on these sites is 175.

FACTORIES ACT, 1937

Local Authorities or "District Councils" as they are termed under the Factories Act, 1937, are responsible for administering the provisions relating to :-

Sanitary conveniences in all types of factories;

Cleanliness, overcrowding, temperature and ventilation in non-mechanical power factories; and

Homework (Outworkers) - Conditions of premises in relation to health of outworkers.
