



Hawkers of food and their premises are required to be registered under this Act. Seven hawkers are registered to trade in the Borough and periodical inspection of their vehicles ensured a satisfactory standard being maintained

Ice-Crean - Food and Drugs Act. 1955 - Section 16.

83 visits were paid to premises registered for the storage and sale of ice crean under the above section. 72 samples were taken for bacteriological examination and submitted to a methylene blue reduction test. 70 samples were reported as satisfactory, 61 being placed in grade one and 9 in grade two, whilst the two unsatisfactory samples were placed in grade three and one in grade four.

Milk Supply - The Milk and Dairies (General) Regulations 1959. The Milk (Special Designation) Regulations 1963/72.

At the end of the year 87 persons were registered as distributors of milk, and in each case a dealers licence was in force for the sale of pre-packed designated milk.
