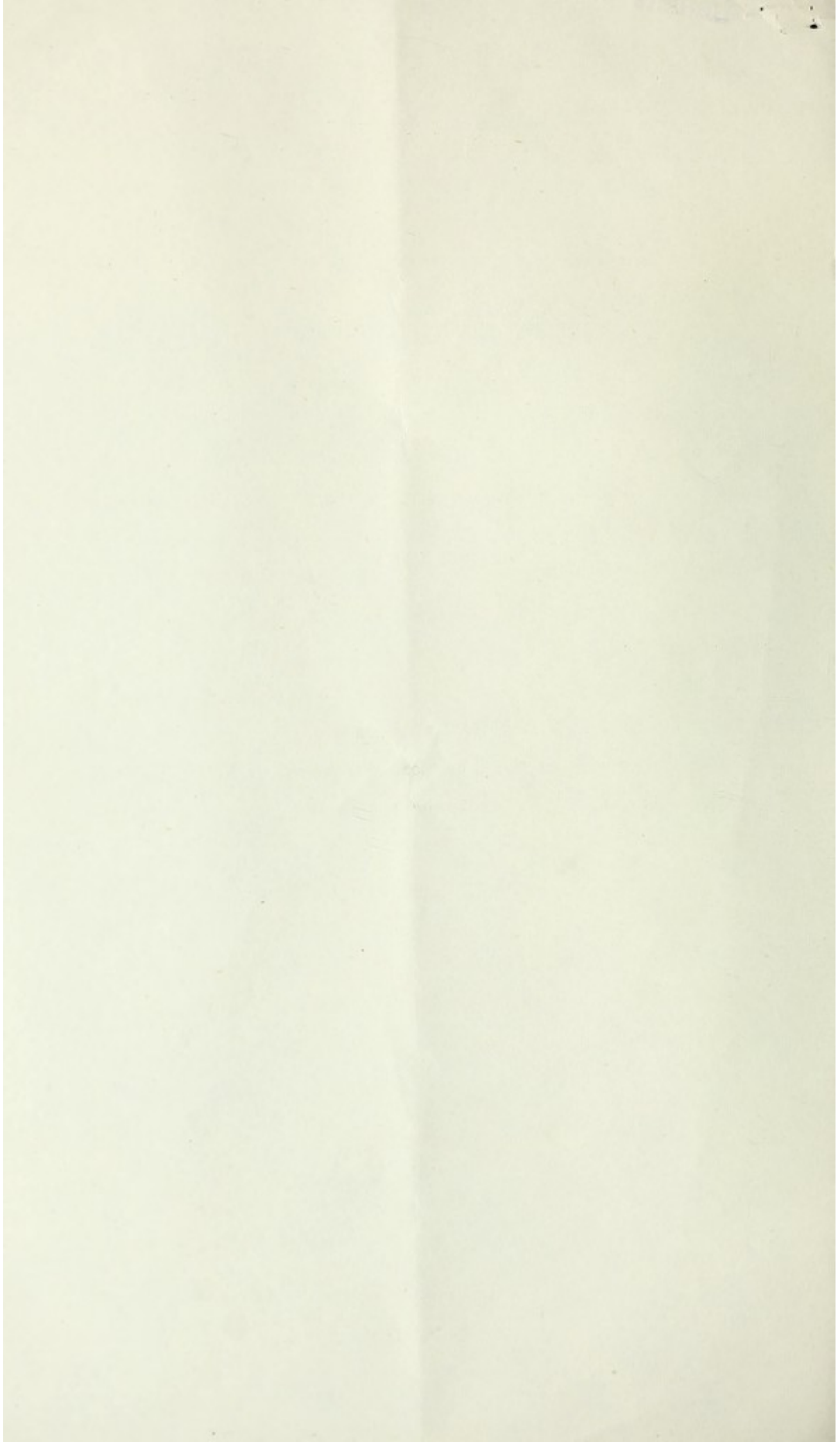

Gentlemen:

In the absence of Dr. C.A. O'Neil, F.B. CH.B B.A.O. it is my duty and privilege to present to you the annual report upon the health and sanitary circumstances of the Darlington Rural District Council for the year ending the 31st December, 1946.

So far as the health of the population as a whole is concerned, and so far as it can be measured by the incidence of infectious and other diseases, the year 1946 may be described as being rather better than the average. The usual vital and mortal statistics do not vary much from the normal.

During the early part of the year six cases ~~cases~~ of contact with Smallpox arrived in the district (service-men returning from abroad). In each case an examination and enquiries were made but no case of Smallpox resulted.

The progress on schemes of housing, water supply, sewerage and sewage disposal appears very slow and it is hoped that the improvement will be more marked next year, although considerable difficulties brought about by shortage of labour and materials still lie ahead.

My grateful thanks are due to your Surveyor and Sanitary Inspector who together with his staff have diligently dealt with the work of the department, and I also would like to acknowledge the courtesy afforded by the Chairman and Members of the Council.

SOCIAL CONDITIONS AND EMPLOYMENT.

The chief industries are Agriculture, Lime Burning, and General Quarrying. Many of the population are engaged in works in the Borough of Darlington, the Urban District of Shildon and The Rural District of Stockton.

The conversion of the Royal Ordnance Factory at Aycliffe into a Trading Estate has made good progress to date. There are 42 industrial undertakings operating as tenants on the Estate and employing approximately 2,600 people. Some of these undertakings have come from other parts of the country necessitating the importing of key men into the area. In view of this and the need for housing in connection with the Trading Estate the Minister of Town & Country Planning has considered the necessity of a new town at Aycliffe. Sites have been suggested one south of the existing village and the other to the north.

Messrs. Crossley & Sons, Brick Factory at Hurworth is now in the course of erection and it is hoped that by the autumn of 1947 it will be in production.

Messrs. W. H. Arnott Young Limited commenced in February with the demolition and site clearance of the Linthorpe and Dinsdale Smelting Company Limited works at Middleton-St-George. These comprised three large furnaces, engine shops and approximately six miles of railway sidings. Approximately 20-30 men have had employment during the year and 8,000 tons of iron and steel and 1,000,000 bricks have been salvaged which will help to meet the present shortage of these materials. The Linthorpe & Dinsdale Smelting Co. Ltd., has not operated since 1931 and I understand that the derelict works have been cleared to provide sites for light industrial undertakings.

Unemployment in the area during 1946 was negligible and those out of work were suffering from physical handicap or were past middle age. Aycliffe Trading Estate is still absorbing a large amount of labour and will continue to do so during 1947.

The number of children immunised against Diphtheria during the year was 47, of this total 5 were of the 5 - 15 groups and 42 of the 0 - 5 group. The percentage of immunised children in the area is 81 per cent, in the 5 - 15 group, and 51 per cent in the 0 - 5 group.

SMALLPOX

SECTION C. SANITARY CONCERNANCES, WATER SUPPLY, SEWAGE DISPOSAL.

WATER.

for

1. No samples of water ~~for~~ chemical and bacteriological examination have been taken by the Council from the Tees Valley Water Board, Darlington Corporation or the Durham County Water Board. No complaint has been received regarding the quality of the water, as regular sampling for the purposes of analysis is carried out by these public bodies.

2. The water supply to the major part of the Rural District is by public mains (within the statutory areas of the Tees Valley Water Board, The Darlington Corporation, and the Durham County Water Board) and has been satisfactory both in quality and quantity. However, there are parts of the area which have an unsatisfactory supply both in quality and quantity, as follows:- Houghton-le-Side, Houghton Bank, Great Stainton, Walworth Castle, and Walworth Gate, also several isolated farms.

3. No waters within the area of the Rural District are known to have Plumbo-Solvent action. The degrees of hardness are given as follows: Durham County Water Board 2.5; Darlington Corporation 8; and the Tees Valley Water Board 4.8.

4. The proportion of dwelling houses and the proportion of the population supplied from public water mains being as follows:-
was

(a) Direct to the houses 90.8 of the houses and 79.8 of population.

(b) By means of Stand-pipe 7.6 of the houses and 6.8 of population.

IMPROVEMENTS.

(a) Redworth

As a direct result of the unsatisfactory sample of water taken from the public well at Redworth and following the installation of a standpipe from the Durham County Water Board's mains last year, the owners of the 21 houses concerned after service of Statutory Notice laid on a piped water supply within each house.

(b) Bishepton

Further to the sampling of the public well and resultant unsatisfactory analysis found last year, Statutory Notices were served on the owners of 21 houses where the occupiers took this water supply from the well. Resulting from the action a piped water supply has been laid within 16 houses from the Tees Valley Water Board's mains. It was agreed in one case not to require the notice to be complied with on receipt of a letter from the owner promising that the premises concerned shall cease to be used for housing purposes immediately the tenant finds alternative accommodation. With regard to the other 4 houses it is hoped they will be dealt with next year.

PROPOSED SCHEMES

WATER SUPPLY & SEWERAGE ACT, 1944.

(a) Houghton Bank and Houghton-le-Side.

In connection with the proposal mentioned in last year's report to afford a supply of water to Houghton Bank and Houghton-le-Side particulars and estimates of the scheme have been considered by both the County Council and the Ministry of Health and approved. It is hoped that the main will be ready next year. This scheme is being carried out in conjunction with the scheme of Barnard Castle R.D.C. providing for the laying of a 6" main through the above area to Bolam at a cost of £5,700. Half of this cost to be borne by each Council.

(b) Great Stainton.

It was decided after very careful consideration to submit a scheme to the County Council and the Ministry of Health for approval for a supply of water from the Durham County Water Board's proposed main at Stainton Hill House to Great Stainton. This scheme which is estimated to cost £1,424 for the laying of 2200 yards of 3" main is to be carried out in conjunction with one proposed by the Sedgfield R.D.C.

(c) Walworth and Walworth Gate.

A scheme estimated to cost £3,200 and providing for the laying of 3,800 yards of 4" and 400 yards of 3" water mains from Heighington via Cross Lane and Walworth Gate to Walworth was approved by the Council and submitted to the County Council for approval.

(d) Neasham Low, and Over Dinsdale.

The Tees Valley Water Board were advised of the inadequacy of the existing supply at Neasham (pressure and volume) and in connection with its improvement were informed of the possibility of the Council requiring an extension to afford a supply to Over Dinsdale and Low Dinsdale. We are now waiting for an estimate and report from the Tees Valley Water Board.

SEWERAGE & SEWAGE DISPOSAL.

Improvements.

The survey having been made of the whole of the Rural District in connection with sewerage and sewage disposal preliminary estimates for Improvements, extensions, and new works amounting to £67,657 were submitted to and approved by the Council and the County Council.

The Parishes concerned being Archdeacon Newton, Aycliffe, Bishopton, Blackwell, Brafferton, Coatham Lundeville Transport Cafe Area, Great Burdon, Great Stainton, High Coniscliffe, Hurworth, Low Coniscliffe, Merrybent Estate, Middleton-St-George, Neasham, Piercebridge, Sadberge, Summerhouse and Whessoe.

Four small private drainage schemes were carried out during the year to isolated properties.

Rivers and Streams (River Pollution Prevention Act).

River Skerne

The County Council Report's indicate that some pollution was observed in the third quarter but after preventative measures had been taken the last quarterly report indicates that the river is free from serious pollution.

River Tees.

The condition of the river shows evidence of pollution by deposits of Whinstone Dust before it enters this district.

No complaint has been received from the County Council regarding any pollution in this District.

Bishopton Beck.

Some pollution of this beck was reported in the County Council's second Quarterly Return but later returns show that the condition of the beck has improved.

General

During the year all of the Council's sewage disposal works received attention from time to time, so that as far as possible every effort was made to prevent a pollution of the river and water courses concerned.

CLOSET ACCOMODATION

During the year 11 ash closets and 16 privy middens were converted into water closets under Section 47 of the Public Health Act, 1936. The owners of the property concerned receive a grant of half of the cost, the maximum grant paid being £12-10-0 for each conversion.

During the year, the Council paid £218-15-0 on grants as against £40 the previous year.

This work is carried out by direct labour, and for this purpose the Council own the following vehicles:-

- (1) Morris 30 cwt. vehicle (first registered March, 1935).
- (2) Vulcan 2 ton vehicle (first registered January, 1935).
- (3) " 2 " " (first registered February, 1926).

The third vehicle is mainly used for general sanitary work but in case of emergency it is made available for scavenging purposes.

In November the Council brought into use a new Bedford 3 ton vehicle to replace the Morris vehicle.

A new Ford 10 cwt van was made available from 1st April, for the use of the sanitary and Scavenging foreman to carry out miscellaneous duties.

Wet scavenging (i.e. Cess Pool emptying) is carried out in the following Parishes where the Council are responsible for the maintenance, repair and emptying of certain cess pools.

This work is done by direct labour, the Council employing a team of five men, all are continuously employed emptying cess pools, scraping and flushing sewers and generally attending to the Council's sewage works.

CIVIL BUILDING LICENCES.

The Council as Licensing Authority were authorised to issue licences for all Building Works costing over £10 and under £100 and costing over £100, in the case of conversions or adaptations of buildings to give additional housing accommodation. During the year 235 licences were issued in connection with housing amounting to £14,838.10s.0d. and 92 licences were issued in connection with work other than housing amounting to £4,962.15s.0d. making a total of £19,801.5s.0d. as compared with £3,211.10s.10d. for last year.

PLANS AND TOWN PLANNING.

A Planning Scheme for the greater part of the District is in course of preparation by the South Durham Joint Planning Committee; the Council making all interim decisions after consultation with the executive Officer of the aforementioned Committee. A portion of the District immediately adjacent to Darlington is covered by the Darlington Corporation Planning Scheme, and is directly dealt with by them.

includes 60 producers of Accredited Milk and 2 producers of Tuberculin Tested Milk, One Supplementary licence to sell Tuberculin Tested Milk and two Supplementary Licences to sell Pasteurised Milk were issued.

The total number of cow sheds and dairies inspected during the year were 33; of these 6 were for registration under the Milk (Special Designation) Order.

MEAT AND OTHER FOODS

No licences were issued in respect of slaughter houses during the year as none of the slaughter houses are in use under the Government scheme for centralising slaughter houses. The Central Slaughter House for Darlington area is in Park Lane, Darlington, and no complaints have been received from local butchers in connection with this scheme.
