Ladies and Gentlemen,

I have the honour to present the Annual Report on the Health and Sanitary Conditions of the Rural District for the year 1959.

The Registrar General's estimate of the mid-year population was 12,660 compared with 12,740 in 1958.

The birth rate after correction for age and sex distribution of the local population was 17.3 which is approximately 1.0 per thousand less than in 1958 but 0.8 above the rate for England and Wales.

The death rate after the necessary adjustment was 10.2 per 1,000 population and shows a small fractional increase on the rate for the previous year, but compares favourably with the rate for England and Wales.

The infant mortality rate was less favourable however, being 37.0 per 1,000 live births. This is 2.2 above the figure for 1958 and is again considerably higher than the national rate of 22.0.

The actual number of infant deaths was the same as in the preceding year and the increased rate was therefore the result of fewer births in the year under review.

There were no maternal deaths during the year.

Although there were no epidemics of notifiable infectious disease, a seasonal outbreak of influenza was recorded. The disease was generally mild and complications were few.

Steady progress in improving the sanitary circumstances of the District continued especially in connection with drainage and sewerage in two parishes, and I am indebted to the Senior Public Health Inspector for the relevant details and other information concerning the District generally, supplied for inclusion in this Report.

To the Chairman and Members of the Public Health Committee and to the Clerk of the Council I would like to express my appreciation of their consideration and support throughout the year.

The area comparability factors for use with crude birth and death rates contain adjustments for boundary changes and make allowance for the way in which the sex and age distribution of the local population differs from that for England and Wales as a whole. ### SECTION B

#### GENERAL PROVISIONS OF HEALTH SERVICES

#### Laboratory Facilities

Clinical material for examination may be submitted to the Local Hospitals' Laboratory Service as well as to the Public Health Laboratory at Maidstone where all routine examinations of samples of milk, water, etc., are carried out.

# Hospitals

There are no hospitals situated within the Rural District but three hospitals in the Borough of Dover, which are administered by the South East Metropolitan Regional Hospital Board, provide appropriate facilities for general medical, surgical, maternity and infectious cases.

St. Augustine's Mursing Home, Kearsney, a privately run Home, admits medical, surgical and maternity cases.

### Nursing and Midwifery Services

The Kent County Council as the administrative Authority responsible, provides these services in the Rural area, and I am indebted to the County Medical Officer for the following information on the work of the services during 1959:-

### Clinics and Welfare Centres

The County Council as the Local Health and Education Authority provides various specialist and consultant services for expectant and nursing mothers, infants, toddlers and children of school age.

The Regional Hospital Board also provides local clinic services including facilities for the diagnosis and treatment of tuberculosis and of veneral disease.

### SECTION C

### SANITARY CIRCUMSTANCES OF THE AREA

# Water Supply

Over 98% of the houses in the Rural District are supplied from the public mains. Of the sixteen parishes in the district fourteen are supplied by the Mid Kent Water Company and two by the Folkestone and District Water Company.

Eleven samples of water were taken from the mains supply, and all of these proved to be highly satisfactory. Eight samples of mains water were also taken after storage in a defective tank, the first four samples were unsatisfactory, but the final four samples were highly satisfactory.

Two samples of water were taken from private sources and these proved to be unsatisfactory. In one case a second sample proved to be highly satisfactory, and in the other case statutory action was taken under the Housing Act, 1957.

### Drainage and Sewerage

There are two main sewerage systems in operation in the area, serving part of Temple Ewell and Capel-le-Ferne, otherwise sewage is disposed of by means of cesspools, septic tanks, pail closets and chemical closets.

Work was completed on the second phase of the Temple Ewell sewerage scheme to serve a further seventy five properties, sixty of which have been connected.

### Scavenging

The collection and removal of domestic refuse, the emptying of cesspools and collection of pails has been carried out by direct labour, and has worked very satisfactorily.

As from the 1st April the pail closet emptying service was extended to cover all the parishes in the district.

### Camping Sites

There are nine sites licensed in the district for the summer months: viz Capel-le-Ferne five; Hougham two; Martin Mill one; Whitfield one. Two sites at Capel-le-Ferne are licensed for a total of twenty two caravans for the winter months. These sites are kept under regular supervision.

### SECTION D

## HOUSING

During the year one hundred and twenty one houses were inspected for housing defects. Twelve houses included in the Council's slum clearance programme were dealt with under the Housing Act, 1957.

In connection with discretionary improvement grants, thirty eight schemes for improvement and one for conversion were submitted to the Council and thirty two schemes were approved and the Council's offer of grant accepted by the applicants. Total costs on these schemes amounted to £16,340 and the costs on which grants were made amounted to £12,353, the grants amounted to £6,176. Twenty five schemes were completed during the year.

Three schemes were submitted to the Council for standard improvement grants, all these were approved and the Council's offer of grant accepted by the applicants. The maximum grant permitted on these schemes amounted to £335.

Seventy four new houses were completed by private enterprise and forty one were under construction at the end of the year.

Twelve old people's bungalows were built by the Council during the year, and twenty six old People's bungalows and two houses were in course of erection at the end of the year.

### Rent Act, 1957

Two applications for certificates of disrepair were received and two certificates were issued.

Thirteen Pasteurised and five Tuberculin Tested milk samples were taken and found to be satisfactory. Three samples of raw milk were also taken and found to be satisfactory.

### Shops Act, 1950

Regular inspections of all shops were made, and any necessary instructions given in regard to ventilation, temperature, lighting and sanitary accommodation.

### Food and Drugs Act, 1955

Under Section 16 (1) (a) of the above Act, forty one premises are registered for the sale of ice cream, and under Section 16 (1) (b) four premises are registered. The type of premises registered under Section 16 (1) (a) are - Cafes 3; Shops 29; Camps 4; Public Houses 4; N.A.A.F.I. 1; and under Section 16 (1) (b) - Cafe 1; Shops 2; Butchers Shop 1.

Six samples of ice cream were submitted for bacteriological examination, and the results were -

#### Grade I - 6

Sixty one visits were made during the year to registered food premises and regular visits were made to other . food premises and food shops in the district. Particular reference was paid to the requirements of the Food and Drugs Act, 1955, Ice Cream (Heat Treatment, etc.) Regulations, 1947 - 1952 and the Food Hygiene Regulations, 1955 - 1956.
