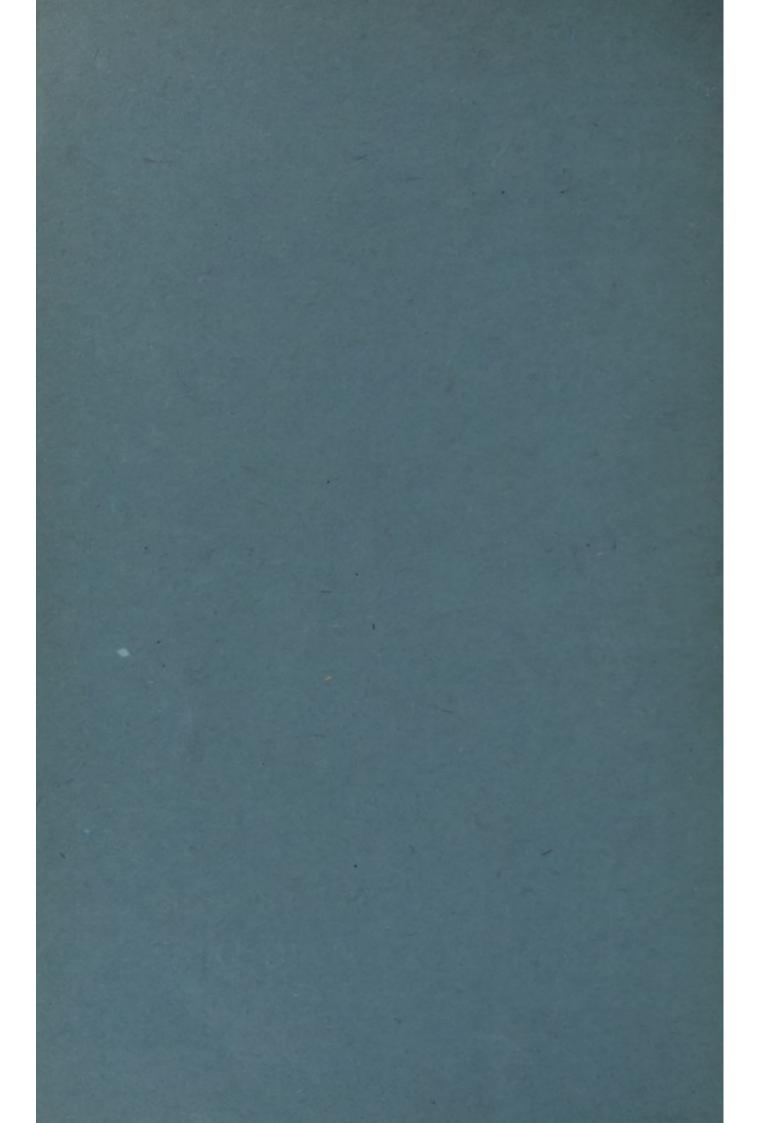

#### (b) STILL-BIRTHS.

There was 1 still-birth (legitimate) during the year, equivalent to a rate of 0.09 per 1,000 population.

# (c) DEATHS.

The number of deaths registered during the year as belonging to the Rural District was 137. This is equal to a death-rate of 12.3 per 1,000. The comparability factor to correct the crude death-rate for age and sex distribution in the Rural District is calculated by the Registrar General at 0.94, this on multiplication with the actual rate gives a comparative death-rate of 11.5 per 1,000.

The causes are given in Table 1.

# (d) INFANT MORTALITY RATE.

There were 3 deaths (legitimate) in infants under 1 year of age. The infantile mortality rate, based upon the number of live births registered during the year, i.e., 146, is equivalent to a rate of 20.5 per 1,000 births.

# (e) MATERNAL MORTALITY.

There were no deaths from maternal causes.

#### GENERAL PROVISION OF HEALTH SERVICES FOR THE AREA.

#### LABORATORY FACILITIES.

Specimens for bacteriological and pathological examinations are sent either to the Public Health Laboratory of the Medical Research Council at Hull or to the Pathological Laboratory at the County Hospital, Beverley. The bacteriological examination of water supplies, milk supplies and ice cream is carried out at the Laboratory of the Medical Research Council at Hull.

#### AMBULANCE FACILITIES.

The service is maintained by the County Council.

#### MATERNITY AND CHILD WELFARE.

These services are maintained by the East Riding County Council. Clinics serving the area are established in Driffield, Kilham and Middleton.

#### SCHOOL MEDICAL SERVICES.

The Divisional and Assistant Divisional Medical Officers are responsible for these services in the area.

#### SANITARY CIRCUMSTANCES OF THE AREA.

WATER SUPPLY.

During the year under review, a 2" extension from Rectory Farm, Beeford, was completed to service Pinderhill. Also a 3" main extension from Garton to Elmswell was laid and a 5" main laid in the village street of Watton, all of which were carried out by direct labour.

In October, work was commenced on Contract No. 4 for the laying of the mains in connection with the Kilham pumping station scheme. The Contractor, Mr. J. G. Wigley, of Kirbymoorside, commenced to lay the 4" main from Langtoft to Kilham and by the end of December he had completed this, also three hundred yards of 6" main for the new reservoir at Tibthorpe, and had commenced laying the new 6" main from Wetwang booster station to Garton booster station.

55 new connections were made to the Council's mains during the year, 34 domestic and 21 metered.

Water at Hutton and Nafferton pumping stations is chlorinated, the reagent used being Voxan Special Type C solution, and the feeders by Wallace & Tiernan, Ltd., the dosage per 30,000 gallons of raw water being 2 gallons of 0.5% solution at Hutton and  $2\frac{1}{2}$  gallons 0.5% solution at Nafferton.

20 samples of raw water from the pumping stations and 6 from public standpipes or consumer points were submitted for bacteriological examination, all of which were reported as highly satisfactory.

6 of the 8 samples taken from private supplies were unsatisfactory. four of these were from properties which, as a result of the main extension at Elmswell, have since been put on mains supply, and action to provide a suitable supply was taken in the other two cases.

#### DRAINAGE AND SEWERAGE.

With the approval of the Ministry of Housing and Local Government, work was commenced during the year on the North Dalton and Langtoft Sewerage and Sewage Disposal Schemes, estimated to cost £19,446 and £19,190 respectively. The Ministry also approved, in principle, the sewerage and sewage disposal proposals for Hutton Cranswick (with Watton), but tenders for this work had not been obtained by the close of the year.

Other sewerage and sewage disposal proposals commenced during the year were the laying of a sewer from the site of the proposed Kilham Pumping Station to connect to the existing village sewer (estimated to cost £1,492) and the laying of a sewer at Wetwang to serve the Southfield View Council Houses, in Back Street, and other properties in the vicinity (estimated to cost £1,421).

During the severe weather in the early part of the year, the filter at the Wetwang Sewage Works became frozen up despite lagging previously carried out wherever possible. This entailed by-passing the filters with a diversion direct from the settling tank to the irrigation area. 134 yards of 6", 100 yards of 9" and 60 yards of 12" piping was laid to replace open drains in the villages of North Frodingham, Beeford, Foston, Middleton and Cranswick.

#### CLOSET ACCOMMODATION.

As in the previous year, steady progress has been made in the conversion of pail closets to water closets, despite the fact that the Council offers no financial assistance under Section 47 of the Public Health Act, 1936. Nevertheless, during the year, 39 water closets were provided by conversion from pail closets, and of these, 13 were in connection with general works subject to Improvement Grants under the Housing Act, 1949.

As outlined above, the new sewerage schemes to Langtoft and North Dalton were not completed during the year and the impetus of conversions following these schemes has not yet been evident.

All the 18 new Council Houses erected during the year were provided with water closet accommodation, as were all the 10 houses built privately, with the exception of two, where chemical closet accommodation was installed.

The approximate numbers of the various types of accommodation at the end of the year were as follows:—Water Closets, 1,012; Pail Closets, 2,089; Privy Middens, 339.

#### SCAVENGING AND CLEANSING.

The position as to scavenging throughout the district is as described in previous reports, viz., a collection each calendar month by the Council's refuse collection vehicle of indestructible household refuse only. (The 173 houses on the Driffield R.A.F. Station, by special arrangement with the Air Ministry, are given a weekly collection of household refuse.)

There is no collection of closet pail contents except in the villages of Nafferton and Wansford by a private contractor, paid by the Council for his work at Nafferton, for which a special rate contribution is collected, and paid directly by householders at Wansford.

As previouly commented on, the arrangement whereby in the rest of the district householders have to dispose of closet pail contents on whatever land is available is fraught with the excessive fouling of land and other insanitary methods of disposal. However, there does not appear to be any immediate possibility of a suitable service being provided by the Council.

Reference was made in my last report to the out-moded practice of emptying septic tank contents to Council House Sites and settling tanks at small village works by hand into small lagoons often closely adjacent to dwellings. As then envisaged, during the year under review arrangements were made to borrow a cesspool emptier from a neighbouring authority, Bridlington M.B., to test the efficiency and practicability of emptying the tanks mechanically and disposing of the contents by spread-

ing on agricultural land for manurial purposes. Theses tests confirmed the desirability of such a system and the result was reported to the Committee accordingly. The Committee agreed to purchase a new fitment in the form of a "Vaci-tank," which consists of a trailer mounted 250 gallons tank with suction developed directly from the engine of the towing vehicle. This equipment has worked very successfully, and though not having the versatility of a conventional cesspool emptying machine, has largely solved the problem of tank emptying with a minimum of nuisance.

During the year, 5 additional litter baskets have been provided, now making a total of 19 throughout the district.

#### SALVAGE.

Tins, light metal and other salvagable materials delivered to the Council's tips are sold to a Salvage Dealer. The dealer is responsible for sorting and loading his own transport and the income derived from these sales amounted to £83 5s. 0d. during the year.

#### CAMPING SITES.

There is still a fairly big demand for sites on which to station temporary dwellings, used chiefly for week-end and holiday periods, though in a few cases applications were received for use as permanent dwellings. Town and Country Planning legislation is probably the most efficient limiting factor on this type of development, and this Council has, as far as licensing under Section 269 of the Public Health Act, 1936, dealt with each case on merit.

Licences have been issued authorising the use of moveable dwellings as follows:—Beeford 2, Lowthorpe 1, Gembling 1, Hutton 1, Kilham 2, Nafferton 2, North Frodingham 9, Watton 1.

A licence was also issued in respect of a camping site for 9 caravans at the King's Head Inn, Nafferton.

#### SWIMMING BATHS AND POOLS.

There are no swimming baths or pools in the district, either public or private.

#### RODENT CONTROL.

The Council's rodent control operates under the system of part grant towards the work from the Ministry of Agriculture and Fisheries, subject to the standard of control being satisfactory. During the year, test bait and maintenance treatment were carried out on the district's sewers. Regular treatments were given to the Cranswick Tip and other known black spots in various villages, again with satisfactory results. In addition, treatments were given to many private premises.

Many farmers avail theselves of the service of the Rodent Control Section of the Agricultural Executive Committee for regular treatment, and to those who have not yet adopted this system, it is strongly recommended as a worthwhile service enabling them to comply with their responsibilities under the Pests Act, and as a means of preventing damage to their foodstuffs.

### VERMINOUS PREMISES.

It is pleasing to report that no house, either private or Council house, was found to be infested with bed bugs, though occasional disinfestations were made for fleas and cockroaches.

#### SCHOOLS.

Steady progress is being made by the East Riding County Council in providing water closet accommodation at Schools, and during the year the Middleton-on-the-Wolds School was converted to water carriage system, whilst other schemes are also proposed.

## HOUSING.

During the year considerable work was done in an effort to assess the district's slum clearance problem and particulars contained in the Rural Housing Survey records proved very useful. It was estimated from the results of this work that there were 203 houses unfit for human habitation besides the 57 already subject to confirmed demolition and clearance orders, and although the Council wished to deal with these 260 unfit houses as soon as possible, they considered that it could take up to 15 years to provide replacements for all of them.

Three individual unfit houses were condemned during the year under Section 11 of the Housing Act, 1936; two of these were at Kilham and the other at Foston, and in all cases the families displaced were re-housed

by the Council.

18 Council houses were erected during the year (as shown below). 14 of these were occupied by families removed from slum properties and in all cases the unfit houses were demolished.

Under private enterprise, 12 houses have been completed and 5 are in course of erection, all of traditional types.

During the year 7 cases of overcrowding were abated by moving into Council Houses.

Applications for Improvement Grants under the Housing Act, 1949, showed yet another increase numbering 26, involving on completion of the works 29 separate dwellings. In respect of 25 of these proposed improvements, grants of  $33\frac{1}{3}\%$  were given, while in 3 other cases he maximum grant of £400 was allowed. One application was refused.

Thirteen of the schemes were completed during the year, as were four granted in the previous year, making in all a total of 17.

#### FOOD.

#### MILK SUPPLY.

Biological samples of milk are taken by the Ministry of Agriculture and Fisheries' officers. No samples were reported as being positive during the year.

By far the largest proportion of milk retailed in the district is supplied by large dairy concerns, most of the milk being heat treated. As from 6th December, 1955, under the Milk (Special Designations) (Specified Areas) (No. 2) Order, 1955, the whole of the Driffield Rural District was included in an area in which the sale of milk other than of an approved Special Designation was prohibited. The effect of this is that raw untreated milk other than tuberculin tested is no longer available. There are still a number of producer-retailers supplying tuberculin tested milk direct from the farm to customers, though in the main the small producer-retailer now sends his milk to the larger dairies where heat treatment is given to the milk.

#### ICE-CREAM.

23 premises are registered for the sale of ice-cream, only one of these being a manufactory. Supplies are chiefly from firms of national repute, with sales in pre-packed form. All 9 samples submitted were reported as being Grade 1. MEAT AND OTHER FOODS.

The position as to slaughtering facilities was fully dealt with in last year's report, and all the 8 slaughterhouses licensed continued in use. The only change was the cessation of use of Mr. J. H. Warwick's slaughterhouse at Wetwang for slaughtering of animals for Smithfield Market, though its use for local purposes continued.

100% inspection of carcases was maintained and whilst conditions are not all that can be desired in all the slaughterhouses, it is only fair to say that on the whole a good measure of co-operation is given by the trade in turning out a satisfactory commodity. Here it may be mentioned that the general standard of animals slaughtered is of prime quality.

The total number of visits made for meat inspection purposes was 852, this involving the spending of an excessive amount of time and effort in relation to the numbers of animals inspected, averaging approximately 4 animals per visit.

Condemned meat and offals are coloured green with a marking fluid specially prepared for the purpose and the surrender certificate issued incorporates a form of receipt from the collector to the effect that none of the meat will be used for human consumption.

10 premises were on the register for the preparation of preserved food.

#### FOOD POISONING.

During the year an outbreak of salmonella food poisoning, with all the cases occurring in adjoining districts, was traced to an infected  $6\frac{1}{2}$  lbs. tin of corned beef sold loose on his round by a butcher, whose shop is situate within this district. Thanks to some excellent co-operation from the medical practitioners, the Public Health Laboratory, and the firm involved, it was possible to recover the infected tin and to arrive at conclusive evidence as to the source. The corned beef was manufactured

and packed by a firm of international repute and needless to say following this incident they took the most stringent steps to ensure that all known tins of the same batch were recalled and precautions taken to prevent any recurrence.

It was gratifying to be able to report the prompt diagnosis and notification of these cases by the patients' doctor (always the starting point for investigations) and which in this case enabled steps to be taken to prevent any secondary infections.
