TO THE CHAIRMAN AND MEMBERS OF THE PUBLIC HEALTH COMMITTEE.

Mr. Chairman, Ladies and Gentlemen,

I have the honour to present my Annual Report on the health of the Rural District for the year ended 31st. December 1961.

Fewer notifications of infectious disease are being received each year which may be considered as an indication of the raised standard of health in the community. To some extent this may be attributed to an acceptance of the various vaccination and immunisation procedures offered to the general public, but also to a generally improved standard of care by both the hospital and general practitioner services.

A triple antigen is now being used for protection against Diphtheria, Whooping Cough and Tetanus, and Smallpox vaccination is now carried out by a multiple puncture technique which produces fewer reactions than the old scratch method. Injections are no longer necessary against Poliomyelitis, the new Sabin vaccine being adminestered in syrup or on a lump of sugar. B.C.G.Vaccination against Tuberculosis is also carried out by an improved technique. Tests on the Urine for the detection of diabetes, kidney and other diseases can now be carried out in a matter of seconds in the clinic or at home; thus it will be seen that recent advances in Public Health have been quite considerable.

The standard of environmental hygiene has also improved steadily but more slowly. Droitwich Rural district has made steady progress in providing piped water and sewage disposal works where required. Some 65% of the population are supplied with mains water and allbut two or three villages are sewered (see p.p. 8 & 9). The building of houses and flats has progressed, with plans well laid for the future, and this has been accompanied by fairly steady progress in slum clearance (p.13) The only disturbing factor appears to be the steadily increasing number of caravans entering the district and the difficulty in providing satisfactory site conditions for them. The Council are however, investigating the possibility of providing a permanent residential caravan site in the south of the district, which I am sure would help to solve this problem

The Surveyor and Public Health Inspectors seem to have an increasing number of duties placed upon them each year and I would like to congratulate them on the way in which they tackle their problems, and for their co-operation with me.

## SECTION B.

## GENERAL PROVISIONS OF HEALTH

#### SERVICES FOR THE AREA.

## (a) Hospitals.

These services are administered by Birmingham Regional Hospital  $B_0$ ard.

- (1) The district is served by general hospitals situated in Worcester, Bromsgrove, Kidderminster and Birmingham.
- (2) The isolation hospital, which serves the area is situated at Newtown, Worcester.
- (3) Maternity hospitals which serve the district are situated at Stourport, Bromsgrove and Worcester.
- (4) Sanatoria for the treatment of cases of Tuberculosis are situated at Knightwick and Worcester.
- (5) St. John's Hospital and Highfield Hospital, Droitwich are National Hospitals for the treatment of Rheumatic diseases.
- (6) Psychiatric Hospitals for mental disorders are available at Powick, Worcester & Barnsley Hall, Bromsgrove.

## (b) Ambulance Service.

This service is provided by the County Council. Ambulance stations which serve Droitwich Rural District are situated at Worcester, Kidderminster, Bromsgrove and Redditch. The list below shows the parishes covered by each ambulance station for non-emergency cases. In all cases of emergency the ambulance should be summoned in the usual way - that is, by asking the telephone operator for "Ambulance" or by dialling "999".

Bromsgrove Ambulance Station - Upton Warren and Northern part of Parish of Dodderhill.

Kidderminster Ambulance Station - Hartlebury.

Redditch Ambulance Station - Stock & Bradley.

Worcester Ambulance Station - All other parishes in the Rural District.

Patients suffering from infectious diseases are conveyed to hospitals in special ambulances which are stationed at the isolation hospitals. The hospital car service, manned in most cases by volunteers, is used to supplement the Ambulance Service.

# (c) Home Nursing & Health Visiting.

This service is provided by the County Council, and in most instances in the Rural District this work is done by the District Nurse/Midwife, who is also the Health Visitor. The following nurses are working in the Rural District -

## (d) Care of Expectant and Nursing Mothers and Young Children.

The district is served by the following Clinics:-

Cases near Droitwich are now expected to attend their own Doctor for ante-natal Care. Ante-Natal Exercices and Health Education are still provided on alternate Thursdays at 2 p.m., at the Baptists Hall,

Lucy Baldwin Maternity Hospital, Stourport. Open every Tuesday at 1.30 p.m.

Coventry Street, Kidderminster. Open every Monday at 2.0 p.m.

#### Infant Welfare Clinics.

Baptist Church Hall, Droitwich. Open every Tuesday at 2.0 p.m.

Memorial Hall, Ombersley. Open on 1st and 3rd. Fridays in the month at 2.30 p.m.

Parish Hall, Hanbury. Open on 3rd. Thursday in the month at 2.0 p.m.

Village Hall, Crowle. Open on 4th Wednesday in the month at 2.30 p.m.

The Memorial Hall, Fernhill Heath. Open on 2nd and 4th Friday in the month at 2.0 p.m.

Village Hall, Wychbold. Open on 2nd. and 4th Mondays in the month at 2.30 p.m.

Parish Hall, Hartlebury. Open on 1st. and 3rd. Wednesday in the month at 2.30 p.m.

### (e) Home Help Service.

This service is administered by the Women's Voluntery Service from Droitwich on behalf of the County Council.

The service provides domestic help for the aged, in case of illness and for maternity cases during confinement.

### (f) Vaccination and Immunisation.

Vaccination against Smapplox and Poliomyelitis and Immunisation against Diphtheria, Whooping Cough and Tetanus are carried out free of charge, at any of the County Council Clinics or by the patient's own doctor.

## (3) Polimyelitis Vaccination.

A considerable number of persons received injections of Salk Vactine during the year. The scheme is administered direct by the County Council and details are available in the County Medical Officer's Annual Report. Sabin Vaccine is now being used, and is administered orally on a lump of sugar.

## (g) Welfare Services.

The Welfare Services are adminstered by the Welfare Section of the Health Department under the direction of the County Welfare Officer. The following facilities are available -

- (1) Residential accommodation for the elderly who are unable to look after themselves in their own homes.
- (2) Temporary accomodation for persons in urgent need.
- (3) Special services for Blind persons.
- (4) Special services for Deaf & Dumb persons.
- (5) Special assistance for other Handicapped persons.

### SECTION C.

## SANITARY CIRCUMSTANCES OF THE AREA.

## (1) Water Supply.

The East Worcestershire Waterworks Company are now the statutary water undertakers for the greater part of Droitwich Rural District. Following the transfer of the undertaking to them in April 1960, good progress was made with the Southern Parishes scheme so that by mid-1961 mains water had been extended into the following parishes: - Himbleton, Hadzor, Crowle, Huddington, Tibberton, Oddingley and Hindlip (part). The new Water Tower at Yew Tree Hill, Droitwich which is 100 ft. high, was designed to provide adequate pressure and sufficient reserve for this area in particular, and has a capacity of 150,000 gallons.

It is now hoped to extend the mains from Droitwich through Ladywood to the parish of Ombersley, which is at present supplied from a small bore-hole, the water from which is not entirely satisfactory. Unless this work is done, extensions will be held up to Chatley, Hawford Wood, Hay Lane, Sytchampton, Conhampton and Acton.

The three parishes which are not supplied by the Company are - (1) Hartlebury - which is to be incorporated in the North-West Worcestershire Water Board's area of supply. (2) Westwood - which has a private supply. (3) Warndon where a few properties are supplied by Worcester City.

Details are given below of the number of premises supplied by mains water from which it will be seen that approx. 65% of the population are catered for; the remaining 35% are supplied from shallow wells, many of which are unsatisfactory.

#### (2) Sewerage & Sewage Disposal.

Sewage Disposal Works are operating satisfactorily in the following villages:- Wychbold, Fernhill Heath, Crowle and Ombersley. Extensions to the sewers in the parish of Ombersley have recently been completed to cater for the villages of Uphampton & Oldfield. Sewage from the parish of Hartlebury is pumped to the Kidderminster Sewage disposal works. The central village area has been catered for for some years, and further work was carried out in the Summerfield area in 1959-60. Tenders have now been accepted for work to be carried out in Moors Avenue and Station Road, which should mean that the parish is well covered.

The only two villages where there are drainage problems are Hanbury and Tibberton. A Private Ministrial Enquiry was made into the proposed Hanbury Sewage Scheme early in the year, at which the Severn River Board expressed their concern over the extremely low rate of flow in the stream which was to receive the effluent from the disposal works. A modified scheme has now been prepared providing additional surface water sewers discharging into the brook, and this is now awaiting approval by the Ministry. At Tibberton a site has been chosen for these works and detailed plans are being prepared by the Council's Consulting Engineer.

### (2) Slum Clearance.

Steady progress has been made with slum clearance as will be seen from the Table following. There still remain a number of properties which have not been demolished by the owners, although demolition orders are operative. The Surveyor has been given authority to employ a demolition contractor and demolish in default in these A number of houses are also in occupation by elderly people who are not anxious to move, but it is hoped that there will be an opportunity to offer them Flatlet accommodation in various parts of the district (e.g. Ombersley, Wychbold and Fernhill Heath) when this becomes available.

The block of property at Causeway Meadows, Stoke Works, remains to be dealt with. Provision has veen made as part of a new housing scheme at Wychbold to provide 20 - 30 Units of accomodation for the inhabitants of this area.

The Council formed a Caravan Committee which met on a number of occasions during 1961 to determine a large number of Planning decisions and applications for Site licences. A problem still exists in dealing with the large number of caravans used for seasonal labour, particularly in the parish of Ombersley (as they are exempt from site licence conditions under the 1st. schedule of the Act). The farmers have been asked in these cases to provide sanitation, watersupply and washing facilities in accordance with Section 3 of the Agriculture (Safety, Health and Welfare Provisions) Act 1956.
