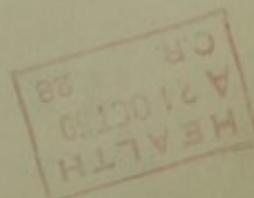

The birth rate (17.06) is 3.04 lower than in 1945 and compares with a rate of 19.1 for England and Wales.

Illegitimate births represented 13.7% of the total births as compared with 13% last year.

There were 7 deaths of infants under one year of age, giving a rate per 1,000 live births of 64, as compared with 8 last year.

The death rate (13.6) is 0.3% lower than in 1945, and 2.1 higher than the rate for England and Wales (11.5).

Section B. GENERAL PROVISIONS OF HEALTH SERVICES FOR THE AREA

The Public Health Staff of the Urban District Council consists of a part-time Medical Officer of Health and a Sanitary Inspector. The latter also carries out the duties of Engineer, Surveyor, Markets, Meat and Food Inspector.

The County Isolation Hospital at Dereham has accommodation for 96 beds. Huts provide accommodation for an additional 29 beds. Shortage of nursing and domestic staff has prevented full use being made of the accommodation available. 7 patients from the District were admitted during the year.

Section C. SANITARY CIRCUMSTANCES OF THE AREA.

1. WATER.

The average daily consumption was 139,236 gallons as compared with 131,990 gallons in the previous year, the average daily pumping hours being 11.9 compared with 15.6 in 1945.

Pumping was at the rate of 10,702 gallons per hour.

During the year new automatic control gear for the new 35 h.p. Beresford pump on No.3 bore-hole at the Waterworks was fitted, together with a new float switch operating mechanism.

Sampling of the main water supply on consumers premises gave satisfactory results throughout the year.

Plans for the installation of filtration and softening plant were considered.

There was only one breakdown during the year of one day's duration because of an electric failure.

The subsidiary water supply on the Yaxham Road Council Houses Site gave a highly satisfactory result. An unsatisfactory report on the Etling Green village pump water supply was given and action to improve the quality of this supply was taken.

Bacteriological examination of all Waterworks employees was instituted during the year.

During the year 817 properties were on the mains supply, while 288 properties were supplied by yard stand pipes.

A total of 50,777,736 gallons was pumped during the year, representing an increase of 2,600,391 gallons as compared with the previous year.

2. DRAINAGE AND SEWERAGE

Drains were tested during the year and where found defective notices to repair were served. An extension to cater for the Littlefields Council Houses Estate was approved.

The ditch receiving the effluent from the Urban District Council Gasworks was cleansed during the year and the Railway authorities agreed to de-silt their waste water before discharging into it.

During the year two new distributors were installed at the Sewerage Works which was also provided with a replacement flowmeter. The pump engine was overhauled and an accumulation of sludge was carted away.

Systematic rat baiting of the sewers was commenced.

The question of the provision of sewerage for Toftwood at an estimated cost of £20,000 was the subject of a report by the Urban District Council's Consulting Engineers. Such a scheme would rank for a considerable grant under the 1944 Rural Water and Sewerage Act.

3. CLOSET ACCOMMODATION.

Seven properties were converted from pail closet to the water carriage system during the year. It was estimated that if all the Toftwood area of the Urban District was sewered and all possible conversions to the water carriage system were also made in Dereham itself, over 80% of the Urban District would be on the water carriage system and many cesspools would be out out.

4. PUBLIC CLEANSING.

The Refuse Dump at the rear of the Northgate Council Houses continued in use throughout the year.

Some 1,700 dustbins are emptied weekly. Many cesspools and privy vaults have been emptied during the year.

The Sanitary Inspector attended a Course on the destruction of rats as the Urban District Council agreed to receive delegated powers from the Norfolk County Council under the Rats and Mice Destruction Act. As a result of schemes initiated following this Course, 224 rats were killed by bait, numerous properties being treated.

(b) Meat and Other Foods

Slaughtering is carried out at a central Slaughter House under Government control. This site suffers mainly from its inadequate accommodation, apart from the undesirability of slaughtering animals near the middle of an urban area. An alternative site was considered and officials of the Ministries of Health and Food were invited to inspect existing arrangements.

Regular inspection of meat is carried out by the Meat Inspector.

A total of 4,200 carcasses were examined by the Meat Inspector during 1946.
