





BOROUGH OF EAST RETFORD.

To the Urban District Council of the Borough of East Retford.

GENTLEMEN,

I have the honor to present to you my inual Report for the year 1910.

The population of the Borough estimated to the middle of 1910 is 13865, showing an increase of 167 on the preceding year.

The Births for the year number 335 as against 366 in the preceding year, a decrease of 31. The Birth Rate is 26.4 per thousand, the average for the past 10 years being 26.

The Deaths registered were 168 as against 182 in the preceding year, a decrease of 14, making the Death Rate for the year 12.1

Infant Mortality. The number of deaths of children under 1 year of age is 30 as against 31 for the for the preceding year, the rate per thousand births registered being 81.96 as against 84.7 in 1909. This number was made up by deaths from the following causes:—4 cases of Premature Birth, 3 of Diarrhæa, 6 of Debility, 3 of Congenial Defects, 1 of Gastro Intestinal Catarrah, 1 of Tuberculous Meningitis, 1 of Other Tuberculous Diseases, 2 of Convulsions, 4 of Bronchitis, 3 of Pneumonia, and 2 of Overlying.

On referring to the rate of Infant Mortality throughout the County, as set out in the Annual Report of the County Medical Officer for the year 1909, I find that East Retford with a Death Rate of 84 per thousand births in that year was the lowest on the list of the 15 Boroughs and Urban Districts, with the exception of West Bridgford, which, owing to its being a purely residential district, has an exceptionally low Infantile Death Rate.

Medical Inspection of School Children. As Schools Medical Officer it is my duty to report to the Local Education Authority on the Medical Inspection for the year so that it is not necessary for me to deal further with the matter in this report.

Infectious Diseases. I am glad to be able to state that the Borough has been free from any outbreak of Epidemic Disease during the year.

Notifiable Infectious Diseases. There were on 26 cases during the year, notified, as against 43 in 1909. This is a distinct decrease both on last year and 1908. The cases were distributed amongst the various parishes as follow:—

East Retford ... 9
North Retford ... 5
Ordsall ... 12
West Retford ... Nil

Scarlet Fever. There were 10 cases of Scarlet Fever all of a mild type, and all the patients recovered. Four of the cases were treated at the Isolation Hospital.

Diphtheria and Membranous Croup. There was only 1 case of Diphtheria.

Typhoid Fever. There was only 1 case of Typhoid Fever.

NON-NOTIFIABLE DISEASES.

Measles. The Borough has been singularly free from this troublesome disorder. A few cases only have occurred from time to time.

Whooping Cough. Scarcely any cases have come under my notice during the past year, and there have been no fatal cases.

Discases during the year, 3 of these being Infants under 1 year of age. The immunity which the Borough has experienced is attributable in no small degree to the comparatively cold weather in the summer months.

OTHER DISEASES.

Cancer. There were 5 deaths from Cancer as against 8 in 1909, the latter number being less than that of the 2 preceding years, so that the present figure may be regarded as particularly low for the population.

Tubercular Diseases. There were 17 deaths from Tubercular Diseases as against 12 in the preceding year. Four of these were cases of phthisis, the remainder being other tubercular diseases. Four cases of pulmonary tuberculosis were notified by the Poor Law Medical Officers. It customary in the last named cases to take steps to thoroughly disinfect the premises, &c. occupied by the patient either on their removal or decease.

Small Pox Hospital. Again I am glad to report that there has been no necessity to make use of this Hospital.

Retford Hospital. During the past year a new Scheme of Management has been brought into force whereby all the Medical Practioners of the town are now members of the Medical and Surgical Staff. Eight deaths of patients occurred in the Hospital during the year 7 of which were of non-residents.

Union Workhouse. There were 17 deaths in the Workhouse during the year, 7 of which were of non-residents.

Elementary Schools. It has not been found necessary to order any closure of schools owing to eyidemic disease during the year.

The Inspector of Nuisances. I should like to take this opportunity of expressing my gratitude to the Inspector for the invaluable assistance he has so willingly rendered to me at all times, and especially with regard to the preparation of that part of my report which, under a new order of the Local Government Board I have for the first time been called upon to introduce in the report.

Under the Regulations of a General Order issued by the Local Government Board to Medical Officers of Health and Inspectors of Nuisances, it is incumbent upon me to specifically report on certain matters affecting the public health enumerated in such Order.

(a). During the year 1910 there have been no epidemics, but as some cases of Cerebro Spinal Meningitis occurred in the County this disease was made a notifiable one for a limited period.

The Council have authorized me to keep a supply of Anti Diphtheria Serum for distribution amongst the Medical Practitioners of the Town when the need arises.

To the best of my knowledge the health of the district is not threatened by any special influence.

(b). On March 30th, 1910, Dr. Farrar, of the Local Government Board, made an inspection of the Registered Lodging House, with a view to ascertaining the accommodation for workmen engaged on public works in the vicinity of the district.

On November 29th, 1910, Dr. Darra Mair carried out an enquiry as to the Sanitary Administration, &c. of the Borough.

On December 15th, 1910, Dr. Handford, the County Medical Officer, owing to complaints from the River Idle Fishing Club, came to Retford and investigated matters of complaint with regard to River pollution.

(c). The Inspector of Nuisances has made a report to me as to the work performed by him during the year which is embodied in this Report.

- (d). The milk supply of the Borough is largely derived from neighbouring villages and hamlets, these are mostly situated within the area of the East Retford Rural District Council.
- Dairies, Cowsheds, and Milkshops. There has been some improvement in the conditions of these since the Regulations affecting the same came into force. Three excellent new cowsheds have been constructed during the year. I made a complete inspection of all milkshops on the register, and reported on the same to the Council. Many cowkeepers claim exemption from the regulations regarding air space as their cows are habitually grazed during the daytime at all seasons.
- (e). With regard to the conditions affecting the wholesomeness of foods for human consumption other than milk, I beg leave to refer to the report of the Meat Inspector.
- (f). The water supply of the district is excellent both as regards sufficiency and quality. It is derived from a deep well in the New Red Sandstone, in the parish of Ordsall. The analysis proves it to be soft, wholesome, and suitable for domestic purposes. The whole of the Borough is supplied from this source with the exception of the Hamlet of Little Gringley which obtaines its water supply from an artesian well sunk in the parish of Grove. Both these sources of supply are constant.
- (g). There is still some pollution of the River Idle and its tributaries. Good progress, however, is being made towards complete purification, the sewage of more than 2000 houses, besides Schools, Public Institutions, and Trade Effluents having been diverted into the new town sewers.
- (h). The District is provided with sufficient sewers and proper Disposal Works. Compressed air raises the sewage at the outfall works, and it is subsequently chemically treated and filtered through land before it passes into the River Idle.

(i). Closet Accommodation. There are now 278 privies as against 364 in 1909, 86 having been abolished during the year.

There are 395 pail or tub closets as against 443 in the preceding year. There are 59 Waste Water Closets, and 2379 fresh Water Closets.

(j). The arrangements for removal of house refuse and the cleansing of earth closets privies, ashpits, and cesspools in the District are as follow:

For house refuse moveable receptacles are chiefly in use. There are, however, some fixed receptacles. The former are emptied weekly, and the latter monthly. The cleansing of pail closets is weekly and bi-weekly. Privy Middens are emptied as required. Pail Closets and Privies are gradually being converted into water closets. At the present rate of progress it is confidently hoped that in a few years the District will be completely supplied with water closets.

- (k). An Officer has recently been appointed to carry out the duties under my supervision, under the Housing and Town Planning Act of 1909.
- (1). The Statements of Vital Statistics will be found in another place.
- (m). The Midwives Act 1902 is administered by the County Council.

The Annual Reports of the Inspector of Nuisances, the Meat Inspector, the Lodging House and Canal Boats Inspector will be found in the Appendix. A statement as to the Rainfall in the district, will be found embodied in the Report of the Inspector of Nuisances.

Meat Inspection. In August information was received from the Inspector of Meat that there was a diseased carcase of a beast at the Cattle Market Slaughter House, prepared for sale. The carcase was eized and destroyed, and the owner was prosecuted.

Although the case was strenuously defended a fine of £5 including costs was imposed.

Infectious Disease Prevention, etc. It was found necessary to serve a notice, under this Act, on an owner of a dirty house. The house and contents were cleansed and purified at her expense.

23 houses and 160 articles have been disinfected at the expense of the Council.

Lodging Houses. On the night of the 30th of March, Dr. Farrar of the Local Government Board, accompanied by you and me, inspected Cobb's Lodging House, Moorgate, and made enquiries respecting lodging accommodation for workmen from Rampton Asylum Building Works and the Lincoln Waterworks Pipe Track.

Sanitary Administration. On the 29th of November, I attended an enquiry held by Dr. L. W. Darra Mair in connection with the Sanitary Administration of the East Retford Urban District River Pollution. On December 15th, I accompanied Dr. Henry Handford, County Medical Officer of Health, to several works in the town to make inquiries as to pollution of the river Idle and its tributaries by trade waste liquors.

Schools. In accordance with instructions given by the Education Authority all the drains of the schools under the control of the Authority have been inspected and flushed, and the interiors of the schools and conveniences disinfected and purified.

Factory and Workshops. 22 inspections of factories and workshops were made.

DEFECTS FOUND. Drainage 6, insanitary condition of closets 5, insufficient sanitary accommodation to factory and dirty workroom.

NOTICES SERVED 5, all of which save one complied with.

Building Progress. 41 plans approved for one new street, 68 houses, 16 alterations to buildings, 1 temporary building, 1 factory, 5 factory extensions, 2 cowsheds. 3 stables and other buildings, 1 skating rink.

Certificates issued for 74 new houses fit for human habitation.

Other buildings erected. 14 alterations and additions, 2 factory extensions, 1 factory, 2 cowsheds, 1 bakehouse, 3 stables and other buildings, and a skating rink.

I have the honour to report for your information that during the past year I have inspected the Butchers' Shops daily, and the Shambles every Saturday, except during the months of June and July, when I was laid up in consequence of having met with an accident, and found the meat to be of good quality with two exceptions in the Shambles, in which case the meat was of very inferior quality, but not in such a state as would have warranted my seizing it.

I have also inspected during the past year, 14 carcases at the Retford Cattle Market Slaughterhouse, which had been brought there for sale, one of which, the carcass of a Heifer belonging to Albert Ostick, Junr., of the Shambles, I, on the 23rd of August detained, and it was afterwards seized by Mr. J. D. Kennedy, Inspector of Nuisances, and condemned on the 24th August by Mr. J. N. Fletcher, J.P., and destroyed. On the 26th of September, Albert Ostick, Junr., was proceeded against, and fined £5.
