Report of the MEDICAL OFFICER OF HEALTH for the Year 1937.

Agriculture and its allied industries are the chief occupations of the District, and there are in it no trades which could be regarded as injurious to health.

representing a rate of 14.81 per 1,000. Of the deaths, 8 were from diseases of the Heart; 4 were from Cancer, and 2 from Tuberculosis. There were no puerperal deaths.

SECTION B.

General Provision of Health Services in the Area.

Public Health Officers. Dr. W. M. Casper, M.R.C.S., is the Medical Officer of Health. The Sanitary Inspector is Mr. W. H. Davis, M.S.I.A., A.M.I.S.E., who also fills the offices of Surveyor, Sewage Works Manager and Markets Superintendent.

Nursing in the home is carried out by District Nurses not under the control of the Council.

Legislation in force, Laboratory Facilities, Hospitals, Ambulance arrangements, Clinics and Treatment Centres are as before, no change having taken place.

SECTION C.

Sanitary Circumstances of the District.

Water Supply.

The water supply of the District is good, both in quantity and quality. The Scotland Street main has been extended to supply the Council's new housing scheme, Beech Grove, on the Oswestry Road. The supply is also ample for use in case of fire. Many properties in the Ellesmere Rural area are supplied from the Urban Council's mains.

Sewerage and Drainage.

So far as your sewerage works are concerned there is no change to record. The effluents continue to be good and give no cause for complaint.

The Government Department of Industrial and Scientific Research are still engaged in carrying out their research work at the sewage works of the United Dairies Milk Factory into the treatment of Milk Factory Effluents, and the same spirit of helpfulness and advice continues to be given when asked for.

Extensions to the sewers for serving the Beech Grove Housing Scheme have been carried out on the partially separate system, all highway water being discharged direct to the Newnes Brook, while the soil sewage goes to the Newnes Brook sewage works for treatment.

Streams.

Of the two known remaining sources of stream pollution, one has been remedied by the closing of the James Yard cottages since the completion of the new housing scheme. The known remaining source from the County Council's Public Institution (Assistance) will close when the building which now is derelict, is pulled down.

Closet Accommodation.

All new houses are connected to the sewers, otherwise there is no change.

Public Cleansing.

The two tips are still in use, also the covered cart for refuse collection. The watch for rats is still kept and their destruction is effected when observed.

Slaughter Houses.

The old slaughter houses are still in use. These are very unsatisfactory, but the continued delay in deciding the future of slaughtering in private slaughter houses makes it very difficult to secure any improvement. In two cases the tenants are prepared to consider the erection of new premises entirely, but are not willing to spend the money necessary for this purpose until they know what their position as to being allowed to slaughter privately will be in the future. All offals produced at these slaughterhouses are regularly collected and conveyed to the artificial manure works for conversion into manures.

Smoke Abatement.

Mechanical stokers are still in use in the Area.

Schools.

The old schools are still in use, and the delay in the provision of new schools is to be regretted. This delay is due to the necessity for selecting an alternative site to that of the old derelict Public Assistance Institution and it is hoped that now this difficulty has apparently been overcome, this very pressing need of the District will soon become a thing of the past.

The whole carcases condemned were 2 beef carcases for generalised tuberculosis, both beasts having been bought in a cattle market by auction after having been graded as suitable to qualify for Subsidy under the Meat grading scheme. Both beasts appeared good on appearance during life. One carcase was that of a sheep with uraemia, and one of a pig with generalised tuberculosis.

The diseased conditions found in the organs were, Tuberculosis, Hydatid Cysts and Liver Flukes, with Cirrhosis.
