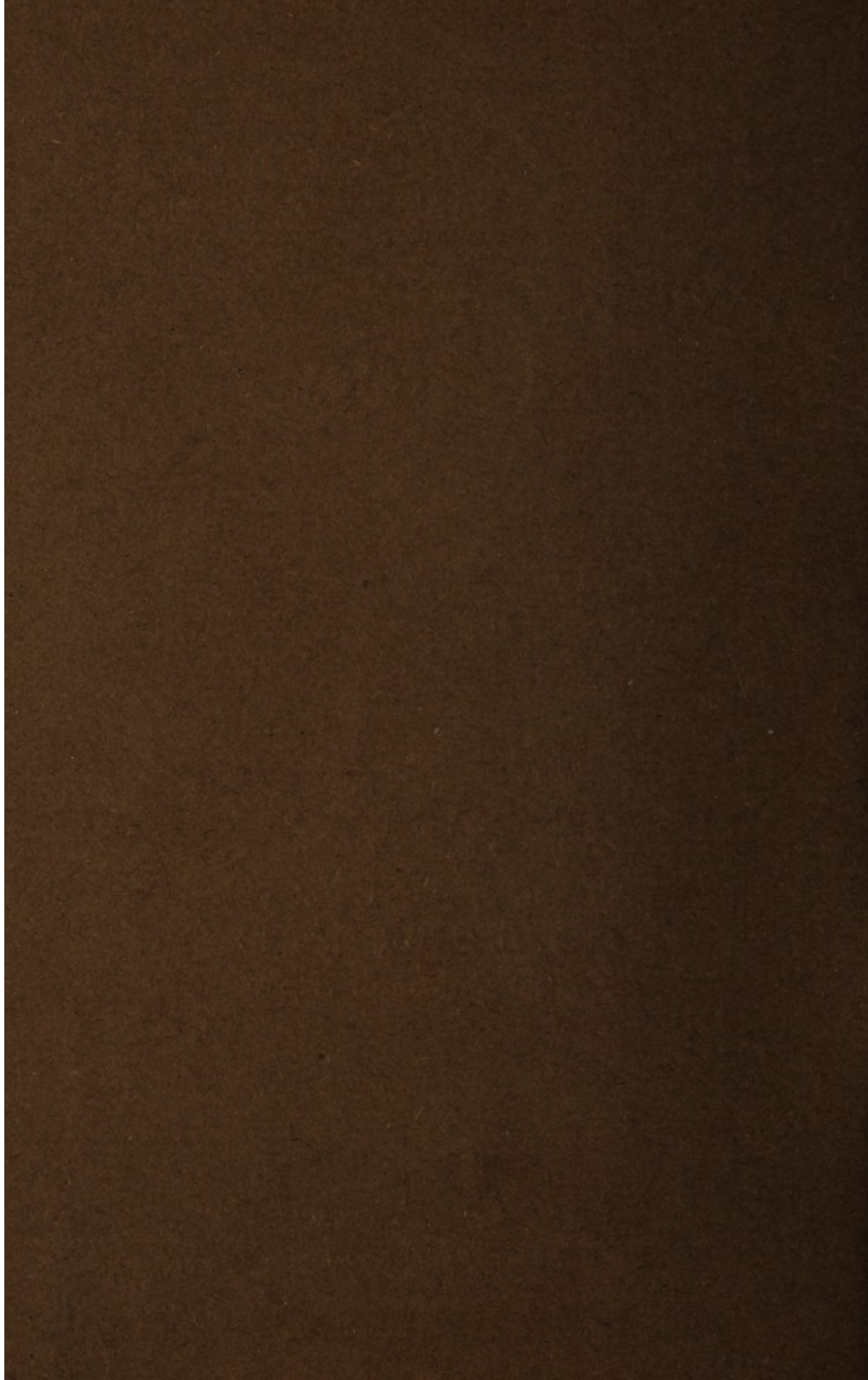

ON THE HEALTH OF FARSLEY FOR THE YEAR ENDED - - - - DECEMBER 31st, 1925. - - - -

GENTLEMEN,

I have the honour to submit to you my second Annual Report on the health of the district.

The year 1925 was a satisfactory one in many ways. I am able to report a considerable increase in the Birth-rate of the district and a decrease in the Death-rate and in the rate of Infant Mortality. There have also been fewer epidemics and the number of notifications of infectious diseases, while slightly higher than in 1924, is still not high.

Natural and Social Conditions of the Area. The Urban District of Farsley has an extent of 821 acres. Its population is 6,117 according to the Census of 1921, while, in 1925, it was estimated at 6,113, giving an average of 7.5 persons per acre. The village is about a mile long and healthily situated on the slope of a hill. The nearest river is the River Aire, which is about a mile and a quarter distant from the most northerly point of the village.

There are three streams running through the village: Red Beck, Farsley Beck, and Stanningley Beck.

The number of inhabited houses in 1921 was 1,624, while the number of families occupying them was 1,627. The rateable value is £35,824 5s. 0d., and sum represented by a penny rate is £145. The amount of Poor Law Relief in the district is under £20 per week.

The district is situated between the cities of Bradford and Leeds and so forms a part of a large manufacturing area. The chief occupation is the manufacture of textiles, in which 1,180 people, 501 men and 679 women, are engaged. There are over four hundred metal workers in the district, over two hundred engaged in trade, and almost as many clerks and typists. There is very little agriculture in the district.

Vital Statistics. The number of births registered in the district in 1925 was 64, 38 boys and 26 girls. To these must be added 12 transferable births, 6 boys and 6 girls, making a total of 76 in all. On an estimated population of 6,113 this gives a birth-rate of 12·4 per 1,000 per annum. The birth-rate in the district for the last five years has been as follows:—

The birth-rate for England and Wales for 1925 was 17·3.

Only one illegitimate birth was registered in the district in 1925.

58 deaths were registered, 28 men and 30 women, to which must be added 11 transferable deaths occurring outside the district, making a total of 69, 33 men and 36 women. The death-rate, calculated on a population of 6,113, is 11·3, 1·8 lower than last year's. The figures for the last five years are as follows:—

The death-rate for the whole of England and Wales for 1925 was 12·8.

Only 3 deaths of infants under one year were registered. This is the smallest number since 1921 and compares favourably with the 6 registered in 1922 and 1923, and 8 in 1924. The rate per 1,000 births is 39·46 as compared with 125 in 1924 and with the average rate for England and Wales, which is 91.

The average age of death was 55·4 and excluding the deaths of infants under one year, 58·4.

HOSPITALS.

Very considerable use is made of the Leeds Infirmary for accidents and surgical cases. The majority of general medical and surgical cases requiring hospital treatment also go to this hospital and the X-ray department is used for diagnostic purposes. The bulk of the ear and eye cases received attention at the Bradford Ear, Eye, Nose and Throat Hospital.

PREVALENT ILLNESSES.

There is no form of illness which is particularly prevalent in the district, which is, as a whole, much healthier than would be expected in a manufacturing area. The open situation of the village and the care which is taken to keep the mills well ventilated prevent any ill effects which might result from work in textile mills.

GENERAL PROVISION OF HEALTH SERVICES IN THE AREA.

Hospitals Provided or Subsidised by the Local Authority.

Nearest clinic is the West Riding County Council Clinic at the Town Hall, Pudsey.

There is here accommodation for 54 patients. The hospital consists of three separate blocks, containing six wards, two side wards and offices, a house for the staff, and laundry, boiler-house, etc. The staff consists of a matron, sister, staff nurse, and five junior nurses.

There is no institutional provision for unmarried mothers, illegitimate infants and homeless children, other than the West Riding Council Poor Law Institution.

The average attendance of mothers is about 40 a week, and there are over 120 (coming regularly.) The mothers show great keenness in attending, and the general health of the children attending is excellent. Some ante-natal work is done, but in this respect the clinic is handicapped by the lack of an examination couch.
- (ii) **School Clinic** is held at the same place (Wesleyan School) every Friday morning. Both Clinics (i) and (ii) are provided by the West Riding County Council.
- (iii) **Tuberculosis Dispensary.**—None in the area. Nearest is at Town Hall, Pudsey.
- (iv) **Venereal Disease Clinic.**—None in the area. Cases go to either Leeds General Infirmary or Bradford Royal Infirmary.

Water.

The water supply is supplied by the Bradford Corporation, and is sufficient in quantity and good in quality. The water has no plumbo-solvent action.

Rivers and Streams.

There are only three small streams in the district, none polluted.

Drainage and Sewage.

The greater part of the houses in the district are provided with water-closets, the sewage from which is dealt with at a sewage farm which has three precipitation tanks and four sludge lagoons. The effluent is fairly satisfactory, and the arrangements would appear to be adequate.

During the past year 19 privies have been converted into water-closets, and 90 water-closets have been connected to the sewer.

In 1925, 55 privies were converted and 14 closets connected to the sewer. In 1923, 48 privies were converted into 61 water-closets, and 69 water-closets connected to the sewer.

Thus the conversion of the old types of closet into water-closets is proceeding rapidly.

There has been one new ashpit and 53 new dust bins provided during this year. In 1924, 22 ashpits were converted into 24 new dust bins.

During the year 2,733 ashpits were emptied, which were tipped either on the Council tip, the sewage farm, or on land. 2,114 loads were tipped at the tip.

Sanitary Inspection of the Area.

Twenty-nine notices have been sent out; 1 defective ashpit, 1 burning clippings, 2 defective chimneys, 1 for fixing slop stones and gullies, 24 for insanitary closets. All remedied but nine.

INFECTIOUS DISEASES.

The district is comparatively free from infectious diseases, scarlet fever and a mild form of erysipelas being the commonest. All cases of scarlet fever, diphtheria, and typhoid are removed on notification to the Fever Hospital at Calverley Moor, where a supply of diphtheria antitoxin is always available. There have been no "return" cases of scarlet fever during the year; encephalitis lethargica, malaria and dysentery have not occurred in the area during 1925. Pathological and bacteriological specimens are examined at the County Hall, Wakefield. Disinfection is carried out by the Surveyor and the Calverley Moor Hospital. Use has been made on two occasions of the Schick reaction in the cases of diphtheria contacts coming into the district. No artificial immunization has been attempted.

Vaccination.

Thirty primary vaccinations and one re-vaccination have been performed by the Medical Officer of Health during the year. All have been successful. Unvaccinated children over 6 months old, one. Exemptions, 32.

During the year there were several cases of influenza, measles, both German and English, and chicken-pox, but there was no epidemic of any kind. Only two or three cases of whooping cough occurred. There were no school intimations of infectious disease during the year, and most of the absentees were suffering from coryza of moderate severity. Only one death from influenza occurred.

Cancer is not specially prevalent, but 5 deaths from this cause were notified during the year.

FARM.

The precipitation tanks have several times been emptied and cleaned out of sludge, and the sewage has been distributed on the land and Alumino Ferric used.

The effluent from beds has been fairly satisfactory under the circumstances and conditions.

The four Sludge Lagoons have been charged with sludge and emptied several times. The whole of the sludge is carted away by Mr. Binks, about 807 loads being disposed of during the year.

Two plots of land have been ploughed, etc., and planted with potatoes.

The work generally has been carried out satisfactorily under the circumstances.

INFECTIOUS DISEASE.

During the year 5 cases of Infectious Disease were notified to me, which are as follows: Diphtheria 0, Scarlet Fever 5, Enteric 0. All cases notified by your Medical Officer of Health. Disinfectants are given out when applied for. All cases taken to Hospital.

SLAUGHTER-HOUSES.

There are 6 Slaughter-houses in the district and 5 are constantly used. These are inspected at various periods and I may state that they are kept in good and clean condition.

DAIRIES, COWSHEDS AND MILKSHOPS.

These have been inspected at various times and in each case I found them clean and in a satisfactory order. Limewashing of Cowsheds has been attended to by the farmers.

BAKEHOUSES.

The Bakehouses have been inspected and are kept in fairly clean condition.

NUISANCES.

Twenty-nine notices have been sent out for abatement of Nuisances: 1 defective ashpit, 1 burning clippings, 2 defective chimney, 1 for fixing 6 slopstones and gullies and 24 for insanitary closets.

CLOSET ACCOMMODATION.

During the past year I have the pleasure to report that 90 Water Closets have been connected to sewer, 19 Privies have been converted into Water Closets.
