GENTLEMEN,

I have great pleasure in submitting my Twenty-first Annual Report on the Health and Sanitary condition of your District for 1925.

DEATH-RATE.

During the year 70 deaths (32 male and 38 female) took place, giving the death-rate of 10.3 per 1,000.
