The difficulty in the matter is that the charge of £17. 15. 0 per quarter, which was made up to the commencement of 1902, was very much less than the average cost, and the Committee then felt in view of the financial position of the Institution and of the fact that the patient is not a Member of the Society of Friends, and therefore has no claim on the Charitable funds of the Retreat, that they were compelled to in-

crease the rate to £22. 15. 0 per quarter this figure barely covering the average cost.

The amount of arrears which stood at the end of 1906 at £166. 10. 0 is, as you will see, very much more than the advance named above of £5 per quarter or £20 per year which would only equal for the five years £100 in all, and it is therefore evident that to the extent of some £66, the account has been allowed to get into serious arrear, even if it had been calculated on the basis of the old terms of £17. 15. 0. This may perhaps have been quite unintentional on the part of the patient's friends but ~~which~~ you will see is serious in its incidence on the funds of the Retreat.

The Committee realises the difficulties of your clients in the matter and in view of the patient's long residence in the Institution (though at below cost rates)
