Dear Sir Arthur Mackworth,

I should not have troubled you with a telegram were it not that Lady Mackworth's advanced age makes one feel anxious whenever she is indisposed. She has had a bad cold lately and has been in bed a few days, but seemed to be mending. But yesterday her temperature ran up to 102 in the evening. She was already a little better at 11 o'clock and was very bright, talking most kindly of the nurses, giving them the fanciful names which are habitual with her. Her pulse, however was not very good. This morning she is distinctly better and the temperature has fallen and her cough is easier, but the pulse remains rather rapid.

There is in the neighbourhood a good deal of sickness just at present. People have feverish colds apparently resembling influenza, and others at Belle Vue have been attacked, so it is possible Lady Mackworth's illness is of this character. We will wire again should there be any unfavourable turn; and I will ask Miss Godson to write to you again tomorrow.

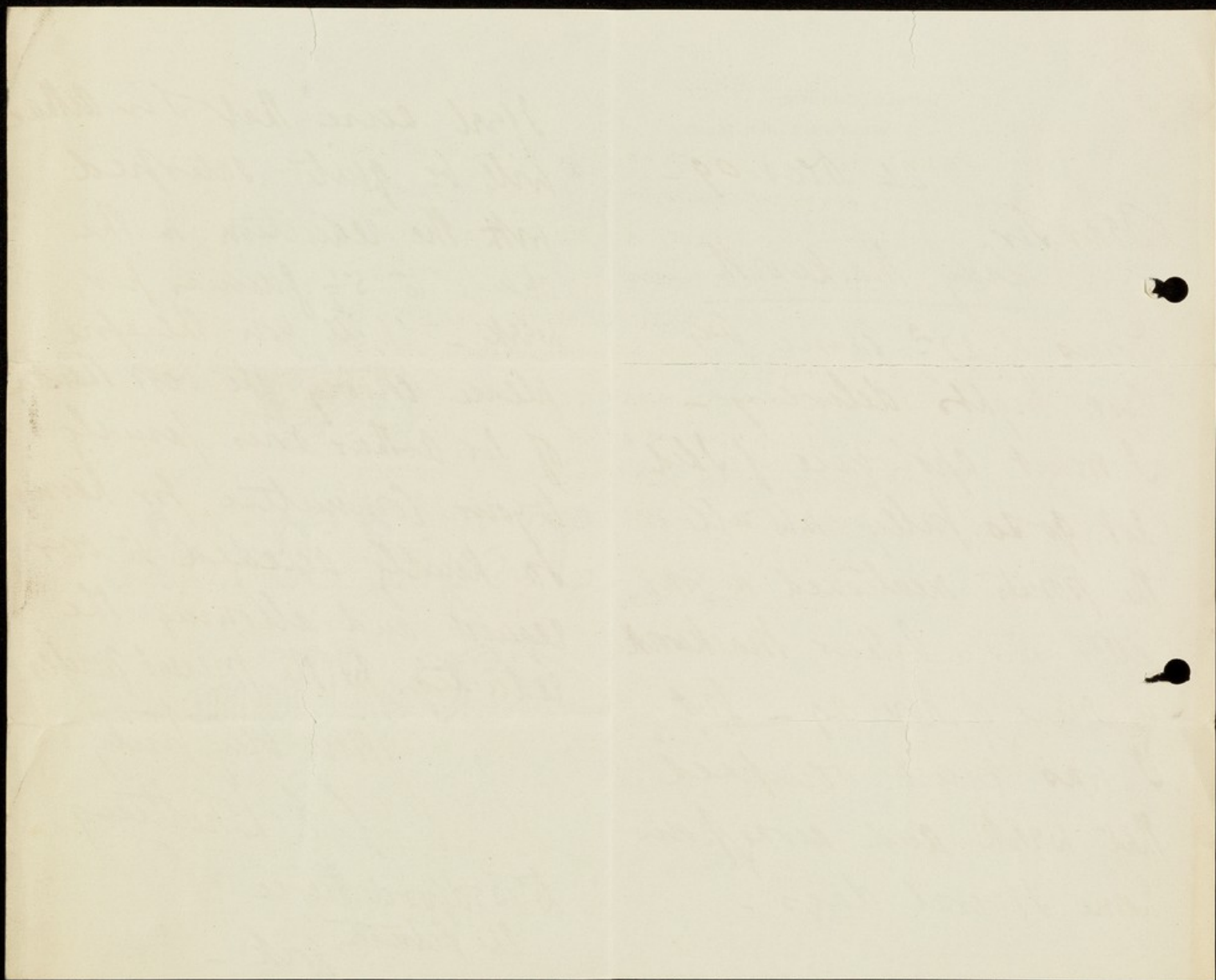

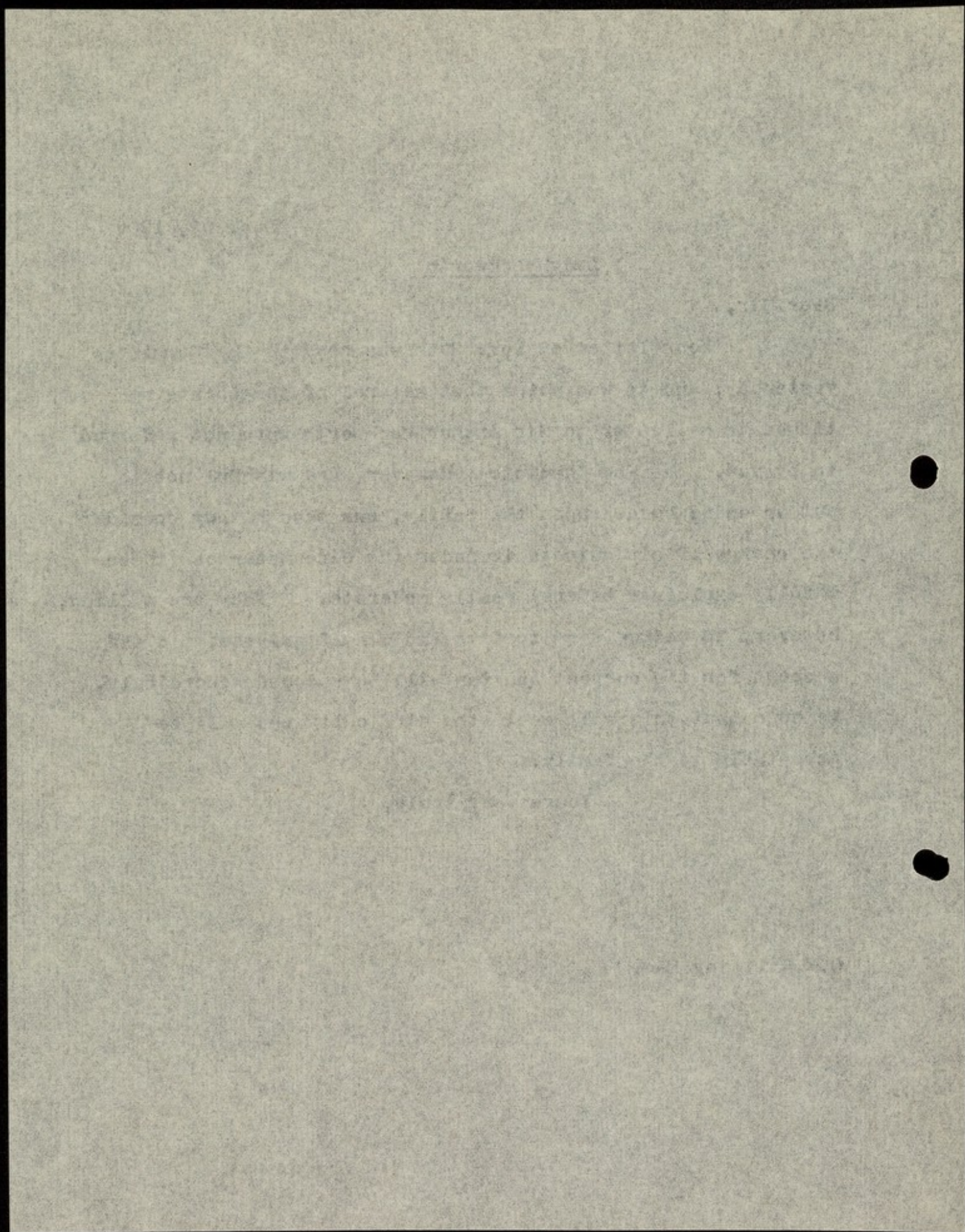

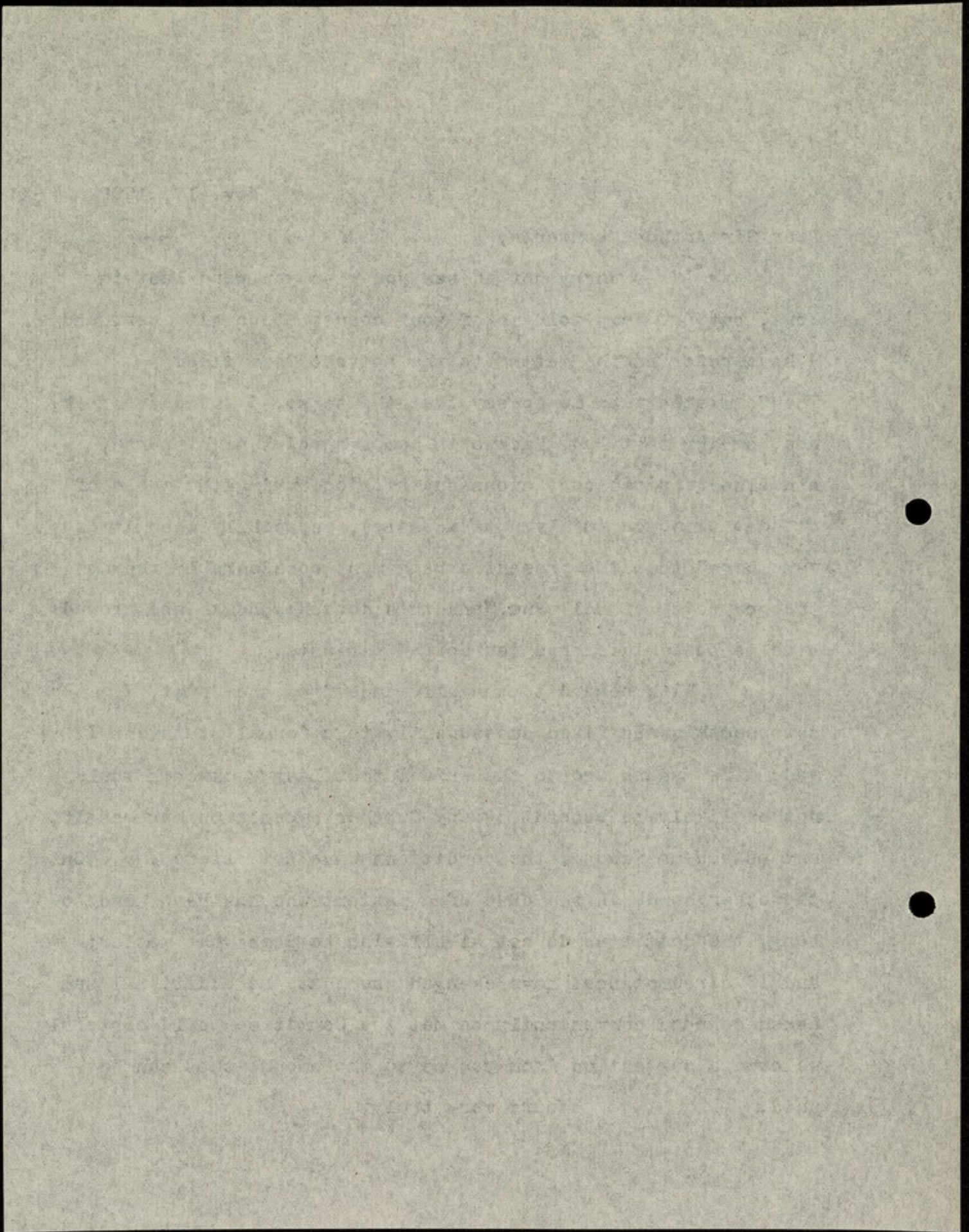

Dear Sir Arthur Mackworth,

I was sorry not to see you when you were last in York, but Dr. Kemp told me of your conversation with her, and I have referred the matter to the Retreat Committee. The Committee wish me to say that the terms, 6 guineas a week, are, seeing that Lady Mackworth has a special night nurse, and also requires continuous supervision during the whole of the day time, certainly not excessive, especially when it is remembered that the present arrangement considerably reduces the capacity of Bellevue, and this detached house and grounds have to be administered for so few patients.

With regard to the allowance from the Court, I supposed this was fixed subsequently to a formal statement I made a few years ago to the effect that Lady Mackworth would not be likely to benefit by any further expense on her behalf, and as you are aware, the conditions have now altered. On the other hand, in the case of a patient who has been here so long, the Committee do not at all wish to press the matter; and if circumstances have changed so that the additional sum asked cannot conveniently be met the Committee would certainly welcome a suggestion from you as to the amount that can be paid.

Dear Sir Arthur Mackworth,

I write to say that for some little time past Lady Mackworth has been very restless at night and it has not been possible for the nurse who slept in her room to get sufficient sleep.

I have therefore arranged for Nurse Crossley who was some years ago at Belle Vue and who has done responsible work since, but happened to be free, to come back as night nurse specially for Lady Mackworth.

I am glad to say that Lady Mackworth is very nicely generally, and the trouble I have referred to is largely connected with her failing memory, and she does not understand that there are yet many hours left before morning comes.

This arrangement will involve some extra expense when the matter is reported to the Committee which will meet next week.

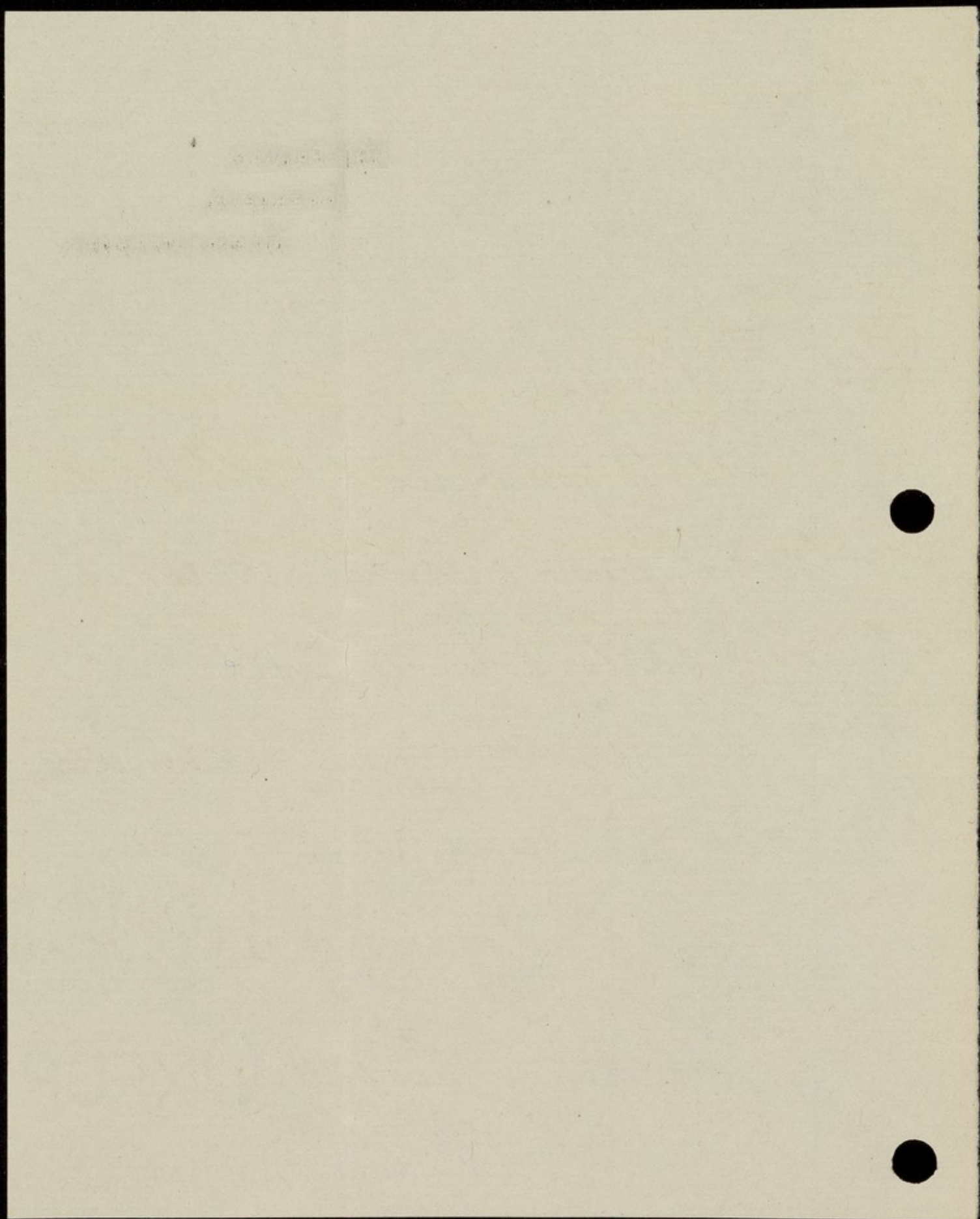
