
Dear Dr. Ozanne,

You will be interested in hearing that Miss Thompson is slowly improving, but she is a long way from being convalescent yet. We are still nursing her in bed, and she is excitable, restless, and talkative. The temperature does not quite reach normal, and there is some troublesome diarrhoea which is rather better since we have given Sauerin.

I was very sorry that Mrs. Hemingway died. I heard from the nurses that she greatly improved mentally and there was hope of her recovery. If I am not troubling you too much I should be glad of a note, which I will consider strictly confidential, as to whether the nurses were thoroughly satisfactory. I may explain that we are establishing a Trained Nurses Institution, and it is sufficiently important that nurses who join should be in every way satisfactory.

Dear Madam,

Miss Thompson remains in a very uncertain mental state. At one time she is restless and uncontrolled, altogether incoherent and beside herself. At others she is fairly quiet and able to converse fairly reasonably. She does not realise her position in the slightest. Her bodily health seems to be improved. We are giving her some open air treatment during the day time. She has a little temperature every evening, but a careful examination of the chest does not disclose any serious signs of disease.

Your account of the insanitary condition of the house is very interesting, and it is quite possible that the bronchitis may have been produced by the damp. We, however, know so little as to the causation of bronchitis that it is difficult to speak with certainty, although there is good reason to think that disease is frequently produced a lowered power of resistance arising from unhealthy conditions of life.

YORK RETREAT HOSPITAL FOR THE INSANE.

In consideration of the Directors of the York Retreat Hospital for the Insane agreeing to receive Hannah Thompson of _____ as a patient in the said Hospital, I HEREBY UNDERTAKE AND AGREE with Richard Thompson of Dringcliffe, The Mount, York the Treasurer of the said Hospital, to pay or cause to be paid, to the said Richard Thompson as such Treasurer, or to the Treasurer for the time being of the said Hospital, all such Sum or Sums of Money as shall from time to time be or become due and payable for the Lodging, Maintenance, and care of the said patient in the said Hospital, or whilst under the charge of the Authorities of the said Hospital, and all such Sum or Sums of Money as shall be paid or disbursed by or on behalf of the said Institution for any articles of Wearing Apparel, or other necessaries, or extras supplied to, or provided for the said Patient, or the repairing or mending and washing of the articles of Wearing Apparel of the said Patient, so long as the said Patient shall continue in the said Hospital, or be under the charge of the Authorities of the said Hospital, and also to pay or cause to be paid the expenses in respect of the Funeral of the said Patient, in case the said Patient shall die in the said Hospital, or whilst under the charge of the Authorities of the said Hospital. AND I FURTHER AGREE to pay Interest at the rate of five per cent. per annum on any accounts due from me as above, which shall not have been discharged within Twenty-eight days from the receipt of such account from the Treasurer, Secretary, or Clerk of the said Hospital. AND I ALSO UNDERTAKE AND AGREE, at my own expense, to remove the said Patient from the said Hospital within Fourteen days after receiving Notice in writing from the Treasurer, Secretary or Clerk for the time being of the said Hospital, requiring such removal.

N.B.—The charge for Board, Lodging and Medical care is payable quarterly, in advance. Disbursements by the Institution on behalf of patients, and other exceptional expenses, are charged in the following quarter's account. A residence of less than a month is charged as a month.

In the event of the death, removal, or discharge of a patient before the expiry of the quarter covered by the last payment, the surplus amount is returned by the Retreat.
