

By the Commissioners for executing the Office of Lord High Admiral of the United Kingdom of GREAT BRITAIN and IRELAND, &c.

WHEREAS we have thought fit to establish the following Instructions for the Government of Surgeons-Superintendent on board Convict Ships:

You are therefore hereby required and directed to pay the strictest regard and attention thereto; and to enforce similar obedience on the part of all persons employed under you. You are also to pay the same strict regard and attention to all orders and directions that may be addressed to you, under our sanction, by The Comptroller of the Victualling and Transport Services, as if such orders had proceeded direct from ourselves.

#### INSTRUCTIONS

FOR SURGEONS-SUPERINTENDENT ON BOARD CONVICT SHIPS

Proceeding to New South Wales or Van Diemen's Land.

1.

Upon your being appointed Surgeon-Superintendent to a To join. Convict Ship, you are, after receiving your Instructions from the Comptroller of Victualling and Transport Services, to proceed forthwith to Deptford, and report yourself to the Captain Superintendent at that place, and you are afterwards to join the ship without delay; observing that you are not to leave her, after the embarkation of the Guard or Convicts, without having previously obtained our special permission for the purpose.

You are to take care that the Conditions of the Charter-party Charter Party. (of which a Form is annexed, Appendix No. 1, page 48, as well as Extracts from the Form of Charter-party for the guidance of the Owners and Master, See Appendix No. 2, page 56,) be in all respects strictly complied with by the Master, reporting any attempted deviation from them to our Secretary, and to The Governor of the Colony, and specially noting the circumstances in your Journal.

2.

You will be provided with a suitable Mess during the Voyage Mess. under the same Regulations as are established by the Charterparty for the Military Officers embarked with the Guard; and you will be liable to the payment of 3s. 6d. a day to be abated from your growing pay, as your allotted contribution towards your Mess, the whole expense of which will be paid by the Public to the Master of the Ship, and your daily contribution of 3s. 6d., will be made according to the number of dinner meals taken on board the Ship, the first and last of which are to be noted on the Certificate granted to the Master for Mess.

3.

Medical ComfortsandStores.

Lists of the Proportions of Medical Comforts and Stores allowed for every 100 Male and every 100 Female Convicts are annexed, (see Appendix No. 3, page 58); and you are to take care that the same have been supplied to the Ship according to those Lists, for the number of Convicts she is fitted to carry.

4.

Stores.

You are to obtain from the Master all the information you may require with regard to the quantities of Provisious and of the different Stores shipped for the use of the Guard, Convicts, Settlers, and Passengers. You are also to muster the Crew, and to make a special Return to The Comptroller of Victualling and Transport Services of their Names, Ages, and Qualities, immediately before the Ship proceeds to Sea.

Crew to be Mustered.

5.

Receipts.

You are to be careful to sign all Documents which may require your signature, for Supplies made to you either from the Victualling Establishment at Deptford, or from any other source, and to deliver the same to the proper Officers before the Ship sails.

6.

Private Goods.

You are strictly forbidden under any pretence whatever to ship Goods yourself, or to allow Goods to be shipped either by the Master or any other person for private account: and no Articles or Packages of any description, for any Person whatever, are to be received on board, except by our special authority. You are most particularly enjoined to report to The Governor any infraction of the Charter-party in the above or in any other respect, in order that the circumstance may be investigated, and communicated to our Secretary with a view to our enforcing against the Owners of the Ship the penalty which will be thereby incurred.

Baggage.

You will be allowed to Ship Baggage, &c., exclusive of Cabin Furniture and Necessaries for the Voyage, to the extent

of one ton. If, however, you should abuse this privilege by availing yourself of it for the purposes of trade, you will incur our severest displeasure. On your arrival in England you are to deliver to The Comptroller of Victualling and Transport Services, with the Journal of your proceedings described in Article 37, page 24, of these Instructions, a written declaration to the effect "that on your Honour as an Officer and a Gentle-"man, you have not in any manner contravened this special "injunction by shipping or by landing in the Colony any article "whatever for Sale."

7.

The Master and Crew are to have the benefit of your medical To attend the assistance when necessary, but you are not in any way to interfere with them in the Navigation of the Ship.

8.

Not any Convict for transportation is to be received on board, Embarkation unless he be in such a state of health as to make it probable that his Life will not be endangered by the Voyage, nor unless he be free from any infectious disorder: and to this end every Prisoner is to be previously examined by yourself in the presence of the Medical Officer of the Prison or Convict Hulk from which he shall have to be received, the Medical Officer having been directed not to cause any Prisoner to be selected for embarkation whose state of Health may appear to exhibit any danger, or who may be objected to by you: but it is to be observed that old age or bodily infirmity alone, if not such as to make the Voyage dangerous to the Life of a Prisoner, is not to prevent his being embarked.

9.

You are to cause all Packages belonging to Convicts, the Packages, contents of which may not be indispensably required by them during the Voyage, to be delivered to the Master, who is to give Receipts, for the same, to the Convicts, and to cause them to be stowed away in a place of safety; taking care that they

are occasionally aired, and returned to the Convicts when they are disembarked.

10.

Money, Goods, &c., belonging to Convicts. You are not to allow any Convict, under any pretence whatever, to retain personal possession of Money, Goods, or other Property, excepting only such change of Clothing as may be suitable for the Voyage. With that exception, you are to take charge of the whole of such Property as may be in personal possession of any Convict when embarked, for which you are to grant Receipts to the Parties; and, on the Ship's arrival at the Colony, and before the Convicts are landed, you are to furnish The Governor with a List of the Names of those from whom you may have received such Property, together with a description of the particular articles you may have taken into your charge, and to dispose of the same as the Governor may direct.

11.

Remittances to Convicts. In order to prevent as much as possible Remittances to Convicts in the Colonies through private hands on board Convict Ships, you are to take all possible care that no Person under your control receives any Money on account either of the Convicts embarked, or for conveyance to other Convicts in the Colonies.

Use of Tobacco prohibited. You are to prohibit the use of Tobacco by Prisoners during the Voyage, and to prevent as far as practicable all intercourse between the Convicts and their friends and other persons after embarkation, in order that no opportunity may be afforded of conveying to them either Money or Tobacco. And you are to enforce most rigidly the directions contained in this and the preceding Article regarding Prisoners' Money.

12.

Co-operation with Officer of Guard and Master.

You are to use your best endeavours on all occasions to secure the cordial co-operation of the Officers of the Guard and the Master, in the execution of the duties respectively intrusted to them, in order that by your united exertions the service may be performed in the most efficient manner possible; and you are to issue such Rules and Regulations for the promotion of good order on the part of the Convicts as you may judge proper; inserting Copies thereof in your Journal.

An Extract from the Queen's Regulations and orders for the Queen's Re-Army, so far as relates to Troops when embarked on board gulations. Convict Ships, is annexed for your information and guidance, Appendix No. 6, page 100.

If you are appointed to a Ship in which Female Convicts Female are to be embarked, you are to use your utmost endeavours to Convicts. prevent their prostitution; shewing to the other Officers and to the Passengers and Crew a good example in this particular, and not failing to report to The Governor every instance of improper intercourse with any of the Women which may have been detected by you or have come to your knowledge. furtherance of this important object you are on all occasions to retain the Keys of the Prison in your own custody during the night, and not to give them over to the charge of any other Officer, or leave them in places where access can be had to them. It is necessary that the Governor's Certificate, referred to in Article 37, page 26, of these Instructions, should be explicit to the fact of his being satisfied as to all practicable means having been adopted to prevent prostitution; and as an inducement to the Mates of the Ship to support you in your exertions to attain this object, a Gratuity of Twenty Pounds to the Chief Gratuity to Mate and of Fifteen Pounds each to the Second and Third Mates, will be respectively paid to them at the termination of the Voyage, on their producing, to The Comptroller of Victualling and Transport Services, Certificates signed by you as to their having conducted themselves to your satisfaction, which Certificate you are to grant if, in your judgment, they shall be entitled to them, and you are to inform them at the same time that they are not to draw Bills of Exchange in payment of these Gratuities, as such payments will only be made in England on the production in Office of the Certificates.

Free Women. It having been frequently represented that disorderly conduct has prevailed among the Wives of Convicts and other Women who have been granted a passage to the Colony, and which misconduct may have been partly attributable to their having considered themselves not subject to the control of the Surgeon-Superintendent; you are to impress upon all such Persons the necessity of strict obedience to all the Regulations established for the preservation of order and regularity on board: and to inform them that, if by their bad conduct they prove themselves unworthy of the indulgence granted to them by Her Majesty's Government, The Governor, on their misbehaviour being reported to him, will prohibit their being landed in the Colony, or prevent them from remaining there.

> In order to promote the utmost attention to cleanliness and good order among the Female Convicts who may be embarked, you are permitted, at your discretion, to obtain from the Master the necessary quantities of Tea and Sugar, to be given as a Gratuity at the rate of One Ounce of Tea and Six Ounces of Sugar per day to the most orderly and cleanest Mess in each of the two Prisons; granting to the Master a Certificate, as per Form No. 4, F., page 88, in the Appendix, of the quantities of those articles which may have been so supplied, in order that such extra issue may be allowed in his Accounts.

> > 14.

The entire management, as well as the medical treatment, of the Convicts being intrusted to your care, you are to attend and see that they have their full established Rations of Provisions served out by Imperial Weights and Measures, without any deduction whatever, according to the schemes of Victualling, No. 4, A., page 66, in the Appendix, a printed Copy of which is to be hung up in a conspicuous situation near the place where the Provisions are issued out, in order that all persons may know the particulars of the Rations to which they are entitled. You are also to take care that their Victuals are properly cooked and regularly served to them at the usual meal-times, and that they have a sufficient allowance of Water. Two Convicts (one from each of two Messes in rotation) are to be present daily when the Provisions are issued, to see that each Mess

Gratuity for best ordered Messes.

Victualling Scheme.

receives its proper weight and quantity of each article allowed. If, however, you should find, from experience, that waste takes place in consequence of the established Ration of any particular article being greater than some of the Convicts can consume, you are to require the Master to reduce the issue of such article to the quantity you may have found to be sufficient for them, furnishing the Master in such a case with the Document required by Form No. 4, G., page 89, in the Appendix; but you are strictly to investigate all complaints that may be made on the subject of the issue of the Public Provisions,—to take care that all such as may prove to be well founded be forthwith redressed, —and to note every such Complaint, and what shall have been done with respect to it, in the Journal of your proceedings. The allowance of Water to each Person on board should, if necessary, Water. be limited to Eight Pints per Day while within the Tropics, and Six Pints per Day at other times.

Every opportunity is to be taken during the Voyage, of filling the empty Water Casks when rain falls.

#### 15.

Previously to the Receipt of Sailing Orders you are to take Provisions care that the Ship be completed in Provisions and Water, so as pleted. to insure her proceeding to Sea complete in all respects for Six In case of putting into any Port on her way down Channel, she is again to be completed, and you are to state to The Comptroller of Victualling and Transport Services, before you again sail, that the Ship has been so completed to the period for which she was originally ordered to be victualled.

You are to attend in person the opening of all Casks of Pro- Attendance visions which may have been received from the Public Stores, for issue. They are to be brought upon deck for the purpose, and you are to note the state and condition, mark, number, and contents, of each Cask in the Journal you are directed to keep by the 37th Article, page 24, of these Instructions. Two Harness Casks (with Padlocks), one for Beef and one for Pork, are to be supplied to the Ship, into which the contents of each Cask of Salt

Provisions are to be put, and the Keys given in charge of the Master.

Survey on defective or decayed Provisions,

Whenever any Provisions or other Public Stores placed in charge of the Master shall be reported to you as defective or decayed while at Sea, you are in each case to cause a Survey to be held on the same, which is to be attended by yourself, the Master, and Chief Mate, who, with yourself, are to sign a Report of Survey, in which are to be mentioned the state and condition in which the Stores are found, the probable causes of their defects, and whether any blame is attributable to any party either for the said Stores not having been taken due care of, or from their not having been stowed in a proper place for their preservation and security; and the said Stores, if condemned as unfit for Service, are to be kept on board till the arrival of the Ship at the Colony, where they are to be returned into the Public Stores. If, however, they cannot be kept on board with due regard to the health of the Ship, and it should in your opinion be advisable that they should be thrown overboard, it is to be so stated in the Survey, and you are to certify at the foot of the Report of Survey that they were actually thrown overboard as recommended in your presence, as, unless it is so certified, no credit will be allowed for the same on the Master's Account.

Survey on Remains. At the conclusion of the Voyage, you are, in concert with the Master and Chief Mate, to survey and take an Account of the Public Provisions and Stores of every description remaining on board in the Master's charge, previously to their being landed and delivered into the Commissariat Stores, sending to the Commissary one copy of the Report of Survey (according to Form No. 4, M., page 97, in the Appendix), wherein is to be shown the exact quantities and state in which the several Articles may be found, and another to The Comptroller of Victualling and Transport Services, under cover to our Secretary, by the first conveyance that may offer, observing that you are to satisfy yourself that the whole of the Remains of provisions and stores, &c., shall have been then brought

under your notice by the Master, and that not any article of Public Property be concealed or otherwise retained by the Master for any purpose whatever.

16.

You are to see that all Fresh meat, or other Articles, which Purchases. may be purchased by the Master on account of the Public at any Port the Ship may put into on her passage, be of good and proper quality, giving to the Master a Certificate to that effect, and to the articles having been purchased at the fair Market-price; and in the case of Oxen or Sheep being purchased and slaughtered on board, you are to grant to the Master a separate Certificate of the actual produce of the Oxen slaughtered distinct from the produce of the Sheep slaughtered.

Bills of exchange drawn by the Master upon the Accountant-Bills drawn. General of the Navy for the purchase of Provisions are to be approved by you.

17.

You are, at your discretion, to cause Lemon-Juice and Sugar Lemon-Juice to be issued, at the rate of One Ounce of each per day, to every Convict, mixed as Sherbet, and occasionally with the wine allowed, unless at any time you should consider it prejudicial to any of them, and the same Articles are to be issued to the Guard and Settlers at your discretion, but not, except in particular cases, exceeding that rate of issue. You are also to cause the preserved Potatoes to be issued in the manner pointed out Preserved in the scale of Victualling, No. 4, A., page 66, and in this case, Potatoes. as well as in that of the Lemon-Juice and Sugar above referred to, Certificates of the quantities actually Issued, as well to the Convicts as to the Guard and Settlers are to be given to the Master in order that the same may be allowed on his Accounts, Certificates. according to the Appendix, No. 4, L 1, in the case of Preserved Potatoes, and No. 4, L 2, in the case of Lemon-Juice and Sugar, pages 95 and 96.

18.

You are to keep up such a succession of Vaccinated cases as Vaccination. may enable you to convey fresh virus to the Colony, if the

number of Convicts or Passengers on board, who may not have had the Small-Pox nor undergone Vaccination, and who shall consent to be vaccinated, will admit of it, and, on your return to this Country, you are to deliver into the office of The Director General of the Medical Department of the Navy, with your other Papers, a List, showing the name of every person you have vaccinated, with the date and result of the Vaccination; and likewise an acknowledgment from the Medical Officer of the Colony, stating whether you have delivered to him any recent virus consequent upon Vaccination of individuals during the Voyage.

19.

Diseases.

You are to make a daily inspection of the Convicts with a view to discover the earliest symptoms of Fever, Flux, Scurvy, or any other complaint, and to take the most prompt means to stop the progress of disease amongst them.

20.

Medical Treatment. You are to visit the Sick at least twice a day, and oftener if necessary; and to pay every attention to their diet, nursing, and general comfort, administering to them such Medical Treatment as you may deem most advisable.

21.

Hospital.

The hospital being intended chiefly for Patients labouring under infectious complaints, or under such diseases as render confinement to bed necessary, you are not to admit into it Persons affected with slight complaints, but to attend to them in their own Berths.

22.

Infection.

Upon Patients with infectious disorders being received into the Hospital, their hair is to be cut off, if considered necessary. Their persons are also to be thoroughly cleansed, and their Clothing washed in boiling water, or fumigated, before it is stowed away, to prevent the possibility of infection. 23

You are to appoint, from among the Convicts in Health, those Nurses. whom you may think most fit and trustworthy to act as Attendants on the Sick. And you are authorized to select as a servant one of the Convicts whom you may consider most fit Servant. to act in that capacity.

#### 24.

All Persons who become sick shall, while they remain so, Diet of Sick. be checked of their established Rations of Provisions, and victualled according to your discretion, and you are to cause the Articles specially provided for them, as Medical Comforts, as well as such of the articles provided by the Scale of Victualling as may, in your judgment, be applicable to their respective cases, to be supplied for their use, while checked of their regular Rations; granting the Master a certified List of such Checks, and an Account as per Form No. 4, E., page 87, Checks. in the Appendix, of the articles of Provisions actually supplied for the Sick, while so checked of their regular Rations.

25.

You are to be particularly careful to observe all practicable Medical economy in the expenditure of the Medical Comforts (which are not on any account to be issued except to the Sick,) as well as of all other Necessaries, Medicines, and Utensils; and you are to return the remains of the Medicines, and Medical Stores, as well as the Medicine Chests in your charge, to the Principal Colonial Surgeon, from whom you are to obtain regular Receipts, with a Certificate of their having been returned in good and proper order.

You will be supplied with a case of Midwifery Instruments, Instruments, which you are not to deliver to the Colonial Surgeon, unless specially required to do so; in which case you must procure his receipt for them, and his Certificate to their being in a perfect condition; but in case they are not required by the Colonial Surgeon, you are upon your return to England to de-

liver them into the charge of the Medical Storekeeper in the Victualling Yard at Deptford, who will grant a proper Receipt and Certificate of condition. The greatest care must be taken of these Instruments, the value of which will be charged against your Pay, if they be found in a defective state, the cause of which cannot be satisfactorily accounted for by you.

26

Expenditure of Stores.

You are to furnish the Master with a general Certificate of all Medical Comforts, including Lemon-Juice, which may have been supplied by him for the use of the Sick during the Voyage, and to state thereon that you are ready to make a declaration to the fact of the whole of the same having been actually supplied by him and expended for the sick accordingly.

Extra Issues.

You are also to furnish the Master with Certificates of all duly authorized issues of Lemon-Juice and Sugar, and other extra articles made by him to the Guard, Settlers, or other Passengers and Convicts in Health, and of all articles of Bedding and Hospital Furniture which having been so supplied, shall have been properly expended during the Voyage, and therefore not ultimately returned into the master's charge, in order that credit for all such Certified Issues and Expenditures may be allowed on the Master's Accounts.

27.

Accounts.

You are to keep and render such an Account as is usual on board each of Her Majesty's Ships, of the Receipt, Expenditure, and Return of all Medicines, Utensils, and Necessaries with which you may be supplied; verifying the same by Declaration and to deliver it, together with the Colonial Surgeon's Receipt, &c., as required in Article 25, page 19, of these Instructions, into the Department of The Director General of the Medical Department of the Navy, before you will be allowed to receive the Balance of your Pay.

28.

Prisons.

You are to take care that the Convicts' Berths are kept as clean and as airy as possible; that the greatest Cleanliness

habits, and in the Hospital; and that as much Ventilation is used as may be consistent with due warmth. As it is very essential that damps should be prevented by every prac-Damps. ticable means, you are to cause the Swinging Stoves, which will have been supplied to the Ship, to be frequently used in different parts of the Prison and the Hospital, for the promoting of warmth, dryness, and a circulation of air, and you are to cause lighted Candles, or Oil Lights, to be kept in the two Lanterns which the Owners are bound to provide, viz., one in the Fore and one in the Main Hatchway, during the Night for the purpose of facilitating the prevention of any irregularities.

29

You are to select some Men from among the Convicts in order Water-Closets, that one may be placed as a Guard over each Water-Closet between Decks, to prevent anything being thrown into it that would tend to choke the pipe; and to see that it is cleansed by letting Water pass through from the Cistern every time it is used. These Guards are to be relieved at fixed periods, according to your discretion; and you are to cause the Convicts to use the seats of ease on Deck as much as possible, in preference to the Water-Closets.

30.

A Religious Instructor having been appointed to attend on the Religious Voyage to the Religious and Moral improvement of the Convicts who may be embarked in *England*, you are to afford him every necessary assistance in the performance of his duties, according to his instructions, a copy of which is annexed for your information and guidance, Appendix No. 10, page 109.

For this purpose you are to uphold the authority of the Religious Instructor, giving him your advice and support in cases of difficulty and reproving and punishing any Convict who may be guilty of misconduct towards him, or disobey the orders given by him in the execution of his duties.

Irish Convicts. As it is highly desirable, in the event of Irish Convicts being embarked, that their minds should be kept as constantly and usefully employed as possible, you are in the absence of a Religious Instructor, to exert your best endeavours to establish Schools under such Regulations as circumstances will permit; and should any of such Convicts prove to be particulary bad and vicious dispositions, they should be separated from the others in the best way in your power, and every means taken to effect their reform. You are to read the Church Service every for performing Divine Service, Sunday to these Convicts, and also a Sermon or some well selected parts from the Religious Tracts supplied to the Ship. You are to observe, however, that attendance at Divine Worship according to the Church of England is not to be exacted from Roman Catholics.

Regulations

Exemption.

Bibles, &c.

You are to cause the Bibles and Religious books supplied for the use of the Convicts, to be placed in charge of the Religious Instructor, for the purpose of being distributed among them in the following proportions, viz.:-

2 Common Prayer Books.	For each mess of Eight persons				
2 Psalters	To each mess of Eight persons.				
5 New Testaments	For each Sixteen persons.				
3 Bibles	For each Sixteen persons.				

You are to use every possible means in conjunction with the Religious Instructor, to promote religious and moral disposition in the convicts, and on your arrival in the Colony, you are to obtain these books from the Religious Instructor, and deliver them to the Governor with a list of the names of those Convicts who, from their general good conduct the Religious Instructor and yourself may consider deserving of having the same delivered to them as presents.

32.

Convicts to be admitted on Deck.

You are to allow the Convicts to be on Deck as much as possible, consistently with safety, when the weather and other circumstances will admit of it; and you are at all times to be Precautionary Measures to on your guard against any attempt at mutiny amongst them, be taken. taking precautions to prevent any surprise, particularly during the time of Divine Service, as well as at any other time when considerable numbers are admitted upon Deck, and to adopt every precaution, and to redouble your vigilance while within the tropics, instead of, as may have been the case, relaxing the discipline of the ship in those latitudes. And you are to issue Ceremonies or strict orders forbidding any ceremonies or amusements upon forbidden upon crossing the Line.

33

The Secretary of State for the Home Department will Punishment. furnish a printed Circular, a copy of which is annexed for your information, Appendix No. 7, page 104, which contains a copy of a clause in the Act of Parliament authorizing the infliction of personal punishment on Convicts; and whenever it may be necessary to inflict corporeal punishment on a Convict you are to cause it to be done in the most public manner possible, in order that the example may have the effect of deterring others from the commission of offences (the Guard on these occasions being under arms), taking care to obtain the Master's written approbation in every instance, and that an entry is made by the Master in the Log Book on the same day of such written approbation, together with the particulars of the offence, and the nature and extent of the punishment ordered. At the end of your Journal a List is to be inserted, shewing the names of List thereof. the Convicts upon whom punishment shall have been inflicted -the date when-the nature of the offence-and the extent of the punishment inflicted.

If the Ship should touch at any place on her passage, you Arrival in a are to report her arrival to the Senior Officer of Her Majesty's Ships present; and if any circumstance shall have occurred to render assistance necessary, you are to apply to him for it, showing him these Instructions.

35.

Cape of Good Hope, or other Settlement. If the Ship should touch at Simon's Bay, Cape of Good Hope, or at any other British Settlement, on her way out, you are also to report her arrival to The Governor of such Settlement, who, if he thinks proper, and there be accommodation on board, will give directions for the embarkation of any Convicts which there may be at such settlement or Colony, under sentence of transportation; but the Ship is not to be unnecessarily detained for such purpose. The Convicts are, in such a case, to be received on board, and victualled and treated in all respects in the same manner as the other Convicts.

36

Letters on Service. You are to avail yourself of every opportunity during the Voyage of reporting to our Secretary the progress of the Ship, and every occurrence worthy of notice which may have taken place since her last leaving Port; observing that your Letters are to be numbered, commencing with No. 1, and written draft wise, or on the half of the sheet, each paragraph being numbered and on all occasions your letters are to be addressed to the Secretary of the Admiralty, and are to be marked on the lower left-hand corner of the cover with the following words, viz.:— "Comptroller of Victualling and Transport Services," or "Director-General of the Medical Department of the Navy," as the case may be.

37.

Journal .

You are to keep a Journal of your proceedings, in which is to be noted every occurrence of any moment—particularly what may relate to the Convicts—the number of Sick each day—the Deaths—the nature of the Diseases and the Cause to which such Diseases are in your opinion attributable—suggesting any method which may appear to you likely to prevent them in future, particularly if they be of an infectious nature. You are to particularize in your Journal the Number of Convicts admitted daily upon Deck—the times when the Decks were scraped—when the Ship was fumigated—and when the Berths were cleaned and ventilated—the Latitude and Longitude of the

Ship at noon, the state of the Thermometer—and all other circumstances which may either immediately or remotely affect the Health of the Guard, Convicts, Settlers, or Crew, as well as the particulars before referred to in Articles No. 12, 14, 15, and 33, pages 12, 14, 15, and 23 of these Instructions.

You are also to insert in your Journal a List of the Convicts placed in your charge, and to state against their Names whether they were born in England, Wales, Scotland, Ireland, or elsewhere—whether they have been educated at a Sunday or any other school,—and at the end of such List you are to give a Summary as follows, viz.:—

You are to submit this Journal to The Governor's inspection, making Declaration, if required, to the correctness of the particulars related in it; and obtain from him a Certificate of your having done so, and of your Duty having been performed in every respect, but with particular reference to the subject of Article 13, page 13 of these Instructions, to The Governor's satisfaction. On your return to England, you are to deliver this Journal and Certificate to The Comptroller of Victualling and Transport Services.

Sick Book and Synopsis.

You are also to keep a Journal with a Sick-book and Synopsis, the same in all respects as if serving in a Ship-of-War, and in strict conformity with the Medical Instructions; taking care to insert in this Journal, under the head of Remarks, a concise Statement, shewing the Number of Convicts embarked, from whence they were received, and their general condition and state of Health on embarking and disembarking, which Journal and other Documents, together with a Certificate from the Medical Storekeeper at Deptford, obtained previous to your Sailing, of the efficiency and number of your Instruments, according to the List No. 3 in the Appendix to the Naval Medical Instructions, you are to deliver to The Director-General of the Medical Department of the Navy on your return to this Country.

Copy to be sent Home.

But immediately after your arrival in the Colony, or by the first subsequent opportunity, you are to forward of that Officer, under cover, as usual, to our Secretary, a Copy of the Synopsis of your Journal; accompanied by such remarks in explanation as may afford a complete history of the Convicts, as to their health and condition during the Voyage; and on your arrival in England, you are to deliver into the Office of the Director General, a Return in the form No. 9, page 108 of the Appendix, properly filled up, observing that till this shall be complied with, Certificates to enable you to receive your pay and gratuity will not be granted.

A Certificate from the Director-General of the Medical Department of the Navy, stating that no unnecessary expenditure appeared to have been made of the Medicines, Medical Comforts, or Necessaries, while the same were in your charge or under your control.

In addition to these Certificates, you are further to observe, that the recommendation to the Home Office for the granting of the said Gratuity will also depend upon your having strictly complied with every Article of these Instructions, their Lordships reserving to themselves the power of withholding such recommendation in case your conduct has not in every respect been perfectly satisfactory.

You are to report, to The Comptroller of Victualling and Return to Transport Services, your return to England immediately on your arrival; and personally to deliver into Office the several Documents required of you by these Instructions, according

to the List in the Appendix, pages 111 and 112. You are also in like manner to report yourself personally to The Director-General of the Medical Department of the Navy without delay.

#### 44.

Family not to Embark.

You are not, on any account or pretence whatever, to take your Wife, or any part of your Family, to Sea with you; nor to allow either the Wife, or any other Relation of the Master or any other Person not forming part of the Crew, to be taken to Sea, in the Ship, without our special Authority.

#### 45.

Pendant.

As a Pendant, similar to that carried by Transports, will be supplied to you, for the purpose of being hoisted if the Ship should touch at any Foreign Port on the Voyage from England, you are to consider the same in your charge, and to hoist it upon such occasions accordingly; and upon your arrival in this Country to return it to the Transport Department at Deptford.

You are, on your arrival at any Foreign Port, to wear the uniform established for your Rank in Her Majesty's Navy.

#### 46.

May call at the Cape de Verds, or Simon's Bay, Cape of Good Hope.

You are to consider yourself authorized to require the Master, as stipulated in the Charter-party, to call either at the Cape de Verd Islands, or in Simon's Bay at the Cape of Good Hope, for fresh Provisions, if from the state of Health of the Convicts you should deem it necessary to do so.

#### 47

Master's Instructions. A copy of the Instructions issued to the Master is annexed for your information and guidance in seeing that the Master complies with them, and at the conclusion of the Voyage or on your return Home, the Volume of these Instructions is to be delivered into Office, with your other Documents, in failure of which the value will be charged against your pay.

## INSTRUCTIONS

POR

#### THE MASTERS OF CONVICT SHIPS

Proceeding to New South Wales or Van Diemen's Lund.

1.

You are to apply to the Captain-Superintendent at Deptford Stores. for such Provisions and other Stores as may be necessary for the Voyage; observing that all demands are to be approved by that Officer. You are also to take care that the Ship is supplied, as stipulated in the Charter-party, (a copy of which will be furnished to you), with sufficient Scrapers, Brooms, Swabs, and whatever else may be necessary for keeping her sweet and clean; together with a sufficient quantity of Coals, Wood, Coke for airing Stoves, suitable Fire-hearths, Coppers and Furnaces for Cooking and Dressing the Provisions, Bowls, Spoons, Platters, Hen-coops and all other Necessaries (see Extract No. 2, page 56, of the Appendix), for such a number of Convicts, and other Persons as are to be embarked.

2.

You are to be careful to sign all Documents to which your Documents. signature may be required, for Supplies of Provisions and Stores made to the Ship from the Establishments at Deptford; and to deliver the same to the proper Officers before you sail. The same Rule is to be observed with regard to Supplies received either from other Establishments or Contractors. In all cases of Consignments of Provisions or other Public Stores, you are to pay the Storekeeper for the Stamps on the Bills of Stamps. Lading or Receipts.

3

In order to prevent, as much as possible, Remittances to Remittances, Convicts in the Colonies through private hands on board

Convict Ships, you are strictly forbidden yourself, and you are required strictly to prevent, as much as you may be able, all Persons under your control, from receiving any Money, either on account of the Convicts embarked, or for conveyance to other Convicts in the Colonies.

4.

Passengers.

Packages.

You are strictly enjoined not to allow to be received on board either on your own, or the Owner's private account, any other Passengers, or any Packages, or Articles of any description for any Person whatever, except by our special authority. If any infraction of the Charter-party, in this respect, should take place, the penalty which will be thereby incurred, will be strictly enforced against the Owners of the Ship.

5.

Victualling.

You are to victual the Surgeon, Guard, Convicts, Settlers, and Passengers, according to the respective Schemes of Victualling in Form No. 4, A., page 66, in the Appendix; taking care that each person receives the full Rations established by the said Schemes without any diminution whatever, except in the cases provided for in the 14th and 24th Articles of the Surgeon's Instructions, pages 14 and 19; and you are to make up your Accounts according to the Forms and Instructions contained in the Appendix No. 4, B. to M., pages 69 to 97, observing that, unless the whole of them are prepared strictly according to those Forms, and all the Certificates and other Documents produced, they will not be acted upon in Office.

Accounts.

Stoppages from Temperance men. When stoppages of Spirits shall have been made from the Troops embarked as Guard over the Convicts, i.e., in consequence of their being "Temperance Men," such stoppages are to be made good to them, either by their being allowed double their respective authorized Rations of Sugar, Chocolate, and Tea, or they may be allowed to decline to receive the additional Rations of Sugar, Chocolate, and Tea, in lieu of the Rations of Spirits not taken up by them.

In these cases the following directions are to be strictly attended to by you, viz., at the end of the Certificates to be signed by the Commanding Officer of the Guard, as to the accuracy of the Lists of the Troops victualled, the following words are to be added, in the first case, "except for the Men Certificates. " marked x from whom as Temperance Men there have been Rations of Spirits, and to whom there has been " stopped " issued, in lieu, a double allowance of Sugar, Chocolate, and " Tea;" or, in the second case, in the event of not any substitutes having been furnished, then to add at the end of the Certificate the following words,-" except for the Men marked " I from whom as Temperance Men there have been stopped Rations of Spirits, and to whom there has not been " issued, in lieu, any allowance of Sugar, Chocolate, and Tea." You are most strictly to consider every direction given on any Form in the Appendix, as having the full force and validity of

a separate Instruction.

All Provisions are to be served out by full Imperial Weights and Measures, duly stamped, which you are to provide; and which are to be submitted to the inspection and approval of the Transport Officers at Deptford before the Ship sails. On the Allowance for passing of your Accounts at the Admiralty, you will be allowed waste in issuing. Credit for a quantity of every species of Provisions (Fresh Meat and Vegetables, and Salt Meat excepted), equal to onetenth part of the established proportion for the number of Persons of the different descriptions you may have actually victualled, in full indemnity for Waste, and for destruction by Vermin; but it is to be observed, that no part of the said allowance of tenths, nor of any Article of Public Provisions or Stores whatever, is to be applied by you in kind, either to your own use, or to that of the Owner or any other Person not being an authorized Public Passenger; as payment will be made in Money to the Contracting Owner, for the Amount of Credits of Credits. each species of Provisions which may appear to be due upon the final balance of the Account, under the regulations noted on the Form No. 4, B., page 80, in the Appendix.

6.

Surgeon-Superintendent. You are to comply with such Regulations as the Surgeon-Superintendent may consider it necessary to establish respecting the management and treatment of the Convicts during the Voyage; to submit to his inspection, whenever he may require it, the attested copy of the Ship's Charter-party with which you will be furnished; and likewise to give to him every information which he may desire with regard to the quantities of the different Stores and Provisions shipped for the use of the Guard, Convicts, Settlers, and Passengers; observing that no part thereof is on any account to be applied to the use of yourself or the Ship's Crew, or to any other purpose than that for which they were supplied; and you are strictly to obey all Orders which may be given to you by the Surgeon-Super-intendent under the stipulations of the Charter-party.

7

Female Convicts. If the Ship should convey Female Convicts, you are to use your utmost endeavours to prevent their prostitution with any Person on Board; and you are yourself to show a good example in this particular; observing that no Gratuity will be granted to you unless The Governor's Certificate be explicit as to the fact of his being satisfied that all practicable means have been taken by you to prevent prostitution.

Gratuities to Mates. As an inducement to the Mates to support you in your exertions to attain this object, a Gratuity of Twenty Pounds to the Chief Mate, and of Fifteen Pounds each to the Second and Third Mates, will, on the termination of the Voyage, be respectively paid to them on their producing to The Comptroller of Victualling and Transport Services Certificates signed by the Surgeon Superintendent as to their having conducted themselves in this respect to his entire satisfaction, but you are to inform them that no Bills of Exchange are to be drawn by them for the payments of these gratuities.

8

Purchases.

In case it should be necessary to purchase Provisions at any Port you may put into on the Voyage you are to draw at the foot of the Voucher to the purchase, a Bill of Exchange, to be Bills to be approved by the Surgeon-Superintendent, at three days' sight, upon the Accountant-General of the Navy, in payment for the same, and to forward as soon afterwards as practicable, to our Secretary, for the Accountant-General of the Navy, a certificate from the Surgeon-Superintendent, that the Articles so purchased were of good and proper quality, and to their having been purchased at the fair Market-price. Such purchases will be charged against the ship until proper documents are delivered into office.

You are to allow the Convicts to be admitted upon Deck daily Convicts to be for the benefit of the air, when the weather will permit, and the Deck. Surgeon-Superintendent shall require it; noting the same in your Log-book, which is to be kept in the usual Form, and to Log-Book. be delivered into Office with the other Documents necessary for passing your Accounts, in failure of which the owners will be subject to a deduction of one Hundred Pounds from the Freight of the Ship.

You are also to deliver a copy of your Log-book to The Governor on the landing of the Convicts in the Colony.

10.

Spirits.

You are most strictly charged not to suffer, on any pretence whatever, Spirituous Liquors to be drawn off, or put from one cask into another, under any circumstances, in any part of the Ship, except upon the Upper or Main Deck, and then by daylight only; and still further to guard against accidents by fire, the alarm of which in Convict Ships, where there are so many persons confined together, may cause the utmost confusion, dismay, and mischief, you are at all times, when lights may be required in the Lazaretto, After-hold, or Store-Rooms, to see that a careful Officer attends with good lanterns, and to give him the most peremptory orders not to suffer the candles to be taken out of them.

## 11.

Simon's Bay, Cape of Good Settlement.

If the Ship should touch at Simon's Bay, Cape of Good Hope, Hope, or other or at any other British Settlement in her way out, you are to receive on board such number of Convicts under sentence of Transportation as The Governor of such Settlement may require, and as can be conveniently accommodated; but the Ship is not to be unnecessarily detained for such purpose. The Convicts are in such case to be received on board, and victualled and treated in all respects in the same manner as the other Convicts.

12.

Port Regulations.

On your arrival at the Colony you are to pay strict attention to the Port Regulations, a copy of which will be found in the Appendix, No. 8, page 106, and you are not to suffer any person under your control to leave the Ship; nor any Packages whatever to be landed until The Governor's sanction for landing shall have been given, and you are to submit to The Governor's inspection the attested copy of the Ship's Charter-party with which you will have been furnished; and to observe that His Excellency's Certificate, to your having done so, must be produced in office with your Accounts.

13.

At the conclusion of the Voyage, i. e., after the Convicts Remains of shall have been landed, a Survey is to be held by yourself, the Provisions, &c. Surgeon-Superintendent and Chief Mate; and an Account taken, in Triplicate, of the Public Provisions and Stores remaining on board; previously to their being landed and delivered into the charge of the Commissariat. One copy of which Report of Survey (according to Form No. 4, M., page 97, in the Appendix), showing the exact quantities and state in which the several Articles may be found, is to be sent to the Commissary by the Surgeon-Superintendent—another delivered to the Surgeon-Superintendent for the purpose of being transmitted to The Comptroller of Victualling and Transport Services, under cover to our Secretary, by the first conveyance that may offer—and the third to be retained in your own possession for the purpose of being delivered into Office with your Accounts.

After the Survey has taken place, you are to deliver to the Commissary all the Provisions and Public Stores remaining on board without any exception whatever; and to take Receipts for the same, which vouchers must be delivered into the proper Offices with your Accounts. Bazzles and Chains, and such other Stores, however, as The Governor may think proper to order to be returned to England by your Ship, you are to receive again on board; taking care that they are properly packed up in Casks, and delivered into store at Deptford on your return to this Country: and you are to obtain the necessary Receipts, whereon the tonnage of the Articles so returned must be specified, in order that the Owners may be paid freight for the same according to the Charter-party.

It is to be observed that the whole of the Provisions and To whom they Public stores remaining on board in your charge at the end of are to be returned. the Voyage are to be delivered in the Colony to the Commissariat, and to no other Department; and if, in violation of this Instruction, it shall be found that any portion of the said Provisions or Public Stores have been retained on board or applied to the Ships or your own use, or to any other than

the public Service, you will be liable to a Criminal Prosecution, and the Owners to such Mulct as their Lordships may impose under the Charter-party.

Surveys on defective or decayed Provisions, &c.

Whenever any Provisions or other Public Stores placed in your charge shall be found to be defective, or decayed while at Sea, you are in each case to report the same to the Surgeon-Superintendent, who will cause a Survey to be held on the same, which is to be attended by the Surgeon-Superintendent, yourself, and Chief Mate, who, with yourself, are to sign a Report of Survey, in which is to be mentioned the state and condition in which the Stores are found, the probable causes of their defects, and whether any blame is attributable to any party, either for the said Stores not having been taken due care of, or from their not having been stowed in a proper place for their preservation and security; and the said Stores, if condemned as unfit for Service, are to be kept on board by you till the arrival of the Ship at the Colony, where they are to be returned into the Public Stores. If, however, they cannot be kept on board with due regard to the health of the Ship, and it should in the opinion of the Surgeon-Superintendent, be found advisable that they should be thrown overboard, it is to be so stated in the Survey, and the Surgeon-Superintendent will certify at the foot of the Report of Survey, that they were actually thrown overboard, as recommended, in his presence,—as, unless it is so certified, no credit will be allowed for the same on your account.

14.

Gratuity to the Master. You are to produce the undermentioned Documents in support of your claim to the Gratuity of Fifty Pounds which is grantable by the Lords of the Treasury to the Masters of Convict Ships if their conduct shall have been in all respects satisfactory, viz.:—1st. A Certificate from the Governor as to the number of Convicts landed:—to his having been furnished with a copy of the Ship's Log-book:—to your having complied with all the conditions of the Charter Party, the attested copy of which has been submitted to his (The Governor's) inspection, as required

by the 9th and 12th Articles, pages 39 and 40 of these Instructions: - and to your having in all other respects conducted yourself in a proper and satisfactory manner.—2ndly.A Certificate from the Surgeon-Superintendent as to your having treated the Convicts, during the Voyage, with the most careful attention as regarded their comfort and the preservation of their Health :to your having supplied them with their full established rations of Provisions, with such variations or modifications only, as may have been directed by the Surgeon-Superintendent:-to the several stores shipped for their use having been faithfully appropriated thereto: - and to your having complied with the several recommendations made by the Surgeon-Superintendent as to the management of the Prisoners. The recommendation to the Home Office for the payment of the said Gratuity will, however, also depend upon your having strictly complied with every Article of these Instructions, and upon your conduct having been in all other respects satisfactory, and with the view of meriting the payment of this gratuity it is expected that you will use your best endeavours on all occasions cordially to co-operate with the Surgeon-Superintendent and the Officers of the Guard, in the execution of the duties respectively entrusted to them, in order that by your united exertions, the service may be performed in the most efficient manner possible.

You are also to observe that the payment of the Mess money Mess Certificates for the Surgeon-Superintendent and Officers of the Guard, &c., will not be made to you unless the proper Certificates signed by the said Officers, &c., are produced in Office stating that a good and sufficient Mess had been provided in every respect according to the conditions of the Charter-party, and it must also be stated in the Certificate the date of the first and last Dinner Meal taken on board.

You are to receive on board for conveyance to Australia any Letters from Bags or Packets of Letters which may be sent to you from the Post-Office.

#### CHARTER PARTY.

This Charter Party of Affreightment made and concluded upon this

Day of One Thousand Eight Hundred and Forty BY AND BETWEEN the Commissioners for executing the Office of Lord High Admiral of the United Kingdom of Great Britain and Ireland (for and on the behalf of Her Majesty) of the one Part and

(for and on behalf of the owners of the Ship undermentioned) of the other ha let and the said Part Witnesseth that the said second-named Part Commissioners have on behalf of Her Majesty taken to hire the said Ship for carrying Convicts and other Persons Provisions Stores or whatever else may be ordered on board by the said Commissioners or their Agents from the Rivers Thames and Medway or either of them to any Port or Place in the English Channel or to Kingstown and Cork in Ireland all or any of them where if required the same may be landed and other Convicts and other Persons Stores or other Articles at the discretion of the said Commissioners or their Agents may be taken or laden on board and the said Ship with her lading is then to proceed to Port Jackson in New South Wales or Hobart Town on the River Derwent in Van Diemen's Land both or either as directed and if required by the said Commissioners or by the Governor Lieutenant-Governor or Commander-in-Chief for the time being from Port Jackson or Hobart Town to Norfolk Island either with the same or other Persons and Convicts

AND the said second-named Part for Executors and Administrators

covenant and agree with the said Commissioners in manner following that is to say that the said Ship shall be tight strong and substantial both above water and beneath and at all times during the intended Voyage shall be manned (not less than half to be Able Seamen) with seven Men and a Boy (consisting of the proportion of British subjects as by law established but excluding Lascars) to every One Hundred Tons Register (Old Measurement) and in that Proportion for any number of Tons less than One Hundred fit and capable to manage and navigate her all of whom are to be constantly on board except when their duty requires their absence on shore and each of whom (except the Master) shall sign Articles whereby he engages to inflict such punishment on disorderly Convicts as may be ordered by the Surgeon Superintendent under his Instructions from the Secretary of State for the Home Department and that she shall be fitted and furnished with Masts Sails Yards Anchors Cables Cordage Apparel and all other Furniture fit and needful for such a Voyage and also shall have not less than Three proper Boats and sufficient and wholesome Provisions for the Ship's Company and be provided with Hammock Cloths for covering the Bedding within the Hammock Stantions and with two Windsails and shall be furnished with sufficient Scrapers Brooms Swabs and whatever else may be necessary to make clean the parts of the Ship in which the said Convicts or other Persons may be the whole of which shall be at all times at the Disposal and be subject to be used according to the direction of the Surgeon Superintendent on board the said Ship and that a strong Bulkhead (if required) shall be put upon the Deck so as to admit of the Convicts coming up and remaining upon Deck securely when ordered And that the said Ship shall also be provided with a sufficient quantity of screened or Washed Ballast Coals Wood Coke for airing Stoves suitable Fire-hearths Coppers and Furnaces for Cooking and Dressing the Provisions and with Bowls Spoons Platters Hen Coops and all other Necessaries including the proper Stamped Weights and Measures for such a number of Convicts and other Persons as shall be embarked as aforesaid for which the Owners are to be allowed as necessary money Fourteen Pence per Lunar Month for each Convict and other Persons embarked by order of the said Commissioners or their Agents and the Ship shall also be provided with Water Casks and Filtered Water to be obtained from the Thames Filtered Water Company for the Ship's Company Convicts and other Persons of every description embarked at the rate of One Butt for each Person and with a sufficient number of Cans and Pumps for serving out the same ALL of which Articles are to be provided at the proper Cost and Charge of the Owners.

And the said second-named Part for and on behalf of and the Owner of the said Ship covenant promise and agree in manner following that is to say

That all due care shall be taken by the Master and Crew of the said Ship of the Provisions and Stores that shall be put on board thereof on behalf of Her Majesty that there shall be no waste embezzlement or misappropriation of any part thereof that the Public Stores and Provisions shall be stowed away and kept separate and apart from those intended for the use of the Ship's Company and that there shall not under any pretence whatever be supplied to the Ship's Company any of the Provisions or Stores belonging to the Public or on the contrary any of the Ship's Provisions and Stores served out to the Convicts or other Persons embarked by order of the said Commis-

sioners or their Agents and it is distinctly understood and agreed that the said second-named Part and the Owners shall be responsible to the Crown for the amount of any loss to be sustained by any embezzlement misappropriation or waste of any part of the Public Stores or Provisions which shall have been committed by the Master or by any of the Officers or Crew of the said Ship loss arising from the dangers of the seas only excepted

AND that the Master of the said Ship shall strictly follow and execute the Printed Instructions with which he will be furnished for his guidance previously to his Sailing and shall also obey all other Orders that he may receive from the said Commissioners through any of their Officers or Agents under whose directions he may be and that the said Ship shall forthwith be in readiness to receive on board in the Rivers Thames and Medway or either of them such number of Convicts or other Persons Provisions Stores or other things as shall be ordered by the said Commissioners or their Agents to be received on board and the Master having signed proper Receipts Bills of Lading or other Indents for the same shall proceed with the said Ship from the Rivers Thames and Medway or either of them to such Port or Place Ports or Places in the English Channel or to Kingstown and Cork in Ireland or all or any of them as the said Commissioners or their Agents may direct and there deliver all or any part of the said Convicts and other Persons Provisions Stores and whatever else may have been laden or taken on board in the prosecution of the said intended Voyage as may be required and then and there receive or take on board all such other Convicts and other Persons Provisions Stores or whatever else may be deemed necessary by the said Commissioners or their Agents to be taken or laden on board the said Ship and the Master having signed proper Receipts Bills of Lading or other Indents for the same shall immediately proceed to Port Jackson in New South Wales or Hobart Town on the River Derwent in Van Diemen's Land or both as he shall be ordered and also from Port Jackson or Hobart Town to Norfolk Island if required as aforesaid without stopping at any other place unless by the Surgeon Superintendent it be found absolutely necessary to do so for taking in Water or Refreshments on account of the Health of the said Convicts or other Persons and in that case the Ship is not to remain for the private Concerns of the Master or Owner or for any other cause longer than is absolutely necessary for taking in Water or Refreshments and that should the said Vessel be required to proceed to Norfolk Island she is if required to return from that place to Port Jackson or Hobart Town with the Guard Fittings and remains of Provisions and other Public Stores And that during the Voyage every possible Expedition is to be used by the Master and Crew provided always that no extra charge be made to the Crown in any such case of stoppage And that upon the arrival of the Ship at her Port or respective Ports of Destination the Master shall there deliver the said Convicts and other Persons Provisions Stores and whatever else may belong to Government or that may have been delivered into the Master's Charge for Conveyance thither by order of the said Commissioners their Agents or other properly authorised Persons accordingly as he may be directed by the Governor Lieutenant-Governor or Commander-in-Chief for the time being

AND further that when the said Convicts and other Persons shall have been duly landed and delivered a survey shall be immediately held of the remains of the Public Stores and Provisions by the Master the Chief Mate and the Surgeon Superintendent and a true account thereof taken in writing which shall be signed by each of them after which the whole of such remains without any exception whatever shall be landed and delivered into the charge of the Commissariat and to no other department of the Crown and if in violation of this Agreement it shall be discovered and proved to the satisfaction of the said Commissioners that any part of the said Public Stores and Provisions shall have been retained on board the said Ship or during the Voyage shall have been embezzled wasted or misappropriated by the Master or any of the Officers or Crew the Owners shall be subject to such mulct or fine as the said Commissioners shall deem just in that respect

AND ALSO that during the Passage the Master of the said Ship and his Crew shall use all the means in their power for ventilating and cleaning the parts of the Ship in which the said Convicts and other Persons may be and shall and will from time to time admit the Convicts on Deck particularly those whose health may most require it taking care to admit such number only at a time as shall be consistent with the due security and safety of the Ship and in these several respects that the Master shall comply with the Requisitions of the Surgeon Superintendent and that during the Voyage the Master shall keep Two Log Books (Duplicates of each other) of the Winds and Weather and of all remarkable observations particularly respecting the said Convicts such as Births Sickness Behaviour or Deaths the number of Convicts from time to time admitted on Deck or reasons why they are not admitted on Deck and the said Master shall be obliged to enter in the said Log Books any Requisitions made by the said Surgeon Superintendent touching the said Convicts and shall on his arrival at any Port or Place during the Voyage send the most early notice thereof to the said Commissioners and on arrival at Port Jackson Hobart Town and Norfolk Island deliver to the Governor or Lieutenant-Governor or Person acting as such (verifying the same by Declaration if required) one of the said Log Books and obtain a Certificate of having so done and at the End and Termination of the Voyage deliver the other to the said Commissioners (verifying the same by Declaration if required) together with all the Orders and Instructions which he may have received from the Surgeon Superintendent relative to such Entries and likewise the Survey of Remains required to he held and taken as above mentioned

AND further that Thirty Working Days from the Time the Ship is certified to be in complete readiness on the Owner's Part shall be allowed to the said Commissioners to build the Cabins and perform other necessary works and to embark the said Convicts and other Persons Provisions and Stores in the River Thames or wherever else they may be ordered to embark and Twenty Working Days shall also be allowed to disembark the said Convicts and other Persons Provisions and Stores at Port Jackson or Hobart Town or Norfolk Island after Notice being given by the Master to the proper Officers

of the Ship's arrival there and of her being ready for these purposes but if it shall happen that the said Ship shall be detained by the Orders of Government in fitting embarking or disembarking more than Fifty Working Days shall be allowed Demuraltogether the said second-named Part rage at the rate of Ten Shillings per Register Ton (Old Measurement) per Calendar Month during such detention but notwithstanding if the Master shall be guilty of any delay or if any of the Ship's Crew shall be absent or not give every assistance in their power with the Ship's Boats both in embarking and disembarking the said Convicts and other Persons Provisions and Stores no claim shall in that case be allowed for the said Demurrage Provided always that nothing herein contained shall extend to render Her Majesty liable to Demurrage or chargeable with any loss or expense which may happen to be incurred by or occasioned to the said Ship or her Owners by detention delay or otherwise in consequence of the carrying into effect any Regulations relating to the Laws of Quarantine

AND further that no Private Passengers or Goods Packages or Packets whatsoever being Private Property shall be received on board the said Ship without the Special Licence and Consent of the said Commissioners nor shall the Master or any other Person having charge of the said Ship bring any Person or Persons away from either of the Settlements at New South Wales and Van Diemen's Land or Norfolk Island without Orders in Writing from the Governor or Lieutenant-Governor of the Settlement for the time being which Orders if given he is to produce upon his return to the said Commissioners under the Penalty in either case of One Thousand Pounds of lawful Money of Great Britain to be forfeited and paid over and above the Penalty hereinafter stipulated to be paid on breach of any of the Covenants and Agreements herein contained on the part of the said second-named Part or of the Master or Owners to be observed and performed And also that neither the Master nor any of the Ship's Company shall land Spirits or any other Commodities at either of the Settlements in New South Wales and Van Diemen's Land or Norfolk Island that are forbidden by the Port Orders without a regular Permit first obtained from the Governor Lieutenant-Governor or the Commander-in-Chief for the time being

AND in the event of any of the said Convicts or other Persons or Provisions Stores or other Articles belonging to Government being required to be landed in Van Diemen's Land the Master of the said Ship for the time being shall after landing the same take on Board and from thence safely convey to Port Jackson or Norfolk Island and land such other Convicts and other Persons Provisions Stores and Articles as he shall be required to do by the Governor Lieutenant-Governor Commander-in-Chief or by the Agent or other authorized Officer of the said Commissioners at Hobart Town it being fully understood that the Government shall have for its own purposes the entire use and employment of the said Ship from the time of her sailing from the Port of London until her arrival in Van Diemen's Land and New South Wales and in Norfolk Island if required to proceed to the last-named place

AND it is further declared and agreed that the Master of the said Ship shall after his arrival at Van Diemen's Land and New South Wales and Norfolk Island respectively and before sailing again from those respective places receive on board for conveyance back to England all such of the remains of the Public Stores and other Articles which shall have been Shipped for the use or for the security of the Convicts during their Passage to those Settlements as the Governor or the Agent or other authorized Officer of the said Commissioners shall think proper to send back And that he shall safely convey back all such Stores and Articles as aforesaid and on his return deliver the same into Her Majesty's Stores at Deptford for which service he shall be paid after the rate of Four Pounds per Ton on producing at the Admiralty Office Somerset Place a receipt for the same under the Hand of the proper Receiving Officer at Deptford with a correct Account of the Tonnage thereof

In consideration of which Covenants and Conditions it is agreed by the said Commissioners (on behalf of Her Majesty) that the said second-named Part shall be paid for the Hire and Freight of the said Vessel for the Voyage to Port Jackson and Hobart Town both or either at the Rate of

per Register Ton (Old Measurement) in manner following viz.—One Third of the Freight to be paid on producing a Certificate from the Comptroller of Victualling and Transport Services of

the Ship's having finally sailed from

on her intended Voyage complete in Men and Stores and in every other respect fitted and furnished as above stated on the Owner's part and the Remainder together with an additional Rate of

per Register Ton (Old Measurement) should the Vessel have proceeded from Port Jackson or Hobart Town to Norfolk Island after being required as aforesaid and have returned from that Island to Port Jackson or Hobart Town with the Guard Fittings and remains of Provisions and other Public Stores on the production and delivery at the Admiralty Office Somerset Place of the several Certificates Receipts Accounts and Vouchers required in the printed Book of Instructions with which the Master shall have been furnished as above mentioned and that such Payments shall be made by Bills at Sight payable by Her Majesty's Paymaster General Provided always and it is hereby agreed and declared that if at any time or times hereafter it shall be made to appear to the Commissioners for executing the Office of Lord High Admiral aforesaid for the time being that any Loss of Time Breach of Orders or Neglect of Duty by the said Master or other Persons having charge of the said Ship hath happened during the aforesaid service or that from any deficiency of Men want of Provisions or Stores or any defect or cause whatsoever the said Ship became incapable to proceed to the Port or Place of her destination or on the service for which she is engaged then and in every such case it shall and may be lawful to and for the said Commissioners for the time being to make such Abatement out of the Hire and Frieght of the said Ship by way of Mulct as they the said Commissioners shall adjudge fit and reasonable any thing herein contained to the contrary thereof notwithstanding

AND it is further agreed that a sufficient space shall be allowed to the Owners for the Stores necessary for the Voyage for the use of the Ship and Ship's Company a Schedule of which with the Tonnage the same may occupy is to be forthwith delivered to the said Commissioners or their Agent and that a proper Cabin shall be allowed for the Master and small ones for the first and second Mates

IT is also agreed that if the Commissioners for executing the Office of Lord High Admiral aforesaid for the time being shall require a suitable Table to be kept by the Master of the said Ship for such Officers (civil or military) including the Surgeon Superintendent or other Persons as may be ordered on Board by the said Commissioners for a Passage to any Port or Place to which the said Ship may be destined then and in that case a sufficient and respectable Table (including Breakfast Dinner Tea and Supper and a pint of good Port Wine or good Foreign White Wine per diem for each Officer or Person) shall be provided accordingly during such Passage in consideration of which there shall be allowed and paid by the said Commissioners in respect of each such Officer or Person the Sum of Fifty-six Pounds of lawful British Money One third of which Sum shall be payable immediately on his embarkation on the production of a Certificate signed by the Officer of his having embarked and the remainder on the production of a Certificate under the Hand of each such Officer or Person of his having been landed at the Place of his Destination and properly Messed as aforesaid Provided always that if required by the said Officers but not otherwise a suitable Table shall be provided by the said Master for their Wives Children and Female Servants who may be ordered on board the said Ship by the said Commissioners for a passage to any Port or Place to which she may be destined for whose Mess the amount to be paid to the Master by such Officers shall in no case whatever exceed the following proportions of the Sum hereby agreed to be paid by the Crown for the Mess of such Officers that is to say-

Two-thirds for an Officer's Wife and for every Child above Sixteen years of Age One-third for every Child above Seven and not above Sixteen years of Age

One-fourth for every Child not above Seven years of Age

Nor shall such Officer be required to pay to the Master for the Mess of a

Female Servant more than Two Shillings and Sixpence per diem

Provided nevertheless that the said Officers shall always be at liberty to provide a Mess for themselves and their families upon giving the Master of the said Ship Four Days' notice of their intention so to do and further that the said Commissioners' Agent at the Port or Place where the Ship may be fitted out shall as soon as conveniently may be and not less than Seven Days previously to the sailing of the said Ship from Deptford deliver or cause to be delivered to the said second-named Part or to the Master of the said Ship a List in writing of such Officers or Persons as are to proceed in the said Ship and to be Messed or Victualled as before mentioned and in case any of the Officers or Persons named in such List or any other or others who may be afterwards substituted by the Authority of the said Commissioners for any of those who may have been named therein (and which substitution may take place at any time before the final sailing of such Ship from

# EXTRACTS FROM THE CHARTER-PARTY OF A SHIP, FOR THE GUIDANCE OF THE OWNERS AND MASTER.

Seven men and one boy per hundred tons register.

Three proper boats in good repair.

Three wind sails and two water hoses.

Two lamps for hanging in the hatchways, with oil, cotton, &c., (similar to the pattern to be seen at the Transport Office, Deptford).

Scrapers, brooms, swabs, &c., for keeping ship clean.

A strong bulk-head, fore part of quarter-deck, to keep the prisoners forward,

(in male ships only).

Coals, wood, improved fire hearths with funnels, to be under the forecastle or under cover; separate coppers for guard and for convicts, and in female ships for convicts and free settlers.

Two tons coke to air the 'tween decks.

One pint tin pot for each person, and a platter for each mess of six persons, including the guard.

One spoon for each person, and in female ships one tin plate for each

Weights, scales, and measures (imperial).

Hen coops, candles, and other necessaries.

Stout tight water casks, half a ton for each person, to be embarked, including crew, guard, passengers, and convicts (a few tons extra are recommended), with cans and pumps for serving the water.

The whole of the water casks to be filled with filtered water.

Hammock stantions for bedding round the waist, with painted hammock cloths to cover them.

Four Guns, with 30 rounds of powder and shot for each gun.

A stand of Arms, including a cartouch box, a cutlass, and a boarding pike for each of the ship's company; and in male ships, 10 pistols with ammunition, and 10 cutlasses extra for the use of the guard.

Scuttles to be cut in the 'tween decks, well lined and fitted as may be required by the Government authorities.

The upper deck to be cut for air tubes, water closets, &c., in such places as the Government officers may consider requisite.

Such quantity of Ballast as may be directed, and to be properly screened and washed.

A lazarette deck to be laid from the stern to the fore part of the after-hatch and a bulk-head, and rooms for issuing provisions to be built thereon.

A small magazine to be fitted close aft on the lazarette deck.

A bulk-head in fore-hold for coals.

The Boatswain, Officers, and the whole of the crew, on signing articles, to engage to inflict corporeal and other punishments on the convicts whenever required so to do by the Surgeon Superintendent.

The lazarette deck and bulk-head in after-hold for security of provisions, and the bulk-head in fore-hold for coals, to be built, and coals shipped; the 'tween decks to be quite clear, and painted with two coats of white paint; the ground tier of water casks to be on board stowed and filled; and the top-gallant yards across, before the Government authorities will take the ship in hand at Deptford, to whom a report is to be made when the several articles above mentioned are on board ready for inspection.

The Wives of the Guard are to be served with half the Allowance granted to their Husbands; and their Children, under Ten Years of Age, with one quarter of that Allowance, excepting that Spirits shall never be served either to such Women or to their Children: but the Stoppages thereof shall be made good to them by their being allowed double their respective prescribed Rations of Sugar, Chocolate, and Tea; the Master taking care to charge himself, on the Debtor side of his General Account, with the amount of such Stoppages of Spirits, together with the Tenths thereon, and to take credit per contra for the Amount of the respective extra Rations of Sugar, Chocolate, and Tea, as also for Tenths upon the same.

All Children above Ten Years of Age are to be considered as Adults, and victualled—the Boys in the same manner as their Fathers—and the Girls in the same manner as their Mothers.

Each Convict or Settler, Male or Female, as well as each of their Children, is to be allowed two gallons of Wine during the Voyage.

Whenever the Master shall have been ordered, by competent authority, to receive on board any Officer or other Male Person, not coming under the description of "Settler," for a Passage, such person is to be victualled at two-thirds of the Allowance established for each Soldier of the Guard. All Troops on Passage, not doing duty as Guard over Convicts, are to be victualled as Passengers, namely, at two-thirds Allowance only.

The above Allowance of Oatmeal to Male Convicts or Settlers is to be issued to them for Breakfast; and the Chocolate (or Tea, on alternate days) for Supper.

Suet and Raisins, or Suet and Currants, shall be substituted for one-fourth part of the above proportion of Flour, one-half of the said fourth part in Suet, and the other half in Raisins or Currants, at the following rates, viz.:—

Half a pound of Suet is to be considered equal to one pound of Flour; and one pound of Raisins, or half a pound of Currants, is to be considered equal to one pound of Flour.

EXTRACT from "The Queen's Regulations and Orders for the Army," so far as relates to Troops when Embarked on board Convict Ships.

## INSTRUCTIONS FOR TROOPS WHEN ON BOARD CONVICT SHIPS.

THERE is no Duty which can occur to a Regimental Officer (whatever his rank) in which unceasing Vigilance is more required, than that connected with the command of a Convict-Guard; and there is no point connected with that Duty in which Watchfulness and Attention on his part are more essential, than the rigid enforcement, in the Men of his Detachment, of the Instructions laid down for his guidance.

The General Commanding-in-Chief is anxious to impress these Instructions upon the attention of Officers commanding Detachments employed on this Duty; as any laxity of discipline, or deficiency in the exercise of proper Vigilance and Caution, might be attended with most serious consequences, and entail disgrace on the Officers and Soldiers, and also on the Regiment to which they belong, by whose remissness and neglect such consequences may have arisen.

1st. The Officer commanding a Guard, immediately it is embarked, is to apply to the Surgeon, or Superintending Officer, for his full and active cooperation in carrying these Instructions into effect.

2nd. The Soldiers are to be cautioned and strictly prohibited from holding any intercourse or communication with the Convicts, and that a disregard of the Orders on this subject will meet with certain punishment. The Soldier, even the Sentinel, is not to reply to any question or communication addressed to him by a Convict; in the event of being addressed, he must call for the Non-commissioned Officer on duty, but he is on no occasion at liberty to answer the Convict. The Convicts will be apprised, by the Surgeon Superintending, of this Order to the Soldiers.

3rd. The Detachment is to be divided into three Watches or Reliefs, each Relief to continue on Duty as follows, viz:—

4th. During the Day the Guard is to be stationed on the Poop, and their Arms so disposed on the top of the Arm Chest, as to be immediately at hand in case of need. At night the Guard is to be stationed on the Quarter-Deck, and the Arms placed in an Arm-Rack to be made for this purpose.

5th. Three Sentries are to be furnished and relieved every hour.

6th. During the Day, the Sentries are to be posted as follows:-

One at the Windward Gangway, and one on each side the front of the Poop; the former is to keep the Doors in the Barricado constantly closed, prevent the Prisoners from coming aft, except passed by order, and will attend generally to their behaviour whilst on deck;—the latter will overlook the Convicts, and immediately report to the Non-Commissioned Officer of the Watch any irregularity he may notice, or, if necessary, call on the Guard to stand to their Arms.

7th. The Officer commanding the Detachment must be immediately acquainted with any instance of disorderly Conduct amongst the Prisoners, and, in concert with the Surgeon Superintending, take such measures as are necessary to repress it.

8th. During the Night, the Sentries are to be posted as follows:-

One down each Hatchway, and one at the Windward Gangway.

The former are to prevent the Prisoners from making a noise, and to report any sounds they may hear, which appear to proceed from sawing Planks, filing Iron, or from any other cause of a suspicious nature.

9th. Should any light be observed in the Prison, the circumstance is to be immediately reported to the Surgeon Superintending. These Sentries are to be armed with a Pistol and Cutlass, and previous to taking charge of their Post, are to ascertain that the Locks on the Prison Doors are secure.

10th. The Sentinel at the Gangway is to keep the Door of the Barricado closed, and will be in immediate communication with the Guard.

11th. When the Ship's Bell strikes the half-hour, the Sentries are to call "All is well," commencing with No. 1, and being repeated in succession by Nos. 2 and 3.

12th. In case of Alarm, the Guard is immediately to stand to their arms, and be in readiness to act as circumstances may require.

13th. The Non-commissioned Officer of the Guard during the Day is to take charge of the Keys of the Prison, and attend to any instructions he may receive from the Surgeon Superintending, with reference to the Prisoners.

14th. He is to post the Sentries, attend to the Reliefs, and see that the Men are vigilant in the performance of their Duties.

15th. Whilst on Duty, no Soldier is to quit the Post assigned for the Guard, without permission to do so.

16th. Besides the Non-commissioned Officer of the Watch, a Non-com-

missioned Officer of the Day must be appointed, for the purpose of superintending the Messing, cleaning the Barracks, and attending to other details of this description.

17th. The Detachment is to Breakfast at eight o'clock, and, immediately after Breakfast, every one must repair on Deck, with the exception of the Men who are appointed to clean the Barracks.

18th. At Ten o'clock the Watches off Duty are to parade without Arms for the purpose of Inspection, and twice each Week without Shoes or Stockings. At One o'clock the Men are to dine, and at Six the Fire is to be put out. On Sundays, the Detachment is to parade with Arms, when the Firelocks and Ammunition are to be carefully examined.

19th. In case of Alarm during the Night, the Guard on Duty is immediately to occupy the Hatchways, and if necessary, employ their arms to repel any attempt on the part of the Convicts to gain the Deck. The Soldiers of the next Relief are to hasten to the Barricado, and to occupy each Gangway. The remaining Watch is to proceed to the Poop, and act as a Reserve.

20th. The Sailors, armed with Cutlasses, are to proceed to the Hatchways, or assist in defending the Barricado and Quarter-Deck. If necessary, the Men on the Quarter-Deck are to retire into the Cuddy, and fire through the Windows; the Reserve is then to fire from the Poop.

21st. It is right to caution the Soldiers against making any unnecessary noise, as it is important that the Orders, which it may be necessary to give, be distinctly heard.

22nd. Should an attempt be made to capture the Vessel during the day, the Guard on Duty, instead of repairing to the Hatchways, is to defend the Barricado and Quarter-Deck, and to be reinforced by the next Watch. If the Quarter-Deck be carried, the Men on Guard are to retire to the Cuddy, and the next Relief is to hasten to join the Reserve on the Poop.

23rd. It is necessary to caution the Detachment against the means which may be employed to divert their attention, in the event of an attempt to carry the Vessel being meditated. In cases where this intention has existed, an Alarm has been created by the cry of "a Man overboard," or by some such means; and during the tumult which followed, the Prisoners rushed aft, and endeavoured to effect their purpose. It must therefore be distinctly understood, that in all cases of Alarm, the Guard immediately stand to their Arms, and the Men not on Duty repair to their respective Posts. The Soldiers of the Detachment must likewise be cautioned to be vigilant in the discharge of their duty as Sentinels; they must not relax in their watchfulness, nor permit the seeming tranquillity of the Prisoners to lull them into a dangerous security. The Officers of the Detachment, and the Non-commissioned Officers of the Watch, are to visit the Sentries frequently during the night.

24th. It will be advisable from time to time, when the Convicts are below, to practise the Watches in repairing to their Posts. This may be done without Arms, and, if possible, so as to prevent the Prisoners becoming

acquainted with the Arrangements. Whenever it is necessary to flog a Convict, a Guard must parade under Arms on the Poop, and at all times when the whole of the Prisoners are on Deck, the Detachment of Troops is to be on the Poop, and ready to act.

25th. For the purpose of keeping the Arms in perfect Order, and in a state of fitness for service, the Arms of each Watch are to be used alternately throughout the 24 hours: they are to be discharged at daylight in the Morning, and those of the next Watch loaded.

26th. Upon all occasions when Arms and Accoutrements are issued from the Ordnance Stores, for the temporary use of Men composing, or forming a part of, a Convict-Guard, the Officer embarking in charge thereof is to sign a Receipt to the Storekeeper for the Number delivered to him, as also for the Ammunition, and is held responsible that such Arms and Accoutrements, as soon as the Service for which they were issued is completed, are carefully given in to the Ordnance Storekeeper at the Station at which the Convicts disembark, taking from him, in return, a Receipt for those Articles, and for whatever spare Ammunition may remain, after the prescribed Daily Expenditure during the Joyage. The Officer is to transmit a Copy of this Receipt, through the Officer Commanding on the Station (New South Wales or Van Diemen's Land), to the Commandant at Chatham, for the purpose of being forwarded to the Office of Ordnance.

27th. In the event of Officers, who proceed in charge of Convict-Guards, having any complaint to make respecting their accommodation, they are to prefer the same to the General or other Officer Commanding at the Station where the Detachment may disembark, in order that immediate investigation may take place on the spot, and a special report (if necessary) made of the result.

#### No. 7.

(Referred to in the 33rd Article, page 23, of the Instructions to Surgeons Superintendent.)

SIR,

Whitehall,

You, being appointed Surgeon of the Ship , which is to be employed for the Transportation of Convicts from Great Britain, under and by virtue of an Act passed in the Fifth Year of the Reign of His late Majesty, intituled "An Act for the Transportation of Offenders from Great Britain," will have to execute the Duty of punishing such of the Convicts as may be guilty of Misbehaviour or disorderly Conduct on board the Ship during her Voyage. As this Power is conferred upon you by a Clause in the above-mentioned Act, I think it right to supply you with a copy of that Clause, which you will find on the other Side, and to enjoin you, in the Exercise of the Power, to adhere strictly to the Terms of the Law.

Where mild and persuasive Means (which are in all Cases to be first tried) fail in securing the good Conduct of any Convict, you are authorized to punish him according to the Nature of his Offence, either by reducing his daily Allowance of Provisions, or by confining him in a dark Cell, with no other Provisions than Bread and Water, or by moderate Whipping. Where personal Punishment is necessary, it must first receive the Approbation of the Master or Principal Officer of the Ship, and an Entry must afterwards be made in the Log Book, agreeably to the Act. You must never fail to be present at the Infliction of the Punishment, in order that you may judge how far the State of the Convict's Bodily Health will admit of its being carried; and Twelve of the Convicts at least are also to be present, unless there be some urgent Reason to the contrary, approved by the Master of the Ship, and entered in the Log Book.

"VI. And be it further enacted, That if any such Offender shall be guilty of Misbehaviour or disorderly Conduct on board of the Ship in which he or she shall be transported, it shall be lawful for the Surgeon or principal Medical Officer for the Time being of such Ship to inflict or cause to be inflicted on such misbehaving or disorderly Offender such moderate Punishment or Correction as may be authorized by the Instructions which he may receive from one of Her Majesty's Principal Secretaries of State: Provided always, that no such Punishment or Correction shall be so inflicted unless the Master or Principal Officer for the Time being of such Ship shall first signify his Approbation thereof in Writing under his hand; and every such Punishment or Correction, together with the Particulars of the Offeuce for which the same is inflicted, and such written Approbation as aforesaid shall on the same Day, in all Cases, be entered by such Master or Principal Officer as aforesaid upon the Log Book of the Ship, under a Penalty of Twenty Pounds for every Neglect to make such Entry, to be recovered to the Use of the Informer, by Bill, Plaint, or Information, in any Court of Record in England, or in one of the Supreme Courts of New South Wales or Van Diemen's Land,"

INSTRUCTIONS FOR THE GUIDANCE OF SURGEONS-SUPER-INTENDENT AND MASTERS OF CONVICT SHIPS ARRIVING IN AUSTRALIA.

(Copy.)

- I. The Port Officer or his Deputy will first board the Ship, and receive the Despatches and Mail; and, if necessary, the Health Officer will also visit it.
- II. The Comptroller-General of Convicts, or his Assistant, will afterwards inspect the Vessel.
- III. A Government Boat will attend the Ship until the Convicts are landed, by which means alone all communication, official or otherwise, is to be maintained.
- IV. No other persons than the Harbour Master, Port Officer, Health Officer, Colonial Secretary, Private Secretary, Comptroller-General or his Assistant, Registrar and his Clerks, Chief Police Magistrate, and Deputy-Inspector-General of Hospitals, are to be permitted on Board the Ship, or to communicate personally or by letter with any of the Convicts, before debarkation.
- V. The Boats which carry authorized persons on Board are not to be suffered to remain alongside, nor near enough to admit of conversation (which is strictly prohibited) between the Crews of the Boats and Persons in the Ship.
- VI. When the Officers above named, respectively, visit the Ship for the purposes of Inspection and Report, all due information and attention are to be afforded them by the Surgeon and Master.
- VII. The Surgeon will be informed by the Comptroller-General when the foregoing Restrictions are removed.
- VIII. The Surgeon will personally furnish the Comptroller-General with the following Returns as soon as possible after the arrival of the Vessel:—
  - 1. A nominal Return of the Convicts, corresponding with the Prison or Hulk List, specifying the conduct of each during the voyage, especially all cases of good or bad behaviour, together with the Prison or Hulk Lists, and all other Papers relating to the conduct or treatment of the Convicts.

- 2. A Return of Sick at the date of arrival, briefly stating the complaint of each.
- 3. A Return of the Prisoners who may have deposited money in his hands, showing the several sums belonging to each.
- 4. A Return of Packages belonging to the Convicts, specifying the description of each, whether box, trunk, &c., and the nature of the contents generally.
- 5. A Return of all Clothing and Bedding; but which are not to be issued after the arrival of the Ship without an order through the Comptroller-General.
- IX. The Surgeon will furnish the Colonial Secretary with a nominal Return of Free Passengers.
- X. The Surgeon and Master will furnish the Colonial Secretary, as soon after their arrival as may be practicable, with the Journal, a Copy of the Ship's Log-book, and the certified copy of the Charter-party.
- XI. The Surgeon-Superintendent will take especial care that no information respecting the character or qualifications of any Convict on board is conveyed to private individuals, and that no letters or parcels, or other thing whatever, to or from Convicts are allowed to pass; and he is requested to enjoin the adoption of the same course upon the Officers of the Guard, and of the Vessel.
- XII. The Surgeon-Superintendent is to direct the Master to deliver to the Comptroller-General any Bibles, Testaments, or other religious books remaining in his possession at the end of the Voyage, and which the Surgeon-Superintendent may not require to appropriate amongst the Prisoners on board as rewards for good conduct, obtaining proper receipts for the same.
- XIII. No article of food or luxury is to be permitted to be introduced on board the Ship on any account whatever, excepting the authorized Rations through the Commissariat Department; nor is anything to be purchased by the Surgeon, or by his permission, for the Convicts after arrival.

## INSTRUCTIONS TO RELIGIOUS INSTRUCTORS OF CONVICT SHIPS.

1st. You will immediately, on your appointment, place yourself under the directions of the Inspectors of Milbank Prison, and attend daily at the Prison for the purpose of assisting, under the orders of the Chaplain, in making such arrangements as may be deemed advisable for the Instruction of the party of Convicts to be confided to your care, and of employing such part of your time as may not be so engaged in the Religious and Moral Improvement of the Prisoners confined at Milbank.

2nd. When nominated to a Convict Ship, and prior to your embarkation, you will make yourself acquainted, as far as circumstances will admit, with the Character, Conduct, and Case of every Convict, and submit to the Inspectors, for their approval, a Classification of such Convicts, with reference to the Instruction which it is proposed to afford to them during the Voyage. You will also point out to the Surgeon-Superintendent for appointment such of the Convicts as are most suitable to act as Monitors on the Voyage.

3rd. It will be your duty to devote your best exertions to the Religious and Moral Improvement of the Convicts at all times, and you will, for that purpose, submit for the consideration of the Surgeon-Superintendent, such arrangements as may appear to you to be likely to conduce to that object; taking care to avoid any interference with the Rules for the safe Custody and Discipline of the Convicts, or with the authority vested in the Surgeon-Superintendent, a Copy of whose Instructions is enclosed.

4th. You will read to the Prisoners every Morning and Evening, when practicable, a selection of prayers from the Liturgy of the Church of England, together with a portion of Scripture and a short practical Exposition; and on every Sunday, Christmas-day, and Good Friday, the appointed Morning and Evening Services of the Church, and also a Sermon.

5th. You will, in addition to the performance of the stated Religious Services, assemble the Prisoners in Classes for both Religious and Secular Instruction.

6th. You will form Classes for the Elementary Instruction of the most ignorant in Reading, Writing, and Arithmetic; and, with the concurrence of

the Surgeon-Superintendent, take such steps as you may deem most efficacious for imparting both Scriptural and general Information to Prisoners of all Classes; and you will pay special attention to the Instruction and Improvement of Juvenile Prisoners. You will also, at suitable times, see each Prisoner in private, in order to be able to direct your advice and instruction with reference to the peculiar character and state of his mind. You will, with the previous sanction of the Surgeon-Superintendent, visit any Prisoner who may be in the Infirmary, for the purpose of affording him spiritual advice and consolation.

7th. In the performance of these duties, the Surgeon-Superintendent will receive directions to facilitate your arrangements, and uphold your authority; and upon any occasion in which a Prisoner shall misconduct himself or disobey your directions, you will report him to the Surgeon-Superintendent for reproof or punishment.

8th. You will keep a Journal, in which you will record every occurrence of interest in your Department during the Voyage.

9th. You will also keep a Character-Book, recording the progress of the Prisoners' improvement, change of Conduct, &c.

10th. You will, on your arrival in the Colony, and after the landing of the Prisoners, immediately apply to the Governor for a passage home; and should he not have the opportunity of providing one, a sum sufficient will be allowed for providing your own Conveyance and Mess; and you will, in such case, be at liberty to draw a Bill, at three days' sight, for the sum, on the Inspectors of Milbank Prison, stating that it is drawn to defray the expense of your passage to this country; and you will obtain the Governor's approval on the Bill so to be drawn, in the following words, "Approved, no public conveyance offering."

11th. You will, on your return to England, immediately report yourself to the Inspectors of Milbank Prison, and deliver to them your Journal and Character Book; and after a short period of leave of absence, (if requested,) resume your duties at Milbank, preparatory to your accompanying another Draft.

12th. You will avail yourself of every opportunity during the Voyage of reporting to the Inspectors of Milbank Prison the progress of the Vessel, and any occurrence, worthy of notice, which has taken place since her last leaving Port.

13th. In the event of there being amongst the Convicts on board, any who, on account of their dissent from the Service of the Church of England, wish to absent themselves from the Church Service, they are to be permitted to do so.
