I have the honour to present the Annual Report of the Medical Officer of Health for 1963.

The standardised Birth Rate has again risen.

The Infant Mortality Rate has reached a new low level - 7.88 per 1000 live births. This is most satisfactory.

The Stillbirth Rate has also shown a very gratifying decrease and the Standardised Death Rate has fallen to 9.60.

There have been no significant changes in the causes of death.

The Registrar General has continued to supply a comparability factor, 0.87, by which the Crude Death Rate must be adjusted for comparison with other areas of the country. As this factor is less than unity, the Standardised, or corrected Death Rate is less than the Crude Death Rate. This indicates that Hartismere has a greater "weighting" of elderly persons than the average for the rest of the country.

6. WATER SUPPLY.

Connections.

99 connections to properties were made during the year. Of these 19 were metered supplies, and 80 were domestic supplies.

The water undertaking was taken over by the East Anglian Water Company from 1st October, 1963.

Water Examination.

Well Water -- 2 samples were taken both of which were found to be satisfactory.

Mains Supply - 12 routine samples were taken in difference parishes and a further 12 taken at source (Redgrave Headworks). All reports showed the findings to be excellent.

Well Water Cyanosis.

During the year 6 samples were taken - 5 of these were found to be safe and 1 unsafe. The families concerned in the unsafe case were warned and advised to obtain an alternative supply.

8. MILK DEALERS LICENCES.

There are now eight licences issued by the County Council under the Milk (Special Designation) regulations, 1960, enabling persons to sell prepacked milk from an approved source in this district.

9. MILK SAMPLING.

Statutory - 21 samples taken (including 1 school milk) of which 1 sample failed methylene blue test for keeping quality.

Chemical Analysis - 13 samples taken of which one sample was found to be deficient in fat.

Biologicals - 40 samples taken. All results satisfactory.

10. FOOD INSPECTION.

156 Cattle were killed in the one licenced slaughter house during the year and 100% inspection of carcases was carried out. No carcases were condemned which again shows the first class quality of meat handled.
