

THE ANNUAL REPORT OF THE MEDICAL OFFICER OF HEALTH

FOR THE YEAR 1967

TO : THE CHAIRMAN AND MEMBERS OF THE COUNCIL

Mr. Chairman and Members,

Because of alterations to the boundaries of the County, the North Riding County Council decided to abclish Local Health Sub-Committees with effect from the beginning of the financial year 1968-69. This may be the last occasion on which matters which were the concern of the Ryedale Area Local Health Sub-Committee will be referred to in this report.

The Ryedale Area Local Health Sub-Committee was formed in 1948 and consisted of members from the constituent district councils, county councillors and co-opted members. Through the Area Health Office this Sub-Committee was responsible for the direct administration of the services of the Local Health Authority under Part III of the National Health Service Act 1946. During its existence many changes have taken place examples of which are the expansion of the Home Help Service and the development of the Chiropody Service.

In 1948 two part-time home helps were employed for a total of 140 hours. In 1967 the establishment was the whole time equivalent of 22 and 103 part-time helps were employed in 130 households for a total of 42,624 hours. This increase was probably inevitable but the anticipation of the need was pressed by the Local Health Sub-Committee at a time when there was some reluctance on the part of the Local Health Authority to expand the service.

In 1948 no Chiropody Service existed. This service was initiated by the Sub-Committee on voluntary funds and afterwards developed into a full time local authority service providing treatment throughout the whole area. In 1967 a total of 2,584 treatments were given in 12 centres and 847 treatments at home.

Many changes have been and are taking place in the boundaries and structure of local authorities. There is little doubt that there is room for improvement. The general tendency is to form larger authorities but this in itself will not improve efficiency.

A major public health problem is that of the aged and chronic sick. It is almost universally agreed that it is more efficient and economical, as well as being more humane, to help people to remain as independent as possible for as long as possible in their own homes. Age itself does not give rise to any particular difficulties. It is only when some degree of ill-health, often associated with complicating factors such as bad or inconvenient domestic circumstances, gives rise to difficulties that services, including those of the local authorities, become necessary. The basic problem is the maintenance of health. This can only be achieved by preventive medicine and, when prevention fails, the proper kind of support at the right time may do much to aleviate the difficulties. These are health problems and no category or combination of categories of social or welfare workers is capable of dealing with them as a whole. There is a tendency to set up organisations, even within the same authority, which deal separately with mental and physical health, welfare, housing, care and after care so that no one person has to deal with all aspects of the same problem. The fact that these related problems are frequently difficult and sometimes apparently incapable of solution, is no reason for devising organisations in which so many institutions, departments, committees and officials are partially responsible that none of them has the authority to deal with the whole matter and all of them have an excuse for doing nothing.

It is becoming difficult to recruit combined duty nurses, (i.e. nurses who are qualified as midwife, health visitor and district nurse) and who provide those services in one district. It may be that the work expected of a combined duty nurse is so demanding that nurses may have to be recruited for separate duties. This would increase the size of area served by each kind of nurse and would also increase the tendency to the fragmentation of responsibility referred to above.

GENERAL PROVISION OF HEALTH SERVICES FOR THE RYEDALE AREA.

For the purposes of the day to day administration of the Local Health Authority's Services under Part III of the National Health Service Act, 1946, the North Riding is divided into 10 Areas.

The Ryedale Area consists of the Urban Districts of Malton and Pickering and the Rural Districts of Helmsley, Kirkbymoorside, Malton and Pickering. The Area Health Sub-Committee, to which the Area Medical Officer is responsible consists of representatives of the County Council, the District Councils and co-opted members. This Sub-Committee meets six times per year.

AMBULANCE SERVICES.

The Area is served by Ambulance Stations at Kirkbymoorside and Malton.

CHILD WELFARE.

Two purpose built clinics, one at Malton and one at Pickering exist which provide a wide range of services in addition to Child Welfare.

Child Welfare Clinics are held at 10 Centres in the Area and the table shows the number of Clinics held and the attendances at these Clinics.

NURSING SERVICES - (INCLUDING HOME NURSING, HEALTH VISITING & MIDWIFERY).

The Area is divided into 15 nursing districts. The nurses appointed to these districts undertake Home Nursing, Health Visiting and Domiciliary Midwifery.

The area is at present served by 14 full time and one part time nurse. 6 nurses are qualified Health Visitors, 7 have nursing and midwifery qualifications and two full time and one of the part time nurses have qualified as District Nurses.

The majority of confinements take place in hospital.

HOME HELP SERVICE.

CARE AND AFTER CARE

Nursing aids are supplied on request by the Area Health Office on the recommendation of the general practitioner or nurse. In certain cases extra items of diet may be provided. Hearing Aid accessories are provided at the Area Health Office at Pickering.

HEALTH EDUCATION.

Most of this work is carried out by nurses and doctors in clinics and in the home. Occasionally formal lectures with the aid of film strips and other visual material may be given.

HOSPITALS

Cases of infectious disease are admitted to Cross Lane Hospital, Scarborough or Yearsley Bridge Hospital, York, when necessary.

In recent years there has been a great increase in the number of hospital confinements and expectant mothers are admitted to St. Mary's Hospital, Scarborough, Scarborough General Hospital, Westow Croft Maternity Hospital, Fulford Maternity Hospital and Northallerton Maternity Hospital.

St. Hilda's Hospital, Whitby, St. Mary's Hospital, Scarborough and St. Mary's Hospital, York, are available for the admission of geriatric patients. There is excellent liaison particularly with the Scarborough and Whitby Hospitals in regard to the admission and discharge of patients.

VOLUNTARY ORGANISATIONS

Co-operation with voluntary organisations continues but particular mention must be made of the Pickering Ambulance Association. This body provides transport for people in the Pickering Area who would otherwise be unable to attend Chiropody Clinics and also provides extra items of nursing equipment.

CERVICAL CYTOLOGY

Arrangements have been made to hold regular Clinics at Malton and Pickering to provide for this service. The response to this service has not been as good as it should be and every effort is being made by the district nurses to encourage people to attend.

LABORATORY FACILITIES

The Public Health Laboratory at Northallerton carries out examination of water, milk, ice-cream and pathological specimens taken during the investigation of infecticus diseases.

FAMILY PLANNING

The Family Planning Association provides regular clinic sessions at Pickering.

During the year four one-bedroom bungalows were erected at Ampleforth together with three three-bedroom houses of the proposed eight houses at Elmslac Road, Helmsley.

HOUSING ESTATE MAINTENANCE

The sausage and pie factory established some time ago and operated by Messrs. Palethorpes Ltd. of Tipton, Staffs. is to close down in the coming year.

One hundred per cent inspection of meat is maintained but shortage of staff prevents much being done in connection with Food Hygiene generally,

Shops, Stalls and Vehicles

Regular supervision has been maintained over closed vehicles dealing in food and conditions were found to be satisfactory.

Food Preparation Premises

Inspection of hotels, cafes and other premises dealing in the preparation of food have been carried out and conditions were found to be satisfactory.

Ice-Cream

No ice-cream is manufactured in the district. There are 19 premises registered to retail ice-cream in the pre-packed form. Seven samples of ice-cream were sent for examination, and were all classed Grade 1.

Bakehouses

There are two bakehouses in the district which have been visited regularly and conditions were found to be satisfactory.

Offensive Trades

There are no designated offensive Trades in the district.

Helmsley Market

The Helmsley Market Place purchased some time ago from the Duncombe Park Estate is operated by the Council. A public market is held on Friday of each week and in this connection this Department is responsible for setting up, removing, storing and repairing the stalls and clearing the Market Place. A car park attendant is employed at weekends during the summer months when a charge is made for parking. This venture is proving very successful.

Offices, Shops and Railway Premises Act, 1963.

21 shops, 13 offices, 1 warehouse and 9 catering establishments were registered under the above Act at the end of the year.

During the year 17 premises were inspected when the chief defects noted were lighting and sanitary accommodation. WATER SUPPLIES

The water supplies in the district are administered by the Ryedale Joint Water Board, of which this authority is a constituent member.

All the villages in the area enjoy piped water supplies. Outlying farms and properties in the remote districts are supplied by privately owned springs.

During the year 50 samples of water from various parishes of the district were sent for bacteriological examination, 46 of which proved satisfactory and 4 unsatisfactory.

The number of dwelling houses supplied from the public mains is approximately 1,429 and the population supplied is approximately 4,794. The number of houses supplied directly or by means of stand pipes is not known.

PUBLIC CLEANSING

Refuse disposal is by means of partially controlled tipping and is carried out at the Tip at Pockley Dale.

The Refuse Tip continues to be maintained and operated under strict supervision and every effort is made to keep it in a clean and tidy condition. The tractor purchased by the Council continues to give valuable assistance with this work.

Due to the speed at which the present Tip is filling up, it is recommended that steps be taken to secure a new site for the future. The quantities of refuse dealt with increases in bulk from year to year.

House refuse is collected on a fortnightly basis by direct labour using a Shelvoke and Drewry Fore and Aft Tipper 20/25 cu.yd. capacity vehicle and a labour force of two men and additional labour is employed in the town of Helmsley and other more densely populated areas.

The Shelvoke and Drewry Fore and Aft Tipping Compression vehicle was delivered on the 7th March, 1967, and gives satisfaction.

DRAINAGE AND SEMERAGE

There are six seway e disposal works situated in the area, five of which deal exclusively with the treatment of sewage from Helmsley, Sproxton, Oswaldkirk, Ampleforth and Gilling East.

The sixth sewage disposal works at Wombleton serves the parishes of Beadlam, Harome, Nawton and Wombleton and is administered by this Department under the Joint Committee of Helmsley and Kirkbymoorside Rural District Councils. A scheme has been prepared to take the sewage from Nunnington in the Kirkbymoorside Rural District area to these works for treatment.

The day to day maintenance of these works is carried out by a mobile team of two men with a Morris van for transport. The use of the tractor assists greatly in maintenance of these works.

It is pleasing to know that a scheme for Wass is now well advanced and that negotiations for Rievaulx and the Ampleforth College sewage works are receiving consideration. With the completion of these schemes the Council might consider the provision of schemes for the villages of Hawnby, Stonegrave, Coulton, Old Byland, Oldstead, Pockley, Scawton, Cold Kirby and Cawton.

CLOSET ACCOMMODATION

During the year there were 16 conversions to the water carriage system in the various parishes of the district. There were also 33 new houses erected with water carriage facilities.

SALVAGE

There is no salvage scheme in operation in the area.

PUBLIC CONVENIENCES

The Public Conveniences at Helmsley and Rievaulx have operated satisfactorily during the year.

SMOKE ABATEMENT

No action has been found necessary.

SWIMMING BATHS AND POOLS

There are no publicly owned pools in the area. There are privately owned pools at Queen Mary's School, Helmsley, and Ampleforth College.

CARAVAN SITES

The only caravan site in the area has been visited from time to time and has been well maintained.

RODENT CONTROL

The Rodent Operator employed jointly by this Council and Kirkbymoorside Rural District Council to carry out their obligations under the Prevention of Damage by Pests, Act, 1949, has been fully engaged throughout the year. Regular treatments have been carried out at the Council owned Refuse Tips, sewers and sewage disposal works and open ditches. The number of properties in the district surveyed was 117 and 215 treatments were carried out. A new Austin A35 van was purchased during the year to replace the existing one.

The sum of £148-13-2. is recoverable for work carried out on business premises.

14 applications for Standard Grants were received as against 15 in the previous year but there was an increase from 9 applications to 11 for Discretionary Grants.

Where it is necessary to provide a mains water supply for the first time, construct a septic tank or extend a small house to provide a bathroom it is possible for the standard grant to be increased by half the cost of the additional work up to a maximum of £350. Of the 9 schemes completed 4 increased grants were paid all of which were in respect of septic tanks. In the case of the 13 approved 3 were increased for bathroom extensions, one for septic tank drainage and one for a mains water supply.

In many cases there is a reluctance on the part of the owner to provide a food store on the grounds that refrigerator accommodation is available. Perhaps this aspect of the grant requirements should be reconsidered.

DISCRETIONARY GRANTS

The figures for applications received show an increase of 2. 10 were approved and one was left in abeyance until further information on cost was available. In 4 of the applications the houses concerned would soon have become unfit for habitation but the extensive renovation work proposed will bring them to a desirable standard. One application related to the conversion of an existing sound building to form a dwelling.

Since the inception of Discretionary Grants a total of 160 applications have been received. Of these 133 schemes have been completed involving 140 dwellings. 7 of this total were completed in 1967 and £2,427. 0. 0. paid in grants. £38,812. 10. 0. has now been paid at an average cost per house of £277. 4. 7.

The number of houses improved with both types of grant aid is now 264 which is 16.5% of the total housing accommodation of the district.

As mentioned in the 1966 report, the time must fast be approaching when an increase in the maximum of $\pounds400.0.0.$ will be authorised. If $\pounds400.$ was considered to be a reasonable figure in 1949 it surely must now be doubled.

UNFIT HOUSES

One house was demolished during the year under review and two undertakings were accepted which have the effect of closing the two properties concerned.

Four houses which were considered to be unfit for human habitation were subsequently brought up to a satisfactory standard.

PRIVATE HOUSING

A total of 17 private houses were completed in 1967.

COUNCIL HOUSES

Further land was purchased at Queen's Way to add to that already obtained by way of a Compulsory Purchase Order. Approximately 4 acres in all, the land will provide for a valuable extension to the Queen's Way Estate. The extension of existing sites, wherever possible, is to be recommended for maintenance costs are higher where small sites are involved.

After many difficulties, the Manor Close (Dale End) Scheme was finally approved and work commenced. In contrast to the earlier delays the Builders made extremely good progress and there is every prospect of the scheme being completed in good time.

A further two houses are under construction at Hutton-le-Hole and this will complete the site.

Two houses are in the Drawing Board stage for Appleton-le-Moors to complete this site and the only other land available in the District is at Spaunton (two houses) but there is little demand for houses in this village.

The painting of Council Houses and repairs other than plumbing and electrical work are carried out by the Council's own staff. 30 houses were painted and the handyman was kept fully employed on work to Council property. Wherever possible he has been given the assistance of another workman when available from refuse or sewage disposal duties. In view of the increase in Council owned property and the additional labour required for sewage disposal, delays have occurred and it is now obvious that an additional man will be required as soon as the Manor Close site is completed. Someone who can turn a hand to painting and minor works of repair would be valuable.

Housing repairs during the year cost £1,996.

FOOD ADMINISTRATION

Milk Supplies

It has been found that milk sampling was being duplicated in the district. This department was obtaining samples from the retailers whilst the County Public Health Inspector was also taking them from the retailers and also the farmers. Arrangements were made for the County Inspector to take all samples as he has right of entry to the dairy farms. Unsatisfactory analysis reports are forwarded to the Medical Officer of Health for attention. It has not been necessary to take any legal action during the year.

Fish frying is carried out at 2 premises and there are 3 producers of meat products. The latter are all relatively small producers and carry out this work in conjunction with their normal business as butchers.

ICE CREAM

20 premises are licensed to retail ice-cream and in each case the pre-packed varieties are sold. Cold mix ice cream is retailed from vans based outside the district.

FOOD POISONING

There were no cases of food poisoning to investigate.

MARKETS, STALLS AND DELIVERY VEHICLES

Purveyors of fish, fruit and vegetables frequent the Kirkbymoorside market and arrangements have been made by the market authority, the Memorial Hall Committee, to make W.C.'s, wash-basins, sinks, hot water and paper towels available in the Memorial Hall.

All persons owning vehicles used for delivery purposes have been advised that the regulations are in force and supplied with details of their requirements. Follow-up visits are being made to ensure compliance.

SHELL FISH REGULATIONS

These regulations present no problems to this District.

BAKEHOUSES

Bread and cakes are manufactured for sale at one property in Kirkbymoorside and these products are retailed from the firms own shop.

MEAT INSPECTION

The Council fixed the hours of slaughter of animals under the Meat Inspection (Amendment) Regulations 1966, and, whilst prohibiting work on Sundays, does permit slaughtering until 8 p.m. each Saturday. In order to obtain 100% meat inspection it has therefore been necessary throughout the year to visit the Nunnington Slaughterhouse each Saturday evening. The premises continue to be a dead weight centre. Apart from casualty animals, all meat is of a high standard and no cases of tuberculosis or cysticercus bovis were found. 267 visits were made and 2,626 carcases inspected. This is an increase of 314 over the 1966 figures and represents approximately 10 animals per visit.

There are no designated offensive trades in this area.

No out work is carried out in this District.

WATER SUPPLIES

The responsibility for water supplies in the District rests with the Ryedale Joint Water Board and whilst no new sources have been developed plans are in course of preparation for Appleton-le-Moors, Lastingham and Spaunton to be supplied from Cropton. This will improve the supply in times of drought.

Virtually all supplies are now chlorinated and where this is not carried out householders are advised to boil all water after heavy rainfall.

Attention has been given to those supplies which are plumbo-solvent in that samples are to be taken by the Board for chemical analysis. The existing byelaws require that lead pipes are not used in certain areas but the number of old houses with lead pipes and the possible dangers to health need further investigation.

22 samples were taken for bacteriological analysis in addition to those taken by the Board's staff. All were found to give satisfactory results.

Almost all houses in the district have a mains supply. The exceptions are those in remote areas. The following table gives the relevant details:

SEWAGE DISPOSAL

Kirby Mills Sewage Disposal Works

Being the main disposal system in the District, these works continue to receive the most attention. The works receive sewage from Kirkbymoorside and Kirby Mills and a scheme has been prepared which shows that many of the Keldholme properties could be connected by gravity.

Difficulties have again been experienced in drying sludge due to the vagaries of English weather. At the end of the year enquiries were being made regarding the availability of the sludge emptying vehicle operated by Pickering R.D.C. The use of such a vehicle would mean that liquid sludge could be removed from the works and applied to agricultural land at some distance from habitation. Savings in manpower would result and the risk of smell from the works would be reduced.

No complaints of smell were received during the year and it is hoped that this bears a direct relationship to the use of "Alamask" re-odourant whenever weather conditions are conducive to the production and spread of objectionable odours.

The works receive heavy flows in time of storm due to surface water being drained into the sewers. As there are no alternative disposal facilities for this water, any flow in excess of six times the dry weather flow is discharged direct to the river by way of the two storm overflow weirs.

Kirkbymoorside Sewers

A scheme to provide a new main sewer for the town is under consideration by the Council and part was laid through the new Manor Close housing estate. The existing sewers surcharge at several points during storm conditions and the provision of new housing estates can only aggravate the problem.

Development could be delayed if the sewer is not provided and this can hardly be to the advantage of the area.

Hutton-le-Hole

A separate system of sewers is in operation in this village and 1967 saw the system in operation for its first full year. Foul sewage from all the houses is connected to the system and there are no discharges to the village stream.

A connection is available for future public conveniences and whilst heavier flows are experienced in summer there have been no problems to date.

Lastingham

This system is similar to the one at Hutton-le-Hole and almost all the earlier remarks apply. Whilst the works are slightly different their operation has so far presented few difficulties.

Nunnington

One polite word sums up progress to date - "frustrating". Delay has been added to delay in an effort, one assumes, to conform to the Government's monetary problem. At the end of the year all details required by the various departments had been provided.

The existing village drainage system, although of doubtful construction, continues to discharge to the river an effluent equally as doubtful in composition. It is extremely unfortunate for those villagers who have still to empty pail and earth closets but it is hoped that they will not have to endure these conditions in 1969.

Wombleton and Nawton

Both these villages have foul and surface water sewers with the foul system discharging to the Harome works operated jointly with the Helmsley Rural District. It is into these works that sewage from Nunnington will ultimately be connected. Certain items of repair are necessary to these works and these have been put in hand by the Joint Committee.

Appleton-le-Moors, Great Edstone, Fadmoor, Gillamoor, Salton and Spaunton

All of these villages are without main sewage disposal systems and, whilst all except Salton do not discharge directly into watercourses, they suffer from inefficient soakaways or foul gutters.

If only the colour had been removed from these channels before it was added to the channels of communication!

Drainage Generally

Few difficulties have been experienced in operating the Building Regulations 1965

so far as they relate to drainage. The most common fault has been the omission of back-inlet gullies and several Contractors have been required to amend drainage systems to incorporate this provision.

A notice was served during the year under Section 47 of the Public Health Act 1936 requiring the provision of water closets to six cottages in Chapel Street, Nawton. Work should begin early in 1968.

Owners of property at Hutton-le-Hole and Lastingham have been requested to provide water closets but the response has not been swift. After a reasonable time has been given, the Council will be asked to serve notices as for Nawton.

A further 14 conservancy type closets were converted to the water carriage system during the year.

PUBLIC CLEANSING

The Refuse Collection system was improved slightly during 1967 with the introduction of a fortnightly collection in the main part of Farndale. The northern end of Farndale, all Bransdale and Sleightholmedale are visited once a month with fortnightly visits in all other parishes except Kirkbymoorside, Keldholme, Kirby Mills, Nawton and Wombleton where weekly visits are made.

The only refuse tip in use is at Cockerhill Quarry, Wombleton where adequate space is available for many years to come.

Bins are collected and returned except where there is no rear access and in these circumstances the tenant leaves the bin at the front door.

Several paper sack systems have been on trial and a pilot scheme, for the Manor Close Estate and existing Council Houses where long distances are involved, is justified. Although slightly more expensive there are savings in manhours and the collection vehicle has less standing time. This system makes the work easier and cleaner for the workmen and the householder has a clean sack each week instead of a filthy dustbin.

The cost of refuse collection for 1967 was £3,221 compared with £3,310 for 1966.

PUBLIC CONVENIENCES

Comparatively little damage was done to the Kirkbymoorside conveniences this year being, no doubt, due to a police investigation into damage the previous year. Although the police felt they had wasted their time, this action scared the culprits and damage virtually ceased.

Cleansing is still a difficult problem in that a full-time attendant cannot be justified but the toilets may be fouled within a very short time of the Cleaner leaving. In numerous visits to all types of houses, fouling to this extent of private W.C.'s has never been encountered. Surely it is too much to assume that the culprits do not live in this district!

Hutton-le-Hole is now to be provided with Public Conveniences on the site of the public car park. For many years the villagers have been pestered with visitors. The scheme should be completed in 1968 and will naturally be connected to the public sewer.

Similar arrangements will be made as for Low Mills in that the North Riding County Council will provide and maintain the conveniences but this authority will be responsible for cleansing.

Receipts for the year were £22. 13. 9. from Kirkbymoorside and £17. 10. 6. from Farndale.

The coin-operated locks will need converting to decimal currency when this is introduced.

OFFICES, SHOPS AND RAILWAY PREMISES ACT 1963

No serious deficiencies have been found in the premises visited. Owners have invariably been prepared to co-operate.

CARAVAN SITES AND CONTROL OF DEVELOPMENT ACT 1960

Informal action was taken to have 11 caravans removed from land at Hutton-le-Hole, Spaunton and Wombleton Aerodrome. The full co-operation of the respective owners was obtained in each case.

At the end of the year two caravans were stationed on another site at Wombleton Aerodrome and action was being taken to have them removed.

There are no commercial sites in this district but as in previous years the Caravan Club issued certificates for sites at Hutton-le-Hole (Mrs. N. Payne) and Wombleton Aerodrome (Mr. Hannan).

CLEAN AIR ACT 1956

No action has been necessary.

SWIMMING POOLS AND BATHS

There are no public swimming pools or baths in this District.

PREVENTION OF DAMAGE BY PESTS ACT 1949

Careful observations are being made as to the continued efficiency of Warfarin for rodent control. Resistance to this poison has not been found but the values of alternative poisons are continually under review should such resistance develop.

The scheme whereby a rodent control operative is employed jointly with the Helmsley R.D.C. continues and this can only be described as highly successful. Rodent populations are seldom given an opportunity to become major infestations but instances have been noted where members of the public have known of rodents being present without reporting the matter. Anyone who see these animals or signs of their presence should notify the local authority immediately. The service is free to householders but a charge is made for treating business premises and those householders who keep livestock. This charge is virtually the cost to the local authority and is considered to be very reasonable for the benefits obtained.

The Operative visits all Council owned property at regular intervals and private land as requested or for purposes of survey. £96. 11. 3. was recovered for treatments to business premises.

FERAL PIGEONS

Following the work carried out during 1966 in the control of these birds a further 146 were caught in 1967 and 50 - 60 eggs destroyed. Investigations confirmed that a good proportion of the birds were sleeping in buildings on the disused Wombleton Aerodrome. Preparations were made and 70 pigeons caught in one night. Obviously this drastically reduced the numbers which could be seen in Kirkbymoorside but there were still some 60 or 70 birds in the town.

In the past, pigeons have been caught in old buildings but with constant trapping the birds became wary and were to be found sleeping on roofs even during extremely cold and wet weather. Finally it was decided that further progress could only be made if a trap was built in the area of the Council Offices where the pests congregate. Such a trap is under construction and will be placed on the new flat roof at the rear of the Offices.

In two years 271 pigeons have been caught. Progress is slow, problems are many and even when the flock has been controlled tired racing pigeons will present the nucleus of other flocks unless regularly trapped.

BUILDING REGULATIONS

The operation of the Building Regulations 1965 takes up considerable time and it has been necessary on occasions to pass some of the work to either the Council's foreman or handyman. When appointments or meetings have been previously arranged it is impossible to visit works in progress before the statutory time allowed has expired. To visit after the expiration of the prescribed period could mean that the work to be inspected has been covered over. Concern that speculative building would proceed at such a pace that inspections could not be made were prevalent early in the year but the developments proposed were not carried out and consequently it was possible to manage as in previous years.

The No. 5 Area Planning Committee of the North Riding County Council continues to be responsible for planning decisions. All applications are forwarded to this office for onward transmission and the Council's observations obtained and made available to the Planning Officer. It is understood that where planning conditions are made taking into account the amenity aspect, and additional expense will be involved, a farmer is now able to claim grant on the additional cost. The grant is available under the Farm Improvement Scheme as provided for in the Agriculture Act 1967. No similar provisions are available for house owners under other statutes.

Yet another case of animals receiving attention before human beings. One would think that a grant towards the cost of building a bathroom with stone walls was as important as one for improving the appearance of a farm building.

SCHOOLS

Owing to the delay in obtaining consent for the sewer at Nunnington it now appears likely that the Education Committee will provide water closets with drainage to a septic tank.

CONCLUSION

The Council's programme for the construction of village sewage disposal systems may have been delayed by the financial situation but it has been said that where there are serious public health hazards schemes will be approved. This has been the case at Nunnington and it was necessary to submit a report to the Ministry on the health dangers which are present. There is no doubt that a good case can be made for each of the remaining villages.

The operation of a meat inspection service, which ensures that all carcases are inspected, has been particularly onerous. Slaughtering was being carried out every Sunday and although the hours were limited and Sunday work prohibited it was still necessary to make inspections at 8 p.m. every Saturday. Where only one inspector is available this severely limits the leisure value of a weekend.

My thanks are due once again to <u>all</u> members of the Council's Staff for their help this year as in previous years.



Water Supply.

13 samples of water were submitted for bacteriological examination during the year, 10 from public supplies and 3 from private supplies, all of which on analysis proved to be satisfactory.

Refuse Collection.

The fortnightly collection service has been maintained without break throughout the year and dustbins are almost universally provided.

Tipping is now concentrated at one point and continuous soil cover has been provided. The area remaining available is rapidly decreasing.

Discussions commenced during the year on the possibility of joint action with adjoining Authorities for the provision of a pulverising plant. As the conditions at your tip cannot be considered entirely satisfactory it is hoped that these negotiations will lead to an early improvement in the method of refuse disposal and at the same time afford an opportunity to increase the frequency of the collection service.

Sewage Disposal.

Your plant has continued to provide effluents of a satisfactory standard as required by the River Board and again I must pay tribute to the work carried out by your outside staff.

Work commenced at Hovingham on the provision of a new extended aeration sewage works and the re-laying of sewers to provide a separate system. This will remove a source of nuisance caused by the fouling of the Marrs Beck.

These standards could be improved if the average citizen would demand and expect cleanliness in the handling, storage and display of food in shops and restaurants.

Compulsory temperature control of particularly hazardous foods whilst on display in retail shops and restaurants is an essential factor in the prevention of food poisoning. Bakehouses

There are two bakehouses in the area which have been visited. Satisfactory conditions prevailed.

The Liquid Egg (Pasteurisation) Regulations, 1963.

There are no plants in the District that deal with pasteurisation, so no samples have been taken.

Meat Regulations, 1963.

Meat continues to be inspected at the one remaining Slaughterhouse in the area.

Meat is stamped and a charge is made.

Hours of slaughter are fixed. There is full co-operation from the owner and satisfactory conditions prevail.

All Parishes except Allerston, Hartoft, Wrelton (Part), Kingthorpe and Rosedale East and West are supplied with water by the Ryedale Joint Water Board.

The above waters are obtained from springs from limestone strata and are predominantly hard.

The precautions against plumbsolvency are not required. Water Supply General.

The Ryedale Joint Water Board is responsible for the supply and distribution of water throughout the Rural District, except of course where private supplies still exist. The private supplies are usually unsatisfactory in their quantity or quality, sometimes in both.

Boiling orders have been issued under the direction of the Medical Officer of Health where any excessive degree of contamination has been found.

Refuse Storage and Collection

A recent publication on a report of the Working Party has shown this service at present as being inadequate and below the accepted standard, however this will be reviewed when the economical position has improved.

Refuse Disposal

This in many Districts is becoming a difficult problem. In this district the Council is served by two tips and has received Planning Permission for a further tip site. These I feel will be hard to acquire in the future and Authorities will have to be collective in this service and probably resort to mechanical means of disposal. The North York Moors National Park area is not the place for refuse tips.

Method of disposal is by crude tipping only. This is possible due to isolation factor, but it is not hygienic or to be recommended. Complaints occur from time to time. No constant labour or supervision takes place on tips. Levelling is carried out periodically by hired bulldozer. Sites of tips are isolated and very little nuisance occurs.

The Refuse Collection Service demands increases every year with new houses and conversions. The consistency of household refuse is changing rapidly over to packages, tins and other bulk items. <u>Sewerage</u>

There are now five sewerage schemes in operation in the District serving a total of approximately **798** houses. They are situated as follows:-

The majority receive daily attention and four samples taken by the River Pollution Board, where applicable, ensure that this work is done methodically and satisfactorily.

Cesspool Emptier

This vehicle was brought into service in May. It has greatly improved the standard of sanitation and sewage disposal throughout the district. Unlike any other sewage disposal appliance it has brought in a return of £148. Os. Od. in re-chargeable work.

Two collective systems of Sewerage to serve as many villages as economically as possible with two Disposal Works are planned for the near future viz:-

> Ebberston, /.llerston, Wilton and Thornton Dale.

Works at Thornton Dale.

Aislaby, Niddleton and Wrelton Works at Pickering.

Public Lavatories

These are situated in the Farishes of Thornton Dale and Rosedale Abbey, and cater for the visitors to the District.

The one at Rosedale is closed for the winter months. They are supervised by direct labour.

No charge is made for admission.

Licensed Premises.

There are twenty-one Licensed Premises in the area. Satisfactory conditions prevail in all except one, which is under consideration.

Caravan Sites and Control of Development Act, 1960.

Four Sites were licensed during the year.

There are now fifteen sites licensed in the area involving one hundred and fifteen caravans.

The last few years has seen a very large use within the area for caravans for holidays.

They fall into two categories:-

(a) sites for continuous use for a number of caravans, and

(b) those used only at week-ends by a single caravan.

The Model Standards have not been difficult to achieve with the larger type of site, but with the single type however, it has been more difficult in some cases and in one particular instance no progress has been made to date.

HOUSING

IMPROVEMENT GRANTS

Up to date four hundred and twenty one houses have been brought up to modern standards in this district with financial assistance from the Authority involving grants of £84,224.

Thirty two enquiries have been dealt with and twenty-nine proceeded with.

From the details available it would appear that a considerable amount of work is being carried out to old property to provide modern amenities, particularly when change of ownership occurs. This preserves the amenities and character of a village.

Demolition is only resorted to when houses are badly situated and not capable of being rendered fit. The standard of accommodation in the country Villages is far higher than certain areas of our towns and citis

Sub Standard Houses

The Report reveals that there are still four hundred and thirty one sub-standard houses in the District.

Many are sound structurally, but they have no bathroom, hot water and W.C. and the kitchen leaves much to be desired.

In some cases the owners cannot afford the expense to modernise, they are not aware that the Local Authority can assist them and the Tenant is not aware that he can require the Cwner to carry out these improvements.

The year under review seems to mark the commencement of a decline in this work.

Can it be that the £400 maximum fixed in 1949 also needs reviewing.

Housing - General

The building of houses by private enterprise in the District has been steady and has kept pace with the Demand.

There are still a few new houses available for house purchase, but again the price of new houses would appear to be out of range of the lower income group.

Eighteen houses were completed during the year by private enterprise and **nine** by the Local Authority.

It was regretted that the development at Normanby was delayed. The Local Authority has always been conscious of the needs

and welfare of the older people living in the District.

They have provided forty four bungalows in seven Parishes for this obvious need.

Accommodation consists of Sitting Room, Dining Space, Double Bedroom and Mitchenette with Bathroom and J.C.

Building Regulations contd

The practical administration of these Regulations has produced numerous amendments from the Ministry concerned, but this legislation is again paving the way to producing uniformity of Building Standards for all classes of buildings throughout the country.

There are however, many who still have a mis-apprehension that agricultural buildings do not need any permission under the above Regulations.

Factory Farming

The development of agriculture in this field gives cause for concern.

The trend towards intensive animal and poultry husbandry to continue to produce food at the present rate and reasonable price must be coupled with efficient public health methods and practice, with particular reference to Odour, Noise and Rodent.Control.

HOUSING

Distribution

There are 184 Council Houses under the Control of the Local Authority scattered over 16 villages. 104 of these houses are connected to a main sewerage system, the reminader are served by septic tanks.

General maintenance has been carried out satisfactorily both by our own labour and private enterprise. Details are given overleaf showing a comparison for last year.
