SECTION B.

GENERAL PROVISION OF HEALTH SERVICES IN THE AREA

- (a) Laboratory Facilities. No change
- (b) Ambulance Facilities. The private ambulance situated in the town has continued to give prompt and effective service.
- (c) Nursing Facilities No change.
- (d) Clinics and Treatment Centres No change
- (e) Hospitals Considerable extension of St. Margaret's Hospital, both in the matter of accommodation and surgical equipment and appliances.
- (f) Maternity and Child Welfare No change.

SECTION C.

SANITARY CIRCUMSTANCES OF THE AREA

- (i) Water No change.
- (ii) Drainage and Sewerage. As a result of an adverse report upon the effluent from the Northern Outfall late in 1944 considerable attention was devoted to the Northern Outfall during 1945. The undermentioned works were carried out.
 - (a) Distributor arms to rotating sprinklers were repaired.
 - (b) Bleach powder treatment was applied to two of the four clinker beds
 - (c) The storm water area was cleaned
 - (d) The sludge disposal area was cleaned and
 - (f) A Lea Flow Recorder was installed.

A further recommendation of the Council to the Ministry of Health that the whole of the filter media be renewed at a cost of £1,845 was not agreed to by the Ministry. Instead an effort was made to cleanse the clinkers with bleaching powder but this treatment was not altogether satisfactory.

From May onwards during 1945 regular monthly samples were taken and only upon one occasion was an adverse report received. Meanwhile conditions are being closely watched and the Flow Recordings are being maintained.

No alterations were carried out to the Southern Outfall and the works continue to produce satisfactory results.

SECTION D.

Whilst it has not been possible to institute a systematic inspection of houses in the district more complaints have been received and effectively dealt with, and a large number of defects remedied.

There are no longer any evacuees remaining in this district although several families who came to Epping as Billetees have found permanent accommodation in the town.

SECTION E.

INSPECTION OF FOOD.

Meat. Occasionally small quantities of meat unfit for human consumption have been seized. Most of these seizures have been in connection with tinned goods and for the most part comprise cases where the tins themselves have been punctured as a result of bad handling.
