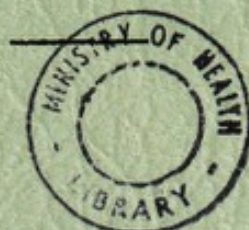
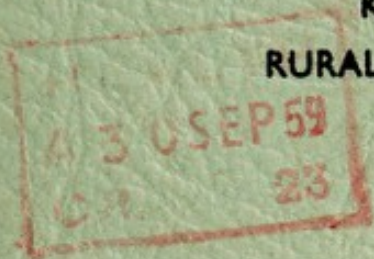

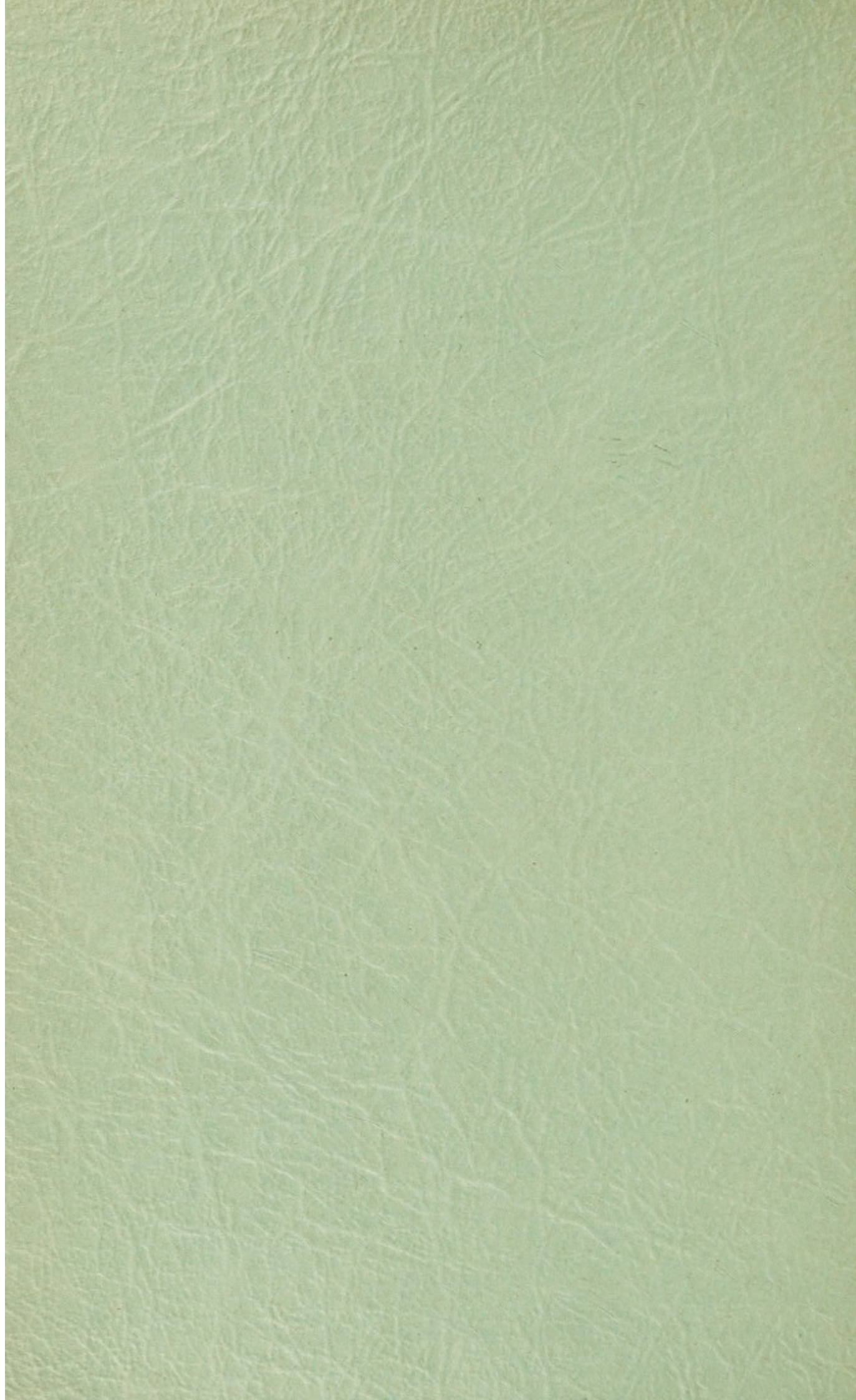

SECTION B.

General Provision of Health Services in the Area.

Staff.

I have the assistance and co-operation of the Public Health Inspector, Mr. R. S. Porter, who holds the Certificate of the Royal Sanitary Institute as Inspector of Meat and other Foods, and of Miss J. E. Mantle as Public Health Clerk.

Laboratory Facilities.

The Worcestershire County Council Laboratories are available for the chemical examination of water, milk and foodstuffs, and the work is carried out by the County Analyst.

All clinical bacteriology is carried out by the Public Health Laboratory, situated at Worcester Royal Infirmary.

Ambulance Facilities.

For Infectious Diseases an ambulance is provided by the Regional Hospital Board, and operates from Hayley Green Hospital.

For other cases an ambulance service is provided by the County Council, and operates from Kidderminster.

Nursing at Home.

There are four District Nurses in the area, who also practise as Midwives and act as Health Visitors. Two other District Nurses and one Health Visitor also deal with portions of the Area.

Infant Welfare Centres.

There are five Infant Welfare Centres in the Area — at Far Forest, Wolverley, Cookley, Chaddesley Corbett, and Blakedown, where Immunisation and Vaccination is carried out.

The Welfare Centre at Wribbenhall is also used by residents of the Area.

Hospitals.

The Kidderminster and District General Hospital is available for all residents in our Area, but some patients are admitted direct or transferred to All Saints' Hospital, Bromsgrove, which is most difficult of access to their relatives.

For Infectious Diseases the Isolation Hospital at Hayley Green is available.

Tuberculosis.

This work is the responsibility of the Regional Hospital Board, who arrange sanatorium treatment where possible. Dispensaries are held every Tuesday at 6-30 p.m., Wednesday at 10 a.m., and Thursday at 2 p.m. at the Kidderminster General Hospital, where Dr. R. Cronin attends.

The County Council are responsible for after-care and this work is administered locally by the After-Care Sub-Committee of the Divisional Area Committee.

Venereal Disease.

The Regional Hospital Board arrange for treatment and follow-up of these cases at the Kidderminster General Hospital.

SECTION C.

Sanitary Circumstances of the Area.

Water.

The Council own approximately 85 miles of water pipes, and the water in the Rural District is supplied by :

- (1) The Council's Borehole at Cookley.
- (2) The City of Birmingham Elan Aqueduct.
- (3) The Stourbridge Water Board.
- (4) The East Worcestershire Water Board.
- (5) The South Staffordshire Waterworks Company.
- (6) Kidderminster Corporation.

The supply is satisfactory both in regard to quality and quantity.

The Public Health Inspector submitted 42 samples of water from the six main sources for chemical and bacteriological examination. All the samples were satisfactory.

The above figures are approximate. Included in the 716 houses supplied from standpipes are several areas of bungalow development, and camping sites.

Drainage and Sewerage.

Work has progressed satisfactorily with the connection of houses to the new sewers in Wolverley and Cookley. By the end of the year the vast majority of properties had been dealt with.

The improvement in the hygienic conditions in these villages is so marked that it underlines the deplorable conditions existing in Chaddesley Corbett. It is hoped that the amended plan for Chaddesley Corbett will soon be available and put out to tender.

In areas likely to remain unsewered further progress has been made in conversion to water carriage to efficient private disposal plants.

As a result of the Council's progressive building programme, the number of cases of overcrowding in the Area has been reduced to very small proportions.

Prevalence of and Control over Infectious and Other Diseases. Immunisations against Diphtheria.

Despite our efforts many children remain un-immunised at least until school age and parents must be made to realise the serious risk of the return of diphtheria as a killing disease if they do not take advantage of the protection provided.

A further 112 children under five years and 22 children from 5 to 15 years of age were given primary courses of treatment and 123 were given booster doses.

No cases of diphtheria were notified.

Vaccination against Smallpox

During the year 80 children under one year, 7 children from one to four years, 2 children from five to fifteen years and 4 persons over fifteen years were given primary vaccination. 3 children from five to fifteen and 7 persons over fifteen were re-vaccinated.

It was not necessary to take any action under the Public Health Act (Prevention of Tuberculosis Regulations) 1925, or under Section 172 of the Public Health Act, 1936.

Conclusion.

The existing sanitary services in the area have proved satisfactory.

Good progress has been made in the condemnation of unfit properties and the rehousing of the occupants. The Council have given a good deal of time to the consideration of each case and have been very willing to accept any really sound scheme for the reconditioning of such houses by their owners.

A considerable number of properties once thought to be beyond repair at reasonable cost have been reconditioned by owner-occupiers. As a result the general standard of this type of house in the District has risen.

Milk.

There has been further evidence of the advantages gained from the wholesale pasteurisation of milk supplies. There has been no concrete evidence of the alleged sale of loose milk.

Efforts have been made to educate the consumers to clean thoroughly empty bottles before return to the retailer. This still remains a problem, but there is evidence of an improvement

It is pleasing to report that our food traders and handlers have a high sense of their responsibilities with regard to food hygiene. Wherever practicable they have carried out our requirements with regard to structural alterations and provision and maintenance of equipment. Proprietors of premises where meals are prepared and sold welcome inspections and ask for suggestions to improve conditions.

A problem which appears to be on the increase arises from mobile canteens. Whilst the majority are scrupulously clean, there are a number which are far from satisfactory and their migratory habits make it difficult to follow them up efficiently. They move overnight and leave quantities of litter. Fortunately co-operation with neighbouring Districts is good and much has been done to control this problem.

Another problem which has received attention is refreshment stalls at one-day functions. e.g. point-to-point races, flower shows and garden fetes. Whilst in the main every precaution is taken by those responsible, the greatest difficulty is still the provision of an adequate water supply for washing up. We have been successful in arranging for far greater supplies to be made available in several cases.

A continuous campaign of personal contact with traders and staffs on all matters relating to clean food was maintained.

Ice Cream.

Having only one small manufacturer of ice cream, the vast majority of ice-cream sold in the district comes from large concerns in other areas. This ice-cream is almost invariably supplied to the customer in cartons or wrappings.

It has not been necessary to draw attention to any infringements during the year.

PUBLIC CLEANSING.

Refuse Collection and Disposal.

This service is carried out by three lorries. One S.D. Freighter with a crew of three, one Morris Commercial with a crew of three and a Contractor's lorry manned by the Contractor and his son.

The S.D. Freighter covers the parishes of Wolverley, Cookley, Churchill and Blakedown and Broome and gives a fortnightly service to these built up areas. The Morris Commercial deals with the parishes of Chaddesley Corbett, Stone and Rushock and gives a fortnightly service. The parishes of Rock, Upper Arley, Kidderminster Foreign and Ribbesford are dealt with by the Contractor.

An ever present problem is the provision of adequate land for tipping.

All these tips are regularly sprayed with D.D.T. and other insecticides and little nuisance has arisen from flies, crickets, etc

Night Soil Collection.

A weekly collection of night soil is made from Chaddesley Corbett Village. The work is done by a local contractor, who uses a motor lorry provided with suitable bins for the carriage of the night soil. No complaints have been received with regard to the manner in which this work is done. The tenants of the houses concerned are to be congratulated on the way in which they cope with the situation and there has been no cause to draw their attention to any matter during the year.

The Council's proposed Sewerage Scheme for the village will render this service unnecessary, but as a temporary measure the system is as efficient as possible.

Number of pail closets emptied per week : 87.

Cesspools.

Nuisances from overflowing cesspools have again been dealt with by the use of a hired cesspool emptying vehicle as and when necessary. Cesspools have been emptied at the owner's expense. This problem is getting less as the years go by, mainly due the Council's progress with sewerage schemes and there are not sufficient homes requiring the service to warrant it being provided regularly.

WATER SUPPLY.

The Rural District is very well supplied with water from several sources. Bacteriological samples are regularly taken and when necessary chemical analyses are made. Details of samples taken are as follows :

It was not necessary to draw the attention of any Licencee to any serious infringements of the Acts.

In conclusion, Gentlemen, may I express my thanks for the interest and support given by the whole of the Council during the year.

I would also express my appreciation of the willing co-operation which I have received from the Clerk, Mr. J. H. Swann, the Surveyor, Mr. A. S. Northover, the Rating Officer, Miss I. M. Mountford, and the whole of the Council's staff.
