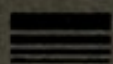

MR. CHAIRMAN, MISS TREEBY AND GENTLEMEN,

I beg to present my Report for the year ending December 31st, 1938.

STATISTICS AND SOCIAL CONDITIONS OF THE AREA.

Area (in acres)—1147½.

Population—The Registrar General's estimate of the resident population—3,084.

Number of inhabited Houses (end of 1938) according to the Rate Books—963.

Rateable Value—£20,591.

Sum represented by a Penny Rate—(estimated) £81 19 4.

The town of Kingsbridge is the market centre of an agricultural and highly attractive country district, and its inhabitants are mainly engaged in commerce. Unemployment has not had any prejudicial effect on the general health of the community.

The social conditions are generally favourable to health and longevity.

The conditions of occupation and of environment on the whole have not had a prejudicial influence on the general health or mortality.

GENERAL PROVISIONS OF HEALTH SERVICES FOR THE AREA.

The Public Health Officers of the Authority are a Medical Officer of Health (also Medical Officer of Health of the Plympton Rural and Kingsbridge Rural Districts, Assistant County Medical Officer, and School Medical Inspector, Devon County Council).

Deputy Medical Officer of Health (occasional). One full-time Surveyor and Sanitary Inspector.

Laboratory Facilities are provided by the County Council for the examination of milk and water in addition to the usual bacteriological examinations.

Provision of Antitoxin.—Medical men practising in the district can obtain a free supply of Diphtheria Antitoxin and Scarlatinal Serum. Material is also supplied for the immunization of children of the district against Diphtheria free of cost.

The South Hams Cottage Hospital provides 16 beds for patients from Kingsbridge and the surrounding district :—

It is supported by voluntary effort.

31 cases were admitted from Kingsbridge and Dodbrooke.

Isolation Hospital.—None in the district, but by arrangement with the Plymouth City Council infectious cases requiring hospital treatment may be sent to Swilly Isolation Hospital,

Plymouth. The Council have also an arrangement with the Paignton Urban District Council by which infectious cases requiring Hospital treatment can be sent to their Isolation Hospital.

The arrangements referred to are provisional only, pending the completion and adoption of a Scheme under Section 63, of the Local Government Act, 1929, for the provision of hospital accommodation for this part of the Administrative County and which Scheme is in the course of preparation.

Nursing in the Home.—The Kingsbridge Nursing Association is doing excellent work.

Of the three cases of Scarlet Fever admitted to Hospital one proved to be Toxic Erythema. All the cases recovered and there were no complications.

The case of Cerebo-Spinal Meningitis was treated by M and B 693, his progress was uneventful and he was discharged fit within a month.

Two cases were notified as Acute Anterior Poliomyelitis and were admitted. After observation one proved to be suffering from Primary Pneumococcal Meningitis and died. The other was thought to be a case of Cerebral Tumour and was transferred to the Prince of Wales Hospital for further investigation.

Drainage and Sewerage.—One length of sewer which was liable to blockages was reconstructed. There has been no important extensions and the system generally is satisfactory.

Watercourses.—Referring to my report for the previous year, the Council, by arrangement with certain Owners have undertaken the clearing of sections of the water-courses in the built-up area but there are still some water-courses which are silted up and liable to cause flooding.

Closet Accommodation.—There are no closets on the conservancy system within the built-up area.

Public Cleansing.—The refuse collecting system was re-organised during the year. The Council adopted a standard

bin for use throughout the district and undertook to supply the same under Section 75 (3) of the Public Health Act 1936. Arrangements were also made for the collection of refuse from all backways and passages by means of a sanitary truck and refuse is now collected from all premises in the built-up area twice weekly.

Swimming Baths and Pools.—There are no baths or pools in the area.

Eradication of Bed Bugs.—There were no cases in the district during the year.

Schools.—The sanitary condition and water supply of all public elementary and secondary schools in the district are satisfactory.

Milk Supply.—Much time and attention has been devoted to this question; and improvements have been effected during the year. Many samples have however failed to pass the test for Cleanliness, especially during the summer months. Close co-operation continues with the County and Rural Authorities an every effort has been made to ensure the supply of "clean milk."
