MEDICAL OFFICER'S ANNUAL REPORT

For the Year ended December 31st, 1905.

To the Chairman and Councillors of the Knaresborough Rural District Council.

GENTLEMEN,

I have pleasure in laying before you my Seventh Annual Report as Medical Officer of Health for the Knaresborough Rural District, for the year ended December 31st, 1905.

The estimated population of the district up to the **Population**. middle of the year 1905, is 8655. The chief increase has been in Pannal, Forest Moor, and Killinghall.

The number of births registered in the district during **Births**. the year was 180, viz., 94 males and 86 females. The annual birth rate is 20.9 per thousand of the estimated population. This is the lowest recorded birth-rate for the district. It is very much below that for England and Wales, which was 27.2, although this is also the lowest ever recorded.

Deaths.

The deaths registered in the district in 1905 numbered 100. This is five less than the previous year, and gives the very low death rate of 11.55 per thousand of the estimated population. The death rate for England and Wales for the same period was 15.2 (the lowest on record).

Deaths under one Year of age The deaths in children under one year of age were 26 in number. This is exactly double of that for the previous year. The infantile mortality for the year was 144.4 per thousand births registered. This is exceedingly high compared with that for England and Wales for the same period, which was 128 per thousand births. The great increase from last year does not appear to be due to any particular or preventable cause, as is well shown in Table V. One half of the deaths were in children under one month, and 10 of these did not survive one week. When these premature and weakly infants are deducted the mortality from preventable causes is not so black as it might at first sight appear.

Causes of Death.

Between the ages of 1 and 25 the number of deaths was 19; between 25 and 65 the number was also 19; and in persons over 65 there were 36 deaths. The principal causes of death were:—Phthisis and other tubercular diseases, 14; Heart Diseases 10; Bronchitis, 10.; Pneumonia, 8; Cancer, 7; Whooping Cough 3; Diphtheria 2; Scarlet Fever, 2; and Measles, 1. See Table IV.

Zymotic diseases caused 10 deaths. This gives a zymotic death rate of 1.15 per thousand per annum. The zymotic death rate for England and Wales for the same period was 1.52 per thousand.

Phthisis and other tubercular diseases caused 14
 and other Tubercular deaths. The deaths under this heading have been increasing during the past few years, the numbers being 1902, 5; 1903, 9; 1904, 11. The chief increase is in tubercular diseases of other organs of the body other than tubercular diseases of

the lungs. There were 3 deaths in children under one year of age from this cause. These were probably due to feeding children on milk derived from cows suffering from tuberculosis.

The number of deaths from Cancer was 7. This is **Cancer**. about the average number of deaths from this cause annually in the district.

There were no deaths from Diarrhœa during the year. **Diarrhœa**. The death rate in the district from it has been very favourable for the last few years. The leaflet I drew up some time ago, with a view to the prevention of this disease, is being distributed by the Registrars of Births.

The number of Infectious Diseases notified during the **Diseases** year was 36, as compared with 58 last year. They were as **Notified**. follows:---Scarlet Fever, 20; Diphtheria, 7; Erysipelas, 4; Enteric Fever, 3; and Continued Fever, 2.

The Scarlet Fever cases were less than half that of the Scarlet previous year. Follifoot and Killinghall suffered most from **Fever**. it. Isolated cases occurred in several of the other parishes. Two deaths were due to it. The number of patients from the district treated in the hospital were 9.

There were 7 cases of Diphtheria, 2 of which proved **Diphtheria**. fatal. Six of these occurred in Killinghall and one in Knaresborough Outer. The use of Antitoxin during the last few years has been very beneficial in lowering the death rate of this disease. As its expense places it to a certain extent out of the reach of the poorer people, I think it would be to the benefit of the district if your Council provided it in such cases.

There were only 3 cases of Enteric Fever during the Enteric Fever.

- Whooping Cough. There were 3 deaths from Whooping Cough. This disease was not prevalent during the year. Any cases that occurred were the continuation of the outbreak during the end of the year 1904.
- Measles. There was a severe outbreak of Measles at Pannal and Killinghall in the early part of the year. The remainder of the district was fairly free from the disease. One death was caused by it.

Small Pox. We had no Small-Pox during the year.

Sewerage and Drainage. A scheme of 1462 yards of sewer has been carried out in Forest Moor. This has been a much needed work, and is being taken advantage of by the builders, as there has been a great increase of buildings in that part lately.

> The much needed scheme for Pannal has been submitted to the Local Government Board. The village of Pannal (particularly that portion situated in Follifoot) being the part most in need of it.

> The village of Kettlesing, in the parish of Felliscliffe, is much in need of drainage, and can, I believe, be done at very little expense.

The village of Follifoot also requires attention.

Water Supply.

At Plompton private works are in hand for the supply of water to Plompton Square and the neighbouring farms. The progress of these works is very slow, in fact, they seem to have been at a standstill for some time. I have been complaining of the water supply here for over five years. I hope the promises your Council have had may soon be fulfilled.

Last year I reported that the means of conveying the water from its source to the village of Kettlesing required improvement. At its source the spring is very good. The water from it is conveyed in pipes to a neighbouring field, where it runs into a cattle trough, The overflow pipe runs from this trough to the next field, where it again empties into another trough, and so on until finally after passing through a series of troughs it is supplied to the village.

A short extension of water main in Pannal has been the only portion of the district which has had a new supply of water during the year.

The water supply of the rest of the dictrict is at present satisfactory.

There are 9 Slaughter Houses registered in the district. Slaughter These are in a satisfactory condition. Houses.

There are 84 Cowsheds on the register. These also **Cowsheds**. are in a satisfactory condition. One of these has been the cause of complaint during the year. Some improvements have been carried out and others promised.

The number of Factories and Workshops in the district Factories is 74, viv., Domestic Workshops, 10; Retail Bakehouses, Workshops 6; Laundries, 2; Factories, 12; Work Places, 9; and other Workshops, 35.

No defect of sanitation of workshops has been found. Sanitation Under this heading are (1) Cleanliness—No action required; Workshops (2) Air Space—This was sufficient; (3) Ventilation—This was fairly good, no action considered necessary; and (4) Drainage of Wet Floors—None.

There are 6 Retail Bakehouses in the district. The sanitary Sanitation condition of these was satisfactory. They comply with the of Bakehouses. Act as regards closets, drains, water cisterns of w.c.'s, sleeping places, and limewashing. It was not necessary to give any notice to limewash. Und'rgr'nd There are no Underground Bakeries in the district. Bakeho'ses.

Safety from Fire. This portion of the Act does not apply to any Factory-Workshop in the district.

There is no Home Work in the District within the meaning of the Act.
