

#### MEDICAL OFFICER'S ANNUAL REPORT

For the Year ended December 31st, 1913.

To the Chairman and Councillors of the Knaresborough Rural
District Council.

GENTLEMEN,

I have pleasure in laying before you my Fifteenth Annual Report as Medical Officer of Health for the Knaresborough Rural District, for the year ended December 31st, 1913.

The population of the district has not increased much **Population** during the year, as there has been very little building done in any portion of the district. The estimated population up to the middle of 1913 is 8,575.

The number of births registered as belonging to the Births. district was 169. This is 5 less than that of the previous year, and gives an annual birth rate of 19'7 per thousand of the estimated population. This is very low, and compares unfavourably with that for England and Wales, which was 23'9.

The number of deaths of residents in the district and **Deaths**.

f residents in places outside the district was 89. This is

2 less than last year. The annual death rate for the year 1913 was 10'35 per thousand of the estimated population. This is a very satisfactory rate. The corresponding rate for England and Wales was 13'7.

Deaths under one

The deaths in children under one year of age were 9 year of age in number. Five of these were in premature or debilitated infants. Two were due to convulsions, one to acute dermatitis, and one to suffocation. The infantile mortality for the year was 53'2 per thousand births registered. This is the lowest death rate in infants of which I have any record in the district. This is less than half that for England and Wales for the same period, viz.: 109 per thousand births.

Causes of Death at all ages.

Between the ages of 1 and 2 years there were 2 deaths; between 2 and 15 there were 3 deaths; between 15 and 25 there were 5; between 25 and 45 there were 11; between 45 and 65 there were 22; and over 65 there were 37. There were 31 deaths in persons 70 years and upwards, and of these 14 were between the ages of 80 and 92. The principal causes of death were: Heart disease, 16; Cancer, 10; Pneumonia, 5; Phthisis and other Tubercular Diseases, 5; Bright's Disease, 4; and Bronchitis, 1.

Zymotic Diseases.

There were no deaths from the Zymotic Diseases; therefore the annual death rate from this cause is 0. zymotic death rate for England and Wales for the same period was 1'20 per thousand of the estimated population.

Cancer.

There were 10 deaths registered as due to Cancer. This is slightly above the average for the district, viz.: 7. These cases occurred in the following parishes:—Pannal, 3; Knaresborough Outer, 3; Ripley, Brearton, Nidd, and Hampsthwaite, 1 each. Seven were males and 3 females,

**Phthisis** Phthisis and other Tubercular Disease caused 5 deaths. and other Tubercular The number of deaths due to this cause in previous years Diseases. was:-1902, 5; 1903, 9; 1904, 11; 1905, 14; 1906, 13;

1907, 14; 1908, 5; 1909, 10; 1910, 8; 1911, 5; 1912, 6. This is the first year during which Tuberculosis of any organ of the body was a notifiable disease. During this period 11 cases were notified.

Diarrhœa caused no deaths during the year. It is an Diarrhœa. exceedingly rare cause of death in the district. Some years ago it was a frequent cause.

The number of Infectious Diseases notified to me Infectious during the year was 31, viz.:—Scarlet Fever, 10; Diphtheria, Notified. 5; Enteric Fever, 3; Erysipelas, 2; and Phthisis and other Tubercular Diseases, 11.

Scarlet Fever occurred in the following parishes:—Searlet Fever. Bilton, 4; Knaresborough Outer, 3; and Pannal, 3. There were five different outbreaks of the disease, all of which were of a mild character. No deaths were due to this disease.

Diphtheria occurred in Pannal (3), Knaresborough **Diphtheria** Outer (1), and Hampsthwaite (1). There were no deaths from this disease.

At Hampsthwaite three cases of Enteric Fever Enteric occurred. The cause was no doubt due to the water supply. The village is supplied by three public and several private wells, all of which are "surface wells." During the year the greater part of the wells were dry, so that the inhabitants to a great extent were dependent on a well in the Village Green. This well and two others were found on analysis unfit for domestic use. Several others shewed that the surrounding soil which has been acting as a filtering medium was beginning to be overtaxed, and consequently the water in these wells was likely to become polluted.

There were no cases of this disease in the district Polioduring the year. Whooping Cough.

There were not many cases of Whooping Cough during the year. The cases were of a mild nature, and caused no deaths.

Measles.

Measles was less prevalent than usual in the district, No deaths were attributed to this cause.

Small Pox.

No case of Small Pox was notified during the year.

Sewage Disposal. There have been no developments as regards Sewage disposal during the year. A scheme has been prepared to drain the Follifoot end of Pannal village, which has for a considerable time been very unsanitary. This will be carried out early during the next year. The extension of the sewers in Pannal and Knaresborough Outer (Forest Moor) has resulted in the re-draining of practically all the old houses within these districts, the numerous cesspools and foul ditches of a few years ago being abolished. Schemes are being prepared for the drainage of Burton Leonard and Hampsthwaite. The villages of Scotton, Ferrensby, Flaxby, and South Stainley are all in need of drainage. At Brearton the drains in the village have been relaid with new pipes. A better method of disposal of the sewage is required.

Water Supply. There is a good supply of water in the whole district, with the exception of the villages of Scotton, Brearton, Hampsthwaite, and Flaxby. A great number of the wells (particularly in Hampsthwaite and Scotton) have been dry during the summer and autumn, and if another dry summer should follow this last one there will be a greater shortage still. I have already dealt with the impure water at Hampsthwaite under the heading of Enteric Fever.

Slaughter Houses. There are 14 Slaughter Houses registered in the district. Three seizures of unsound food were made during the year. Improvements have been made in several of the Slaughter Houses, but some are in an unsatisfactory state.

There are 180 Cowsheds registered in the district. Cowsheds. Several have been newly constructed. Notices have been given for existing defective sheds to be brought up to the Council's requirements before the end of next summer. A much higher standard of cleanliness of the animals, sheds and milking is being secured.

The Council have obtained power to deal with private **Streets**. streets, and intend to make up several of the worst back streets.

There are 14 Schools in the district. There has not **Schools.** been any epidemic of infectious disease to necessitate the closure of any of these during the year.

The scavenging of Pannal has been undertaken by the Seaven-Council. Killinghall and Knaresborough Outer require ging. similar treatment.

Under the Housing (Inspection of District) Regula-Housing. tions 79 houses were inspected. Of these 9 were found not reasonably fit for human habitation. Two houses were represented to the Council as totally unfit for human habitation. Closing orders were made in respect of 3 houses. Three dwelling-houses were closed as unfit for human habitation after closing orders were made. In 59 cases defects were remedied without making of closing orders. At Burton Leonard there is a scarcity of houses.

The number of Factories and Workshops in the Factories and district is 72, viz.: Factories (including Factory Laundries), Workshops 17; Workplaces (including Workshop Laundries), 12; Domestic Workshops, 5; Retail Bakehouses, 2; and other Workshops, 36.

No defect of Sanitation of Workshops as regards Sanitation of cleanliness, air space, ventilation, or drainage of wet Workshops floors was found.

Retail Bak'houses

There are 2 Retail Bakehouses in the district. These comply with the Factories and Workshops Act as regards closets, drains, water cisterns to w.c.'s, sleeping places, and limewashing.

Underground Bak'houses Home

Work.

There are no Underground Bakehouses in the district.

There is no "Home Work" in the district within the meaning of the Factories and Workshops Act.
