For the Year ending Dec. 31st, 1923.

To the Chairman and Councillors of the Knaresborough Urban District Council.

Population.

The population as given by the Registrar General is 8,609. This amount you will notice is less than his estimate for last year or for the census year (1921). I do not think that the population of your district is decreasing, but on the contrary I feel sure we have an increase on previous years. My estimate of the population is 8,920.

Births.

The number of births as furnished by the Registrar General is 129—69 males and 60 females. This gives an annual birth rate of 14.97 per thousand of the estimated population. This is a slight improvement on last year when there were 17 births less. The corresponding birth rate for England and Wales was 19.7. Nine births, 7 males and 3 females were registered as illegitimate. The number in 1922 was 7.

Deaths.

The number of deaths of residents of the district was 95—44 males and 51 females. This is 21 less than in the previous year, and gives a death rate of 11.03 per thousand per annum of the estimated population. The corresponding death rate for England and Wales was 11.6.

Infantile Mortality.

There were 7 deaths of infants under 1 year of age. This is the same as in 1922. Five of these were due to premature birth. One was due to convulsions and one to congenital specific disease. This gives an infantile mortality of 51.8 per thousand births registered. The corresponding rate for England and Wales was 69.

Causes of Death at all Ages.

The principal causes of death were:—Heart Disease, 17; Cancer, 11; Apoplexy, 9; Phthisis and other Tubercular Diseases, 8; Bronchitis, 4; Pneumonia, 3; Diabetes, 3; and Influenza, 2.

Infectious Diseases.

The number of Infectious Diseases notified in 1923 was 34. In the previous year there were 39 eases.

Diphtheria.

There were only 2 cases of Diphtheria notified during the year. There were no deaths from this cause. They were both admitted to hospital.

Scarlet Fever.

Eleven cases of Scarlet Fever were notified. The number treated in hospital was 10. There were no deaths from this cause.

Enteric Fever.

There were no cases of Enteric Fever notified.

Puerpural Fever.

There were no cases of Puerpural Fever notified.

Pneumonia.

There were 8 cases of Pneumonia notified. There were 3 deaths from this cause. Two of these were notified.

Erysipelas.

There were no cases of Erysipelas notified.

Phthisis and other Tuberculous Liseases.

Five cases of Phthisis and 6 of other Tubercular Diseases were notified. The deaths from this cause were 7 of the lungs, and 1 from spine.

Ophthalmia Neonatorum.

There was 1 case of Ophthalmia Neonatorum notified. This case was treated at home, and the vision was unimpaired. There was no death from this cause.

Measles.

Measles was not very prevalent during the year. There were no deaths from it.

Whooping Cough.

Whooping Cough was epidemic nearly all over the district. It was not of a severe type, and there were no deaths from it.

Encephalitis Lethargica.

There was 1 case of Encephalitis Lethargica notified, and it was fatal.

Causes of Sickness.

There was no particular cause of sickness or invalidity of special note during the year.

Summary of Nursing Arrangements, Hospitals, and other Institutions available for the District.

The County Council are the authority under the Notification of Births and Child Welfare Acts for the whole of the District.

For Health Visiting and School Nursing purposes the District is divided into 6 nursing areas, one area being worked by a whole-time Nurse, and the remaining 5 by District Nursing Associations. These latter Associations, in addition to performing Health Visiting and School Nursing Work on behalf of the County Council, undertake Midwifery and District Nursing Work.

MIDWIFERY SECTION.

Midwifery is undertaken by the District Nurses in Hampsthwaite, Farnham, Scotton, Brearton, Ferrensby, Burton Leonard, Pannal, Beckwithshaw, and Killinghall.

No Nurses are employed or subsidised by the Local Authority.

HOSPITALS PROVIDED OR SUBSIDISED BY THE LOCAL AUTHORITY OR COUNTY COUNCIL.

(1) Tuberculosis.

The Local Authority does not provide hospitals for Tuberculosis, but this class of case is admitted to hospitals provided by the County Council, none of which are situated in this district.

(2) Maternity.

There is no Maternity Hospital in the district.

(3) Children.

There is no hospital for the treatment of children in the district.

(4) Fever.

The Harrogate and Knaresborough Joint Isolation Hospital, situated in Knaresborough Outer, provides accommodation for 72 patients.

(5) Small Pox.

The Small Pox Hospital, situated in Killinghall, is provided by the Harrogate and Knaresborough Joint Isolation Committee. It has 16 beds.

(6) Other Hospitals.

There are no other hospitals in the district. The hospitals available for the district are the General and Special Hospitals situated in Harrogate, Leeds, Bradford, and York.

Institutional Provision for Unmarried Mothers and Illegitimate Children.

There are no Institutions within the district for unmarried mothers or illegitimate children.

AMBULANCE FACILITIES.

The Ambulance facilities for (a) infectious cases are provided by the Harrogate and Knaresborough Joint Isolation Hospital Committee; (b) non-infectious cases, an ambulance (unhorsed) can be borrowed from the Knaresborough Union Hospital.

The West Riding County Council carry out Bacteriological examinations at their laboratory at Wakefield. Outfits for specimens are supplied to medical men on application.

use in necessitous cases from the Medical Officer of Health.

Water Supply.

The Parishes provided with a good water supply cover an area equal to two-thirds of the whole area of the district. The remainder of the district gets its supply from wells, mostly surface wells. Three bore holes have been sunk in the village of Scotton. This will remedy the inadequate and impure supply of this village. In Hampsthwaite the wells are liable to pollution from surface water, and in most summers there is a shortage of supply.
