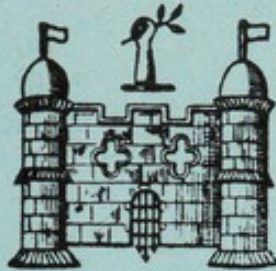

Population.

The population of the district as estimated by the Registrar General is 8,641, or only one more than at the census of 1921. I feel sure this is very much underestimated, and that a much more correct estimate is 9,459.

Births.

The number of births for 1925 was 118—64 males and 54 females. The number for the previous four years was:—1921—148 ; 1922—116 ; 1923—129 ; 1924—119. This gives an annual birth rate of 13·65 per thousand of the estimated population. The corresponding birth rate for England and Wales was 18·3. Eight births—4 males and 4 females—were registered as illegitimate.

Deaths.

The number of deaths of residents of the district was 100—36 males and 64 females. This gives an annual death rate of 11·56 per

thousand of the estimated population. The death rates for the previous four years were:—1921—10·07; 1922—13·35; 1923—11·03; and 1924—13·77. The corresponding death rate for England and Wales was 12·2.

Infantile Mortality.

There were 7 deaths of infants under 1 year of age. Three of these were in illegitimate children. The causes of death were Premature Birth, 4; Whooping Cough, 2; Meningitis, 1; and Convulsions, 1. This gives an infantile mortality of 59·31 per 1,000 births registered. The corresponding rate for England and Wales was 75.

Causes of Death at all Ages.

The principal causes of death were:—Cancer, 16; Tuberculosis of Lungs and other Tuberculous Diseases, 10; Heart Disease, 10; Arterio-sclerosis, 9; Cerebral Hæmorrhage, 7; Pneumonia, 6; Bronchitis, 4; Influenza, 4; Violence, 3; and Suicides, 2.

Infectious Diseases.

The number of Infectious Diseases notified in 1925 was 46. In the previous four years the numbers were:—1921, 56; 1922, 39; 1923, 34; and 1924, 45.

There has not been any notifiable infectious disease specially prevalent during the last five years. Two cases of Encephalitis Lethargica were notified, with one death. The latter, however, turned out to be Tubercular Meningitis. All cases of Pneumonia were not notified.

Pathological and bacteriological specimens are examined at County Hall, Wakefield, and frequent use is made of the facilities there.

No use, so far, has been made of the Schick and Dick tests in Diphtheria and Scarlet Fever respectively.

No vaccinations have been performed by the Medical Officer of Health under the Public Health (Small-pox Preventive) Regulations, 1917.

Influenza of a mild type has occurred during the year, with four deaths.

Cancer caused 16 deaths during the year. This is the highest death rate from this cause during the last 25 years. In the previous four years the numbers were:—1921—9; 1922—7; 1923—8; 1924—8.

Disinfection of infected premises is carried out, and articles exposed to infection are disinfected at the Isolation Hospital.

Causes of Sickness.

There was no particular cause of sickness or invalidity of special note during the year.

Summary of Nursing Arrangements, Hospitals, and other Institutions available for the District.

The County Council are the Authority under the Notification of Births and Child Welfare Acts for the whole of the District.

For Health Visiting and School Nursing purposes the District is divided into 6 nursing areas, one area being worked by a whole-time Nurse, and the remaining 5 by District Nursing Associations. These latter Associations, in addition to performing Health Visiting and School Nursing Work on behalf of the County Council, undertake Midwifery and District Nursing Work.

MIDWIFERY SECTION.

Midwifery is undertaken by the District Nurses in Hampsthwaite, Farnham, Scotton, Brearton, Ferrensby, Burton Leonard, Pannal, Beckwithshaw, and Killinghall.

No Nurses are employed or subsidised by the Local Authority.

HOSPITALS PROVIDED OR SUBSIDISED BY THE LOCAL AUTHORITY OR COUNTY COUNCIL.

(1) *Tuberculosis.*

The Local Authority does not provide hospitals for Tuberculosis, but this class of case is admitted to hospitals provided by the County Council, none of which are situated in this district.

(2) *Maternity.*

There is no Maternity Hospital in the district.

(3) *Children.*

There is no hospital for the treatment of children in the district.

(4) *Fever.*

The Harrogate and Knaresborough Joint Isolation Hospital, situated in Knaresborough Outer, provides accommodation for 72 patients.

(5) *Small Pox.*

The Small Pox Hospital, situated in Killinghall, is provided by the Harrogate and Knaresborough Joint Isolation Committee. It has 16 beds.

(6) *Other Hospitals.*

There are no other hospitals in the district. The hospitals available for the district are the General and Special Hospitals situated in Harrogate, Leeds, Bradford, and York.

INSTITUTIONAL PROVISION FOR UNMARRIED MOTHERS AND ILLEGITIMATE CHILDREN.

There are no Institutions within the district for unmarried mothers or illegitimate children.

AMBULANCE FACILITIES.

The Ambulance facilities for (a) infectious cases are provided by the Harrogate and Knaresborough Joint Isolation Hospital Committee; (b) non-infectious cases, an ambulance is supplied by the Knaresborough Ambulance Committee.

Laboratory Work.

The West Riding County Council carry out Bacteriological examinations at their laboratory at Wakefield. Outfits for specimens are supplied to medical men on application.

Diphtheria Anti-toxin can be obtained by medical practitioners for use in necessitous cases from the Medical Officer of Health.

Sanitary circumstances of the area.

Water Supply,

The district contains 22 parishes, with a total area of 37,362 acres, and a population of 8,640 (census, 1921).

Ten parishes—Bilton, Burton Leonard, Follifoot, Goldsborough, Haverah Park, Killinghall, Knaresborough Outer, Pannal, Scriven, and Starbeck—have public supplies, and the area of these districts contains 21,176 acres and 5,900 population.

Three parishes—Nidd, Plompton, and Ripley—have private supplies, and the area of these districts contains 4,983 acres and 650 population.

Nine parishes depend on wells with an area of 11,203 acres and a population of 1,090.

As regards the sufficiency and quantity of the water supply in these nine parishes, the conditions are as follows :—

- (1) South Stainley.—Village spring ; varies very little.
- (2) Walkingham-Hill-with-Occaney.—Sufficient.
- (3) Farnham.—Sufficient, but very hard.
- (4) Brearton.—Mostly sufficient.
- (5) Flaxby.—Mostly sufficient, but very hard.
- (6) Ferrensby.—Mostly sufficient ; from public well.
- (7) Felliscliffe.—Mostly sufficient.
- (8) Hampsthwaite.—The wells in the village are mostly shallow and liable to pollution. There is a shortage in dry periods.
- (9) Scotton.—Three wells have been sunk by the Council lately which prevents the shortage which used to occur in dry periods.

Rivers and Streams.—The only complaint of pollution of rivers is at Hampsthwaite, where the drainage of the village opens direct into the river. A sewerage scheme is being prepared to remedy this condition.

Drainage and Sewerage.—Sewerage of the following villages is required :—Burton Leonard, Ferrensby, Scotton, South Stainley, Hampsthwaite, and Kettlesing.

Closet Accommodation.—See Table C.

Scavenging.—In Pannal the scavenging is done by contract at a cost of £260. Killinghall, Hampsthwaite, and Knaresborough Outer require scavenging.

Sanitary Inspection of the Area.—See Table C.

Schools.—The sanitary conditions and water supply of the schools in the area is on the whole satisfactory. Several schools were closed during the year owing to outbreaks of measles and whooping cough.
