I have the honour to submit the Annual Report on the Vital Statistics and Sanitary Administration of the Borough for the year ending December 31st, 1937.

SOCIAL CONDITIONS. The Industries are those of a market town serving an extensive Agricultural area, and its prosperity and the conditions of employment chiefly depend on the state of Agriculture. It is, in addition, a residential place and much frequented by visitors on account of its historical interest and the beauty of its surroundings.

The Registrar-General's estimate of the population at the middle of the year was 77 less than last year.

THE BIRTH-RATE (13.09) shows a decline from last year when it was 15.8. The rate for England and Wales for the year was 14.9. Only two births were illegitimate, equal to 2.6 per cent. of the total.

THE DEATH-RATE (14.66). When the factor 0.77 supplied by the Registrar-General is used, the corrected death-rate is 11.2 compared with 12.4 for England and Wales for the year.

The causes of death were: Influenza 5, Tuberculosis of the Respiratory System 4, other Tuberculosis 2, Cancer 12, Diabetes 3, Cerebral Hæmorrhage 11, Heart Disease 10, Bronchitis 6, Pneumonia 3, Appendicitis 1, Digestive Diseases 2, Nephritis 3, Congenital Debility and Premature Birth 3, Senility 2, Suicide 2, other defined diseases 15.

The death-rate for Pulmonary Tuberculosis for the year was 0.69 per thousand of the population and for Cancer 2.09. The former is satisfactory and the latter somewhat high when compared with the Shropshire rates for last year. Influenza was prevalent in the schools and was responsible for five deaths.

INFANTILE MORTALITY RATE (53). It was based on four deaths, three of which were due to Congenital Debility and Premature Birth and one to Pneumonia. It is very similar to last year for the Borough. The rate for England and Wales for the year was 58.

General Provision of Health Services for the Area.

- 1. The only whole time Public Health Officer of the Authority is Mr. W. G. Lane, who has held the offices of Surveyor, Water Engineer and Sanitary Inspector since 1913. A contribution is made to his salary and that of the Medical Officer of Health under the Public Health Acts.
- 2. (a) LABORATORY FACILITIES. The arrangement made by the County Council for the examination of Pathological specimens by the University of Birmingham still continues, and is taken full advantage of by Medical Practitioners in the area.
- (b) AMBULANCE FACILITIES. For Infectious cases the Monkmoor Hospital send their Ambulance for the collecting of cases. The Borough Council disposed of their Ambulance last year and the district is now dependent on the Red Cross Ambulance for accidents and sickness.
- (c) NURSING IN THE HOME. There are a number of Nurses engaged in this work provided by the local Nursing Association, and from personal observations I know the work is efficiently carried out.
- (d) TREATMENT CENTRES AND CLINICS. There is a Treatment Centre every morning for School Children for minor ailments and a Child Welfare Centre once a week which is very well attended and is staffed by the County Council in buildings provided by the County and run by a local Committee.
- (e) HOSPITALS. The Infectious Disease Hospital was closed throughout the year; cases necessitating removal on account of absence of proper isolation at home were sent to Monkmoor. The Cottage Hospital is the only voluntary hospital and is of great assistance to the town. There is a good Hospital at the Workhouse which is generally full up.

Sanitary Circumstances of the Area.

1. WATER. A constant and satisfactory service was maintained throughout the year by drawing on the Birmingham main and mixing it with Burway supply. Regular samples were sent to the County Analyst and the results were very satisfactory.

Six additional houses were connected to the existing mains and a short length of main laid for the purpose.

DRAINAGE AND SEWERAGE. New drains were laid at six premises and six new houses connected to existing sewers. The Sewerage Works have been carefully supervised and the final

effluent, which is run into the Teme, has been uniformly clear. I understand that the tanks are filled by six hours' flow of the sewage and from this it is obvious that they should be considerably enlarged on the ground which is available for this purpose, adjacent to the existing ones.

PUBLIC CLEANSING. The collection of house and trade refuse is promptly and efficiently carried out and deposited on a tip on the outskirts of the town and carefully covered up to prevent any nuisance. The fouling of footpaths by dogs has recently been receiving consideration and the question of bye-laws to relieve the trouble has been explored. There is little doubt that the increasing motor traffic on the roads is largely the cause of the nuisance.

Sanitary Inspection of the Area.

Appended to the Report is an account furnished by the Surveyor of the Sanitary work completed during the year. One hundred and forty-two houses were visited and inspected and two legal and sixty-four informal notices served on owners, and forty-nine of these were complied with, and a considerable amount of valuable sanitary improvements completed.

SHOPS. No action was necessary during the year under the provisions of the Shops Act, 1934, relating to ventilation and temperature of Shops and to sanitary conveniences.

SMOKE ABATEMENT. No complaints were received in respect of nuisance from smoke in the area.

SWIMMING BATHS AND POOLS. There are no public or privately owned Swimming Baths or Pools open to the public in the area. There is a Swimming Pool on the river, but the Council take no responsibility for the condition of the water beyond seeing that there is no pollution of the river in the Borough A Swimming Bath in which school children could be taught to swim, and where the water is purified by filtration, is, I consider, urgently required in the area. It has been under consideration by the Council for some months and a site is being secured.

ERADICATION OF BED BUGS. No action was called for for this purpose either in Council or other houses during the year.

4. SCHOOLS. The sanitary condition and water supply of the Elementary Schools in the area are very satisfactory. Certain improvements were carried out by the Education Authority at Old Street School during the year.

Plans were passed during the year for the erection of seven houses by private enterprise and six were completed. The Council have secured the land necessary for the houses required to abate the overcrowding and have accepted a tender for their erection. When these are completed it will enable a number of owners to make improvements to their houses to conform to the recently adopted Housing Bye-laws. It is proposed to deal with Rock Lane as an Improvement Area; the houses are so badly arranged and a number of them incurably damp.

Inspection and Supervision of Food.

(a) MILK SUPPLY. There are eight Cowsheds, five Dairies and two Milkshops in the Borough, but so far as I can learn no Pasteurised Milk on sale. The bulk of the milk sold in the town is produced in the Rural District. Milk production in the Borough is generally a side line to some other business.

Fifty-eight inspections were made and seven notices were issued for structural improvements and want of cleanliness, and all complied with. At the elementary schools milk is provided for the children throughout the year.

(b) MEAT AND OTHER FOODS. Frequent inspections have been made of the Meat killed in the area or exposed for sale, and it is stated to be uniformly good in quality. Several of the Slaughter Houses are in congested areas, and a Public Abattoir on the outskirts of the district would be convenient and more sanitary.

Prevalence of, and control over, Infectious and other Diseases.

Fifteen cases of Scarlet Fever were notified throughout the year. The first case was infected whilst on holidays and was, for a few days, back at school before it was discovered. Three cases were sent to Monkmoor Hospital because they were either overcrowded or on business premises. No cases of Diphtheria occurred during the year although numerous swabs were taken and sent to Birmingham University for examination.
