Mr. MAYOR, LADY AND GENTLEMEN,

I have the pleasure of submitting the Annual Report on the Vital Statistics and Sanitary Administration of the Borough for the year ending December 31st, 1938.

SOCIAL CONDITIONS. The Industries are those of a market town serving an extensive Agricultural area, and its prosperity and the conditions of employment chiefly depend on the state of Agriculture. It is, in addition, a residential place and much frequented by visitors on account of its historical interest and the beauty of its surroundings.

The Registrar-General's estimate of the population at the middle of the year was 52 less than the previous year.

THE BIRTH-RATE (18.8) is a big advance on the previous year (13.09). The rate for England and Wales for the year was 15.1.

THE DEATH-RATE (12.33), when the factor 0.77 supplied by the Registrar-General is used, the corrected death-rate is 9.49 compared with 11.6 for England and Wales for the year.

The causes of deaths were: Influenza 1, Tuberculosis of the Respiratory System 1; Cancer 15; Diabetes 3; Cerebral Hæmorrhage 5; Heart Disease 9; other Circulatory Diseases 6; Bronchitis 1; Pneumonia 1; Appendicitis 1; Digestive Disease 2; Congenital Debility and Premature Birth 5, Senility 4; Accidents 3; other defined Diseases 12.

The death-rate from Pulmonary Tuberculosis for the year was 0·17 per thousand of the population, and for Cancer 2·64 per thousand. The former is very satisfactory but the latter is high when compared with the rate for Shropshire. I consider it would be very useful if a Lecture were arranged dealing with the subject of Cancer, in the Town Hall, so that people would know that in the early stages Cancer is very curable and that the mortality is frequently due to delayed treatment.

INFANTILE MORTALITY RATE (46) based on five deaths all due to Congenital Debility and Premature Birth. The rate for England and Wales was for the year 53.

General Provision of Health Services for the Area.

- 1. The only whole time Public Health Officer of the Authority is Mr. W. G. Lane, who has held the offices of Surveyor, Water Engineer and Sanitary Inspector since 1913. A contribution is made to his salary and that of the Medical Officer of Health under the Public Health Acts.
- 2. (a) LABORATORY FACILITIES. The arrangement made by the County Council for the examination of specimens by the University of Birmingham still continues and is taken full advantages of by Medical Practitioners in the area.
- (b) AMBULANCE FACILITIES. For Infectious cases the Monkmoor Hospital send their Ambulance and Nurse for collecting the cases. There is a Red Cross Ambulance at a convenient centre in the town for removing accidents and cases of illness to hospital.
- (c) NURSING IN THE HOME. There are a number of Nurses engaged in this work provided by the local Nursing Association, and from personal observation I know the work is efficiently carried out.
- (d) TREATMENT CENTRES AND CLINICS. There is a Treatment Centre every morning for School Children for minor ailments, and a Child Welfare Centre once a week which is very well attended and is staffed by the County Council in buildings provided by the County and run by a local committee.
- (e) HOSPITALS. The Infectious Disease Hospital is still closed and cases necessitating removal are sent to Monkmoor Hospital, Shrewsbury. The Cottage Hospital is the only voluntary hospital and is of great assistance to the town. There is a good Hospital at the Workhouse which is generally full up.

Sanitary Circumstances of the Area.

1. WATER. A constant and satisfactory service was maintained throughout the year by drawing on the Birmingham main and mixing it with the Burway supply. Regular samples were sent to the County Analyst and the results were uniformly satisfactory.

Thirteen additional houses were connected to the existing supply and 533 yards of new main laid for the purpose.

DRAINAGE AND SEWERAGE. Fifteen additional houses were connected with the public sewers during the year and 180 yards of new sewer laid to connect new houses with the sewers.

The Sewerage Works have been carefully supervised and the final effluent, which runs into the Teme, is uniformly clear. The septic tanks are being enlarged so as to hold two days' supply so that the organic matter will be broken up into simpler compounds and enable the filter beds to oxydise them more completely and produce a more stable effluent.

PUBLIC CLEANSING. The collection of house and trade refuse is promptly and efficiently carried out and deposited on a tip on the outskirts of the town and carefully covered up to prevent any nuisance.

The fouling of foot-paths by dogs is still engaging the attention of the Council, but no Byelaws have yet been adopted, and it is doubtful if they could be of much use owing to the narrow foot-paths and the increasing motor traffic.

Sanitary Inspection of the Area.

Appended to the report is an account furnished by the Surveyor of the Sanitary work completed during the year. Ninety-three houses were inspected and thirty-nine notices were sent out and twenty-seven of them were complied with, and a considerable amount of valuable sanitary improvements carried out.

SHOPS. No action was taken during the year under the provisions of the Shops Act, 1936, relating to ventilation, temperature and sanitary conveniences of Shops.

SMOKE ABATEMENT. Three complaints were received and dealt with, two due to laundries and one from a brick works.

SWIMMING BATHS AND POOLS. There are no Public Swimming Baths in the area open to the public. A covered-in Swimming Bath, in which school children could be taught to swim and where the water is purified by filtration is, I consider, very desirable. The site on the old Smithfield is a very suitable one and very convenient for the schools and new housing schemes. Three small baths with hot water laid on are in demand, owing to the number of houses without baths in Ludlow.

ERADICATION OF BED BUGS. No action was necessary during the year either in Council or other houses.

SCHOOLS. The sanitary condition and water supply of the Elementary Schools in the area are very satisfactory. The improvements made at the Old Street School have been completed and are much appreciated. The large class-room was provided with a heating system.

Plans were passed during the year for the erection of thirteen houses by private enterprise, and all were completed.

The Council secured the land necessary for twenty-six houses required to abate overcrowding, and the houses are in the course of erection and some are now nearing completion.

There are still many houses which are to be considered for demolition in the courts off the main streets, but the cost of the houses makes it very difficult to secure an economic rent from the persons displaced. A number of houses in Rock Lane were greatly improved during the year and in many cases the occupiers were got rid of.

Inspection and Supervision of Food.

(a) MILK SUPPLY. There are nine Cowsheds, six Dairies and two Milkshops in the Borough on the register; they were regularly inspected. Structurally they are in good condition and the only notices served were in regard to the cleanliness of sheds and surroundings, and these were all promptly attended to by the tenants.

At all the Elementary Schools milk is provided for the children throughout the year.

(b) MEAT AND OTHER FOODS. Frequent inspections were made of the meat killed in the district or exposed for sale, and it is stated to be uniformly good in quality. Several of the slaughter-houses are in congested areas and a Public Abattoir on the outskirts of the town would be convenient and more sanitary.

Prevalence of, and control over, Infectious and other Diseases.

Twelve cases of Scarlet Fever were notified during the year. There was a small epidemic in the first three months of the year, the majority in young children who were nursed at home. One adult, who was in lodgings was sent home by car.

There were no cases of Diphtheria notified, but the offer of Immunisation should be made and arranged for at the Centre in Dinham. The Rural District has completed the Immunisation of the children in a number of their schools.
