Mr. Mayor, Aldermen and Councillors,

I have the honour to present to you my Annual Report for the year 1963.

Population

The Registrar General's estimate of the mid-year Home Population was 4,000 which was an increase of 560 over that of the previous year.

Live Births and Birth Rate

The number of live births was 75, (39 M. 36 F.) i.e. 23 more than in the previous year, and the crude birth rate was accordingly 18.75; after adjustment by the Registrar General's Comparability Factor which is computed from a population standardised for age and sex distribution, the rate becomes 22.69 and was appreciably higher than that of 18.2 for England and Wales.

Stillbirths and Rate

One stillbirth was registered and the rate was accordingly 13.16, compared with 17.3 for England and Wales.

Infantile Deaths and Mortality Rate

It is noteworthy to record that no infant deaths were registered and the rate was therefore nil.

Maternal Deaths and Mortality Rate

This rate was also nil as there was no maternal deaths which is a reflection of the high standard of modern obstetric practice.

Total Deaths and Death Rate

The total number of deaths from all causes was 31 (22 M. 9 F.) and the crude death rate was accordingly 7.75 which, after adjustment by the Registrar General's Comparability Factor, as for births, becomes 7.21 and was lower than that of 12.2 for England and Wales.

The chief group cause of deaths was those from natural causes amongst the aged, namely Heart and Circulatory Diseases and Vascular lesions of the Nervous System; of those there were 15.

Disease of the Coronary Artery of the Heart was the cause of six deaths in the following age groups; 1 between 45 - 54; 1 between 55 - 64; 3 between 65 - 74; 1 over 75 years.

Cancer was the second highest cause of deaths, as invariably in previous years, of those there were nine deaths; four of those were in the 65 - 74 age group and two were over 75 years. Procrastination by elderly people in seeking medical advice is the most common factor associated with late diagnosis.

Cancer of the Lung caused 3 (male) deaths in the age-groups; 1 between 45 - 54; 1 between 55 - 64; 1 between 65 - 74 years. Male deaths invariably predominate approximately in the ratio of 3 or 4 to 1, and this ratio might be related to the ratio of male to female cigarette smokers.

The other causes of death were miscellaneous and there was no exceptional mortality.

Infectious Diseases

The incidence of notifiable Infectious Diseases was minimal throughout the year. None of the more serious infections occurred as for example, Poliomyelitis, Diphtheria, Typhoid or Enteric Fevers, Meningococcal Meningitis and others.

Measles

Eighteen cases were notified and there were no deaths. The serious complications of former years such as Bronch-pneumonia, Acute Otitis Media and more rarely Acute Encephalitis do not today occur so frequently and when they do, the former two are usually treated successfully with the Sulpha drugs or Antibiotics.

Whooping Cough

Thirty-two cases were notified. How many of those had been vaccinated is uncertain, but generally the vaccination scheme has proved its effectiveness in preventing outbreaks or epidemics.

Puerperal Pyrexia

Two cases were notified but treatment with the Sulpha drugs or Antibiotics is invariably effective in preventing the onset of sepsis.

Tuberculosis

Two new cases of Respiratory Tuberculosis were notified, one in the 15 - 24 age group and the other in the 55 - 64 age-group. The Chest Physician for the area is responsible for investigating any possible source of infection and for the supervision and examination of contacts.

There were no new cases of non-Respiratory or Bovine Tuberculosis, which is an index of the present-day safety of the milk and to a lesser extent the meat supplies.

Also there were no deaths which is a reflection of the efficacy of modern treatment.

were the first instalment of a scheme for providing 180 houses, 95 by this Council and 85 by the New Romney Borough Council, agreed with the Central Electricity Generating Board.

In September 1963 a fixed price tender was accepted for the construction of a further 28 houses for occupation by the Generating Board's Staff. Thirteen of these houses will each have a garage within the curtilage of the dwelling, and the scheme provides for the siting of 15 battery-type garages with a reasonable distance of the houses. By the end of the year arrangements were in hand for the work on this contract to start early in 1964.

In view of the increasing demand for garages by the tenants of Council Houses, 11 battery-type garages were provided at Tournay Road during the year, and a further 14 were under construction by the end of the year.

With regard to the proposed main drainage scheme for the Lydd Town area, approval in principle to the payment of grants under the Rural Water Supplies and Sewerage Acts, 1944 and 1961 was received from the Ministry of Housing and Local Government and the Kent County Council, and in July, 1963, the Council's Consulting Engineers were instructed to proceed with the preparation of the Outline Scheme for submission to the Ministry and the County Council.

During 1963, work on the construction of Dungeness Power Station proceeded in accordance with the scheduled programme. When completed in 1965 this station will have an output of some 500/550 megawatts of electricity. the interchange of electric power between this Country and France via the 400 kV super-grid from Canterbury, the Converter Station near Pigwell, Lydd, and the Cross-Channel Cable, officially inaugurated on a commercial basis in December 1961, continued during the year.

Community life in the Borough is very much in evidence, Local Organisations and Societies cover a wide range of interests and activities, and include Men's and Women's Branches of the British Legion, a Branch of the Royal Naval Association, Benefit Clubs, Women's Institute, Mothers' Union, Women's Voluntary Services, Lydd Traders' Association, a Ratepayers' Association, Parents' and Teachers' Association, the War Memorial Institute Club, Scouts, Guides, Cubs and Brownies, a Folk Dancing Club and the Lydd Seniors' Club for the elderly. The Clubs and Societies combine their efforts in organising the now widely-known 'Lydd Club Day' on the third Saturday in June in each year.

There is virtually no unemployment, and social conditions are generally satisfactory.
