



TO THE CHAIRMAN AND MEMBERS OF THE LYMM URBAN DISTRICT COUNCIL.

Gentlemen,
I beg to submit my Report for 1944 as follows:-
POPULATION.
The Registrar General's figure is 5,986.
Birth Rate per 1,000 of estimated population = 19.7
Still Births-Legitimate = 1
Illegitimate = Nil
There were 8 Illegitimate Births.
Birth Rate for England and Wales = 17.6
Death Rate per 1,000 of estimated population = 11.3

Deaths from Puerperal Fever = Nil
It is noteworthy that of a total of 68 deaths 1 was over 90 years of age,
12 were between 80 and 90 years of age, 22 were between 70 and 80 years of age.
22 were between 70 and 80 years of age.

This gives over 50% of the total number of deaths as having occurred at over 70 years of age.

The diseases responsible for the highest number of deaths were Diseases of the Heart and Circulation 16, Cancer 11 and Intercranial lesions 13.

INFECTIOUS DISEASES.

Cases notified during the year 34. Scarlet Fever 26, Measles 1, Diphtheria 1, Whooping Cough 3, Pneumonia 1, Dysentery 1, Cerebro Spinal Meningitis 1.

Scabies: 84 cases were treated during the year.

Only one case of Diphtheria was notified and Immunisation showed improvement and the Returns to the Ministry up to the end of the year gave percentages as follows:—

Children 1—5 years of age 70% Children over 5 years of age 90%.

These figures are not yet as satisfactory as they should be considering the appeals on the Cinema, by means of Posters and in the Daily Papers, apart from personal contacts through visits, the valuable co-operation of School Teachers and the excellent encouragement at the Welfare Centre.

There has been no epidemic.

TUBERCULOSIS.

No case was notified during the year but 14 specimens of sputum were examined and all found negative.

VACCINATION AGAINST SMALLPOX.

Medical certificates of successful vaccination represented 34.4% of Births registered in Lymm which is poor indeed.

MILK.

Sixteen samples were taken during the year. All milk-producing farms in the District were inspected and improvements suggested and pressed for where necessary, both constructional and in the conduct of the operations involving drainage, white-washing, thorough swilling of shippon floors, &c. Only I sample was found to contain Tubercle Bacilli. This, as usual, was notified to the County Health Authority to be dealt with.

Housing.

During the year numerous visits were paid to defective property. The shortage of labour and material was still very acute, but definite improvement was effected in a fair number of cases. It is now becoming increasingly obvious that some years must elapse before the question of necessary demolition can take place in solving the housing problem. There was also a large influx of evacuees in July which added considerably to an already difficult state of affairs.

- 2.—(a) LABORATORY FACILITIES Manchester University and Warrington P.H. Department.
 - (b) AMBULANCE FACILITIES—Supplied by Altrincham Borough.
 - (c) THE DISTRICT NURSING ASSOCIATION maintains one nurse.
 - (d) ANTE-NATAL—Maternity and Child Welfare, Tuberculosis, School and Venereal Disease Clinics are under the direct control and administration of the County Council.
 - (e) HOSPITAL ACCOMMODATION for Infectious Diseases is provided by Warrington Borough Council by arrangement.
- WATER SUPPLY is from Artesian Wells and is satisfactory in quantity. It is very hard but safe, and this is certified in the Analyst's Report.
 - (b) SEWAGE—Pending the installation of a modern method of Sewage Disposal the system of Land Filtration is still in operation.
 - (c) CLOSET ACCOMMODATION—About 98 per cent. of the houses in the District are provided with water closets.
 - (d) PUBLIC CLEANSING—The collection of domestic waste, trade waste and street sweepings is carried out by direct labour.

SHOPS AND OFFICES.—Regular supervision of shops and offices in the District was maintained but no action taken under the Shops Act, 1934, or the Public Health Act, 1936.

ERADICATION OF BED BUGS.—Two houses were disinfested.

Schools.—The sanitary conditions and water supply of schools are generally satisfactory.

All the milk samples were tested for the addition of extraneous water, colouring matter preservative and fat deficiency, but in only one instance was a sample reported against. This was a sample certified as deficient in non-fatty solids to the extent of 1.2 per cent. and the seller was cautioned.

With this one exception all the samples of food and drugs submitted were found to be of the recognised standard of quality.
