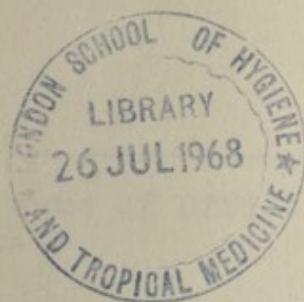

To the Mayor, the Aldermen and the Councillors
of the Borough of Maldon.

Mr. Mayor, Ladies and Gentlemen,

I beg to present my fourth annual report on the sanitary condition of the Port of Maldon covering the year ending 31st December, 1957.

No notifications of infectious diseases were received.

Conditions of boats inspected were found to be satisfactory. The number of inspections made, however, was again inadequate to ensure a reasonable standard of safety.

In June I attended a meeting of the Association of Sea and Air Port Health Authorities at Bristol. The matters under discussion included a survey of recent advances in the analysis of imported foods, from which it was obvious that considerable vigilance will be necessary as the amount of contamination found in some imported foodstuffs suggests that they would be definitely detrimental to health.

The nuisance of excessive noise caused by low flying jet aircraft was also under consideration. This again is a nuisance of which the inhabitants lower down the estuary are well aware.

I am happy to report that progress has been made in ensuring that the oysters produced in the Blackwater will reach the market in a safe condition. The recently opened Public Health Laboratory at Chelmsford, under the direction of Dr. Pilsworth, acting in co-operation with the Ministry of Agriculture, Fisheries and Food, Marine Laboratory, Burnham-on-Crouch, and the Public Health Authorities at West Mersea, have managed to trace what we believe is the main source of infection at the West Mersea Oyster Pits. I am of the opinion that, given, the whole hearted co-operation of those concerned in the industry, it should be possible to ensure a high degree of safety in these pits, and I am hoping that all the necessary steps will be taken voluntarily within the next few months.

Your Port Health Inspector, Mr. Hallett, has not been idle during the year. He has had to deal with a wide variety of problems, including oil pollution, and I am much indebted to him for his industry.
