REPORT.

NATURAL AND SOCIAL CONDITIONS OF THE AREA.

Nantwich, which is an ancient town, is situated in the South-West corner of the County of Cheshire.

The climate is equable and mild, and the geological formation met with consists of red marl.

It is a market town for a large and important agricultural area.

The Brine Baths Hotel is situated on the outskirts of the town, and is visited by a large number of patients suffering from Rheumatism, Gout, Sciatica, Neuritis, etc.

There is a Brine Swimming Pool, 100 feet in length and 50 feet in width. The water is purified and maintained at the highest degree of purity.

The industries consist of Wholesale Clothing Manufactures, Boot and Shoe Manufactures, and a large Tannery.

Estimated population to middle of 1938, 8,345.

Number of inhabited houses (1938), 2,314.

The infantile death rate was 21·27 per 1,000 births.

Disinfection of the rooms is carried out by spraying with Formalin and washing down with a solution of some well-known disinfectant. Bedding and clothing which cannot be boiled are disinfected by means of a Steam Disinfector at the Joint Hospital.

Thirteen cases of Scarlet Fever and 19 of Diphtheria were removed to the Isolation Hospital for treatment. Two cases of Scarlet Fever were treated at home, and recovered.

One Death occurred from Diphtheria at the Isolation Hospital.

DIPHThERIA.

The Council's scheme for the free immunisation against Diphtheria was carried out during February and 540 children between the ages of 1 and 15 years were inoculated.

Nineteen cases of Diphtheria were notified during the year. Five of these cases occurred between April and December, none of whom were inoculated, and one of which proved fatal.

All Tuberculosis deaths have been notified.

During the year all cases of Tuberculosis reported have been frequently visited, sputum cups and disinfectants provided gratis, and leaflets containing information for those suffering from the disease have been distributed.

After death, or removal to Hospital, all bedding, rooms, etc., have been thoroughly disinfected.

PUBLIC HEALTH (PREVENTION OF TUBERCULOSIS) REGULATIONS, 1925—No action taken.

PUBLIC HEALTH ACT, 1925, SECTION 62—No action taken.

NURSING ARRANGEMENTS, HOSPITALS AND OTHER INSTITUTIONS AVAILABLE FOR THE DISTRICT.

The Maternity and Child Welfare Centre in the District is under the County Council, where one Nurse is in attendance.

Two Midwives are practising in the District.

There are two trained Nurses now working in the District, one for District work and the other for Maternity cases. These are supervised by a Committee, and supported by voluntary subscriptions. A small charge is made to those who require the Nurses' services and do not subscribe. Necessitous cases are attended free.

There is a Poor Law Institution and Hospital in the District, also a Cottage Hospital and ambulance facilities.

The Nantwich Joint Isolation Hospital has 41 beds. Three diseases can be concurrently treated. There are also up-to-date Ambulance facilities and Steam Disinfecting Apparatus.

The Smallpox Hospital is situated at Ravensmoor, and is available for both Urban and Rural Districts.

LABORATORY WORK.

Thirty-four specimens of sputum were examined at the County Laboratory.

Diphtheria Antitoxin is supplied by the Council free for necessitous cases.

WATER SUPPLY.

The water supply is satisfactory.

SEWAGE DISPOSAL.

The Sewage Disposal Scheme is working satisfactorily.

HOUSING.

The Council have erected 40 houses during the year to replace houses for demolition and to deal with overcrowding.

The Sanitary Inspector made a re-survey of the District and 57 houses were found to be unfit for human habitation.

These houses I inspected, together with the Inspector, and the position with regard to same at the end of the year will be seen in his report on Housing.

SANITARY INSPECTION OF THE DISTRICT.

The report of the Sanitary Inspector, which is appended, shows in detail the work carried on during the year in the Health Department. It will be seen that a considerable number of inspections have been made.

Visits to work in course of construction and the supervision of work undertaken in the abatement of nuisances have entailed a large amount of work and expenditure of time. This is energy well applied, as it is only by the exercise of close personal supervision that satisfactory results can be obtained.

Particular attention has been paid to the sanitary conditions of premises at which cases of infectious disease occurred, notices being served when required and any defects found remedied.

NOTICES SERVED DURING THE YEAR 1938.

One hundred and eighty-seven Informal Notices were served for the abatement of nuisances, and have been complied with.

One Statutory Notice was served, as follows:—under Section 9 of the Housing Act, 1936; this was complied with.

PAIL CLOSETS.

The scheme for the conversion of pail closets into water closets under Section 47 of the Public Health Act, 1936, has been commenced, and at the end of the year 122 replacements had been carried out.

Forty-six replacements were also carried out voluntarily by the Owners under a guarantee of the Council before the scheme came into operation.

Sixty dilapidated pail closets have been taken down and rebuilt ready for conversion.

DAIRIES AND COWSHEDS.

MILK AND DAIRIES' ORDER, 1926.

There are 14 Cowkeepers in the District. Five are producers of Accredited Milk.

Limewashing has been carried out at least twice during the year.

Four samples of Tuberculin Tested Milk have been taken for examination by the Methylene Blue Test, all of which have satisfied the test.

SCHOOLS.

The Primary School (Juniors' and Infants' Departments) were closed from the 25th November, 1938, to 28th December, 1938, owing to Measles. Disinfecting and cleansing were carried out under supervision.

The following works have been carried out during the year:—

NANTWICH ST. ANNE'S SCHOOL.

New boundary fence erected in girls' playground.

The whole of the playgrounds have been covered with tarmacadam.

NANTWICH COUNCIL (SENIOR) SCHOOL.

Firegrate, No. 6 classroom, repaired.

Steps leading to heating apparatus repaired.

Roof over south-west cloakroom repaired.

MARKET ST. C.E. SCHOOL.

New range of sanitary conveniences erected in Infants' playground.

Additions to heating chamber carried out.

BAKEHOUSES.

There are sixteen retail bakehouses in the District. These have been inspected and found satisfactory, 51 visits having been made.

Notices to limewash have been served in several cases, and have been complied with.

SLAUGHTER-HOUSES, etc.

There are four Registered and four Licensed private Slaughter-houses in the District. Five hundred and fifty-two visits have been made to these premises, which have been kept in a satisfactory state.

Twenty-six Slaughter-men's Licences have been renewed and one new Licence has been granted.

Two pigs which were unfit for human food were voluntarily surrendered.

FOOD SUPPLIES CONTROLLED BY BYE-LAWS AND REGULATIONS.

The premises where food supplies are prepared and exposed for sale are regularly inspected, and no seizure of unsound food has been made during the year.

OFFENSIVE TRADES.

These premises are regularly inspected, are kept in a cleanly state, and no complaints as to nuisances arising therefrom have been received during the year.

The following is a list of the Offensive Trades established within the District, viz:—One large Tannery, a Fellmonger, and one Tripe Boiler.

ERADICATION OF BED BUGS.

No action taken.

COMMON LODGING-HOUSES.

There are three registered Common Lodging-houses in the District.

One hundred and twenty visits have been paid to these premises, which were well conducted and kept in a clean state.

NOTIFICATION OF INFECTIOUS DISEASE AND INFECTION.

All cases of infectious disease notified had immediate attention; precaution papers containing instructions for preventing the spread of the disease were left, also liquid disinfectants for washing and cleansing purposes. After recovery or removal of the patients the infected bedding and clothing were removed to the Isolation Hospital and disinfected by steam. The infected rooms were afterwards sprayed with Formalin and thoroughly cleansed.

Forty-eight rooms were disinfected during the year.

Special attention was paid to the sanitary condition of the premises, and any defects found were immediately remedied.

HOUSING ACT, 1936.

A re-survey of the dwelling houses in the District has been carried out during the year and 57 houses were found to be unfit for human habitation.

Statutory Notices were served under Section 11 of the Housing Act, 1936, and the Owners appeared before the Council

The position at the end of the year with regard to these houses is as follows:—

Forty houses have been erected under the Slum Clearance programme: eighteen with three bedrooms, 20 with four bedrooms, and 2 with five bedrooms.

Ten overcrowded families from Council houses with three bedrooms have been moved to the new houses with four bedrooms, and families displaced from unfit houses have been rehoused in the houses vacated. In this way it has been possible to rehouse 34 families from unfit houses and to deal with 19 of the more serious cases of overcrowding in the District.

Of the 97 houses which were scheduled for demolition 41 have been demolished; 44 of the remaining houses are now vacant and it is hoped to continue with the demolition of these houses early in 1939.

The position in relation to the 29 houses where an undertaking was given not to use for human habitation is as follows:—
