### MEDICAL OFFICER'S ANNUAL REPORT,

For the Year ended December 31st, 1904.

To the Chairman and Councillors of the Knaresborough Rural
District Council.

GENTLEMEN,-

I have pleasure in laying before you my Sixth Annual Report as Medical Officer of Health for the Knaresborough Rural District, for the year ended December 31st, 1904.

Since my last report the district has been altered by the extension of the boundary of the Knaresborough Urban District, incorporating portions of Scriven and Knaresborough Outer. The statistics in Table I. herewith appended for the years 1894 to 1903 (inclusive), are for the district as it existed in those years. They are not of much use for comparison with those for the present year, but are given at the request of the Local Government Board.

The estimated population of the District up to the middle Population. of the year 1904, is 8,130. There has been an increase on last year of about 450, but 420 have been transferred to the Urban District of Knaresborough.

Births.

The number of births registered in the district during the year was 204, viz., 98 males and 106 females. The annual birth rate is 25·1 per thousand of the estimated population of the district. Although this is a slight improvement on the year 1903, still it is rather low. The birth rate for England and Wales was 27·9 per thousand, and this is the lowest on record.

Deaths.

The number of deaths registered in the district in 1904 was 105. This gives an annual death rate of 12.9 per thousand of the estimated population. Although this rate is somewhat higher than last year, still it is highly satisfactory as compared with that for England and Wales for the same period, which was 16.2 per thousand.

The deaths in children under one year of age were only 13 in number; of these 7 were from premature birth, so that only 6 were due to actual disease. The infantile mortality for the year was 63.7 per thousand births registered. This is very low compared with that for England and Wales for the same time, which was 146 per thousand births.

Between the ages of 1 and 25 the number of deaths was 26; between 25 and 65 the number was 34; and in persons over 65 years of age there were 42 deaths.

Causes of Death. The principal causes of death were Heart Diseases, 18; Phthisis and other Tubercular Diseases, 11; Cancer, Bronchitis, Pneumonia, 6 each; Scarlet Fever and Diphtheria, 2 each; Whooping Cough, Enteric Fever, and Diarrhœa, 1 each.

Zymotic Diseases caused 5 deaths. This gives a Zymotic death rate of 0.61 per thousand per annum. The Zymotic death rate for England and Wales for the same period was 1.94 per thousand.

Heart Disease. The number of deaths from Heart Diseases, viz., 18, is unusually large for the district. They were however principally in persons over 70 years of age, so that the disease does not seem to have shortened these lives very much, if at all.

Only one death from Diarrhea occurred during the year. Diarrhea. This was in a child under one year of age. The deaths in infants from this cause have been very few during the last three years. It is to be hoped that this low death rate may continue. This, however, is not to be expected, as, with a hot and dry summer, the death rate from this cause soon mounts up. This is largely owing to the improper and careless feeding of infants, particularly bottle fed children. As a preventative measure, I have thought for some time that at the registration of each birth a leaflet should be presented to the parent, giving a few general directions as to the feeding and care of an infant. If this suggestion should meet with your approval, I shall be pleased to draw up such a leaflet for distribution by the registrars of births in your district.

Phthisis and other Tubercular Diseases caused 11 deaths. Phthisis This is an increase on the two previous years, the numbers being and other Tubercular 1902, 5; and 1903, 9. The increase is in tubercular diseases of Diseases. other organs of the body other than tubercular disease of the lungs.

The number of deaths from Cancer was 6. This is about Cancer. the average number of deaths from this cause annually in the district.

There were 58 cases of Infectious Diseases notified during Diseases the year as compared with 36 last year. These were Scarlet Notified. Fever, 41; Diphtheria, 7; Enteric Fever, 7; Small Pox, 1; Erysipelas, 1; and Continued Fever, 1.

Scarlet Fever was very prevalent in portions of the district Scarlet during the year. It was, however, in those parishes bordering Fever. on neighbouring districts in which the disease was epidemic that it principally occurred. Many cases appeared to be due to infection from patients returned from the infectious hospital. There has been such demand on the limited accommodation at the temporary Isolation Hospital, that patients may possibly, in a few cases (in order to provide for patients in a more serious condition), have been allowed to return home sooner than they otherwise would have done had there been plenty of beds for Scarlet Fever patients. This defect will be remedied by the

opening during the year 1905 of the New Isolation Hospital. Two deaths were due to it. Bilton, Pannal, Nidd, and Brearton, suffered most from the disease. The number of patients treated in hospital was 17.

Diphtheria.

There were 7 cases of Diphtheria in the district, two of which proved fatal.

Enteric Fever. The cases of Enteric Fever, 7 in number, were of a mild nature, 1, however, proved fatal.

Whooping Cough.

Whooping Cough was not prevalent during the year. An outbreak occurred at Hampsthwaite, where the school had to be closed for a short time. One death occurred from it.

Measles.

Several slight outbreaks of measles occurred during the year, but were of a mild nature. No deaths were due to it.

Small Pox.

One case of Small Pox occurred in the district. This was, however, in an official of the Joint Isolation Hospital employed in removing patients to the hospital.

Sewerage and Drainage. There has been no sewerage works during the year in your district, except a short length of about 200 yards of sewer at Burton Leonard. A scheme for draining Forest Moor has been submitted to the Local Government Board. Another scheme for Pannal will, I hope, be undertaken during the year. Follifoot and Scotton are much in need of drainage.

Water Supply. The district is gradually getting well supplied with pure water. The windmills at Burton Leonard, Killinghall, and Follifoot, are working satisfactorily. The latter has given some trouble, but I expect this will soon be rectified. The water supplied by these mills is of the very best quality, and ought to be a great boon to the respective parishes. The water supply to Plompton Square and several of the farms in that neighbourhood is abominable. The water from the well supplying the former place resembles the surface water from roads. The wells supplying the farms are polluted by drainage and are quite unfit for use for domestic purposes. Your Council have been promised a suitable supply for several years, but it is not yet forthcoming. I believe, however, that this matter is likely to be remedied in the near future.

The water supply to Kettlesing, in the Parish of Felliscliff, requires some slight alterations. The spring is of good quality, but the interception in the pipe track of a cattle trough for each field through which it runs, is, to say the least of it, very objectionable.

There are 9 Slaughter Houses registered in the district, all Slaughter of which are in a satisfactory condition. The provision of two Houses. or three public slaughter houses for the district would give easier and consequently much better supervision.

There are 97 Cowsheds registered in the district, these are Cowsheds. in a satisfactory condition.

The number of Factories and Workshops in the district is Factories 59, viz., Domestic Workshops, 2; Retail Bakehouses, 7; and Workshops. Laundries, 3; and other workshops, 47. There are 10 work places.

No defects in the sanitation of workshops have been found, Sanitation of and consequently no action has had to be taken in this direction. Workshops.

The 7 Bakehouses in the district are in a satisfactory con-Sanitation of dition, and comply with the act in every respect.

There are no underground Bakehouses in the district.
