AS LOS TRANSPORTERS OF THE PARTY OF THE PART

Gentlemen,

I have the honour to present my Annual Report for 1957, with the Annual Report of the Surveyor and Chief Public Health Inspector.

The general health of the district has been exceedingly good.

There has been an increase of 3.1 per 1,000 population in the birth rate, and again a decrease of 1.6 per 1,000 in the death rate.

Apart from measles, infectious diseases notified during the year were few. 4 cases of acute poliomyelitis were reported, 1 new case only of tuberculosis, and again no cases of diptheria.

No epidemic of food poisoning occured. I child was reported as being positive to the food poisoning germ of salmonella, and was given the appropriate treatment in hospital.

No action was necessary under the National Assistance Act.

10 houses and 10 old persons bungalows were completed during the year and plans for 46 dwellings to be built by private enterprise were passed by the Council.

Progress has been made with slum clearance by Closing and Demolition Orders.

The work was commenced on the main drainage system of Castor and Ailsworth and Ministry approved the sewerage scheme for the parishes of Glinton, Helpston, Peakirk and Etton. When these two schemes have been completed a very long outstanding need will have been met.

SECTION F. PREVALENCE OF AND CONTROL OVER INFECTIOUS AND OTHER DISEASES.

Food Poisoning.

One child of 19 months was reported as having Salmonella Enteritis. Treatment was given in the Peterborough Isolation Hospital, and the child returned home under the supervision of the County Health Visitor Service.

Health Education.

Model Byelaws of the Ministry of Food are in use in the District. Health Education leaflets are obtained from the County Offices, Bridge Street, Peterborough.

National Assistance Act.

One case only was notified for consideration under the National Assistance Act, an old person with no known relatives. Although her living conditions were far from good, she absolutely refused to accept Part 111 Accommodation, and as her own doctor could not certify that her health was suffering from her home conditions, no action was taken. The case is under supervision by the Health Visitor Service.

Slaughterhouses

There are three licenced private slaughterhouses in the district all attached to butchers shops. These have again been well maintained and kept clean during the year and the licences were renewed for a further 13 months.

Meat Inspection

Fatstock Guarantse Scheme Deadweight Certification of Pigs.

On behalf of the Ministry of Agriculture, Fisheries and Food, a total of 47 pigs were checkweighed at the two approved centres and certificates issued for guarantee payments. This scheme was discontinued in this district by the Ministry in October because of insufficient number of pigs being presented for certification.

The cost of the work carried out to business premises and private houses was charged to the owners. Most owners and occupiers of premises found infested, preferred to deal with them themselves.

Refuse Collection

The collection of house refuse in the district is carried out fortnightly, apart from a few isolated houses where collections are made only upon request.

The work is carried out by Contract and very few complaints have been received.

Night Soil Collection

The collection of night-soil is also carried out by Contract and only isolated complaints have been received.

Plans

The number of plans submitted for approval under Building Byelaws was 93 as against 91 in 1956.

Private Enterprise Housing.

41 plans in connection with 46 dwellings were submitted for approval during the year. These were distributed as follows:-

Ailsworth 3, Castor 3, Deeping Gate 2, Etton 1, Eye 5, Glinton 6, Helpston 3, Marholm 9, Maxey 2, Newborough 6, Northborough 7, Of these, 8 at Marholm were refused by the County Planning Committee.

The number of houses completed during the year was 40 as against 23 in 1956 and they were distributed as follows:-

Castor 5, Deeping Gate 2, Eye 3, Glinton 6, Helpston 1, Marholm 1, Maxey 1, Newborough 2, Northborough 19.

This brings the total number of houses erected by private enterprise since 1945 to 226.

31 dwellings were in the course of erection at the end of the year in the following parishes:-

Ailsworth 1, Castor 1, Deeping Gate 2, Eye 4, Glinton 6, Helpston 2, Marholm 1, Maxey 1, Newborough 4, Northborough 9.

Housing Act, 1949 - Improvement Grants.

Improvement Grants in respect of 16 houses were approved during the year as against 23 in 1956. The total amount of grants made was £4,315. (an average of £257 per dwelling).

11 grants were in respect of tenanted properties and 5 were for Owner/Occupiers; work has been completed at 2 of the properties and is in progress at 8 others.

Council Housing Schemes

10 houses and 10 bungalows, all in the parish of Eye were completed during the year. There were no dwellings in the course of erection at the end of the year.

Council Houses

(a) Maintenance

External decoration to 113 pre-war council houses was nearing completion at the end of the year.

(b) Improvement Work.

The installation of hot water systems in the remaining pre-war houses was nearing completion at the end of the year. There still remains to be done works of improvement to the houses erected in 1914, situate in Back Lane and Eyebury Road, Eye.

Drainage and Sewerage Disposal

I am pleased to report that substantial progress has been made in connection with schemes of sewerage and sewage disposal for the district. A start was made in September on the scheme for the parishes of Castor and Ailaworth. Difficulties were experienced initially with sub-soil water in Castor but fair progress is now being made

Ministry approval has been given to the sewerage scheme for the parishes of Glinton, Helpston, Peakirk and Etton.

The difficulties experienced in connection with the Eye Green Pumping Station and sewers were overcome by the installation of more powerful motors at the Pumping Station.

As soon as a start is made on the Glinton Sewerage Scheme, it is hoped that permission may be obtained to proceed with the scheme for Maxey, Northborough and Deeping Gato. There would then remain only the smaller villages of Marholm, Sutton and Upton and the more densely populated portion of Newborough to be dealt with. Nuisance arising from the discharge of drains etc., from houses and farm premises in the various villages into dykes and water courses, have been reduced as far as possible by regular flushing and cleansing of the dykes and water courses.

Water Supply

The total quantity of water purchased in bulk from the City of Peterborough has been 61,813,000 gallons as against 62,465,000 gallons, a decrease of 652,000 gallons.

This decrease may be attributed to the rather wet summer and a decrease in the number of fractures in mains.

32 new services were connected to the mains during the year, 29 to new dwellings, 1 for agricultural purposes, 1 for the new cemetery at Glinton and 1 for the Crematorium at Marholm.

Petroleum (Rogulations (Act.

51 Licences were issued during the year to store petroleum spirit for private useage and for sale. The total amount of fees collected in respect of the licences issued amounted to £30. 5. Od.

Having spent two-thirds of my life in the service of the Council it is with deep regret I present this, my last Annual Report.
