

#### MEDICAL OFFICER'S REPORT.

The area of the district is 2,410 acres, it is divided into five wards, viz.: Poulton North, Poulton East, Poulton West, Hardhorn and Carleton. It is bounded on the North side by the Urban District of Thornton-Cleveleys, on the East and South by the Parishes of Singleton and Hardhorn-with-Newton, and on the West by the County Borough of Blackpool.

The district is mainly residential, and most of the industrial population is employed by agriculture, the Imperial Chemical Industries, the British Railways and the Building Trades.

The area is supplied with good and wholesome water by the Fylde Water Board. The whole of the area is sewered on the partially separate system; and is carried by gravitation to storage tanks situate on Skippool Marsh, and discharged into the River Wyre Estuary on the ebb tide.

#### Births.

Births: Boys 37; Girls 43; Total 82.

The number of births registered in the district was 82, giving a birth rate of 10.8 per thousand of the population as against 15.4 per thousand for the previous year.

There were four illegitimate births, and four still births registered.

## Infantile Mortality.

Three deaths under one year have been recorded during the year—giving a rate of 37 per thousand live births as against 42 for the previous year.

The rate for England and Wales during the year was 32.

#### Deaths.

Males 60. Females 38. Total 98.

The number of deaths in the district was 98 after deducting deaths of persons not resident in the district, and adding deaths of residents which occurred in other districts.

This gives a crude death rate of 12.9 per thousand, compared with 14.2 in the previous year.

#### Tuberculosis:

The number of new cases notified during the year was eight. Six of which were respiratory and two non-respiratory. Six deaths from Tuberculosis were recorded, four respiratory and two non-respiratory.

The notification of tuberculosis is satisfactory.

## Cancer (Malignant Disease).

There were seventeen deaths from Cancer during the year, giving a rate of 2.23 per thousand as against 2.35 for the previous year.

## Diphtheria.

No cases of Diphtheria were notified during the year.

Supplies of Diphtheria Anti-Toxin are now obtainable by Medical Practitioners from Victoria Hospital, Blackpool.

#### Scarlet Fever.

During the year fifteen cases of Scarlet Fever have been notified. No inoculation has been effected with regard to Scarlet Fever. The incidence of the cases was sporadic.

#### Influenza.

With the exception of sporadic cases of Influenza, the district has been comparatively free during the year.

#### Infectious Diseases.

152 cases of infectious diseases were notified during the year.

#### Measles.

There were one hundred and fourteen cases of measles notified during the year. None of the cases proved fatal.

## Bacteriological Examination.

Facilities for the examination of material for suspected cases of Diphtheria, Typhoid Fever, Tuberculosis, etc., are available for all medical practitioners.

## Home Nursing and Midwifery Service.

General Nursing cases and confinements are attended by District Nurses and Midwives of the Lancashire County Council.

#### Clinic and Treatment Centres.

There are no clinic or treatment centres under the direct control of the local authority.

A school clinic and Child Welfare Centre are held in the morning and afternoon respectively every Tuesday in the Church Hall, Vicarage Road, by the School and Child Welfare Departments of the Lancashire County Council.

A campaign against Venereal Disease is carried out by the County Council in co-operation with the local authority The centres for the treatment of these cases are at Victoria Hospital Blackpool, and the Royal Infirmary, Preston.

## Hospitals.

There is no hospital situated within the district. For general cases the main hospitals used are the Blackpool Victoria and Wesham Park Hospitals of the Blackpool and Fylde Hospital Management Committee and the Preston Royal Infirmary of the Preston and Chorley Hospital Management Committee.

Infectious diseases cases are admitted to Moss Side Hospital, near Lytham, or the Devonshire Road Hospital, Blackpool, excepting cases of tuberculosis and smallpox. Main provision for tuberculosis is at Elswick Sanatorium. Accommodation for smallpox is provided by the Manchester Regional Hospital Board at the Ainsworth Smallpox Hospital, Near Bury.

#### Ambulance Facilities.

The ambulance service is now administered by the Lancashire County Council. The nearest Ambulance Station to the Poulton District is situated at Thornton and in general ambulances are obtained from this station.

## Milk Supply.

There are 39 cow-keepers registered and 10 dairy-men. During the year 25 samples of milk were subject to analysis under the Food and Drugs Act. The results of analysis were all reported as satisfactory with the exception of one sample which proved to be 10% deficient in Fat content.

## Housing Conditions.

## 1. General Observations as to Housing conditions.

Housing conditions in the district are good. 90 per cent of the houses are modern and the older property in the centre of the town is kept in a fair state of repair by the owners.

There are no back-to-back or back-to-earth houses in the District.

## 2. Sufficiency of Supply of Houses.

(a) Extent of Shortage.

There is a definite shortage of houses in the area. 300 applications for municipal houses are already filed.

(b) Particulars of any Housing Scheme.

The Council have let contracts for 109 houses on Lower Green Estate of which 97 were completed at the end of 1949.

It is proposed to compulsorily purchase 17.225 acres of land on the south side of Garstang Road East on which approximately 170 houses, shops and flats will be built, the work commencing in 1950.

In addition it is proposed to purchase 0.75 acres of land in Stanley Avenue on which 8 flats and one pair of houses will be built, and 0.147 acres of land purchased in Princess Avenue on which a block of three houses will be built.

(c) Information as to any important changes in population.

## Summary of Report.

The birth rate shows a decrease on last year.

The crude death rate is lower than in 1948 and than the average for the past five years.

The mortality for Cancer shows a decrease; and that of Tuberculosis shows an increase on the figure for 1948.

The maternal mortality is Nil and the infant mortality is lower.

The general incidence of infectious diseases was low with the exception of measles and scarlet fever.

#### Sewerage.

Regular cleansing and rodding of the sewers have been carried out. The Disposal works consist of Ferro-Concrete tanks with a capacity of six times the dry weather flow of the district served by the sewers. Before the sewage enters these tanks it passes through a screening chamber. The outfall consists of a 27 inch diameter cast iron main fitted with the necessary valves and tidal flap and the sewage is discharged into the River Wyre Estuary on the ebb tide. These works have been satisfactorily maintained during the year and there have been no complaints.

## Scavenging.

The scavenging of the district has been done regularly. The refuse is collected in a covered motor lorry and is conveyed away from the town to Skippool Marsh, where the resultant tip is under control.
