ANNUAL REPORT OF THE MEDICAL OFFICER OF HEALTH FOR THE YEAR 1939.

^{*} This figure to render it comparable with the death rate for the country as a whole, has to be multiplied by the Areal Comparability Factor 0.89 which has been supplied by the Registrar General as requisite to redress the abnormal constitution of the local population from the point of view of sex and age components. Applying this factor, the corrected death rate is 12.6 as compared with 12.1 for the country as a whole.

SECTION B. - GENERAL PROVISION OF HEALTH SERVICES FOR THE AREA.

In respect of (a) Laboratory Facilities, (b) Ambulance Facilities, (c) Nursing in the Home, (d) Treatment Centres and Clinics and (e) Hospitals, there are no essential changes to note.

SECTION C - SANITARY CIRCUMSTANCES OF THE AREA.

Water Supply. The number of houses connected with the public supply at the end of the year was 2,712, an increase of 151 as compared with the number connected at the end of 1938

Closet Accommodation. Of the 128 new houses erected during the year, 120 were connected to the sewer.

48 existing houses were converted from a conservancy system of drainage and were connected to the sever.

· Public Cleansing. The usual work was undertaken and refuse is collected once weekly except from the Rawreth area, where a once fortnightly collection is in operation.

The Council is considering the introduction of a salvage scheme.

Night Soil. Night soil is collected from 66 houses in the district; 42 by the Council and 24 by a contractor.

Visits and Inspections. During the year 989 inspections and visits were made in the detection and abatement of nuisances, repair and improvement of houses, the abatement of overcrowding and the administration of the Factories Acts, Food and Drugs Act, Milk and Dairies Acts and Orders, and enquiries into cases of infectious diseases.

Factories Act, 1937. 16 inspections were made of factories and only on one occasion were conditions found not to be satisfactory. This was remedied by the provision of an additional W. C.

Petroleum (Consolidation) Act, 1928. 17 licences were issued to store petroleum within the district. 20 visits were made to premises licensed for the storage of petroleum.

In other branches of sanitary administration, the usual routine work was carried out without any essential changes.

SECTION D - HOUSING.

Activities in connection with housing were largely curtailed by the outbreak of hostilities.

During the year two houses were demolished as the result of Demolition Orders, and 25 houses were inspected and recorded under the Housing Consolidated Regulations.

SECTION E - INSPECTION AND SUPERVISION OF FOOD.

Milk Supply. 30 persons and promises were registered by the Council at 31st December, 1939.

10 visits were paid to producers premises and to dairies during the year.

4 samples of milk were taken and submitted to bacteriological examination during the year, 3 being of ordinary and one of graded milk. With the exception of one ungraded milk, all were reported as being of a satisfactory standard of cleanliness. In addition to the above samples, 25 damples of milk were taken at Accredited farms in the district by the Essex County Council and of these 6 were reported as unsatisfactory.

20 samples of milk from producers premises in the district were taken by the Essex County Council for Diological examination and all were

reported as not containing tubercle bacilli.

Hilk (Special Designations) Order, 1936. 8 licences were issued by the Essex County Council and the district council for the production and distribution of graded milks.

Ice Cream. 15 persons and promises were registered for the manufacture or sale of ice cream on 31st December, 1939.

Most and Other Foods. There is one registered slaughterhouse in the District and 130 visits both for ante-morten and post-morten inspection were paid during the year. Approximately 1267 lbs. of unsound food were surrendered.

Food and Drugs (Adulteration) Act, 1928. Food and Drugs Act, 1938. The usual sampling was carried cut by the Essex County Council who are the Food and Drugs Authority for the area. 29 samples were taken and all samples except two were found to be genuine.

SECTION F - PREVALENCE OF, AND CONTROL OVER, INFECTIOUS AND OTHER DISPUSES.

In respect of the prevalence of infectious diseases, there are no matters of outstanding importance to report.

Tuberculosis. During the year, a total of thirteen cases of tuberculosis were notified, twelve of which were respiratory and one non-respiratory. Of the respiratory cases, nine were males and three were females and the one non-respiratory case was a male.

It is regretted that during the year four male and one female cases of respiratory tuberculosis died and there was also one male non-respiratory death.

AIR RAID PRECAUTIONS ACT, 1937.

Hedvy responsibilities have devolved upon this Department in respect of the Emergency Medical Services (Casu lty Services).

In this District, one First Aid Post, one Mobile First Aid Unit and one First Aid Point have been established, equipped and staffed as here-under:-

First Aid Post, Eastwood Road, Rayleigh. Medical Officer in charge,

First Aid Point - Rawreth Rectory.

A Nurse in Charge has also been allocated to the First Aid Post and Mobile Unit by the Civil Nursing Reserve.
