To the Chairman (Alderman S. A. Sadler, J.P.) and Members of the River Tees Port Health Authority.

GENTLEMEN,

I have pleasure in submitting the FIFTY-THIRD ANNUAL REPORT on the work of the River Tecs Port Health Authority for the year ended December 31st, 1939.

The Ministry of Health Circular 1937 indicates that having regard to the desirability of reducing the number of records to be kept and to avoid, as far as possible, the disclosure of information relating to the movements of ships, it is desired that some modification of Annual Reports should be made during the period of the Emergency. Furthermore it is indicated that the Report should not be published. In accordance with these instructions this Report has been modified considerably as compared with the previous one.





FOOD INSPECTION.

Consignments of foodstuffs have been systematically examined during the year.

The following foodstuffs were found to be unsound and unfit for food and were destroyed:-

2 tons 15 cwt. oranges.

7 tons 1 cwt. parsnips.

1 barrel strawberry pulp.

15 cwt. onions.

The following samples of foodstuffs were obtained for examination:-

Feb. 15th 1 tin pineapple. Result of analysis showed that tin was present to the extent of .56 grains per 1b.

April 18th 1 tin Condensed Machine Skimmed Milk.

The bacteriological report was satisfactory.

May 25th Sample of periwinkles taken from Seal Sands, River Tees estuary. The bacteriological report stated that the shellfish were in a dirty condition but that no pathogenic organisms were found.

Nov. 8th

2 samples of strawberry pulp.

Preservatives found were 1152 parts per million and 1454 parts per million respectively. These were well within the prescribed limits.

Dec. 15th Sample of Condensed Machine Skimmed Milk.

The result of the bacteriological examination showed that no pathogenic or other micro-organisms were present.

The Annual Meeting of the Association of the Port Health Authorities of the British Isles, was held at Middlesbrough in June, 1939 under the Presidency of Alderman S. A. Sadler, J.P., Chairman of the Tees Port Health Authority. An official velcome was given to the delegates by the Mayor, (Councillor W. Egerton Price, J.P.). The President gave his presidential address which was followed by the business session of the Association.

The delegates then boarded the Steam Tug "Sir Hugh Bell" on the invitation of the Tees Conservancy Commission and proceeded on an inspection of the River Tees.

The delegates disembarked at the 5th Buoy Light where they were entertained to luncheon by the Tees Conservancy Commission under the Chairmanship of Sir Francis Samuelson, Bart., the Chairman of the Cormission.

The delegates and their ladies were entertained to Dinner on the invitation of the Worshipful the Mayor and the Corporation of Middlesbrough at the Town Hall.

On the second day, a paper on "The River Tees" was given by Dr. C. Metcalfe Brown, and a paper on "The Food and Drugs Act, 1938", by Dr. M. T. Morgan.

The neeting ended with a Garden Party when the delegates and their ladies were entertained at Sadberge Hall, by Alderman S. A. Sadler, J.P. and Mrs Sadler.

Subsequently many letters of thanks have been received in Middlesbrough from the delegates of the meeting which have demonstrated that the meeting was regarded as being successful in every way.

I again wish to express my grateful thanks to the Chairman, Members and Staff of the Port Health Authority for their guidance and assistance during the year.
