It will be seen that there was no death from preventable disease as we know it today, and only one infantile death. This, of course, gave a very satisfactory infantile death rate. The birth rate is still below that of the country generally, and it is interesting that there was no male death from malignant disease. Royston has come through the war years with a good health record.

Water Supply.

The whole of the district is supplied with water from the chalk by the Royston Water Company, by a piped supply of excellent quality.

No shortage was experienced during the year.

Conclusion.

The water is in a satisfactory chemical, physical and bacteriological condition and is suitable for drinking purposes.

Section B.

General Provision of Health Services.

Public Health Officials:

(a) Medical.

The Medical Officer of Health is a part-time officer holding a Diploma of Public Health.

(b) Sanitary.

The Sanitary Inspector holds a Certificate of the Royal Sanitary Institute as a Sanitary Inspector and also as an Inspector of Meat and Foods.

He also holds the appointment of Surveyor to the Council.

(c) Clerical.

One male clerk.

Sewerage and Drainage.

2 new houses built by private enterprise were connected to the sewerage system during the year.

l new house was drained to a cesspool temporarily awaiting a short sewer extension before connection thereto.

Sewage Disposal.

The Sewage Farm, situated near the north eastern boundary of the Urban District, covers 164 acres of land, and the method of disposal of sewage is by a system of broad irrigation.

Approximately 32 acres of the land are planted with soft fruit trees, and during the war, a local farmer was allowed to crop the remainder of the land in the interests of food production.

A STATE OF THE PARTY OF THE PAR

A very considerable increase in the quantity of sewage has taken place since the Sewage Farm was laid out in 1903, and considerable difficulty has arisen in late years in disposing of the sewage over the land so as not to cause water logging and sickness and to ensure proper filtration. This difficulty is particularly soute on the portion of land available for the disposal of sewage from the north west portion of the town including the P. O. W. Camp, in which area the Council's Housing Estate will eventually result in a further 84 houses being connected to the sewer, thus further increasing the difficulties of satisfactory disposal.

Refuse Removal & Disposal.

Increasing difficulties were met in maintaining a weekly collection of house and trade refuse, arising from the slow and inadequate system in operation, which is nowadays incapable of efficiently carrying out the job.

The vehicle used for refuse collection is a horse drawn cart with wooden body fitted with sliding covers and mounted on pneumatic tyred wheels, which replaced the original wooden wheels in 1936. This cart was purchased in 1912 and has been in continual use ever since. It is now nearly worn out and quite inadequate for present day requirements.

The rising costs of horse hire, and labour difficulties, during 1945, caused anxiety.

The cost of refuse collection rose to 14/8d. per ton, a considerable increase on previous years, and one which needs to be appreciably lowered by the adoption of up to date methods of collection.

The Council have given careful consideration to this matter, and have come to the decision that the work can be more economically and efficiently carried out by direct labour with a motor vehicle.

At the end of the year it had been decided to examine various types of vehicles with the object of obtaining the one most suitable for legal conditions.

Disposal of refuse is carried out by tipping at the Sewage Farm Tip at Coombes Hole and every effort has been made this year to bring the tip into a cleaner and more sanitary condition following the neglect which occurred during the war years due to the acute shortage of labour. Unfortunately the labour situation did not allow of all the work contemplated being carried out, and we are still faced with the disposal of the large accumulation of tims left at the end of the war. The flattening and spreading of those tims so that the same can be covered over without danger of forming a harbourage for rats must be undertaken at the first opportunity. General straightening and cleaning up of the tip has been done along with the formation of a firm approach road and the making and keeping of a clean tip face.

Disposal costs for the year work out at 1/82d. per ton of refuse.

Rat infestation on the tip and also on the Sewage Farm has been kept down by regular baiting and poisoning carried out by the Rodent Control staff of the Herts. War Agricultural Committee and the County Council under contract with the District Council. Though we cannot claim the area is entirely free from rata, there is no doubt the breeding of these rodents has been severely restricted and their numbers kept low.

SALVAGE.

The collection of waste paper and rags was continued during the year from dwelling houses and shop premises.

This collection is of necessity separate from that of refuse collection, due to the small capacity of the refuse vehicle and the impracticability of using a trailer in conjunction with the horse drawn cart. This results in a high collection cost, which, together with the cost of sorting and baling of the salvage, results in the total costs exceeding the amount realised from the sale of the salvaged materials.

The total weight of salvaged materials collected during the year amounted to 23 tens 11 ewts. which realised a sum of £149 - 5 - 0:

It is anticipated that when a motor refuse vehicle is acquired, the work of refuse and salvage collection can be combined, with a considerable lowering of the cost of collection, resulting in an excess of income from salvaged materials over expenditure.

Salvaged materials are stored, sorted, baled and bundled at the Council's Highway Depot in Queens Road, and the work is carried out in an open fronted shed under cramped and exposed conditions, there being a lack of covered accommodation available at the Depot.

HOUS ING.

Building Programme.

The Council's Post War Housing Programme provides for the erection of 20 houses on the Day's Close Site and 85 houses on the Orchard Road Site.

Day's Close Site.

Site Preparation Works were commenced on this site at the beginning of the year and roads, sewers and other services were laid before the erection of houses commenced. The completion of Site Preparation Works (surfacing of roads and laying of footpaths) has been left until the houses are at or near completion.

The erection of houses was commenced in January and at the end of the year 18 houses were in course of construction, and the first 4 houses were nearly ready for occupation. These houses comprise 16 with three bedrooms and 2 with four bedrooms.

Orchard Road Site.

In April, the Site Preparation Works were commenced on this site, and concrete roads and footpaths were formed and sewers laid before building operations commenced.

In June, the erection of 11 houses was begun, and in September a further 44 houses were started. Of these 44 houses, 4 are to be of two bedroom type, 24 of three bedrooms, and 16 of four bedrooms.

The rate of progress in the completion of houses has been disappointing, but very great difficulties due to shortages in labour and materials have had to be mot, and many obstacles overcome to maintain progress at the maximum rate possible.

HOUSING ACT 1936.

Due to the great amount of time necessarily expended on new housing works and in other directions, it has been impossible to carry out much work in the re-conditioning and repair of old property, and no formal action under the Housing Act was taken during the year.

6 houses in Clearance Areas and 1 house on which a Demolition Order is operative are still awaiting demolition.

Informal action was taken where essential repairs to roofs, walls, floors, windows, ceilings, eaves gutters and downpipes etc. were necessary, with satisfactory results.

Control of Civil Building.

The Sanitary Inspector and Surveyor has been designated as the officer responsible for the issue of Building Licences on behalf of the Minister of Works under Defence Regulation 56A.

During 1946, 6 licences for the crection of new dwelling houses were issued, and three of those houses were completed and occupied by the end of the year.

Two licences were issued for the conversion of existing buildings into dwelling accommodation at an estimated cost of £1225.

304 other applications to carry out building works were received during the year, of which 12 were refused as being for work not considered essential at the present time.

19 licences were issued for work of structural alterations or additions at properties at an estimated cost of £2859. These works included the provision of additional bedrooms, W. C's, bathrooms, garages etc.

273 licences were issued for essential works and repairs to properties of a total estimated cost of £12,819.

Of these licences, 184 were in respect of dwelling houses and 89 in respect of other buildings.

The works licensed included the repair or renewal of roofs, eaves gutters and downpipes, drains, external walls, internal wall plaster, ceilings, chimney stacks, floors, cooking and heating apparatus, water closets, sinks, baths and lavatory basins, the repair and painting of external wood and ironwork, internal redecorations, installation of electricarervices and other essential works to bring property up to a reasonable standard of repair.

The sorting of applications, the inspection of properties to verify the essentiality of the works proposed, the inspection of works in progress and the considerable amount of office work entailed in the issue of licences, added greatly to the work of the Inspector and his clerk and proved a severe strain throughout the year.

INSPECTION AND SUPERVISION OF FOOD.

Milk.

There are three milk producers in the district, one of whom is licensed by the County Council for the production of Tuberculin Tested Milk.

Two of the producers are also retail purveyors of milk in the district and three other retail purveyors obtain their milk from outside the district.

Inspections of the farms and dairies were made and samples of milk taken in accordance with the Milk (Special Designations) Regulations 1936/46 gave results which complied with the standard.

Meat.

No slaughtering of animals is carried out in the district.

Meat in the butchers shops has been inspected, and the following certified as unfit for human consumption.
