To The Chairman and Members  
of the Selby Urban District Council.

Ladies and Gentlemen,

I have the honour to present to you the Annual Report on the health of the Urban District, and the work of the Public Health Department for the year 1969. The report is not really of my work but that of my predecessor, Dr. Appleton, who, as the first Divisional Medical Officer, contributed greatly to the development of the Health Services of this Division and to whom, I am sure, you would wish me to extend your thanks.

### **VITAL STATISTICS**

193 Live births were registered, a decrease of 21, giving a Birth Rate of 17.0 per thousand population (Adjusted Birth Rate 17.7). The County aggregate rate for Urban Districts was 16.8 and for England and Wales 16.3.

Two stillbirths occurred.

There were 139 deaths, giving a Crude Death Rate of 12.3 (Adjusted Death Rate 11.6). The County aggregate of Urban Districts was 12.3 and the rate for England and Wales 11.9.

Births exceeded deaths by 54.

Seven infants died under the age of one year, giving an Infant Mortality Rate of 36.3, the highest for nine years. The County rate was 19.3 and the National rate was 18.1. Five of these deaths were caused by congenital defects, one by respiratory infection and one was due to prematurity.

No maternal deaths occurred during the year, and none has occurred since 1954, when there was one death.

### **INFECTIOUS DISEASES**

14 cases of infectious disease were notified during the year, of which 12 were scarlet fever, and 2 of infective jaundice.

### **CERVICAL CYTOLOGY**

During 1969 94 women had the cancer smear at Selby County Clinic. There were no abnormal smears. No patients were referred for breast tumors to the general practitioners.



## **FAMILY PLANNING**

At the time of writing, the Leeds Branch of the Family Planning Association have just informed me that a clinic will start in the County Clinic, Raincliffe Street, a venue which the County Council has already approved. Clinics will be held weekly on Thursday evenings at 6.30 p.m. from 1st October; Dr. Eileen M. R. Bell-Syer will be the doctor-in-charge.

This clinic will give advice on all modern methods of contraception, although the intrauterine device is only inserted in the larger clinics. Patients will still have to attend York for insertion but can be supervised at Selby. Advice is also available on infertility and other marital problems, and pre-marital couples may attend.

## **MENTAL HEALTH**

At the present time the extensions to the Rawcliffe Training Centre are now well on the way to completion and it is hoped to occupy the main adult workshop in the Autumn. Renovations to the existing building will start when the changeover has been effected and arrangements made to cater for the Junior Department during this difficult period.

## **NURSERIES AND CHILD MINDERS REGULATION ACT, 1948 AS AMENDED BY THE HEALTH SERVICES AND PUBLIC HEALTH ACT, 1968**

People who wish to care for children of others during the day have to be registered either as child minders or have their premises registered as a nursery. This applies to all kinds of day care, including play groups, nursery groups and looking after children in one's own house. The applicants have to meet certain standards before the County Council will register them.

There are, at present, four child care groups registered in Selby Urban District.

1. Mrs. Worton, 80 Leeds Road is registered for 8 places in the age group  $2\frac{1}{2}$  to 5 years. This is a re-registration under the new Act of 1968. Morning sessions only are offered.
2. Mrs. M. Mair, 9 Applecroft Road, is registered for 4 places; age group 0—5 years. This is a new registration and may operate either sessional or full day care.
3. Mrs. P. M. Clay, 4 Doncaster Road, is registered for 13 places; age group  $2\frac{1}{2}$  to 5 years. This nursery caters for full day or sessional care.

4. Mrs. O'Neil, 11 West Park, is registered for 6 places; age group  $2\frac{1}{2}$  to 5 years—sessional care only.

These groups not only allow certain mothers to go out to work but provide a very useful introduction for young children to learn to play with others before they reach school age. They also give many young mothers a very necessary relief from the constant care that young children demand.

In conclusion, I wish to record warm thanks on behalf of both my predecessor and myself for the support of the members and officers of the Council, the loyal services of the Public Health and Divisional Health Staffs, and the help given by voluntary workers at the Clinics.

## ANNUAL REPORT OF THE PUBLIC HEALTH INSPECTOR, 1969.

The Chairman and Members of the Selby Urban District Council.  
Ladies and Gentlemen,

I beg to present to you my fourth Annual Report on the environment in the Selby Urban District for 1969. The most important legislation during the year was probably the 1969 Housing Act which altered the law on Improvement Areas and also strengthened powers to deal with multi-occupation. The Public Health (Recurring Nuisances) Act, gave local authorities additional powers to deal with nuisances and the Clean Air Act passed in the previous year was brought into operation. There was no major legislation in respect to food, but the Meat (Sterilisation) Regulations 1969 enabled a closer check to be kept on the disposal of unfit meat and a new Code of Practice was issued for the meat trades.

### (a) **Water Supply.**

A satisfactory supply of water was maintained throughout the district by the Pontefract, Goole and Selby Water Board. One complaint was received of discolouration and one of fine sand in the water and these were passed to the Boards Engineer for investigation.

(Note: the three houses receiving supplies by stand pipes are in areas for clearance in 1970).

Eleven samples were obtained from domestic premises and submitted for Bacteriological Examination. Two showed slight coliform contamination but two further follow up samples in each case were satisfactory.

### (b) **Sewerage and Sewage Disposal.**

Although the necessary tenders for Phase 2 of the Selby Sewerage Scheme had been accepted during the late summer it was not possible for work to commence before the end of the year under review but work was expected to commence early in 1970.



**(c) Refuse Collection and Disposal.**

A regular weekly collection of household refuse was maintained by the Surveyors Department and trade refuse was collected from retail and commercial premises.

Disposal was continued by tipping at the Bondgate Tip and early in the year agreement was reached with the Selby Rural District Council to tip at the Rural District's Gateforth Tip when the Bondgate Tip was full. Tipping was continued at Bondgate throughout the year and during the warmer periods in the Summer months complaints of fly nuisance were again received. The tip was treated at intervals by the Council's Pest Operators both for flies and rodents and, in addition, spraying for flies was carried out by the Council's own workmen as often as required.

It was hoped to be able to commence closing this tip in 1970.

**(d) Swimming Bath.**

Regular samples of water from the Council's Baths were taken throughout the swimming season (March to October). The total number of samples examined by the Public Health Laboratory at Wakefield was 31. No coliform bacilli or Bact. Coli (Type 1) were isolated and 18 of the samples had a Nil Plate Count; the remainder had a Count of under 10.

**(e) Complaints and Nuisances.**

The number of complaints investigated was 65. At the beginning of the year 1 informal notice and 3 Statutory Notices were outstanding. During the course of the year 43 informal notices and one Statutory Notice were served and all the Statutory Notices outstanding together with 39 informal notices were abated. This left 5 informal notices outstanding at the year end.

A proposal to construct a new service road between Micklegate and Selby Dam was actively proceeded with during the year and when completed it will be possible to demolish and improve a large area of land which is at present inaccessible.

Complaints continued to be received from many persons about the fouling of footpaths and open spaces by dogs. There seems to be no reliable evidence that this is a health hazard but it is certainly aesthetically unpleasant and a nuisance when footwear, particularly of children, is fouled. The public may complain about this with a view to the institution of proceedings by them under the County Councils Bye-Law but there is a reluctance for individuals to get



mixed up with litigation. One can only express the hope that dog lovers will try to exercise their pets so as to cause no inconvenience to other members of the public.

**(f) Noise Abatement Act, 1960.**

Three complaints were received of nuisances; two were of excessive noise from factory premises and one from commercial premises in the town centre. The complaints were investigated and confirmed, where necessary by sound level meter readings. One of the industrial complaints was due to a faulty valve which was abated when the valve was renewed and in the other case the offending process closed down. The noise from the commercial premises was reduced after the proprietors had been interviewed.

Again no complaints were received about noise nuisance from mobile salesmen's chimes.

**(g) Public Conveniences**

Public conveniences are provided by the Council on four sites. The Council arranged for all the conveniences to have four weekly servicing by specialist contractors in addition to the normal day to day cleansing and it is hoped that this will effect an improvement until such time as it is possible to renew the older buildings.

**(h) Special Premises.**

Regular visits were paid to the premises dealing with the cleansing of rags and 21 certificates were issued for the export of this material.

Visits were also paid to inns and places of entertainment to ensure that adequate sanitary arrangements were available for customers. One statutory and one informal notice was served during the year.

At the beginning of the year two piggeries were licensed under the provisions of the Diseases of Animals (Waste Foods) Order, 1957 but one closed during the year. A complaint was investigated about the other piggery but this was not substantiated and no action taken by the Council. A complaint of an accumulation of manure at a further piggery was confirmed and the nuisance abated following verbal representations.

## **PART 2—FOOD INSPECTION AND FOOD HYGIENE**

**(a) Meat and Food Inspection.**

One private slaughterhouse is licensed at 66, Millgate, Selby, but was only used on two occasions during the year the number of animals slaughtered being 8 pigs of which part



of one was rejected as unfit. Meat sold in Selby is obtained from abattoirs outside the district.

Inspection of meat and other types of foodstuffs was carried out at wholesale warehouses, shops, cafes, school canteens and food supermarkets. The following is a summary of food stuffs rejected as unfit for human consumption :—

Unfit meat is disposed of by being taken in sealed vehicles to a sterilization plant at Doncaster and the Meat (Sterilization) Regulations, 1969 which came into force in November, 1969 require that all unfit meat must be sterilised. An additional requirement of the regulations is that all meat so consigned must have a certificate which is taken with the meat to its destination and a permanent record maintained for three months.

Danish bacon in closed, refrigerated containers continued to arrive in Selby throughout the year and the necessary inspections were made here instead of at the port of entry as required by the Imported Food Regulations.

#### (b) Food Complaints

Five complaints of unsatisfactory food were investigated during 1969 as follows :—

The total number of inspections of food premises was 192 during the year.



**(d) Food Hygiene (Market Stalls and Delivery Vehicles) Regulations, 1966.**

Markets are held on Mondays in the Market Place and Micklegate. The number of stalls subject to the above Regulations remained at 17 comprising 8 fruit and vegetable, 2 ice-cream, 2 wet fish, 1 fried fish, 1 bacon and ham, 1 eggs, and 2 sweets and toffee.

87 inspections of these stalls were made throughout the year and inspections were also made of mobile shops and delivery vehicles. One mobile "hot dog" stall was registered during the year.

As a result of the activities associated with the Selby Abbey 1969 Festival more than usual quantities of food were sold out of doors and in tents and marquees. Generally speaking this catering was satisfactory but I would urge to all organisers of events where temporary catering will be required, to ensure that food is prepared and sold in a hygienic manner. If any advice is required the Health Department is only too willing to help.

**(e) Registration of Certain Food Premises—Food and Drugs Act, 1955.**

The only food premises which, by law, have to be registered with the local authority are where ice-cream is manufactured or sold and where sausages and meat products are manufactured.

No ice-cream is manufactured in Selby. Pre-packed ice-cream is sold from 45 shops and loose ice-cream from 1 shop. Ice-cream is also sold from the hotels, cafes and snack-bars and from four mobile vans in the town centre during the warmer months. Four samples of loose ice-cream were examined and reported as satisfactory by the Public Health Laboratory.

The number of premises registered for the manufacture of sausages and meat products remained at 9 but the largest of these (a wholesale factory) closed at the end of the year.

**(f) Milk**

Milk is supplied throughout the district by the Leeds Industrial Cooperative Society Ltd., and Northern Dairies Ltd. No samples of milk were taken by the Selby Health Department but samples of milk retailed were obtained by the West Riding County Sampling Officer. Seven samples of Pasteurised or Sterilized milk were reported as satisfactory.

**(g) Poultry Inspection.**

There are no poultry processing premises within the district.



**(h) Laboratory Facilities.**

I would again record my thanks for the help and assistance given by the Director and his staff at the Wakefield Public Health Laboratory in the examination of water, ice-cream samples and other specimens submitted.

**PART 3—HOUSING.**

**(a) Housing Act, 1957—Unfit Houses.**

Three families were re-housed from the above properties and two were awaiting re-housing at the end of the year. The last occupant of the Leonard Chamberlain Trust Almshouse in Millgate was re-housed during the year and the building then demolished to make way for a road improvement scheme.

At the end of the year 30 houses remained to be dealt with out of the clearance programme accepted by the Council in 1966. Following the passing of the Housing Act, 1969, a Circular was received from the Ministry in November (Ministry of Housing and Local Government Circular 92/69) asking the Council to prepare before the end of January 1970 a programme for dealing with unfit houses from 1970-1973.

Complaints of Housing defects were investigated at ten houses and informal action taken with the various owners. At the end of the year seven of the houses had been repaired and at the remaining three the work had been put in hand.

No applications for Certificates of Disrepair were received under the provisions of the Rent Act.

No alteration was recorded with houses in multiple occupation. One was improved to a higher standard by the installation of additional washing and cooking facilities.



**(b) Caravan Sites and Control of Development Act, 1960.**

Three caravan sites were licensed in the district:—

Regular inspections were carried out at all these sites throughout the year and one written notice issued to abate contraventions of the licence conditions. One caravan on the Flaxley Road site was made the subject of a Demolition Order owing to its age and unsatisfactory condition. In addition a family was rehoused from a caravan on the Millgate site.

No difficulties were experienced with itinerant travellers.

## **PART 4—INDUSTRIAL AND COMMERCIAL ENVIRONMENT**

**(a) Air Pollution Control—Industrial.**

Three complaints of smoke nuisance were investigated. One was found to be due to a breakdown in the automatic stoker and when this was repaired no further nuisance was noted; the second complaint referred to dense smoke as a result of burning waste on a works incinerator and two informal notices were sent before an improvement was effected; the third complaint was as a result of burning rubbish in the open air and a verbal warning was given.

In addition smoke observations were made of a factory premises and two notices served as a result of emission of dark smoke. Consideration was being given to replacing the obsolete type of vertical boiler to effect a permanent remedy.

Two applications were received and approved for the erection of new chimneys and one application for the installation of new coal fired boilers.

A complaint was received about the emission of harmful fumes from industrial premises but this was fully investigated by H.M. District Alkali Inspector and not confirmed. Observations, however, are continuing both in Selby and the adjoining districts.

No action was taken as to domestic smoke control.

**(b) Factories Act, 1961.**

70 factories were registered under the provisions of the above Act. Inspections were made at 16 of these premises. Two persons were notified as outworkers.

One factory was reported by H.M. Inspector of Factories as not having sufficient sanitary accommodation and this was remedied by the year end.

**(c) The Offices, Shops and Railway Premises Act, 1963.**

The number of premises registered fell slightly to a total of 185 comprising 50 offices, 119 retail shops, 3 wholesale premises and 13 catering establishments.

General inspections carried out totalled 56.

One retail shop continued to be exempt from certain provisions of the Act while awaiting enlarging and improving.

Conditions generally were found to be satisfactory in the premises visited and particular attention was paid to the standards of lighting following publication of the Department of Employment and Productivity's booklet on this subject.

Only one accident was notified and this was not a serious one. No prosecutions were instituted under the provisions of the Act.

**(d) Hairdressers' Premises.**

The number of hairdressers and barbers registered under the West Riding Council (General Powers) Act, 1951, was 17. These were 10 ladies' hairdressers, 6 gentlemen's establishments and one dealing with both ladies and gentlemen. One ladies' establishment closed down and three new ladies' salons opened.

All were maintained in a satisfactory manner.

**(e) Pet Animals Act, 1951.**

One pet shop was licensed (market stall) under the provisions of this Act. One contravention of the licence conditions was reported (sale of an animal to a person under the age of 12 years) and a suitable warning issued to the licensee.



## **PART 5—PEST CONTROL**

### **(a) Rats and Mice.**

The Council agreed to continue their contract with Messrs. Rentokil Laboratories to deal with infestations at domestic premises and Council property. The same firm also have contracts with many industrial and commercial occupiers and where no contract existed, "ad hoc" treatments were arranged through the Council. The town and Staynor Wood Estate sewers were treated for rats twice during the year. The level of infestation by rodents remained about the same although some increase in activity in the Ousegate area was noted as a result of disturbance during the rebuilding of Selby Toll Bridge.

Publicity was given during the year to the facilities offered by the Council for treatment of domestic properties at no charge to the tenants. The Council were represented at meetings of the West Riding Pests Control Committee by Cr. C. Coultish, J.P. and myself, and help and advice was always readily available from the local and regional staff of the Ministry's Pest Division.

### **(b) Other Pests.**

Little trouble was experienced again during the year from insect pests and four complaints of cockroaches and crickets gaining access to houses were dealt with by the contractors. As in previous years many house-holders were subject to ant infestation and help was given by the Health Department in 128 houses.

## **PART 6—HOUSING MANAGEMENT**

The Council House Management duties, involving housing applications, transfers and exchanges of tenancy, supervision of the Old People's Wardens Service and general estate management continued to be carried out by the Public Health Inspector. The House-Letting Sub-Committee (Crs. Backhouse (Chairman), Coultish, Mrs. Gant and Mrs. Staniland) allocated exchanges, and new tenancies and met on 15 occasions.

The number of houses owned by the Council increased by one as a result of the purchase of a semi-detached three bedroom bungalow on a private development at Westbourne Park and its adaptation for use by a handicapped person. The total number of Council houses, bungalows and flats at the end of the year being 1,275. No new Council houses were built in 1969.



The number of new tenancies allocated during the year was 30 and the number of exchanges granted was 21. In addition, 2 mutual exchanges were approved by the Housing Committee.

At the beginning of the year there were a total of 418 applications for houses and bungalows. This figure increased to 439 by the year end, of which 121 were applications for bungalows by existing Council house tenants.

As a result of the continuing financial economies no extension was possible of the services of Wardens for Elderly Persons although a survey showed the need of an additional appointment in the Central Ward.

Further old-type houses in Denison Road were improved and modernised by the adaptation of the third bedroom to form a bathroom.

In conclusion, I would thank Miss M. Jackson for her efficient administration particularly with housing management duties, the Medical Officer of Health and the Chief Officers of the Council for their continuing help and assistance, and the Chairman and Members of the Council for their constant support and understanding.
