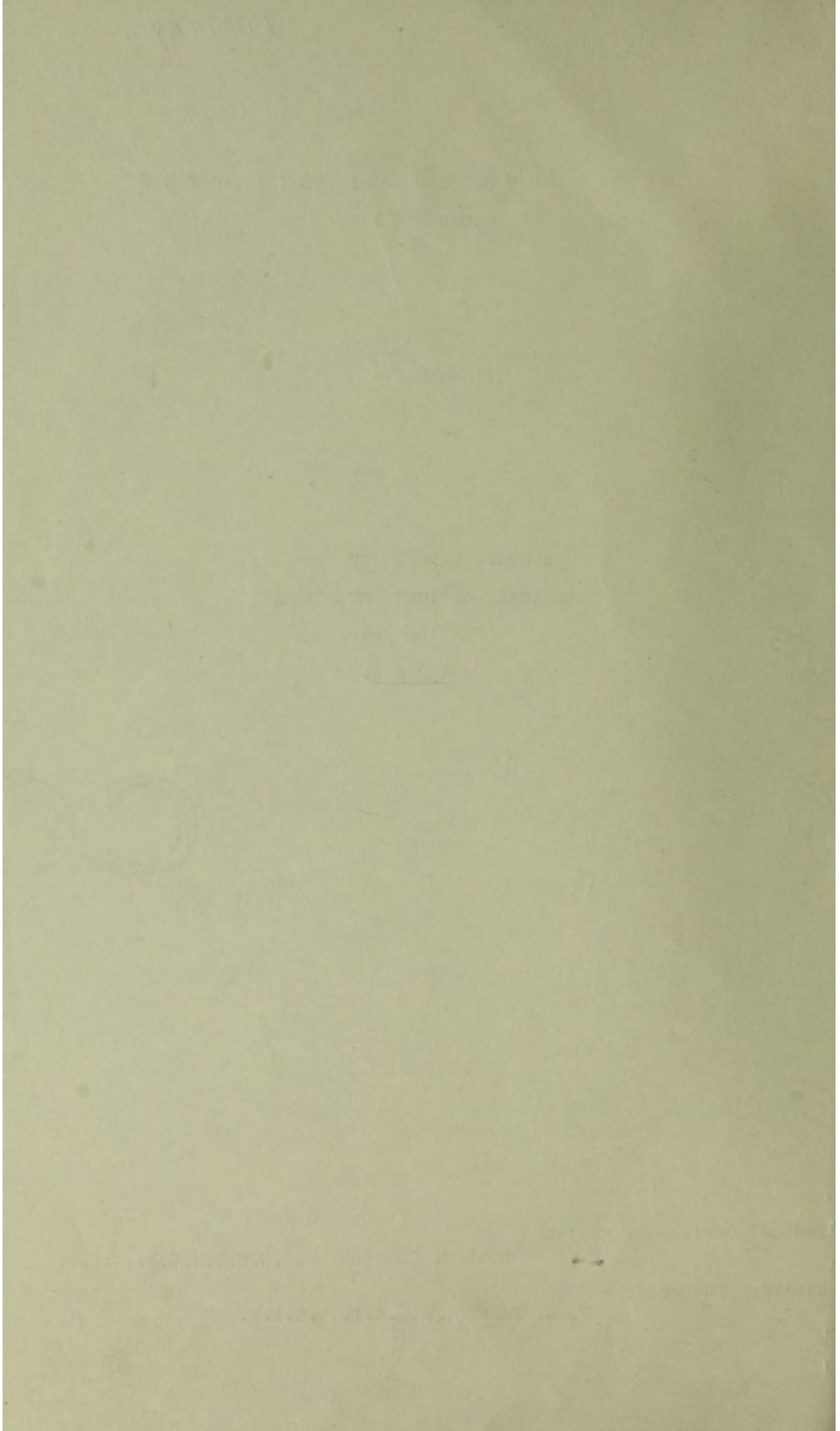

B. Personal Health Services in the district.

The personal health services, including the ambulance service, in the district continued to be provided by the County Council. It has not yet been possible to develop the County Council's Domestic Home Help Service in the district. Otherwise the services provided have been adequate and no further comment with regard to them is considered necessary.

The Public Health Laboratory Services have proved in all respects most helpful and satisfactory.

The year saw a re-organisation in the work of the department. As a result of which, one Sanitary Inspector only is now employed who gives the whole of this time to his statutory duties as Sanitary Inspector, refuse collection and salvage, together with drainage and sewerage disposal arrangements throughout the district.

2. WATER SUPPLY.

Under the re-organisation referred to above, the maintenance of the Council's water supplies is, for the time being, the responsibility of the Council's Consulting Engineer. Ultimately, it is the intention of the Council (in consultation with the Wincanton Rural District Council) to appoint a full time Water-works Manager to be responsible for the maintenance of the whole of the Council's water undertakings.

Rainfall for the year 1952 (as recorded by Mr. C.E. Bean of Barton Gardens, Sherborne) = 34.49 inches.

(a) Quantity. Some temporary shortages of water were again experienced during the year due to a fall in the yields of the springs and to leakages of some of the principal mains caused by Oxford clay erosion. Supplementary supplies were obtained from the Sherborne Urban District Council's supply and from the Sturminster Rural District Council's supply to Holwell and Bishops Caundle.

The Trent Estate found it increasingly difficult to maintain a satisfactory supply from their private Estate supply to the parish by reason of defective service pipes and approaches were made to the Council to take over this private supply. No finality had been reached at the end of the year in this matter.

(b) Quality. The bacteriological quality of some of the supplies still proves unsatisfactory, in particular the Southern Parishes Supply. Chlorination of all the Council's supplies is carried out and regular samples submitted for bacteriological examination and for free chlorine estimation. The details are given below.

Work was commenced during the year on the scheme approved by the Ministry of Health for obtaining a major supply from the Thornford borehole. This new scheme is anxiously awaited in order to augment the present supplies and to enable the unsatisfactory supplies in the district to be eliminated.

(c) New Works and new connections. In connection with the comprehensive water supply scheme from the Thornford borehole, construction began on the pump house, surface tank and roadway at the borehole. Work was completed on the replacement of the cast iron main from The Fox Inn to Cornford Bridge, Holwell, rendered defective by soil action.

3. DRAINAGE AND SEWERAGE.

New works completed during the year. Small sewerage disposal schemes were provided at Purse Caundle, Beerhackett and Ryme Intrinsic for groups of Council houses provided in this parish.

Longburton & Trent. The sewerage schemes for these two parishes were prepared and approved in principle but sanction has not been given owing to the present restrictions on capital expenditure.

4. PUBLIC CLEANSING.

(a) House Refuse. A monthly collection of house refuse is made throughout the district, with the exception of Haydon Park Polish Dependants' Camp where a twice weekly collection is made.

(b) Salvage. The recovery and sale of salvage was continued during the year. Owing to the fall in demand the return from waste paper was disappointing but it is forecast that the demand will shortly improve. Salvage to the value of £175. 6. 9d. was sold during the year.

(c) Cesspool Emptying. The Council's sludge pump was used for the regular emptying of cesspools at Council houses and was also available for private works at a fixed charge.

5. RIVERS AND STREAMS POLLUTION.

Pollution of the River Yeo at Purse Caundle continued and the ditch was cleaned at regular intervals to minimise the nuisance.

Ditches in the parishes of Chetnole, Bishops Caundle, Trent, Thornford, Leigh, Yetminster and Bradford Abbas have been cleaned out regularly. Conditions in the ditches at Bishops Caundle and Bradford Abbas will improve as the sewerage schemes are developed which further serves to emphasise the need for similar schemes in other parishes.

Housing Acts 1949 & 1952 - Improvement Grants.

Two applications were received during the year for grants under these Acts. In one case the grant was forthcoming and in the other case the grant was refused.

The conditions governing the making of Improvement Grants under the Housing Act 1949 have been modified and it is anticipated that in consequence a greater number of applications will be received. The financial limits have been raised so that a maximum grant of £400 may be made in approved cases. Agricultural service cottages may now be included and this, together with the considerable easing of the building licensing situation, offers a good opportunity for improving housing conditions in rural areas at much less expense to the local authority than the building of new houses. It is felt that by this means many of the sub-standard cottages in the district could be restored to a useful life and that sympathetic consideration should be given to applications under this Act.

Housing Applications - Inspections.

Following inspections carried out by the Medical Officer of Health of the conditions under which 8 applicants for Council houses were living, 8 recommendations for the granting of additional points on medical grounds were made.

Comments.

It will be noted that 29 new Council houses were completed by the Council during the year compared with 22 in the preceding year. At the end of the year there were 144 applicants on the Council's waiting list of whom 118 were resident within the district. Of these, 78 were employed outside the district and it is not unreasonable to assume that a large proportion of these would seek housing accommodation, if and when available, in the district where they are employed.

PROTECTIVE INOCULATION.

The value of protective inoculation against Diphtheria has proved itself to such an extent that, except in the largest centres of population, Diphtheria is now virtually unknown. This satisfactory position can only be maintained providing at least 75% of the babies born are immunised against Diphtheria. Whilst the response to immunisation in the district is good, this may not continue to be the case because a generation of parents to whom Diphtheria is only a name cannot be expected to respond to appeals to have their children immunised as parents did ten years ago.

Increasing demands come from parents, fully aware of the distress and suffering occasioned by an attack of Whooping Cough, for their offspring to have protective inoculation against this disease.

It is suggested that the results so far achieved in connection with the protection of children against the worst effects of Whooping Cough by prophylactic inoculation justifies immunisation against this disease being adopted to the same extent as that against Diphtheria.

If immunisation against Whooping Cough was combined with immunisation against Diphtheria (which has been shown to be possible) then it is suggested that not only will the benefits be obtained in respect to Whooping Cough, but also that the level of immunisations against Diphtheria would be maintained at a higher level than can otherwise reasonably be expected.
