B. Nature of the District

The district is rural in character, its main industry being agriculture. A large number of outworkers carry on glove making in their homes for factories situated outside the district. A large dairy, with a wide supply area, is situated within the district.

The district is becoming increasingly a dormitory area for persons working in Sherborne and Yeovil.

C. Health Services in the District which are not the responsibility of the District Council

The Hospital Service

The Yeatman Hospital (West Dorset Hospital Group of the Wessex Regional Hospital Board) provide the local hospital requirements, both in-patient and out-patient.

Laboratory Services

The Public Health Laboratory Service has again proved co-operative and efficient.

General Medical Practitioner, Ophthalmic and Pharmaceutical Services

These are administered locally by the Dorset Executive Committee.

County Council Services

The personal preventive health services are the responsibility of the County Council.

They comprise, the care of mothers and young children, maternity, school health, prophylactic inoculation, home nursing, mental health, the ambulance service, the care and after care of the tuberculous, blind and handicapped, health education, the domestic help service and the welfare of the aged.

Voluntary Services

Acknowledgment must be made to the excellent voluntary work carried out in the district by the British Red Cross Society and the W.V.S. who provide a meals on wheels service - at present limited in scope but which, it is hoped will show expansion in the coming year.

Not only are the meals appreciated by the old people, but even more (one sometimes thinks) are the twice weekly visits by helpers who take the meals around.

D. Environmental Health Services

PUBLIC HEALTH STAFF

Medical Officer of Health(Part time) - NOEL F. PEARSON
M.R.C.S., L.R.C.P., D.P.H.

He also acts as Medical Officer of Health to four other District Councils in the North Dorset area and as Assistant County Medical Officer to the Dorset County Council.

The time available which he has to devote to his duties with your Council is rather less than one half day per week.

Dr. G.B. Hopkins of the Blandford and Wimborne districts acts as his deputy during his absence, on a reciprocal basis.

Public Health Inspector - J.E.T. Bastable.

Certificate of R.S.I. & Sanitary Inspector's Joint Board as Public Health Inspector. Certificate of Royal Society of Health as Inspector of Meat and Foods.

The Public Health Inspector also carries out the duties of Meat Inspector, Refuse Disposal and Maintenance of the Council's sewage schemes, and drainage bye-law administration and petroleum regulations inspector.

Clerical Assistance - One Clerk.

Although attempts were made during the year to appoint an additional public health inspector no appointment was made. Candidates interviewed were not prepared to accept the salary offered by the Council.

WATER SUPPLIES

Public Supplies

The Wessex Water Board are the responsible body for the public water supply in the district.

The supply has remained satisfactory in quality and quantity during the year.

Twelve samples were taken by the Public Health Department and forty six by the Water Board during the year.

Private Supplies

There are numerous private supplies to communities, farms and individual dwellings and, generally, these receive no purification treatment and can only be regarded as suspect.

A very real attempt was made during the year to investigate these supplies and to bring up to date records of properties still on unsatisfactory or suspect private supplies in an endeavour to improve in the qualities of the supplies or connection of properties concerned to the public supply.

This important action could not be effected due to shortage of staff.

It is pleasing to report that following unsatisfactory samples, which were taken from one private source serving a small community and a farm, the public health department were instrumental in securing the provision of a chlorination plant to purify the water. Subsequent samples were satisfactory.

DRAINAGE AND SEWERAGE

Yetminster

The comprehensive scheme for this parish was not completed by the end of the year.

Bradford Abbas

Complaints were received concerning the surface water drainage in part of this parish and representations have been made to the County Council to get improvement.

Continued progress has been made in connecting properties on the line of the sewer in this area.

Oborne & Poyntington

The drainage to the twelve Council houses at Oborne is still unsatisfactory and no improvement is likely until a sewer is laid. The Poyntington works only give a basic settling treatment to the sewage and the effluent is discharged untreated.

The Council have decided that the sewerage scheme to serve these two parishes should receive priority following completion of the schemes which are at present being prepared.

Thornford

Appreciable development in Thornford might well give rise to surcharging of the sewer and may also lead to the need for enlargement of the sewage works.

Alveston, Trent & Bishops Caundle

These parishes are sewered and consequently enable most owners of sub-standard property to improve their houses without the expense of putting in septic tanks.

Leigh, Chetnole, Sandford Orcas and Purse Caundle.

These areas are not sewered. It was found necessary during the year to pipe in a length of roadside ditch at Leigh in order to prevent smell nuisance to nearby dwellings.

General

All of the unsewered villages have problems associated with sewage disposal.

PUBLIC CLEANSING

House Refuse Collection

Twice monthly collections are still in operation. It is causing some confusion to the public due to collections being tied to the calendar month which means that there is, at times, a three week period between collections.

The Leigh tipping site is still in use and due to the abnormal amount of rain towards the end of the year it has been very difficult to gain access to the site due to flooding and impossible to get to the tipping area. Consequently, it has been necessary to obtain the services of a contractor to spread and cover the refuse.

By the end of the year no material progress had been made in securing a new tipping area, so urgently required.

Roadside Sanitation

The rural district laybys do not appear to be overnight stopping places for holiday makers so this possible nuisance is avoided. We do have one particular pull-in on the Marston Road which is used by dealers in rags and metal and this gives rise to the problem of getting them moved on.

Cesspool Emptying

The Modern Cleansing Company (Yeovil) are under contract for work at the Council's housing sites and this arrangement has worked satisfactorily.

RIVERS AND STREAMS POLLUTION

Farm effluent is still responsible for most of the pollution complaints received, especially when silage liquor is discharged.

The Council have accepted the interim and consent standards placed on their various works in the area of the Somerset River Authority.

OFFICES, SHOPS & RAILWAY PREMISES ACT, 1963

Your public health inspector was appointed as an inspector under this Act. Eight inspections only, were carried out during the year.

Intensive agriculture produces its own special public health problems. Serious nuisances have been complained of during the year from the disposal of waste farm effluent and fly nuisance.

PREVENTION OF DAMAGE BY PESTS ACT, 1949

The North Dorset Joint Rodent Committee, of which the Sherborne Rural District Council is one of the six constituent authorities, continued to carry out the provisions of this Act.

The work of the Committee continued to function smoothly and expeditiously.

RAG FLOCK AND OTHER FILLING MATERIALS ACT, 1951

There are no premises subject to registration under the above-mentioned Act, within the district.

ANIMAL BOARDING ESTABLISHMENTS ACT

Under the Act, with certain limited exceptions, any person who carries on a business of providing accommodation for other people's animals, even in a private house, must be registered under this Act, by the District Council.

Two premises in your district are registered under the Act.

Slum Clearance

Very limited action was taken during the year with regard to slum clearance. An appreciable number of houses in the district are recognised as being unfit for habitation but in the absence of new houses being available in quantity for re-housing, limited action only was practicable in enforcing closure or demolition of unfit property.

Overcrowding

No cases of statutory overcrowding were found during the year.

Houses Known to be Let in Lodgings

No houses are known to be let in lodgings.

Improvement Grants (Housing Act, 1949 and Housing Repairs and Rents Act, 1954)

Twenty four applications (compared with fifty in 1964) were received during the year for discretionary grants under the above-mentioned Act, seven applications were received in respect to standing grants compared with six during the preceding year.

It is some years now since any systematic inspection of dwellings in the area has been possible. The Housing Act of 1964 has laid a duty on the Council to carry out such a survey, but with the present staff position it does not appear likely that action in this direction will be able to be taken. This is to be regretted as a positive drive to get all properties in the district brought up to standard would be most welcome.

Provision of New Houses and Re-Housing

Forty six new houses were built in the district by private enterprise (compared with forty two in 1964).

During the year the Council completed eleven new houses and active planning took place with regard to new housing at Thornford and new development in Yetminster.

As the Council house waiting list still reflects a present shortage of houses to let in the district, the provision of these further houses is welcomed.

Waiting List

One hundred and twenty one applicants were on the Council house waiting list at the end of the year, of which seventy one were resident in the district, compared with one hundred and twelve and eighty two respectively, at the end of 1964.

Twenty six applicants were housed by the Council during the year, compared with fourteen during the preceding year.

It was suspected that one person living outside your district had been infected some time previously, by cream produced in your district. Investigation on the farm gave negative results.

2. Other Food Premises

The inspection and supervision of food premises is one of the principal duties of a public health department.

This includes the inspection for evidence of disease and fitness for human consumption of all animals killed at the slaughterhouse, the examination as may be necessary of all other foods sold in the district and the supervision of food premises and food vehicles to ensure that food is stored, prepared and sold under clean and hygienic conditions.

To maintain adequate supervision all food premises should be inspected, at least, twice a year. It is regretted that during 1965 only thirty five of the fifty eight premises in the district were inspected.
