LADIES AND GENTLEMEN,

We have the honour to present the Annual Report for the year 1947.

General Statistics.

The District is now comprised of 8 Parishes instead of 7 as in our last Report for, by an Order made by the Minister of Health on 7th March, 1947, and known as the London Colney and Colney Heath Parishes Order 1947, the old Parish of St. Peter's was dissolved and out of it were formed two Parishes to be known as London Colney and Colney Heath.

**Senior Sanitary Inspector's Report
for the year ended 31st December, 1947.**

Disinfection and Disinfestation.

Thirty rooms were disinfected following cases of infectious diseases. Four houses were treated for the eradication of vermin by the application of D.D.T. preparations.

**Paratyphoid Outbreak, Wheathampstead.
19th July—13th September, 1947.**

This outbreak which occurred during a spell of excessively hot and dry weather affected 24 persons, viz. :—4 men, 10 women and 10 children. It was confined to a small community and did not spread beyond the Parish. In all 900 specimens were collected for laboratory examination comprising specimens of urine, faeces, sewage plant effluents, milk, drinking water, and water from a nearby river.

Work under the Public Health Act, 1936.

Two hundred and thirty-five complaints of alleged nuisances were received and, of these, 209 were satisfactorily dealt with by informal action, leaving twenty-six outstanding at the end of the year. In one case it was found necessary to serve an abatement notice and to take Court proceedings.

One statutory notice was served under Section 50 requiring a cesspool which overflowed to be cleansed, and one statutory notice was served under Section 39 requiring the provision of satisfactory drainage to a dwelling-house.

Thirty-two informal and two formal notices were served under Section 44, and fourteen informal and two formal notices were served under Section 47 requiring the replacement of pail closets by water closets. As a result a total of 36 pail closets were replaced by water-closets.

Thirty-one informal and seventeen formal notices were issued under Section 45 requiring the provision of adequate flushing facilities in connection with existing water closets and the required work was completed in twenty-four cases.

Informal notices under Section 75 calling for the provision of dustbins were served in respect of one hundred and seventy-three premises.

Moveable Dwellings.

At the 31st December, 1947, twenty-seven licences issued under the provisions of Section 269 of the Public Health Act, 1936, were in operation, being an increase of one over the figure at 31st December, 1946.

Housing.

Ten houses which had been the subject of confirmed demolition or clearance orders prior to the outbreak of war were demolished. Seven of these had been occupied under licence until the families concerned could be rehoused. Licences issued under the authority of Defence (General) Regulation No. 68A are in operation permitting the occupation of twenty-five houses which are the subject of confirmed demolition or clearance orders. Five of these houses were purchased by the

Council with a view to improving their sanitary circumstances and thus permit of their being occupied for a further limited period.

Four houses which had been placed in Category 5 in the recent Rural Housing Survey and in respect of which informal notices were served requiring certain improvements, were offered for sale by auction by the owner and were purchased by the Council, and proposals respecting the works required thereat are under consideration.

Water Supplies.

By the end of the year negotiations had reached an advanced stage regarding the provision of piped water supplies to serve Amwell, Nomansland and Bower Heath in the Parish of Wheathampstead, and the Aubrey Estate in the Parish of Redbourn, while the work of laying a main to serve Old Bricket Wood in the Parish of St. Stephen's had actually commenced.

With the consent of the Statutory Undertakers and by arrangement with the Hill End Hospital Authorities from whom the supply is purchased in bulk through a meter, the Council laid a water main through Tyttenhanger Green in the Parish of Colney Heath. This has been greatly appreciated by all the residents as the majority of the wells there were unreliable. Already thirty-two of the forty premises within easy reach of the new main have taken the supply.

5,292 dwellings out of a total of 6,330 dwellings in the District are supplied from Waterworks. Of these 94.63% are supplied from the water mains direct

to the houses and the remaining 5.37% by means of stand-pipes. With one exception, viz.: that to the Aubreys Estate, Redbourn, the quality of the waters is satisfactory and the supplies are constant. There is no evidence of liability to plumbo-solvent action.

In Appendix A to this report details are given regarding the number of dwellings served by each Water Undertaker supplying in the St. Albans Rural District, and in Appendix B figures are given with respect to dwellings in each Parish which are supplied from Waterworks.

Sewerage.

No sewers are available in the following areas:—

- (a) the whole of the Parish of St. Stephen's Rural, except for a privately constructed sewer which serves the 111 houses forming the Christmas Estate.
- (b) certain developed localities within the Parish of Wheathampstead and particularly the Luton Road locality.
- (c) a considerable area within the Parish of Colney Heath, and particularly Colney Heath Lane, Hatfield Road, Tyttenhanger Green, and the Main Road, Tollgate Road, and Roestock Lane, Colney Heath.
- (d) that part of London Colney which lies south of the River Colne.
- (e) the whole of the Parish of St. Michael's Rural.
- (f) the whole of the Parish of Harpenden Rural.

Sewer extensions to serve the outstanding properties at St. Albans Road, Sandridge, were completed in May, and at the end of the year the work in connection with the installation of a rider sewer along an accommodation road lying off Hempstead Road, Redbourn was in hand.

Negotiations proceeded with respect to the proposed provision of main drainage within the Parish of St. Stephen's and considerable progress was made.

The proposed schemes for the Lower Luton Road area of Wheathampstead and for certain areas in the Parish of Colney Heath also received close attention.

**Registrations under Section 14—
Food and Drugs Act, 1938.**

Thirty-nine premises which are used in connection with the manufacture or sale of ice cream or preserved foods, etc., are registered under the above-mentioned Act. Of these six are used for the manufacture of Ice Cream and seventeen are used in connection with the sale of Ice Cream.

Public Cleansing.

Public cleansing is carried out by direct labour. The work includes refuse collection, nightsoil collection, and cesspool emptying.

Refuse Collection.

Four side-loading vehicles are maintained for this work, three being in constant service and one held as a spare machine. Each vehicle is fitted to haul a salvage trailer. Collections are made at intervals of rather under two weeks, but every effort must be made to get back to once-weekly collections. All refuse is dealt with by controlled tipping and three tips are operated, viz.: one at the old gravel pits, Nomansland, in the Parish of Sandridge, one at an old chalk pit on Hedges Farm at Harper Lane, near Radlett, and one at Bartons Dell, Dunstable Road, Redbourn.

Nightsoil Collection.

A once-weekly collection is made wherever the service is required. One vehicle operated by one man is engaged on the work, and the nightsoil is deposited on agricultural land. In all 641 pails are dealt with as follows:—

Cesspool Emptying.

A fleet of four Dennis cesspool emptying vehicles is operated and the question of the acquisition of a further vehicle was under consideration at the end of the year. All cesspools excepting those serving properties which are within 100 feet of a public sewer and which are at a level which makes it reasonably practicable to construct a drain to communicate with a public sewer are cleansed free of charge.

It is a most formidable task, the extent of which is governed by many factors. Unfortunately a very high percentage of the cesspools are not watertight and so the nature of the subsoil, the level of the subsoil water, and the prevailing weather conditions, have an important influence on the rate at which the cesspools fill up and so whenever there is a prolonged period of inclement weather an intolerable situation develops. This was amply demonstrated during the severe winter of 1946-47. At the 9th of November, 1946, the number of cesspools awaiting attention was 15, on the 7th December the figure was 117, on the 11th January, 1947, it was 144, on the 8th February 169, on the 8th March 175, on the 5th April, 340, and on the 10th May, 362. The danger to the public health from such a state of affairs is of course a very real one, and it is clear that the proposed sewerage schemes, and particularly the scheme for the Parish of St. Stephen's, should have the utmost priority. Should however there be any undue delay in the installation and operation of public sewers in that Parish there are two matters which must cause further disquiet (1) the likelihood of further building development which would inevitably aggravate the problem and (2) the

absence of any security of tenure in respect of our main site for the disposal of cesspool sewage. Should this site be lost the cesspool emptying service would be strained to the utmost and we would be faced with a most serious situation.

In Appendix C to this report statistics are given with respect to cesspools which are cleansed by the Council.

Hertfordshire County Council Act, 1935.
Section 26.

Under the provisions of the above Act permission to deposit refuse within the St. Albans Rural District has been granted in respect of three sites, namely :—

Land on the south side of Codicote Road, Wheat-hampstead, known as Black Bridge Tip and owned and operated by Messrs. Inns & Company of London.

An old gravel pit at North Orbital Road, Smallford, in the Parish of Colney Heath owned by Messrs. Inns & Company of London.

Part of a field on the north side of Park Lane, Colney Heath, owned and occupied by Mr. S. G. Turner.
