Mr. Chairman, Ladies and Gentlemen,

I have the honour to present the Annual Reports on the Health and Sanitary circumstances of the St. Austell Rural District and Lostwithiel Municipal Borough for the year 1967. The Lostwithiel Municipal Borough joined with the St. Austell Rural District in April, 1968.

The picture presented is satisfactory, infant mortality is low over the whole district. The real impact of the prophylactic preventive measures against notifiable diseases is shown by the absence of notifications, in the Rural District apart from 2 cases of tuberculosis only measles occurred and in Lostwithiel only measles.

The Services supplied by the County Council are the same throughout the whole of Health area IV which includes both the Rural District and the Borough.

I regret to report that Mr. Setchell who was ill throughout most of 1967 died shortly after the union of St. Austell Rural District and Lostwithiel Municipal Borough. Mr. Lawless and Mr. Down covered the Public Health duties of Lostwithiel during this period.

I must thank Mr. Lawless for his co-operation and for his assistance with this report, also the public health staff for the cheerful help always willingly given. It is also a pleasure for me to record the goodwill and help of all other Officers of the Council.

At this point I usually thank the Health Committee for the interest and courtesy shown to the Public Health Department, but this time I feel I must thank particularly the Lostwithiel Health Committee, and confess that I shall miss them.

The St. Austell Rural District has three main sources of income, farming, China Clay and tourism. Surprisingly these industries do not conflict with one another, and the China Clay region exerts an attraction to the tourists, with its Moon landscape. The China Clay Industry, which has grown in stature steadily particularly over recent years, provides steady all the year employment for many in the Rural District. The climate, as can be expected, varies, being drier and more bracing on the northern aspect and wetter and milder on the south coast.

Lostwithiel is a quiet country town set in pleasant surroundings in the valley of the Fowey River. The Town has many historic associations and has some very well preserved buildings. The only industry of any consequence is the milk depot.

These were available at the Public Health Laboratory, Royal Infirmary (City), Truro.

Personal Services

These services are provided by the Cornwall County Council and include such activities as home nursing, domiciliary midwifery, health visiting, vaccination and immunisation, maternity and child welfare, ante and post natal care, home help, visits to the elderly and the various aspects of school health. The business of a Local Authority health department is to not only take measures to prevent disease but to try to recognise disease in an early stage, particularly those killing diseases which can be cured if treated early. In this respect it is worth recording that during 1967, 875 women were examined at the cervical cytology clinics. These clinics provided a wider screening than merely smear tests, medical examinations were carried out by a lady doctor, urine checks made and breasts examined. The cover, thus provided, extended to checking for many pelvic conditions, breast cancer, kidney disease and diabetes. Many gynaecological conditions were discovered which if left untreated could have given rise later to much ill-health. The patients were in each case advised to seek treatment from their family doctors, and the family doctors informed of the results of examinations.

A Health Education Officer was appointed by the County Council in 1967. This forward step will pay dividends in the future since the ability to use teaching aids to the best advantage is a specialised technique. A considerable extension of the Welfare Services has taken place with a closer relationship between welfare and mental welfare

Clinics functioning throughout the area are given, since all clinics cater for people from the Rural District area and the Borough.

SECTION C

Sanitary Conditions

Water

The North and Mid Cornwall Water Board supplies over 80% of the Rural District population with water, which is good in quality and not plumbo-solvent. Frequent sampling was carried out in various parts of the Rural District throughout 1967. samples from the Board supplies numbered 358, of these 4 were unsatisfactory. Well supplies to individual premises were sampled on 30 occasions, 9 of these being unsatisfactory. In all cases of unsatisfactory samples remedial measures are taken. Lostwithiel Borough is supplied from the North and Mid Cornwall Water Board through the Restormel Works - all samples taken were satisfactory.

Sewerage

The Fraddon Scheme which was commenced in 1965 was completed in February, 1967. Work on the Sticker Scheme was making satisfactory progress. The following parishes are still without facilities viz., Creed, Ianlivery, Luxulyan, St. Ewe, St. Wenn, and St. Michael Caerhays. In the Borough steps are being taken to push ahead with the Sewerage Scheme contemplated for some years past.

Rodent Control

No operator employed by the Council. Domestic complaints are dealt with by the Public Health Inspectors, and tips and sewage works by the Council's staff normally engaged thereon.

Beaches

The Council continues to employ two lifeguards. There was one fatality which occurred whilst the only lifeguard on duty at the time was off the beach taking a short lunch. On other beaches lifebuoys and lines were maintained. Arrangements were made to scavenge one beach.

Scrap Metal Dealers

Thirty three dealers were registered under the Act. There are none which can properly be described as 'itinerant', and none have been so registered.

Animal Boarding Establishments

There are three, which have been found to be satisfactory and registered.

National Assistance Act, 1948

One person was buried and the cost defrayed by the rates.

Petroleum Acts

Seventy eight licences were issued to retailers and private users of petrol from pumps. Tests were required on all petrol tanks over 20 years old.

Litter

Bins provided by the County Council at lay-bys are emptied during the summer months, and payment is made to us of 1/6 per bin or sack.

Refuse Collection

No change. Four vehicles serve practically all the dwellings in the area weekly, and a daily collection is made at R.A.F. Station, St. Mawgan, for which the Air Ministry pay. The summer influx of visitors, campers and caravanners puts considerable extra work on the service.

Refuse Disposal

One tip only, operated with a mechanised scraper/shovel.

Housing

Thirty three houses in the Rural District were the subject of Demolition or Closing Orders. Defects were remedied by informal action in respect of 52 houses. In respect of the Municipal Borough informal notices and interviews with owners secured necessary repairs in 30 instances.

Public Conveniences

The Council own and maintain 10 public conveniences and contribute towards the upkeep of two others which are privately owned. Agreement has been reached for the provision of a public convenience at Golant and a new one has been provided at Portholland in conjunction with the Truro Rural District Council.

Almost always retailed pre-packed. The locally manufactured article is regularly sampled, and where sold from bulk, supervision is made of utensils, storage, etc. All Retailers have proper refrigerators. Itinerant Vendors have suitable equipment and carry proper hand-washing facilities.

Cafes, Restaurants and Food Catering Premises

Visits of inspection are regularly made to all food preparing premises and in general the standard of the cleanliness is satisfactory.

The number of Pulmonary Tuberculosis cases on the register, dropped from 92 to 80 inspite of 2 new notifications, while the Non-Pulmonary cases dropped from 7 to 5.

Tuberculosis Prevention

Although the number of deaths from tuberculosis has diminished very notably over the years, and the notification of new cases has diminished also, but less markedly, a vigorous policy of prevention has been pursued in the County of Cornwall. School children in the age group 11 years are offered B.C.G. vaccination against the disease. In 1967 following preliminary testing of 807 children in the selected age group, 613 children received B.C.G. Children who have already received the vaccine in early life and show a positive reaction on testing do not need vaccination and hence the discrepancy between those tested and those receiving the B.C.G.

In addition to the above, all new cases are visited by the Tuberculosis Health Visitor in order to assist in any measures needed to ensure continuation of treatment, cases on the list receive follow-up visits, and contacts of cases are visited and advice given regarding Xray examination. Patients receive advice regarding the need for care in preventing the spread of the disease to contacts.
