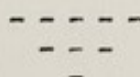

To the Chairman and Councillors of the
St. Austell Rural District Council.

Mr. Chairman, Ladies and Gentlemen,

I have the honour to present the Annual Report on the Health and Sanitary Circumstances of the District for the year 1964.

This, my third Annual Report since arriving in Cornwall, is far and away the most pleasant one. A natural increase in the population of 157 resulted from an increased birth rate and a decreased death rate. This is particularly welcome in a County where most Rural Districts display a declining population, and where people in the upper age groups constitute a higher percentage of the population than in the Country as a whole. The death rate not only dropped in relation to the previous year but was below the rate for England and Wales. The disturbingly high still birth rate of recent years fell to near the National figure, while the Infantile Mortality rate dropped to only half the National rate. It is to be hoped that these excellent figures can be maintained in the future.

In spite of mains water supplies reaching more people each year, there are still too many houses without an indoor piped supply. There is no reason why the Rural resident should lag behind the Urban dweller in the modern amenities of good living. The Council are to be congratulated on the extent of their Sewerage Schemes, the list of works in the pipeline providing sufficient indication of the intention to bring services to most centres of population.

Notifiable diseases were conspicuously down in 1964, and it is a pleasure to note the steadily falling figures in the pulmonary tuberculosis register. There were no cases of food poisoning in spite of the seasonal influx of visitors.

The waiting list for Council housing increased slightly, but the policy of the Council in granting mortgages and in encouraging applications for improvement grants has undoubtedly helped to relieve the demand to some extent.

The Chief Public Health Inspector has contributed substantially to this report, and Mr. Townsend has willingly supplied me with required information for which I thank them. However, I must express my thanks to my colleagues in all departments for the friendly co-operation they always accord the Health Department.

I should like to express my sincere thanks to the Chairman and Members of the Public Health Committee for, not only their unfailing interest and courtesy, but their constant efforts to improve the environmental conditions of the people of St. Austell Rural District.

The St. Austell Rural District is an extensive area stretching across the County and having a northern and southern seaboard. Typical of England, where the weather is a standard source of conversation, the Rural District shows distinct differences in weather conditions between the north and south coasts. The north coast is the drier, more bracing but more windy aspect. The China Clay Industry, Agriculture and the Tourist Trade are the main sources of income. In recent years the China Clay Industry has grown continuously and is a valuable export. The influx of visitors causes a great seasonal increase in population, with the concomitants of increase of prosperity and increase of problems.

Laboratory Facilities

These are available at the Public Health Laboratory, Royal Cornwall Infirmary, Truro.

The services provided by the County Council functioned steadily throughout the year, although one can expect a diminution of the Domiciliary Midwifery Service due to the opening of the new St. Austell Maternity Hospital at the end of September 1964. This hospital has been eagerly awaited and should prove to be of great benefit to both patients and medical practitioners. It is meant to serve an area of roughly about 15 miles radius from the hospital, and it will undoubtedly save many expectant mothers the long journey to Redruth.

The policy of carrying out immunisations and vaccinations continued and supplies of prophylactics can be obtained by Medical Practitioners from the Health Area Office. The nursing and health visitor staff remained at full strength throughout the year.

The consultant ante-natal clinic which previously functioned at Moorland Road, St. Austell, has now been transferred to the Maternity Hospital, St. Austell. Infant Welfare Clinics are carried on at Roche, Indian Queens, St. Dennis and Summercourt. A list of all clinics throughout the No. IV Health Area will be submitted below.

The work of the voluntary helpers at the various Infant Welfare Clinics is much appreciated and these helpers can feel considerable satisfaction in the knowledge that the success of the clinics and the homely atmosphere produced owes much to them.

In addition to the various clinics a list of the Family Planning Clinics will be included, since these clinics although run by a voluntary body operate at the Health Area Office and provide a service for the Rural District population.

SECTION C

Sanitary Conditions

Water Supplies

About 80% of the population of the R.D.C. receive water supplies through three main agencies, viz. Fowey River, Rural District and Newquay Water Company. However all of Mid-Cornwall and the area served by the North Cornwall Water Board will be supplied by one Board as a result of negotiations being carried on with a view to the formation of a new Board - The North and Mid Cornwall Water Board.

The work commenced in 1963 to bring main supplies to Milltown was completed by the end of 1964.

A combined programme for 1964/65 envisaged laying a branch main to Criggan, Roche early in 1965, and for carrying out renewals at Church Road, St. Dennis and Edgcombe Road and Old Bodmin Road, Roche. By the end of 1964 a scheme had been prepared for submission to the Ministry for renewals at Hendra, Hornick and St. Dennis supplies.

Regular sampling of the water supplies was carried out throughout the Rural District. In the Sticker area unsatisfactory samples caused surprise since this was Fowey River water, but energetic cleansing of the reservoir soon resulted in a return to satisfactory samples, although the focus of the trouble was not determined.

Sewerage

The demand for better means of sewage disposal is never-ending, and as a result there is constant activity in this field, schemes being in various stages from the design stage to the completed works. The following list will give information of work completed and envisaged.

1. Roche Sewage Disposal Works and Station Road Sewer Extension was started in February 1964 and completed October 1964.
2. Sewer Extension at Goonamarris, St. Stephen commenced December 1964 and Extension at Castle View, St. Dennis to follow at once.
3. Inquiry on the Fraddon Sewerage Scheme was held in July and tenders were invited for early 1965.
4. Gorran Churchtown Sewerage Scheme ready for starting in early 1965.
5. Quintrell Downs Sewerage Scheme delayed by land purchase difficulties. It is expected, however, that resort to compulsory purchase will not be necessary.
6. Sticker Sewerage Scheme, further design procedure awaits land purchase negotiations.
7. St. Mawgan and Trenance Sewerage Scheme, once again, land purchase difficulties cause delay, also some doubt regarding suitability of site.

The state of the sewerage of the parishes is listed below :-

(a) Parishes served except for minor localities

Grampound, Roche, St. Columb Major, St. Dennis, St. Sampson and St. Stephen in Brannel.

(b) Parishes with partial service

St. Goran and St. Mewan.

(c) Parishes with Schemes awaiting execution

Colan, St. Mawgan in Pydar and St. Enoher.

(d) Parishes with no sewerage facilities

Creed, Lanlivery, Luxulyan, St. Ewe, St. Michael Caerhays and St. Wenn.

No immediate schemes are contemplated for these parishes.

Public Conveniences

The Council own and maintain ten public conveniences and contribute towards the upkeep of two others which are privately owned. Agreement has been reached for the provision of a public convenience for Golant.

In view of the exhortations to the public to wash hands after visiting the lavatory, one would hope that the provision of washing facilities in public conveniences will not be long delayed.

Rodent Control

The Rodent operator continues to be employed on other Public Health Department work also. As was previously mentioned, the fairly widespread

use by farmers and others of "Warfarin" compound keep the problem under a fair degree of control without our intervention. Doubtless the advice widely given has reduced our operative work.

Nuisances

There were the usual number of small drainage troubles, and the occasional complaint about the keeping of animals. In the main these were abated, there remains one drainage nuisance which involves the drainage of several properties, and steps are being taken to secure collective action for abatement.

Beaches - Life Saving

There is only one surfing beach, where a life-guard was employed. There were several rescues during the summer, but regrettably one fatality. The bather was out of sight of the life-guard being 'round the point'. The non-surfing beaches on the south coast are provided with life-belts and lines.

Refuse Collection

No change. Four 12 c.yd. lorries serve the district, and our Contract with the R.A.F. re St. Mawgan Aerodrome was renewed. One new replacement vehicle was delivered.

Refuse Disposal

Two tips are in operation. The hiring of plant for the control thereof is not being very successful, and it is proposed to recommend the purchase of our own machine early next year.

Caravans

The general improvement in existing sites continues, and the number of applications for single van sites is increasing. It is felt that the omission of tents from the Caravan Sites and Control of Development Act, 1960 was a serious fault, and better control would result from their inclusion. Increasing efforts to make the more tardy operators provide all the amenities on the proper scale are meeting with success.

Housing

Action was taken to secure the Closing or Demolition of 10 dwellings.

Quarry (Fencing) Act 1887

Action was taken to cause the proper fencing of two quarries.

Animal Boarding Establishments Act 1963

Three such establishments have been approved and registered.

Offices, Shops and Railway Premises Act 1963

Occupiers of such premises have responded very well to the publicity re registration, but inspection has not yet been commenced.

Preventive measures are taken to limit spread from active cases and to protect immediate contacts of cases of offering B.C.G. vaccination.

Tuberculosis Prevention

For several years the Cornwall County Council has offered B.C.G. vaccination against tuberculosis to all suitable school leavers following preliminary skin testing. The suitable children are those who have not had previous B.C.G. vaccination or previous tubercular infection and therefore react negatively. In 1964 it was decided to lower the age groups to the 11 year old children.

585 children were examined and 481 received B.C.G. vaccine. These figures are for Health Area IV and not St. Austell R.D. only, since many children from the Rural District attend schools in the adjoining Urban Districts.
