The Registrar-General's estimate of population at the middle of 1939 is 20,550, an increase of 70 over the previous year's estimate.

The cases were evenly distributed over the Urban District.

No exceptional measures were considered necessary because of the war. It will be observed that the birth rate has fallen and is now below that of England and Wales, also the death rate has increased slightly but is still below the rate for England and Wales.

TO THE CHAIRMAN AND MEMBERS

OF THE

SWAPLINCOTE DISTRICT URBAN DISTRICT COUNCIL.

Gentlemen,

I have pleasure in presenting the report upon the work of my Department for the year ending December 31st., 1939.

In response to the request of the Ministry of Health, the contents of the report have been kept down to a minimum.

Like almost everyone, my work in 1939 was a strange contrast from the activity of a normal year. The outbreak of war in September suspended for a time many of my public health activities and it was only towards the end of the year that anything approaching normality was restored. The commencement of hostilities, however, meant merely an intensification of the work on various aspects of Civil Defence, which as an officer of the Council I had been concerned with, not only from the commencement of the year, but in 1939 also.

HOUSING.

In July, a Ministry of Health Inquiry was held into the decision of the Council to require the clearance of 143 houses in various parts of the Urban District which were considered unfit for habitation.

Somewhat earlier than this, commencement was made on the housing scheme of 108 houses and 16 bungalows on the site across "The Meadows" in Newhall, which were intended to rehouse the majority of the families living in these houses.

Then the war and instructions of the Ministry of Health suspended everything. We were, however, permitted to complete 44 houses already commenced, and after representations the Ministry agreed early this year to confirm clearance orders on a number of houses sufficient to occupy the houses to be finished.

Closet Accommodation.

During the year continued advantage was taken of the additional power given by the Public Health Act, 1936, to require the conversion of the insanitary types of conveniences into water closets.

Notices were served under Section 47 of the Act, and the conversions were done at the instance of the Council, who paid one-half of the cost involved.
