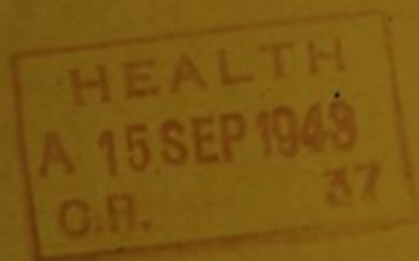

## **To the Chairman and Members of the Thorne Rural District Council**

Gentlemen,

In accordance with instructions from the Ministry of Health in Circular 2773, dated March 10th, 1943, the Annual Report is made as brief as possible. The various tables are in the forms prescribed by the Ministry, and are meant to ensure continuity of records.

The Birth Rate for 1942 is 21.86 per 1,000 population which compares with 15.8 for England. The rate in 1941 was 21.75.

The Death Rate is 9.67. The Death Rate for England is 11.6. The Death Rate for Thorne Rural District in 1941 was 10.8.

The Infantile Mortality Rate is 68.3 per 1,000 live births, which is an improvement on 79.2 for 1941. The rate for England is 49.

There was an increase in the number of deaths from Diarrhoea in infants under 2 years. There were 16 in 1942 and 3 in 1941.

The number of Diptheria cases was 63, which compares favourably with 94 in 1941.

The number of Scarlet Fever cases was also less, there being 29 in 1942 and 39 in 1941.

# **ANNUAL REPORT on the SANITARY CONDITION of the THORNE RURAL DISTRICT for 1942**

---

## ***General Statistics relating to the Rural District***

The Rural District comprises five civil parishes, and has an area of 38,419 acres.

The Registrar-General's estimate of the resident population for the year 1942 is 29,450.

The total number of inhabited houses in the district at the end of 1942, according to the rate books, was 7,161.

The Rateable Value of the district is £116,990.

The sum represented by a penny rate is £446.

## ***Vital Statistics***

In considering the Birth, Death and other rates which have been calculated for 1942, it must be borne in mind that:—

- (1) Non-Civilian Deaths are not included.
- (2) That Deaths and Births occurring amongst persons temporarily residing in this district on account of the war are included in the local figures.

### **Births**

The estimate of population supplied by the Registrar-General for calculating the birth rate is 29,450.

The total number of births during 1942 was 644.

Of these 328 were males and 316 were females.

Legitimate births numbered 598.

Of these legitimate births 308 were males and 290 females.

Illegitimate births numbered 46, 20 being males and 26 females.

The birth rate per 1,000 of the estimated population is 21·86.

The birth rate per 1,000 of the population for England is 15·8.

The total number of stillbirths was 29.

Of these 13 were males and 16 females; and all were legitimate.

The stillbirth rate for the district per 1,000 total (live and still) births is 43.

The stillbirth rate for the district per 1,000 population is 0·98.



## Deaths

The total number of Deaths during 1942 was 285.

Of these 153 were males and 132 females.

The actual or crude death rate for the district is 9.67 per 1,000 population.

No comparability factor is issued by the Registrar-General this year.

The death rate for England is 11.6.

## Deaths of Infants under 1 Year

The total number was 44.

Of these 30 were males and 14 females.

28 males and 13 females were legitimate.

2 males and 1 female were illegitimate.

The death rate of infants under one year per 1,000 live births is 68.30.

The death rate for England is 49.

The death rate of legitimate infants per 1,000 legitimate live births is 68.59.

The death rate of illegitimate infants per 1,000 illegitimate live births is 65.

The Diphtheria case rate for the district works out at 2.13 per 1,000 population, whereas the rate for England is 1.05.

The Scarlet Fever case rate for the district is 0.98 per 1,000 population, whereas England's rate is 2.19.

### ***Measles and Whooping Cough***

Under provisional regulations which came into force on October 23rd, 1939, Measles and Whooping Cough became notifiable diseases. 441 cases of Measles were notified. There were 21 cases of Whooping Cough.

### ***Puerperal Pyrexia***

One case was notified, and was treated under arrangements made by the West Riding County Council.

### ***Public Health (Smallpox Prevention) Regulations 1917***

No vaccinations under these regulations were performed by the Medical Officer of Health during the year.

If any medical practitioner wishes to have a case of Ophthalmia Neonatorum treated in hospital, all he has to do is to apply to the County Medical Officer who will arrange for the treatment.

## School Closures

There were no school closures during the year, but several have been visited by the Sanitary Inspector for purposes of disinfection when cases of diphtheria have been notified from children attending them.

## Water Supply

A bacteriological examination of the water supplied by the Thorne and District Water Company, in February 1942, gave results as follows:—

**Bacteriological Analysis.**—"Presumptive Bacillus Coli: None in 100 ml. of water. The examination shows that this water is satisfactory according to the standard recommended by the Ministry of Health."

## Sewerage

No extension to the Council's sewers was made during 1942.

## Camping Sites

One licence is in operation under Section 269 of the Public Health Act, 1936.



### ***Smoke Abatement***

Three observations were made but no unsatisfactory conditions were found.

### ***Eradication of Bed Bugs***

Seven houses were found to be infested with Bed Bugs. All were treated effectively with insecticides.
