Thorne Rural District Council.*

Ladies and Gentlemen,

As advised by the Ministry of Health in its circular 28/46, dated February 11th 1946, the annual report on the health of the district is again presented in condensed form. The statistical tables are in the forms required by the Ministry.

The population given by the Registrar-General for calculating the birth and death rates is 29,520, an increase of 210 from the number for 1945.

The Birth Rate for 1946 is 24.97 per 1,000 population, an increase of 2 from the rate for 1945. The Birth Rate for England and Wales for 1946 is 19.1 There were 63 more births than in 1945.

The Death Rate for 1946 is 9.1 per 1,000 population. In 1945 it was 7.98. The rate for England and Wales for 1946 is 11.5.

The Infant Mortality Rate is lower at 47 deaths per 1,000 live births. The rate for England and Wales is 43.

There were few notifications of Diphtheria and Scarlatina, the case-rates for these diseases being well below the rates for England.

Annual Report on the Sanitary Condition of the Thorne Rural District for 1946

General Statistics relating to the Rural District

The Rural District comprises five civil parishes, and has an area of 38,419 acres.

The Registrar-General's estimate of the resident population for the year 1946 is 29,520.

The total number of inhabited houses in the district at the end of 1946, according to the rate books, was 7,057.

The Rateable Value of the district is £118,011.

The sum represented by a penny rate is £445/9/6.7

Vital Statistics

Births

The estimate of population supplied by the Registrar-General for calculating the birth rate is 29,520.

The total number of births during 1946 was 737.

Of these 366 were males and 371 were females.

Legitimate births numbered 683.

Of these legitimate births 341 were males and 342 females.

Illegitimate births numbered 54, 25 being males and 29 females.

The birth rate per 1,000 of the estimated population is 25.00.

The birth rate per 1,000 of the population for England and Wales is 19.1.

The total number of stillbirths was 14.

Of these 10 were males and 4 females; 13 were legitimate.

The stillbirth rate for the district per 1,000 total (live and still) births is 18.66

The stillbirth rate for the district per 1,000 population is 0.47.

Deaths

The total number of Deaths during 1946 was 268.

Of these 132 were males and 136 females.

The actual or crude death rate for the district is 9.1 per 1,000 population.

The death rate for England and Wales is 11.5.

Deaths of Infants under 1 Year

The total number was 31.

Of these 15 were males and 16 females.

The death rate of infants under one year per 1,000 live births is 47.

The death rate for England and Wales is 43.

Diphtheria

The Diphtheria case rate for the district works out at 0.17 per 1,000 population, whereas the rate for England and Wales is 0.28.

The Scarlet Fever case rate for the district is 1.05 per 1,000 population. The rate for England and Wales is 1.38.

Measles and Whooping Cough

Under provisional regulations which came into force on October 23rd, 1939, Measles and Whooping Cough became notifiable diseases. There were 147 notifications of measles, and 67 of Whooping Cough.

Public Health (Smallpox Prevention) Regulations 1917

No vaccinations under these regulations were performed by the Medical Officer of Health during the year.

Four cases were notified, and recovery was complete in all.

School Closures

There were no school closures during the year.

Water Supply

Several bacteriological examinations of the water supplied by the Thorne and District Water Company were made during the year.

The report dated Nov. 19th, 1946, by the County Analyst was "Presumptive Bacillus Coli: None in 100 ml. of water. The examination shows that this water is satisfactory according to the standard recommended by the Ministry of Health."

The other reports were in similar terms.

The water is derived from a bore-hole into the New Red Sandstone of the Triassic system. It has been adequate in quantity, and satisfactory in quality throughout the year.

Approximately 6,600 houses have direct water supply from the Company. There are about 20 stand-pipes in the district.

Sewerage

There was one small extension in High Trod Road of 150 yards.

Camping Sites

One licence is in operation under Section 269 of the Public Health Act, 1936.

Smoke Abatement

Three observations of thirty minutes were made but no unsatisfactory conditions were found.

Eradication of Bed Bugs

Eight houses were found to be infested with Bed Bugs. All were treated effectively with insecticides.

Public Cleansing

This work is carried out by contractors.

In Hatfield, Hatfield Woodhouse, Stainforth and Thorne, this work has been carried out satisfactorily.

In Moorends Ward the contractor carried out this work in such an unsatisfactory manner that the Council terminated his contract and the work has since been carried out by direct labour with hired motor vehicles.

The cleansing of the parishes of Fishlake and Sykehouse was undertaken by contract for the first time, no cleansing service having been provided in these parishes previously.

The Council decided to carry out the whole of the Public Cleansing Service by direct labour and have ordered the necessary vehicles and it is hoped to inaugurate the service from the 1st April, 1947.

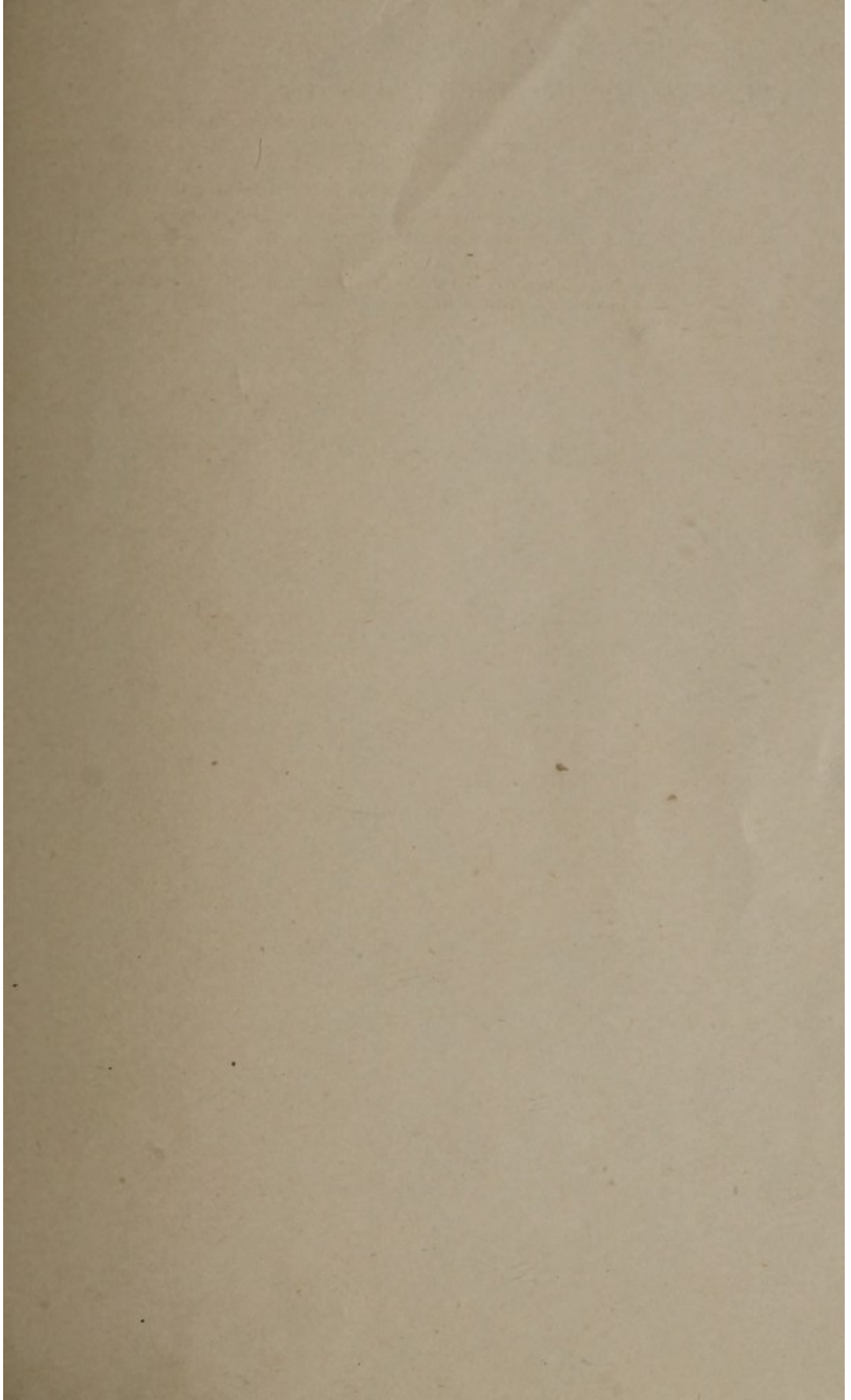
